

COUNTY COURT PROCEEDINGS

MINUTES OF THE MALHEUR COUNTY COURT MEETING - AUGUST 5, 1970:

The Court signed an Order hereby ordering that real property be conveyed, upon receipt of the consideration of \$1,000, to Elmer Hill, et ux, by a deed of conveyance executed by the County Court of Malheur County Oregon.

No action was taken on the "Ordinance on Amusement Festivals" but was continued until August 12, 1970.

The Court agreed to spray the Fairgrounds if the spray would be furnished.

APPROVED Order No. 3, In the matter of payment of claims, that the County Auditor to issue warrants totaling \$64,892.37.

Motion was made and seconded until August 12, 1970.

MINUTES OF THE MALHEUR COUNTY COURT MEETING - AUGUST 12, 1970:

The Court met with Judge White presiding and Commissioners E. W. Maag and Henry Esplin present.

The matter of hiring a supervisor to keep records of gravel and other materials used on roads that are under contractors were discussed but no action was taken at this time.

APPROVED by motion to budget no more than \$500, in the 1971-72 budget to help support a Malheur County booth at the Oregon State Fair.

APPROVED by motion to enter an order to remove two (2) lots in Ontario from the County Land sale for the purpose of carrying out a previous agreement of the Court meeting in January, 1970.

APPROVED by motion to place a notice in the newspapers to advertise the date of hearing, September 9, 1970, "In the Matter of Adoption of a County-Wide Ordinance Relating to Regulating and Licensing Entertainment Assemblies; Establishing Licensing Procedures; and Prescribing Offenses and Penalties".

APPROVED a liquor license application submitted by Wally Warila, Farewell Bend, Oregon.

APPROVED Order No. 4 in the Matter of Payment of Claims, hereby ordering the County Auditor to issue warrants totaling \$34,757.15.

MOTION made and seconded the meeting be adjourned until August 19, 1970.

MINUTES OF THE MALHEUR COUNTY COURT MEETING - AUGUST 19, 1970:

The Court met with Judge White presiding and Commissioner E. W. Maag present.

APPROVED by motion to purchase a cash register for the Tax Office.

The Court signed an application for a Wrecker License of Motor Vehicles to Ernest Norris, d.b.a. Ernie's Auto Salvage, After further discussion and viewing the premise a MOTION was made seconded and approved to rescind the application.

IN THE MATTER OF THE SALE OF COUNTY LANDS. . . The Court signed an Order whereby ordering the Sheriff of Malheur County to advertise the lots and tracts of land to be sold which the County has acquired through delinquent taxes. Such sale to be held on the 25th day of September, 1970, 10:00 a.m., at the front door of the County Courthouse.

The Court signed Order No. 5, In the Matter of Payment of Claims, hereby ordering the County Auditor to issue warrants totaling \$4,959.70.

MOTION made and seconded the meeting be adjourned until August 26, 1970. Voted on and approved.
