PROPOSAL
Shall the Board of Directors of School District No. 26, Nyssa, Oregon be authorized to levy for the fiscal year 1976-1977 the sum of \$ 140,467.00 outside the limitation set forth in Section 11, Article XI of the Oregon Constitution.
Without the approval of the voters the school board has authority to levy only the tax base of the district, which is \$ 701,954.00. This sum, together with available non-tax revenue, is insufficient to provide an education program adequate to meet the needs of the children of this district.
If this measure is approved, the operating budget to be financed by local taxes for the year 1976-1977 will be \$ 140,467.00 Greater than the operating budget financed by local taxes for the preceding year.

TAX LEVY MEASURE

PROPOSAL
Shall the Board of Directors of the Malheur Memorial Hospital District of Malheur County, Oregon be authorized to levy for the fiscal year 1976-1977 the sum of \$203,845.00 outside the limitation set forth in Section 11, Article XI of the Oregon Constitution.
Without the approval of the voters the district board has authority to levy only the tax base of the district, which is \$47,340.00. The tax base, together with available non-tax revenue, is insufficient to provide for the continued operation of Malheur Memorial Hospital. The proposed budget will provide funds for the continued operation of the hospital, recruitment of physicians, and funds for a building and equipment improvement program.
If this measure is approved, the operating budget to be financed by local taxes for the year 1976-1977 will be \$206,525.00 greater than the operating budget financed by local taxes for the preceding year.

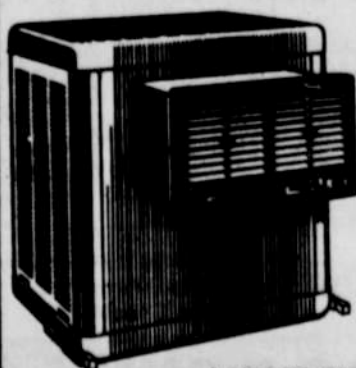
