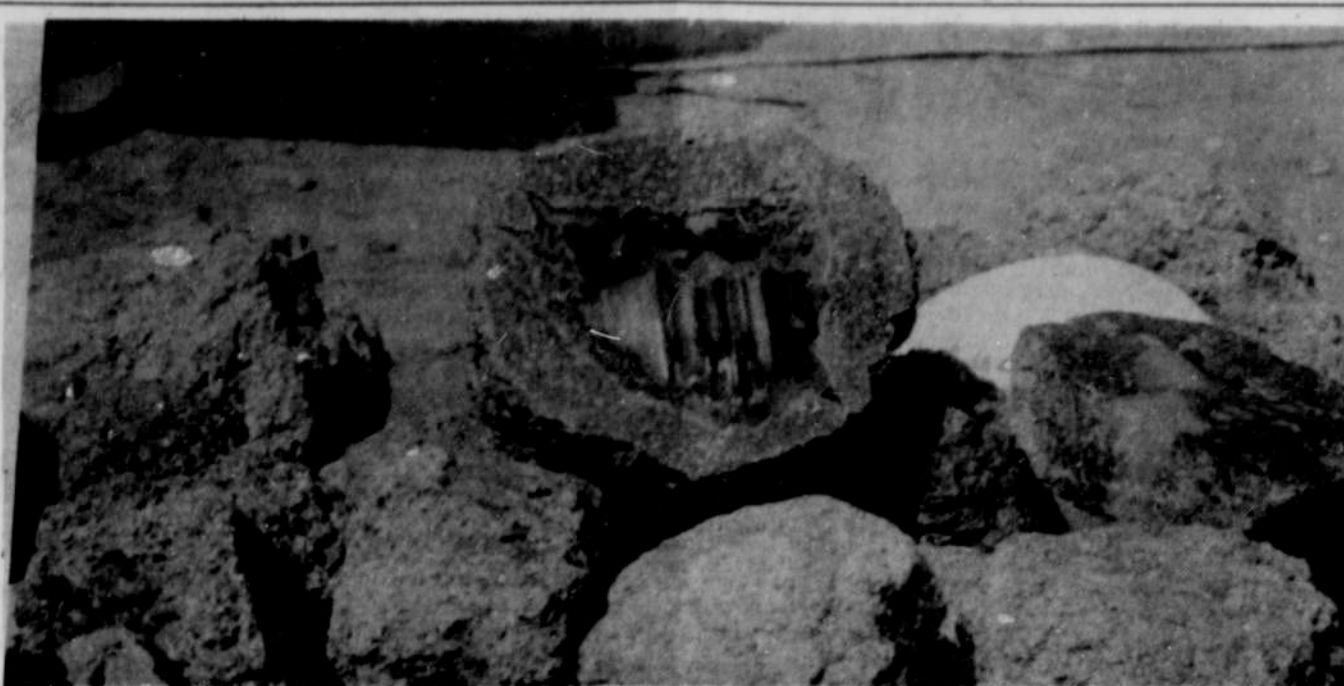

Farm-Home Administration Loans Authorized

To Irrigators on Reclamation Projects

Farmers Home Administration has been authorized to make loans for the Bureau of Reclamation on Federal projects to irrigators for the purpose of undertaking construction, management, conservation activities or the acquisition and transportation of water, which can be expected to have an effect in mitigating losses and damages resulting from the 1976-1977 drought period.

The loans will be only for those purposes specifically related to irrigation. These loans apply only to farms located within the Owyhee and Vale-Oregon Reclamation projects and funds must be obligated before September 30, 1977 and any construction must be completed before November 30, 1977.

Said loans will usually be repaid in less than five years and are interest free. Eligibility requirements are the same as for regular FmHA loans:

1. Be a farm owner, tenant, partnership or domestic corporation engaged in farming without sufficient resources to obtain sufficient credit elsewhere to finance the proposed loans mentioned above.

2. Have repayment ability. Applications can be made at the Farmers Home Administration office in the Agricultural Service Center at 46 S.W. 2nd. Street, Phone 889-7634.

Supervisors are in the office every Monday from 8:00-4:30 and other days by appointment.
