HON. J. H. SLATER DEAD

PASSED AWAY AT HIS HOME IN LA GRANDE YESTERDAY.

A Pioneer of 1850, He Was Long Identified with the History of the State.

W. T. Slater left yesterday afternoon for La Grande, in response to a telegram conveying the sad intelligence of his father's death, at the latter's home in that city.

James Harvey Slater, ex-congressman and ex-United States senator, was a prominent figure in Oregon politics for many years, and was one of the men who contributed much toward the state's prosperity. He was born in Sangamon county, Illinois, in 1826, where he lived until 1849, receiving his education in the common schools. He was one of the many to come to California in 1849, and from there came to Oregon in 1850, settling at Corvallis, in Benton county, where for two years he was a public school teacher. In 1853 he was appointed clerk of the United States district court and in 1854 was admitted to the bar. He served in the territorial legislature of 1857, 1858 and 1859 as an independent democrat, and was also a member of the first state legislature. From 1862 to 1861 he published a paper, called the Oregon Weekly Union, at Corvallis. He was also, for a considerable time, postmaster at the town of Corvallis. In the year 1862 he moved to Baker City, Oregon, where he practiced law for four years, removing to La Grande in 1866. The same year he was elected district attorney of the fourth judicial district and held office for two years. In 1868 he was the successful democratic candidate for presidential elector and cast his vote for Seymour and Blair. In 1870 Mr. Slater was the successful candidate for congress from Oregon and served two years during the forty-second congress. During the next few years he resided at La Grande where he practiced law and engaged extensively in agriculture and stock raising. In 1878 he was honored by being elected United States senator for Oregon and served in that capacity for six years, from March 4, 1879, to March 3, 1885, being succeeded by Hon. John H. Mitchell. He retired to La Grande in 1885, but in 1888 was again called into public life by the appointment as railroad commissioner for Oregon. His time in such office expired in 1889, since which time he has lived a retired life at La Grande, Oregon.

For some months past deceased has been in failing health, but his recovery was not despaired of until a few very days ago, when his condition became worse, and he passed away yesterday morning as indicated above.

He leaves a wife, and four daughters and five sons, as follows: Mrs. Nellie G. Nell, Olive Slater, Bertha Slater, Frank S. John L. and James D. of La Grande; Woodson T. of Salem; Mrs. A. B. Cherry, of Pendleton, and Robert, of Athens.

Deceased was a member of the Masonic fraternity, and his funeral will probably be held under the auspices of that organization.

HISTORIC PRINTING PRESS.

Brought to Oregon by Dr. Marcus Whitman, It is Now Owned by the Pioneer Association.

The first printing press ever seen in Oregon, which has for many years, resided in the office of the state board of horticulture at the capitol, is there no more, it having been taken by the Oregon Pioneer Association, and will be sent to Eugene and placed in the museum of the state university at that place. The press is an historic piece of mechanism. It was originally purchased in Boston by the American Methodist Missionary Society and sent by that organization to the resident missionaries at Honolulu, Sandwich Islands, on a trading vessel, and was around Cape Horn on a trading vessel. Later, when Marcus Whitman had reached Oregon and planted his mission station in the territory, the Honolulu missionaries presented him with the press, this being the first printing outfit brought to what is now the state of Oregon.

The force in State Printer Leeds' office yesterday, before the press was shipped to Eugene, cleaned it and used it in printing a roster of the employees of the state printing office, as a souvenir.

TWO HOP CONTRACTS.

M. L. Jones and E. H. Jones have contracted \$20,000 pounds of hops of this year's crop to T. A. Livesley & Co., of this city. The price to be paid for the hops is 10 cents per pound and 5 cents per pound is to be advanced at picking time. The hops are contracted in two lots of 10,000 and 10,000 pounds, respectively, and the contracts were filed in the office of the county recorder yesterday.

Other documents filed were a chattel mortgage for \$500; three mortgages, aggregating \$1,450, three satisfactions of mortgages, amounting to \$1,450, and an assignment of a mortgage for \$740.

POPULISTS IN CONTROL.

For the First Time in the History of Oregon, Did that Party Elect a Speaker Yesterday.

Oregon has had various complexions of legislative bodies in the past—democratic, republican and sufficiently mixed to make none at all, but yesterday was the first time in its history when the populists were in full control. The remnant of the house which had remained in the city met at 10 o'clock a. m., sixteen answering to roll call, three republicans and thirteen populists. Of course there was no quorum to do business. Speaker Carter had gone south the night before, so a speaker pro tempore had to be chosen, and Mr. Palmer, the trim, dapper little member from Linn county, was the lucky man. In a short time, there were all sorts of mischief, of a jolly sort, and some that was not so jolly. Some members wanted to have the sergeant-at-arms instructed to procure a special train, go to Portland and bring back the members who had gone away without excuses from the house, but that idea was abandoned. Dr. Jones, the venerable free-silver man of Soda Springs, had a radical free-silver resolution prepared to introduce, but was promptly shut off by Speaker Palmer with the ruling that no business could be transacted.

After filibustering for a time, the house finally adjourned to Sunday evening at 7 o'clock, under the impression that the constitutional expression "from day to day" included Sunday. The meeting this evening will probably be short.

LEG AMPUTATED.—State Treasurer C. S. Moore was in Portland a few days of last week, at the bedside of his father, who had an amputation of his right leg, below the knee. His father is W. S. Moore, who was treasurer for Marion county from 1870 to 1872, and who is kindly remembered by many old residents of Salem. Thirty years ago the coming April, Mr. Moore while working at Drake's foundry (the Salem Iron Works) ran a nail into his foot, and this amputation is the result of the wound sustained then. At that time he was in the prime of life, 40 years of age, and very robust physically, being 6 feet 4 inches tall and weighing nearly 250 pounds. Blood poisoning set in shortly after the first injury and as medical science was not as far advanced in curative processes in those days as at present, the proper remedies were not applied to entirely get rid of the wound, and it has troubled him more or less ever since. The family removed from Salem to what is now Klamath county, in 1874, and the old gentleman some years thereafter took up his residence in Portland. There are many old-timers who wish Mr. Moore may now be recovered to health and enjoy a long lease of immunity from the trouble that beset him for nearly half a century.

ARTICLES FILED.—The Kaupisch Creamery Co. filed articles of incorporation in the office of the secretary of state yesterday. The company proposes to deal in farm and dairy products, and to manufacture butter, cheese, ice cream, sterilized milk and conduct a general creamery and produce business. The principal office will be located in Portland. The company is capitalized for \$50,000, divided into 1200 shares of the par value of \$25 each. Julius C. Kaupisch, E. W. Kaupisch, H. M. Kaupisch, M. M. Kaupisch, M. C. Banfield and Thomas Rand are the incorporators of record.

Plaintiff demands judgment against defendant for \$800 with 10 per cent interest from October 24, 1894, less \$519.18 that has been paid on the note, and for \$50 attorney's fees and further asks that the mortgage on lots 9 and 10, block 2, and on lots 1, 2, and 3, in block 1, in Frickley's addition to Salem, given to secure the payment of the note, be foreclosed.

A CHANGE IN BUSINESS.—The firm of Westcott & Irwin, that has been so long and favorably known in the Salem public, has been partially dissolved. Mr. Westcott has purchased the interest of Mr. Irwin in the restaurant and bakery business and will hereafter conduct it alone. Mr. Irwin still retains his interest in the dairy near Salem.

ANOTHER UNION.—The preliminary steps, looking to the union of two hearts and two lives, were taken yesterday afternoon when County Clerk W. W. Hall issued a marriage license permitting Miss Rebecca Ruan to become Mrs. B. G. Frazier. Gibson T. White witnessed the issuance of the license.

A BIT OF POLITICAL HISTORY

RETROSPECTIVE GLANCE OVER FORTY YEARS IN OREGON.

Men Who Have Ruled the Destinies of a State Nearly Forty Years Old.

(From Daily of Jan. 29th.)

The near approach of the fortieth anniversary of the birth of Oregon as a state and the proposed celebration of the event, under the direction of the legislature, tends to bring up old memories and make more interesting a retrospective glance over those forty years, calling up the men who have ruled the destinies of the state and been prominent in its political and business history during that time. Many of the most prominent figures of the early days have passed from the scenes of action, but some remain to witness and enjoy the greatness of the commonwealth whose foundation they wisely laid. On this Sunday morning, the numerous family of Statesman readers will doubtless enjoy a glance at the list of names in official groups, with short historical reference.

GOVERNORS.

The first governor of the territory now embraced in the state of Oregon was Dr. John McLoughlin, who, from 1822 to 1845 ruled its destinies as director of the Hudson Bay Company and by courtesy was termed, "governor." From 1843 to 1844, it was ruled by an executive committee—David Hill, Alanson Beers and Joseph Gale—and in 1844 and 1845 F. C. Stewart, C. Russell and W. J. Bailey were the committee, elected by the people. A provisional government was formed early in 1845 with George Abernethy as governor elected by the people. March 3, 1849, Oregon became a territory of the United States and Gen. Joseph Lane was its first governor by appointment of President Polk. Gen. Lane resigned June 15, 1850, and Kinsling Pritchett, who was secretary, became governor until August 13, 1850, when John P. Gaines was appointed governor by President Taylor. May 16, 1853, Gen. Lane was again appointed governor by President Pierce, but resigned in a few days, and George L. Curry who was secretary, assumed the duties until December 2, 1853, when John W. Davis was appointed, that officer resigning August 1, 1854, and George L. Curry again succeeding to the place, until November 1, 1854, when he was appointed governor by President Pierce and remained such until March 3, 1859. All these men have since died, though numerous relatives of most of them are now honored citizens of the state.

The first state governor was John Whiteaker, a democrat, from March 3, 1859, to September 10, 1862, and he still lives to an honored old age in Cottage Grove, Lane county. He was followed by Addison C. Gibbs, republican, 1862 to 1866, he by George L. Woods, 1866 to 1870, both being now dead. La Fayette Grover, democrat, succeeded Woods, and was re-elected in 1874, resigning in 1877 to go to the United States senate, when Stephen F. Chadwick, democrat, secretary of state, assumed the duties of governor. Mr. Grover is still living in Portland. Mr. Chadwick having died a few years ago in Salem. W. W. Thayer, democrat, was governor from 1878 to 1882, and is still a hale old man in the practice of law at Portland, and spent six years on the supreme bench afterward. Z. F. Moody, republican, held the office from 1882 to 1886, and is still an honored citizen. He holds large business interests at The Dalles, but makes his home principally in Salem. Sylvester Pennoyer, democrat and populist, was governor the next eight years, and is still an active business man and politician in Portland, keeping everybody guessing what lucky hobby he can next grapple onto upon which to ride into public place. William Faine Lord, republican, has just retired from four years as governor with a prospect of many years of usefulness yet, and the place has been assumed by Theodore Thurston Geer, a representative of the younger republicans and of the farming classes.

SECRETARIES OF STATE.

The first secretary was George W. La Breton, 1841 to 1844, followed by Dr. E. J. Long, 1844 to 1846, succeeded by Frederick Prigg, 1846 to 1847, and a remarkable fact is that all three of these suffered a tragic death, the first having been killed by Indians, the other two being drowned in the Clackamas river. Samuel M. Holderness served from 1847 to 1849, when the territory was organized. The territorial secretaries were Kinsling Pritchett, General Edward Hamilton, George L. Curry, Benjamin F. Harding, all democrats. Since becoming a state, Lucien Heath, a democrat, served from March 3, 1859, to September 8, 1862; Samuel E. May, republican, September, 1862, to September, 1870; S. F. Chadwick, democrat, September, 1870 to 1875; R. P. Earhart, republican, September, 1875, to January, 1887; George W. McBride, republican, 1887 to 1895; H. R. Kincaid, republican and silver republican, 1895 to 1899. The last two are living. Mr. McBride being now United States senator. The present incumbent is F. I. Dunbar, republican.

TREASURERS.

W. H. Wilson, 1843 to 1844; Phil Foster, 1844 to 1845, served the people as treasurer. Under the provisional government, F. Emmattager, 1845 and 1846; J. H. Couch, 1846-7; Wm. K. Kilborne, 1847-49. Under territorial government, James Taylor, L. A. Rice, John D. Boone, democrat, Nat E. Lane, democrat, and John D. Boone, democrat, succeeded one another. The state treasurers have been: John D. Boone, democrat, 1853-62; E. N. Cooke, republican, 1862-70; D. Fleischer, democrat, 1870-74; A. H. Brown, democrat, 1874-

75. Edward Hirsch, republican, 1875-87; G. W. Webb, democrat, 1887-91; Phil Mettschan, republican, 1891-99, the present incumbent being Charles S. Moore, republican. Mr. Hirsch is the present postmaster at Salem; Mr. Webb is a resident of La Grande, and Mr. Mettschan is still at the capital, where he has a beautiful home, though elected from Grant county.

STATE PRINTERS.

The secretary of the territory superintended the state printing up to 1849, when Blain Wilson was elected by the legislature to superintend the work. In 1851, Anabel Bush was so elected by the legislature and by each succeeding territorial legislature. He was also elected at the first state election in 1859, thus serving from February 7, 1851, to September 8, 1862. Mr. Bush was followed by Harvey Gordon, 1862 to 1864; Henry L. Patterson, 1864-72; Eugene Semple, 1872-74; Mart V. Brown, 1874-78; W. B. Carter, 1878-80; W. P. Keady, May, 1880-82; W. H. Byars, 1882-87; Frank C. Baker, 1887-95; W. H. Leeds, present incumbent, re-elected. Mr. Bush is still living, a rich and prosperous banker of Salem, recognized as one of the ablest financiers of the country; Mr. Pittcock is one of the proprietors and the business manager of the Oregonian; W. P. Keady is an active political and business worker in Portland; Gen. Odell is clerk of the state land board; Mr. Byars has been the past few years commandant of the Soldiers' Home at Roseburg; Mr. Baker is yet a young man prosperous in business and powerful in politics, residing in Portland.

STATE SCHOOL SUPERINTENDENTS.

This office was established in 1872 and was first filled by Sylvester C. Simpson, democrat, 1872 to 1874, followed by Dr. L. L. Rowland, republican, 1874-75; J. L. Powell, republican, 1875-82; E. B. McElroy, 1882 to 1895; G. M. Irwin, 1895-99; the present incumbent being Prof. J. H. Ackerman. Mr. Simpson is still living in California; Dr. Rowland was superintendent of the state insane asylum 1891 to 1895, and now puts in most of his time on a mountain farm east of Silverton; Mr. Powell is dead; Mr. McElroy is a professor in the University of Oregon at Eugene; Mr. Irwin is a minister of the M. E. church.

CHIEF JUSTICES.

William P. Bryant was chief justice 1843 to 1850, with Peter G. Burnett and Orville C. Platt associates; Thomas Nelson, 1850 to 1853, with Platt and Wm. Strong; George H. UNITED STATES SENATORS.

The first United States senator from Oregon was Delazon Smith, democrat, but he served only from February 14 to March 3, 1853. His colleague was Gen. Joseph Lane, also a democrat. Gen. E. D. Lane, also a democrat, 1861, but served only until October, 1861, when Benjamin Stark, democrat, was appointed to fill the vacancy.

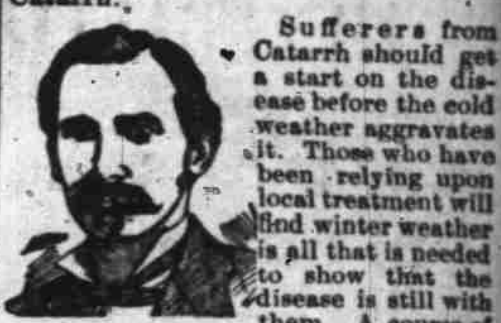
