

HOME FROM THE KLONDIKE.

Charles Craven Was Not Very Favorably Impressed With the Country.

Charles Craven arrived in this city Sunday morning direct from Forty Mile. He was accompanied by Albert M. Griley, also of this city, who came with him to Seattle, where he stopped for a short visit with friends before continuing his way homeward.

Mr. Craven is thoroughly tanned, rather fleshy and looks hale and hearty and to all appearances the trip did him good. While in the frozen region, he experienced no hardships, having an adequate supply of wholesome provisions.

He left this city January 21, 1898 going direct to Skagway, where he remained one month, when he pushed his way on to Dawson. He was joined by Griley in September, last, and together they proceeded to Forty Mile, where for several weeks they prospect- ed but without success.

Mr. Craven is quite disgusted with the Klondike country, and is content to remain in Oregon for a season at least. He says the stories relative to the mineral resources of the Klondike region are badly exaggerated and had their origin largely in the fertile brains of persons financially interested in large transportation companies.

The country, as he found it, was a serious disappointment to him and that his disappointment is shared by others, is quite evident from the conditions existing there. He says there are 1,000 men on the Forty Mile and fully 4,000 men in Dawson City; who are only waiting until the season is more advanced that they may be afforded transportation facilities by water, when they will abandon the country.

He reports the Salem contingent all well and hearty, all of whom, with but few exceptions, are equally as disheartened with the country. The majority of the Salemites will return home this summer.

THE THIRD DAY.

Proceedings of the United Evangelical Conference at Lafayette—Committees Appointed.

Lafayette, Yamhill, Co., Or., April 15.—After devotional exercises, C. C. Poling, in behalf of the ministers and lay delegates, of conference, in a neat and appropriate speech presented M. J. Ballantyne a handsome present as a token of the appreciation and high esteem in which he is held by the members of the conference as a result of his services as presiding elder.

All the pastors reported conversions in their fields of work. Several changes were made in the boundaries of the several charges and also new territory was added. The report of the ways and means committee was full of good suggestions.

H. A. Deck was elected statistical secretary. C. C. Poling, H. L. Pratt and Ell Seese, were elected trustees for Lafayette seminary.

J. Bowersox was elected conference treasurer.

It was decided to hold the next annual conference, commencing on the second Thursday in April, 1900, at Hillsboro.

Bishop Stanford conducted a profitable bible reading on Christian giving, as on opening of the afternoon session, after which the needs of the Lafayette seminary were set forth by C. C. Poling, who made a very earnest and able appeal in behalf of an endowment fund for the seminary which was rewarded by very nearly \$2,000 being pledged within a few minutes.

It was decided to raise \$800 missionary money from the various charges during the year.

The presiding elder and trustees were instructed by the conference to purchase the Congregational church at Independence and the Evangelical association's church at Newburg, if the same could be had at a reasonable price.

M. J. Ballantyne, H. L. Pratt, and H. A. Deck, were elected apportionment committee.

P. Bittner, J. C. McFarlane, and H. A. Deck, were elected on educational committee to be present at the commencement exercises of the Lafayette Seminary, and report the condition of the school to the next annual conference.

FINED FORTY DOLLARS.

Ross McCormick Found Guilty of Petty Larceny—Goes To Jail.

After an examination before the city recorder yesterday afternoon, Ross McCormick was declared guilty of petty larceny. He was fined \$40 and costs, in default of which he was committed to the county jail.

Upon motion of District Attorney Hayden, the defense having consented,

the charge of grand larceny from the person was dismissed and the charge of petty larceny substituted therefor. This was necessary on the part of the state, inasmuch as the amount alleged to have been stolen (\$15) was not sufficiently large to constitute the felonious charge designated by the original charge which places the minimum amount at \$25.

The case then proceeded to trial. It was very stubbornly fought, objections being frequently interposed by one side or the other. D. W. Tarpley and Wm. Kaiser appeared for the defendant, District Attorney S. L. Hayden conducting the prosecution. A large number of witnesses had been subpoenaed, and the introduction of testimony was not completed until 5:30 when the closing arguments were made, the case being submitted to the police magistrate shortly after 6 o'clock.

McCormick's fine is not a heavy one when it is considered that the statute provides for such an offense, a fine of from \$25 to \$100 or from one to six months' imprisonment.

CHEERING THE GOVERNOR.

His Statement Regarding the Return of the Volunteers Meets With Approval.

In the executive office, yesterday, the following letter was received, dated at Eugene, and signed simply, "U. S. Citizen," regarding the governor's reply to the Chicago Tribune, in reference to the return of the volunteers from Manila:

"Gov. Geer:—Hurrah for Oregon's loyal governor!—Your reply to the Chicago Tribune's inquiry has the ring of true metal.

"Oregon wants her boys home, but not as cowards or deserters.

"Dudes and spectacled professors, who fight the battles of our country from lecture platforms are not respected by the intelligence, brawn and muscle of our nation builders. Let our boys stay until the authority of the U. S. is respected by the cowardly Filipinos."

A STRONG CONCERN.—The Anacosta Gold Mining Co., of Bohemia,

yesterday filed articles of incorporation in the state department. The company will engage in extensive mining and development work in the Ethonia district, and will erect smelters, and construct water ditches for the benefit of its property and its mining operations. The headquarters of the company will be located at Eugene, and the capital stock is fixed at \$500,000, divided into as many shares of the par value of \$1 each, the shares to be non-assessable. Several directors will look after the affairs of the company, and those elected to manage affairs for the first year, and charged with the work of setting the corporation's machinery in motion are: Robert McMurphy, B. Edward Hawley, C. M. Young, E. D. Ressler and L. T. Harris, of Eugene; A. D. Charlton, of Portland; and Albert McMurphy, of Milwaukie, Wisconsin.

TOOK NO ACTION.—Sedgwick Post No. 10 G. A. R., at its regular meeting last evening, considered the request made to that organization, to pass resolutions, urging the immediate recall of the Oregon volunteers now in Manila.

After extended discussion of the matter, the old veterans decided to take no action in the premises at this time, as they had full confidence in the judgment of the administration, and believed that President McKinley would do the best in his power for the boys who had gone to the front when needed, and that the government would discharge the volunteers as soon as they could be spared.

A TAILOR NAMED.—Ernest Lane,

son of C. H. Lane, the tailor, has been appointed tailor at the reform school, to take the place made vacant by the resignation of J. H. Lovelee, of Lebanon, who was elected to that position when Supt. Bickers took charge. The position pays \$35 per month, with board and lodging furnished.

FOR TREATMENT.—Lawrence Haun

was brought to the asylum from Pendleton yesterday. He is 25 years old, and this is his third attack. Sheriff Wm. Blakely and one guard escorted the patient to Salem at a cost of \$84.95.

Two women were discharged yesterday, having been permanently restored.

GRAND LODGE SESSION TO BE HELD IN SALEM.

Large Crowds of the Three-Linkers to Gather—Entertainment for the Visitors Arranged.

The grand lodge, I. O. O. F., of Oregon, which meets in Salem during the third week in May, will be one of the largest bodies ever convened in this city, over 300 delegates being elected throughout the state to attend its meeting and participate in the deliberations. The legislative bodies of the three branches of the order—the grand lodge, the grand encampment and the state assembly of the Rebekah branch—will convene here at that time, bringing between 500 and 800 visitors to spend the week in Salem. The grand encampment will meet on Tuesday, May 16th, and complete its business session on the same day. The Rebekah assembly also meets on Tuesday, and continues in session until Friday. The grand lodge meets on Wednesday, May 17th, and adjourns on the Friday following.

The sessions of the grand lodge will be held in the senate chamber of the capitol. Secretary of State F. I. Dunbar having kindly given the permission to use that chamber. This will be the most convenient place available, as no lodge room in Salem is large enough to accommodate the grand lodge. The grand encampment sessions will also be held there, while the Rebekah assembly will hold its sessions in the beautiful hall of the Odd Fellows' lodges in the Holman block, corner of State and Liberty streets. The program of entertainment for the visitors during that week has not been entirely arranged, but enough has been done to give an outline.

On Tuesday evening the Rebekah assembly will meet with Salem Rebekah lodge, when the local team will exemplify the work. A reception will be tendered State President Miss Pauline Kline, of Corvallis.

On Wednesday evening the grand lodge will meet with Chemeketa lodge No. 1, in the I. O. O. F. hall, when entertainment of some sort, to be devised, will be tendered the visitors.

On Thursday evening the Past G and Masters, Patriarchs and Representatives Association will give an entertainment. Gov. T. Geer will deliver an address of welcome on behalf of the state, and Mayor C. P. Bishop, on behalf of the city. Grand Master T. B. Wells and other prominent Odd Fellows will respond, and a brief but excellent program will be rendered.

HEARD IN THE SUPREME COURT ON APPEAL.

Defendant Convicted of Killing a Young Man in Linn County and Sentenced to Death.

(From Daily, April 18th.)

In the supreme court yesterday, the case of the state of Oregon, plaintiff and respondent, vs. M. T. McGrath, defendant and appellant, an appeal from the state circuit court for Linn county, department No. 1, Hon. Geo. H. Burnett, judge, was argued and submitted. J. Russell Wyatt, of Albany, appeared as attorney for the appellant, and Attorney General D. R. N. Blackburn, District Attorney S. L. Hayden and John H. McNary, appeared for the state. Following is a brief statement of the case:

The defendant was indicted by the grand jury of Linn county, for the crime of murder, charging the defendant with murder in the first degree, with the killing of Charles A. Turner, by shooting him with a pistol, in said county, on June 30th. The defendant having pleaded not guilty, trial was had on November 1st and a verdict of guilty as charged in the indictment was returned. On November 4th the defendant filed a motion to set aside the verdict, and for a new trial, on the grounds, first, insufficiency of the evidence to justify the verdict; second, errors of law accruing at the trial, and excepted to by the defendant; third, error of the court in permitting Mrs. Mary McGrath, the wife of the defendant, to testify as a witness on the trial of said cause, over and against the objection of the defendant. The motion being overruled, sentence of death was passed upon the defendant, and it is from the judgment so rendered the appeal was taken.

Defendant killed Chas. A. Turner in a hayfield near Harrisburg, as a result of his jealousy of the deceased, he having brooded for sometime over the fact that deceased was believed to be on undue terms of intimacy with the wife of the defendant, as a result of which the husband and wife had quarrelled, and the wife was contemplating leaving her husband, having made threats to that effect, only the day before the murder.

Among the errors assigned by the ap-

pellant, are the instructions given by the court to the jury, as follows: "Some testimony has been given at this trial about the previous good character of the defendant and his reputation as a law-abiding citizen prior to the killing charged in the indictment. Previous good character and reputation is not a defense against any criminal charge, but evidence on the subject of good character and reputation is admitted for the purpose of strengthening the presumption of innocence, with which the law favors the defendant, hence if the evidence should on the whole case convince you beyond a reasonable doubt that the defendant is guilty, you must return a verdict of guilty, without reference to his previous good character and reputation."

QUESTION OF OWNERSHIP.

Says the Independence West Side, of last week: "The city of Independence seems likely to test the question of ownership of some of the streets next to the river which are occupied now by sheds, warehouses, buildings etc. Several years ago a local water company was organized and built a windmill and tank and dug a large well in the center of Monmouth street, where R. M. Wade & Co., now have their shed warehouse. Several years afterward L. C. Gilmore bought all their rights and titles. If Mr. Gilmore has any title, the city has none, and R. M. Wade & Co., will have to deal with Mr. Gilmore. He has erected a fence about his property yet vacant. We understand however that the title to that land goes back even of the city of Independence, and rests in Polk county. It having been a county road as far back as 1855. There is no record of the county vacating the road, or of the city vacating the street."

A CHANGE.—Geo. N. Patterson,

for the past year chief clerk of the Willamette Hotel, has severed his connection with that hostelry, and left yesterday, for Lewiston, Idaho, where he expects to remain for some time for the benefit of his health. Mr. Patterson was an obliging and popular attaché of the hotel, and made many friends in this city and with the traveling public. Thos. A. Hogan, formerly night clerk, has succeeded Mr. Patterson as chief clerk, and J. J. Keller, of Portland has been engaged to take the position of night clerk, heretofore held by Mr. Hogan.
