

## VOLUNTEERS ARE CALLED

Gen. Otis Will Receive Reinforcements.

## A PROVISIONAL ARMY

Will Be Enlisted Immediately—No State Troops Wanted—Veterans to Have Preference.

CHICAGO, June 27.—A Washington dispatch to the Tribune says: As the result of a conference between President McKinley and Secretary Alger, this afternoon, it has been decided to begin the enlistment of volunteers for two years, for service in the Philippines. Orders to recruiting officers to this effect will be sent out tomorrow. It is proposed to arm and equip at once three brigades or about 10,000 men, and continue the work until the whole 35,000 men, authorized by law, are secured. There will be no call upon the states. The regiments will be organized as United States volunteers. Officers will be appointed by the president, and assigned to the regiments without regard to state lines.

The maximum of the regular army of 45,000 men has been secured, and now enlistments will be for the provisional army, to make up the total strength of 100,000 men. General Otis has 23,300 men on the ground, or under orders and the volunteers will be rushed to him until he has an effective force of 50,000. In the enlistments for United States volunteers, the veterans of the late war, including those who did not get beyond the home camps, but were seasoned, will be given the preference, and the same will be true of officers. One brigadier general for every three regiments, and a major general for each division of three brigades, will be appointed. They will be part regulars and part volunteers and General Joe Wheeler will be among their number.

STENOGRAPHERS FOR MANILA. Chicago, June 27.—A special to the Chronicle from New Orleans, says: New Orleans will furnish the first two of the four English-Spanish stenographers and typewriters wanted by the United States government for the courts in Manila. Louis M. Rodriguez, born in Manila of Spanish parentage, and Carlos Julio Elizalde, a Cuban, at present editor of the Spanish edition of the New Orleans Trade Journal, have accepted the government's offer and will shortly leave for Washington, thence

to New York and Manila. The salary is \$2000 per annum with all expenses to Manila.

## A LONG JOURNEY.

To Summon Jurors, Made by an Idaho Officer.

Wallace, Ida., June 27.—Elmer Southland left today for Pierce City and the south end of the county after jurors. This will carry him 250 miles from here, through Kootenai, Latah and Nez Perce counties, Idaho, and Whitman county, Washington. No jurors from that and have been summoned in the district court, before, since the county seat was moved from Pierce City to Murray, fifteen years ago.

## SPAIN WANTS TROUBLE.

Vancouver, B. C., June 27.—Chinese advices state that Spain will prefer a demand for the lease of Chinese territory, on the ground that China, during the Spanish-American war, permitted shipments of arms and ammunition to the Philippines by American steamers.

## NEW EXPLOSIVE SHELL.

To Be Used in the Philippines—Will Destroy a Battalion.

Chicago, June 27.—A special to the Chronicle from Washington says: A shell of terrific explosive power with a capacity to annihilate by bursting fragments and a shock as effective as a streak of lightning, will be the feature of the fall campaign in the Philippine islands. Tests of the charge of this terrible engine of war are being made at Sandy Hook, the government guarding closely its secret of manufacture.

A shell of this nature, charged with an explosive equal to melinite or dynamite, falling near a battalion of the enemy, would kill or cripple a very large percentage of the battalion. The chances of escape from this tremendous machine will be decreased 100 times, the experts say, as compared with shrapnel discharged at the same objects.

## A RACE WAR IN ALABAMA

Three Negroes Killed by White Men.

## CLASH AT ORE MINES

The Result of an Attempt to Capture a Colored Fiend, Who Assaulted a White Woman.

BIRMINGHAM, Ala., June 27.—Three negroes are dead and one is not expected to live until morning, as a result of a riot between white and negro miners at the ore mines near Cardiff, in Jefferson county. The dead are: Ed. Ellis, Jim Dill, Adam Samuels. The wounded are: Rudolph Williams, George Thomas, mortally.

The two races came to a clash in the late afternoon, in Glasgow Hollow, where the negroes had congregated, armed with Winchester rifles, while a man, passing along the road, was held up and besides being abused was roughly handled. This news soon spread, and an armed body of white miners moved toward the hollow. It is supposed they went around by a circuitous route in the mountains, and came upon the negroes unexpectedly. Ed. Ellis, the ringleader, armed with a Winchester rifle and a Colt's revolver, fell at the first fire. A rifle bullet did the work. There was another volley, and four other negroes fell. Jim Dill and Adam Samuels, died in a few minutes after being removed to a negro house. George Thomas was shot through the abdomen with a Winchester bullet. He is not expected to recover. Rudolph Williams will live.

The trouble started yesterday when it was thought that John Shepherd, who on last Wednesday assaulted Mrs. Monroe Jones, near Corona, was in that community. The negroes armed themselves to prevent his capture. Both sides were aroused, and only the timely arrival of a sheriff's posse prevented an outbreak. This morning the negro miners held a mass meeting, and refused to go to work. They all belong to a secret organization, known as the Knights of Africa or "Mysterious Men."

## DEWEY HOMEWARD BOUND

COLOMBO, Ceylon, June 28.—The United States cruiser Olympia, with Admiral Dewey on board, sailed from here for Port Said this afternoon. The admiral has been living quietly here, and his health has improved. He went on board the cruiser at 10 o'clock this morning. The customary official visits were exchanged during the day. Previous to his departure, Admiral Dewey visited the auxiliary cruiser Yosemite, now at this port, having on board Captain Richard P. Leary, governor of the Island of Guam, who is now on his way to his post.

## SPAIN IS GENEROUS.

Manila, June 28.—4:55 p. m.—General Jaramillo, who is settling Spanish military affairs here, has received a cable message from the minister of war, at Madrid, announcing that the pay of all the soldiers, who are in the hands of the insurgents, will be continued during their captivity. The families of many of these officers and soldiers are in Manila, and are without means of support here, or on their return to Spain.

The new Spanish consul here, Senor Luis Marinan, says, his foremost business is to secure the release of the prisoners. The Spaniards are fast leaving Manila. The steamer Isla de Luzon sails for Spain soon, taking several hundred persons, civil and military officials and their families. The Spanish commercial men are selling out, and some of the largest interests here will soon pass into the hands of English capitalists.

## CHEERS FOR ROOSEVELT

MILWAUKEE, June 28.—"He won with our boys in blue and he will be our president, too," thus ran one of the banner inscriptions, displayed today in the Milwaukee flower parade, of which Governor Roosevelt was the center of attraction. But this apparently did not interest the governor half as much as did that other, displayed everywhere, and sounded by every lip, "Our Teddy."

The governor's part in the flower parade was to lead it in the undecorated carriage of Captain Fred Pabst. Photographers by the score levelled cameras at the governor, and he shouted to them that "Spaniards did not do anything as bad as that."

Little girls and young women ran out to the carriage and threw in clusters of roses and bunches of sweet peas, until it was a bower of flowers. On half of the hundreds of men little white cards were pinned, on which was printed: "Teddy, 1904". Time and time again the shout went up from

street corners and crowded office windows: "Roosevelt for President."

## KENTUCKY DEMOCRATS.

Louisville, Ky., June 28.—The state democratic convention adjourned tonight after nominating the following ticket: Governor, Wm. Goebel, of Kenton county; lieutenant governor, J. C. W. Breckham, of Nelson county; secretary of state, Breck Hill, of Clay county; attorney-general, Judge R. G. Breckinridge, of Boyle county; auditor, Gus Coulter, of Graves county; treasurer, Judge S. W. Haeger, of Boyd county; commissioner of agriculture, I. B. Hall, of Louisville; commissioner of public instruction, H. V. McClesney, of Livingston county.

William Goebel dominated today's proceedings as he has those of every day since the convention began. Coming here with less than one-fourth of the delegates instructed for him, and with the smallest number of such delegates accredited to any one of the three candidates for governor, he leaves the convention holding the nomination for the head of the ticket with the party organization under his control and the ticket made up of his partisans.

C. Leasure, of Portland; grand invitee, Miss Marie Tongue, of Hillsboro; grand outside sentinel, Miss Edith Driscoll, of Junction City; grand orator, Mrs. Olive B. England, of Salem.

The trustees of the grand cabin are as follows: Mrs. Sol Blumauer, Mrs. Ella Lehigh and Mrs. Maude Pope Allyn, of Portland; Miss Ollie Slater, of La Grande; Mrs. C. E. Wolvort, of Eugene; and Mrs. Edith B. Linton, of Eugene. A gavel, made from the steamer Beaver, the first steamer that ever sailed on the waters of the Pacific ocean, was used by the president. She arrived at the Columbia river on March 19, 1826, and at Vancouver, Washington, April 10, 1826. She was wrecked at Burrard's Inlet, B. C., in July, 1888.

## NOT ACCEPTABLE.

Trenton, N. J., June 28.—Attorney-General Gray, this morning filed opinion with the secretary of state, advising the refusal of the articles of incorporation of the American Isthmus Ship Canal Co. The articles provided for an authorized capital of \$30,000, with a provision that the company's stock might be increased to \$250,000,000, by a vote of the holders of not less than three-fourths of the capital stock.

## RECRUITS FOR THE ARMY

Many to Be Sent to the Philippines

## TO REINFORCE OTIS

Officers for New Regiments Will Be Selected from Regulars and Former Volunteers.

WASHINGTON, June 28.—Secretary R. A. Alger, Adjutant-General H. C. Corbin and Colonel Bird, assistant quartermaster-general in charge of transportation, had an hour's consultation with the president today relating to the question of reinforcements for General Otis. A definite decision was reached to continue recruiting men at all the recruiting stations, and Secretary Alger said after the conference that General Otis would have 40,000 when the rainy season closed for resumption of active operations.

The enlistments are to be for service in the regular army and recruits are to be organized into regiments or assigned to regiments already formed after enlistment. No organizations are to be accepted if sufficient recruits can be obtained by regular enlistments. General Corbin said the enlistments would be for three years. Arrangements are to be made at once for increasing the transportation necessary to get these additional troops to the Philippines.

The decision to reinforce General Otis by the end of the rainy season is interpreted to mean that active campaigning will cease until the bad weather ends. By remaining quiet under good shelter during the rainy season it is hoped that the health of our troops will be conserved and the danger from climatic fevers reduced to a minimum. General Otis has cabled to the war department that he has the skeleton organizations of two of three regiments which he proposes to raise in the Philippines.

At the war department this is said to mean that General Otis has the officers for these regiments selected and that they are now to be filled with enlisted men. The war department says that the recruits now being enlisted cannot be used for the volunteer army, although it would be an easy matter to transfer these men with their own consent to the volunteer service if it should be determined to raise additional troops.

Volunteers will not be accepted in organizations, Secretary Alger is determined to adhere to that rule. Looking over the act of congress, he has concluded that the authorization to raise these volunteer troops "at large," in-

dicates the purpose on the part of congress to follow out the plans, successfully adopted in the immune regiments. It is his present purpose to disregard states and localities in securing recruits and welding them into organizations. The regiments will be designated as the first, second, third, etc., volunteer United States infantry or cavalry.

No difficulty is anticipated in securing the men needed. It is believed the 11,000 men, who are weekly offering themselves at the recruiting offices, will be even more willing to enter the army as two year volunteers, than as long term regulars. The officers for these volunteer regiments will be obtained by promoting officers now in the regular army, and by commissioning many of the best officers in the volunteers organizations which saw service.

## COGHILAN COMES WEST.

Washington, June 28.—Captain Coghlan will go to Puget sound, after all, as commandant of the naval station at Port Orchard. The original order was suspended owing to the discovery of the inability of the navy department to retire Captain Green, the present commandant of the station, under the terms of the personnel act. Having already made arrangements to give up his command, however, Captain Green will turn it over to Captain Coghlan on August 1st, and come east.

## SAILED FOR MANILA.

San Francisco, June 28.—The United States transport steamer Valencia sailed tonight for Manila, bearing the headquarters, band and troops B. and M. of the Fourth cavalry, and companies H. and E. of the Twenty-fifth infantry.

## FLED FOR SAFETY.

Japanese Sailors Drown While Fleeing from the Plague.

San Francisco, June 28.—The bodies of two Japanese sailors of the plague ship Nippon Maru were found in the bay today, and were towed to a point off shore by fishermen who were afraid to touch the bodies, more than was necessary to attach a rope to them for towing purposes. The coroner was notified and the bodies were taken to the morgue, where every precaution is being taken to prevent any spread of the disease, should the men have carried any germs with them in the bay. It is believed that the men were afraid to stay on the steamer and, after attaching life preservers to their bodies, jumped overboard and were drowned.

## A NEW GEYSER.

St. Paul, June 27.—A private dispatch from the manager of the Fountain hotel in Yellowstone Park says that for 30 minutes, there was an eruption from a crater about fifty feet north of the Fountain geyser, which has always been considered to be nothing more than a pool. The size of the opening is about the same as the famous Fountain geyser. The eruption played from 200 to 250 feet high.
