PARTIAL LIST OF INSTRUCTORS AT
"OLD WILLAMETTE."Prof. M. E. Baker, of Wisconsin,
Elected to Chair of English—
Other Chairs Filled.

The board of trustees of Willamette University held another adjourned meeting at the office of President W. C. Hawley last evening. The meeting was a long one, the board being in continuous session for nearly four hours.

The faculty of the university for the ensuing year, so far as has been determined by the board of trustees, is as follows:

W. C. Hawley, of this city—President and professor of history and economics.

Prof. Myron E. Baker, A. M., Ph. D., of Payette, Wisconsin—Chair of English and modern languages.

Miss Mary E. Reynolds, of this city—Principal of the preparatory department.

Prof. J. T. Matthews, of this city—Chair of mathematics.

Miss Mabel Lankton Carter, of this city—Chair of oratory and dramatic expression.

Mr. Francesco Seley, of this city—Dean of the College of Music.

There remain to be filled two chairs, viz: Professor of Science and professor of Latin and Greek. These selections will probably be announced at another adjourned meeting of the board to be held next Monday evening.

The number of professors at the university has been reduced, the services of one instructor not being required, so the faculty now numbers ten instead of eleven. Heretofore one instructor has been employed for English while another taught modern languages, both of these departments being called "half-professorships." The board last night concluded to combine the two chairs and elected Prof. Myron E. Baker, of Payette, Wisconsin to that chair. Prof. Baker is a graduate of Harvard University and has travelled extensively in Germany, England, Switzerland, Netherlands and Italy.

The resignation of Mrs. Sara Norrie Brown Savage was presented and accepted, and Miss Mabel Lankton Carter was elected to the chair of oratory and dramatic expression. Prof. F. E. Brown, physical director, also tendered his resignation but his successor has not yet been named.

The filling of the chair of Latin and Greek was referred to the faculty committee with power to act, and the selection will be made in a few days. It is expected an eastern man will be elected to the chair, the board being in communication with the prospective candidate.

THEIR PARENTS SICK.

TO CALL A MEETING.—Secretary Frank Davey, of the state board of immigration, yesterday wrote a letter to J. C. These dates are considered the best time, for the reason that Mr. Colvig, the Jackson county member of the board, who will be in attendance at the grand lodge, A. O. U. W., at The Dalles, July 18th, 19th, 20th and 21st, will be able to attend the board meeting. It held on the 22d or 24th, without the inconvenience and expense of making a special trip here from his home in Southern Oregon. The meeting will probably be held on Saturday, July 22d. The board is receiving many inquiries from the eastern states, and the indications are that a large number of new settlers will soon arrive and become residents in this state, as a result of the work of the board.

This completes a record of which the Salem Hospital has just cause to feel proud. Of the four last appendicitis cases at this institution, operations were performed and complete cures effected in each case, although in two cases the patients had suffered three and four attacks of the ailment. The success attending the treatment of these difficult cases speaks much for the medical profession of the city and for the excellent service rendered by the trained and experienced nurses employed.

WHAT IS THE RAREST UNITED STATES STAMP?

The question is often asked. What is the rarest stamp among the issues of the United States? The highest price ever paid for a single specimen of this country was \$4400, which sum was given for the famous 10-cent stamp of Baltimore, issued by the postmaster of that city in 1845. The design shows the autograph of President Buchanan, with the value below. There are but few copies in existence, and it may truly be said that it is the rarest and most valuable postage stamp in America.

Prior to the sale of this celebrated specimen the highest price paid was \$3000. This was for a fine copy of the 20-cent "St. Louis," which at that time ranked as one of the rarest American stamps. Shortly after it was sold, however, others were found and the price has dropped considerably.

There are a great many United States stamps ranging in value from \$500 to \$2000, among which are the Beaumont, Uniontown and Madison (confederate) Provisionals, and the Brattleboro, Millbury and New Haven postmasters' stamps, all of which are extremely scarce. Such rarities as these are seldom offered for sale, and when by chance one of them comes upon the market there are always many collectors ready and willing to pay full value for it.

In the way of finding rare stamps there are great possibilities for those who have access to old letters and correspondence between the years 1843 and 1865. The early Postmasters' Provisionals were issued in 1845, 1846 and 1847, and the rare confederate stamps in 1863. Besides these there are many old issues of regular United States stamps that are rare, and bring good prices when sold.

The most valuable stamps in the world are the first issues of the island of Mauritius, a small British possession off the coast of Africa. Although between twenty and thirty are known, the last sold brought more than \$5000 when offered in Paris about a year ago.

WRECKS IN THE BLACK SEA. There is no part of the world which has such a black record for wrecks as the Black sea. The number in some years has averaged more than one a day, the greatest number of wrecks recorded in one year being 45, and the smallest 154. About 50 per cent of these vessels became total wrecks; all the crews being lost.

INCENDIARY FIRE

SMALL BLAZE IN A STATE STREET BARBER SHOP.

Stock of Shoes, Belonging to Jacob Vogt, Is Also Damaged—Work of Fire Department.

Shortly before 10 o'clock last evening, fire was discovered in the rear of Morgan & Fuzee's barber shop, in the two-story brick building at No. 95 State street. An alarm was promptly turned in and, after a considerable delay, the department responded. In the absence of the owners, the probable loss to building and contents could not be ascertained last evening.

Morgan & Fuzee succeeded in carrying out their tonsorial chairs and tools before the fire had made any headway and their damage will be very slight. Jacob Vogt, the shoe dealer, sustained the heaviest loss. The damage to his stock of goods, however, was not very great, the water doing the only damage, for the fire was extinguished before it had reached the shoes.

The goods that were shelved in the rear of the store room were the only part of the stock that was damaged by the water. Mr. Vogt resides about six miles from this city and will probably not learn of the fire until he comes to his place of business. For this reason an estimate of his loss cannot be given.

In quenching the flames, considerable water was thrown into the building occupied by Buell & Hamilton as a furniture store. A stream of water shattered windows in the south wall of the store building, immediately in rear of the structure in which the fire originated, and considerable damage was done to the stock stored there.

The goods which sustained damage were principally a number of blankets, framed pictures, a large quantity of picture moulding, wall paper, and some furniture. Mr. Hamilton, of the furniture firm, estimated the damage to the stock at about \$100.

By reason of his duties as driver of the engine team, which makes his presence with the spirited animals, during a fire, an imperative necessity, Fire Chief C. N. Churchill was not enabled last evening to visit the actual scene of the fire until the flames had been subdued. Considering that the hosemen had no one to direct their movements or to superintend the fighting of the fire, they performed their work remarkably well.

IN SUPREME COURT

TEN OPINIONS WERE HAND-ED DOWN YESTERDAY.

Two Eastern Oregon Criminal Cases Affirmed—Life Sentence for a Chinese Murderer.

In the supreme court, yesterday, ten opinions were handed down, in cases heretofore tried. Among them were two criminal cases, tried at the Pendleton term of the court, in May, both of which were affirmed. Following are the cases decided:

State of Oregon, respondent, vs. Wong Gee, appellant, an appeal from Union county, Hon. Robert Eakin, judge, affirmed. Opinion by Associate Justice R. S. Bean.

The defendant was convicted of murder in the second degree; he appealed assigning as error the overruling of his application for a postponement of the trial, which had been requested on account of the absence of some witnesses. The court holds that the matter of granting a postponement lies with the trial court entirely, and the trial judge's action will not be disturbed, in view of the fact that the defense did not show that the testimony of the absent witness was material to the case.

State of Oregon, respondent, vs. Oliver Marshall and William Marshall, appellants, an appeal from Baker county, Hon. Robert Eakin, judge, affirmed. Opinion by Chief Justice C. E. Wolverton.

The defendants were indicted for murder in the first degree, for killing one James Re'd during a quarrel. The defense sought to prove by the wife of one of the defendants that the deceased had made threats, which testimony was ruled out; later the witnesses was allowed to testify to the alleged threats. The defense assigned as an error the failure of the court to permit the testimony being given in the first instance. The court holds that the order of the proof, being regulated by the sound discretion of the trial court, there was no error, and hence the decision of the lower court is affirmed.
