

HE IS CHOSEN

Roosevelt Will Be Nominated for Vice President.

ALL OPPOSITION BREAKS DOWN

Hanna Has Given Up the Fight Reluctantly—Both Candidates Will Be Named by Acclamation.

PHILADELPHIA, Pa., June 20.—Senator Hanna tonight issued this statement: "The administration has had no candidate for Vice President. It has not been for or against any candidate. It has been deemed that the convention should make a candidate, and that has been my position throughout. It is free field for all. In these circumstances several eminent Republicans have been proposed; all of them distinguished men with many friends.

"I will now say that on behalf of all those candidates, and I except none, that I have within the last twelve hours been asked to give my advice. After consulting with as many delegates as possible within the time at my disposal, I have concluded to accept the responsibility involved in this request. In the present situation, with the strong and earnest sentiment of the delegates from all parts of the country for Roosevelt, and since President McKinley is to be re-nominated without a dissenting voice, it is my judgment that Governor Roosevelt should be nominated for Vice President with same unanimity."

This announcement of Senator Hanna was made after a long consultation with many leaders of the party.

MCKINLEY IS OBEYED.

PHILADELPHIA, Pa., June 20.—President McKinley was not re-nominated at the session of the National Republican Convention today. But tomorrow will witness, in all probability, the unparalleled scene of both the Presidential and Vice Presidential candidates being nominated by acclamation. Senator Hanna threw up the sponge today. He found he could not stem the tide of the popular favorite without using the direct influence of the administration at Washington, and this he could not get. Possibly, even with it, he might have failed. But without it the task was hopeless. The President would have no hand in the effort to control the convention. He made known directly to Hanna his wish that the will of the convention should not be thwarted, and when that unequivocal word came, Hanna reluctantly abandoned the fight.

With this retirement from contest the nominations could have been made before the convention adjourned today. The original program was to re-nominate President McKinley today, and to nominate a candidate for Vice President tomorrow. But the Republican National committee had made a compact with the local Philadelphia committee to keep the convention here for three days, and it was feared that, if the nomination for President was made today, the convention might take the bit in its teeth and wind up the business before dark. All preparations for the President's nomination at this session had been perfected. Hundreds of red, white and blue plumes attached to long staffs had been taken down into the delegates' pit before the convention met, and there stored away for the inevitable moment when the climax should be reached.

Considering the temper of the delegates and crowds, Hanna decided to make no risks. And consequently the immense throngs which blackened the vast amphitheatre today were compelled to content themselves with the routine incidents connected with the permanent organization; the election by Senator Lodge, the permanent chairman, and the scene which attended the unanimous adoption of the platform. Then they returned to the city to wait another twenty-four hours for the nominations which they had traveled some hundreds, and others thousands, of miles to witness. It was a great disappointment to most of them. The business of the convention moved so smoothly that the session did not afford them an opportunity to let off steam.

There was not the slightest fear. The hand of Hanna was at the helm. He was an experienced and accomplished manager. Not an eccentric slipped. At one point when the convention strayed on a sand bar over the proposition advanced by ex-Senator Quay, Pennsylvania, to cut down the representation of the Southern States in future conventions to the basis of the pooled votes for the Republican candidates, the lever was reversed and the convention promptly backed off thus avoiding a shoal by postponing a decision of the subject until tomorrow. The Southern delegates, without regard to color, race or previous condition, are very much incensed over what they regard as a blow at their power in the National Conventions, and the growl they emitted today indicates that they propose to fight in their effort to avert it.

Again today Governor Roosevelt carried off the honors. His entrance was the signal for the most pronounced demonstration of the session.

FOR VICE PRESIDENT.

PHILADELPHIA, Pa., June 20.—Theodore Roosevelt probably will be nominated for Vice President by acclamation. The plan is simple and the result sought can easily be brought about.

There will be no necessity for a roll call tomorrow. When the time arrives for nominating the Vice President, the roll of states will be called. When Iowa is reached some delegate will arise and withdraw Dolliver, and place Roosevelt in nomination. Massachusetts will follow, withdrawing Long and according the nomination of the New York man. This is the plan, and if it is done there will be no need of a

WANT A PARDON.—Gov. T. T. Geer, yesterday received a petition for a full pardon for William Hanna, confined in the penitentiary for a term of years, committed from Umatilla county, January, 1890, of concealing stolen property. Hanna was the Pendleton purchasing agent for the Linton horse cannery, and purchased a number of horses from Zibe Morse and Jack Ogg, shipping them to the cannery; it developed that Morse and Ogg had stolen the horses, and they were tried and also convicted and sent to the penitentiary. The petition is signed by E. E. Battezzore, A. B. Stephens, Alex. Drysdale, B. E. Kennedy, D. B. Waffle, N. Howland, J. H. Ferguson and John McGinn, jurors who tried the case, and numerous citizens of Umatilla county. The attorney for the defendant, Thos. Fitzgerald, in a note accompanying the petition, says the jurors who did not sign the petition are now out of the county and cannot be found. This is one of the numerous petitions received by the Governor, to grant all of which applications for clemency would depopulate the penitentiary.

A SOLDIER'S REMAINS.—Gov. T. T. Geer yesterday received a letter from the Quartermaster General of the United States army, advising the Oregon executive to have the nearest relatives of the late Corporal Lincoln G. Gay, Company L, 16th United States Infantry, whose remains are now at San Francisco, request the shipment of the remains to Oregon and they will be sent here for interment. Relatives of the deceased soldier asked this of the Governor some time ago, and they will now be required to make their request known to the quartermaster's department at San Francisco, when their wish will be granted. The Governor was also notified that of the recent burials in Manila, none of the remains will be exhumed before fall.

DIED AT SCIO.—Peter O. Smith, a pioneer of the '50's died at his home in Scio, on Tuesday aged about 70 years, after a lingering illness. Mr. Smith was for many years engaged in the livery business in Marion and Linn counties, being for a time associated in the business with H. A. Johnson, of this city, at Scio in 1885, but for a number of years he has lived in retirement at his home in Scio, having acquired a competency of this world's goods. He leaves a wife and one daughter, Mrs. Frank Mack, who lives near Stayton. The deceased held membership in the I. O. O. F., Masonic and Workman lodges and will probably be buried today.

CONTINUES TO GROW

BUSINESS OF WHITE CLOVER CREAMERY EVER EXPANDING.

Oregon Cream Tests Better Than That of Eastern States—Superior Grade of Dairy Cows.

The business of the White Clover Creamery, located on East State street and owned and operated by T. S. Townsend, of Portland, continues to expand. The plant averages between 300 and 400 pounds of butter per day. Some churnings yield only 200 pounds, while again a day's churning amounts to 600 pounds, which materially increases the general average. During the past few weeks the company has been paying 16½ cents per pound for cream but, beginning today, 17½ cents will be paid. This is the second advance in the price of cream since the Salem institution was started. The price first paid was 16 cents.

L. B. Zimmer, who operated the plant since its installation in this city, has gone to Sheridan to start another plant. He is succeeded in the management of the Salem creamery by Manfred McCrosky, who came here from Albany. Mr. McCrosky originally came to Oregon from Rosswood, Ohio, where for many years he was engaged in the creamery and cheese making business.

Mr. McCrosky says the cream of the Oregon cow tests higher than does that of the Eastern cow. The cause for this, he explains, is two-fold; first, the Oregon farmer produces a better grade of cows and, second, Oregon, and particularly the Willamette valley, affords better pasture. He also notes that the Willamette valley dairymen have placed much faith and dependence in the Jersey, while the Eastern farmers have very generally gone back on that breed of cattle and turned their attention to the raising of a larger cow and better suited for beef purposes. As a consequence there has been a remarkable falling off in the test of the cream. While employed at the Albany creamery, Mr. McCrosky says there were only a few cows whose milk was supplied to the creamery, that went below 4 per cent. At the Albany plant, milk tests are made, but at the Salem institution, where only cream is received, the test is made of the cream. He has not yet been able to ascertain the general average of the cream furnished the creamery here, but is satisfied it will show up well. Two general tests are made each month and the first has just been finished. It revealed the fact that some of the cream tested as high as 43 per cent, that is, 43 pounds of butter fat to 100 pounds of cream. Other cream did not test as well, ranging from 25 to 30 per cent upward.

MOST RADICAL CURE.
