BLOCKED WITH ICE

CAPE NOME ARGONAUTS EXPERIENCE A HARD TRIP.

Behring Sea Is a Mass of Huge Ice Floes Rendering Navigation Very Perilous.

(From Daily Statesman, June 20.)
Navigation en route to Cape Nome at this season of the year is rendered extremely difficult and perilous by reason of the great amount of ice with which Behring sea is supplied. The steamers will be compelled to wait until the sea of ice breaks up before completing the trip.

Mrs. F. W. Waters, of this city, yesterday received a letter from her brother, Willard A. Northup, who sailed for Cape Nome aboard the steamer Senator, leaving Seattle on May 19th. The letter, which bears date of June 7th, was written at Dutch Harbor, near Oumakaska, one of the Government supply stations and a trading post of the Alaska Commercial Company.

Mr. Northup writes that the travelers experienced some rough weather in the Behring sea, reaching ice on May 29th. The steamer worked five days among the ice floes, and reached solid ice June 4th. The steamer then turned back and landed at Dutch Harbor. While among the ice floes, Mr. Northup says he saw a number of vessels in the ice and some will have hard work to get out. One vessel was crushed and was seen to be sinking, but owing to the distance that separated them from the crippled boat, no assistance could be rendered the crew and passengers. All necessary help, however, was furnished by the other steamers lying in close proximity to the vessel.

Dutch Harbor was reached on June 7th, the date upon which the letter was written. Mr. Northup says there are twenty vessels or steamers lying at Dutch Harbor waiting for more suitable weather for continuing the trip. He says there are at least 7000 Nomeites at Dutch Harbor. One passenger died on the Senator May 27th, and was given a Masonic funeral at Dutch Harbor.

Mr. Northup reports himself in good health and says he is standing the trip well. He does not know when the steamer will be able to resume the trip to Cape Nome.

A LESSON IN POLITENESS.

When Alonzo B. Cornell was governor of New York, says a writer in Success, he had a clerk so ungracious in manner that he frequently remained seated while callers at the capitol were obliged to remain standing as they awaited to transact business with him. One day a delegation came from a city in the western part of the state to plead for the life of a condemned man. The governor was seldom known to grant a pardon, but the visitors hoped, at least, that they would be accorded a proper hearing. After the clerk had kept them waiting for two hours in the outer hallway he admitted them and accorded them permission to state their case to the governor—all standing. The executive refused to inter-

cede, and told his visitors so. The spokesman of the little party was Grover Cleveland, then a Buffalo attorney. In one year after the trip referred to he was himself elected governor of the state. When he visited the executive chamber a few days thereafter Governor Cornell showed him over the apartments, and inquired if there was anything he wished to have done in advance of his inauguration. "There is just one thing you can do for me, if you will," said Mr. Cleveland, "and that is to remove the clerk who kept me waiting outside so long when I was last here. It may teach him a lesson in politeness." The clerk was removed.

THE TIE VOTE.—The tie vote for justice of the peace in Mehama precinct was yesterday decided in favor of J. W. Irvine, in the county clerk's office. F. M. Hall and Mr. Irvine who had an equal number of votes for the position, appeared before Clerk W. W. Hall, and in accordance with the statute, drew lots, to decide who should fill the office. Mr. Irvine drawing the long straw. A similar tie in the constable's office in Turner precinct was to have been decided at the same time, but the contestants did not appear.

DAMAGED BY THE RAIN.

Recent Showers, While Beneficial to Growing Grain, Were Disastrous to Hay and Cherry Crops.

While the rains of the past few days have been especially beneficial to growing grain, which was badly in need of moisture, they have proven disastrous to the hay crop and also the cherries. The haying season was not general throughout the valley, but a great amount of fine clover hay will be damaged. The principal damage has been done to cherries, the Royal Anne variety having suffered great injury. The beautiful large cherries have already cracked badly and the extent of the damage will be greater when the sun appears. The fruit is ruined for canning purposes and unless used immediately, fermentation will ensue and this variety of fruit, which promised the growers such substantial returns, will demand for Oregon cherries.

This unexpected misfortune will quite completely paralyze the fruit canning industry being carried on by the Allen Packing Company, which was depending largely on this variety to supply the demand for Oregon cherries.

The rains will prolong the strawberry season for some time. This fruit is being canned daily and will be followed by raspberries.

ARE SET FOR HEARING

FIVE EASTERN OREGON APPEALS TO BE ARGUED THIS WEEK.

That Section of Oregon Has a Vast Advantage over the Western Half in Securing Speedy Justice.

(From Daily Statesman, June 20.)
At the Eastern Oregon term of the Supreme Court, in May, a number of appeal cases, pending for that department, were submitted and transferred to Salem for argument, and, upon a telegraphic request of the attorneys interested in five of these cases, yesterday, Judge J. J. Murphy, clerk of the court, placed them on the trial docket, and arranged for their hearing, immediately upon the arrival of the attorneys in Salem. The attorneys will be here one day this week, and the court will immediately hear the arguments, taking the cases in the order named below.

Litigants in Eastern Oregon have a great advantage over those west of the Cascade mountains, as they are enabled to secure an early hearing for their cases, the court upon its annual visit to Pendleton, hearing all the cases appealed in that section of the state, while the appeals coming up from Western Oregon are compelled to take their turn. This is a partiality to one section of the state over another, for which the court is not to blame, but rather the statute which provides for the Eastern Oregon term of the court. There is considerable feeling among attorneys in every portion of Western Oregon in the matter, and they urge that the eastern half of the state should not thus get the preference. The appeal cases from that part of Oregon are heard in Supreme Court, in many instances, within six months of the trial in the lower court, while those appealed to the court at the Capital are compelled to take their turn on the trial docket which, under ordinary circumstances, means a tedious wait of two years from the time the appeal is perfected to the hearing and final disposition of the same by the tribunal of last resort.

It is urged that the Legislature should remedy this defective difference, and also to limit the number of cases to be appealed to the Supreme Court, protecting that tribunal from being "covered up" with frivolous and petty actions to delay of more important cases. If some such remedy were provided, it is urged, by limiting the appealable actions, the court would soon be able to reach a point where appeal cases could be heard in the course of a few months following the perfection of appeals, and justice would become what it is intended to be—speedy as well as sure.

Non-she-po, appellant, vs. Wawinta-lay-yeck and Charles Wilkins, United States Indian Agent, respondents, appeal from Umatilla county.

Jesse L. Stamper, respondent, vs. Warren W. Raymond, et al., appellants, appeal from Umatilla county.

Bids Invited for Wood and Other Supplies for the Oregon State Penitentiary.

Sealed bids for wood, required at the Penitentiary for next 12 months, will be received at the office of the Superintendent until Saturday June 30, 1900, at 3 o'clock p. m., at which time they will be opened.

Sealed bids for Dry Goods, Groceries, Flour, Shoes, Leather and Findings, Meats, Fish, Plumbing Supplies, Drugs, etc., will be received at the office of the Superintendent until Tuesday, July 10, 1900, at 3 o'clock p. m., at which time they will be opened.

The right is reserved to reject any and all bids or any portion of a bid.

A deposit of \$200 in cash, or certified check, payable to the Superintendent, must accompany each bid for flour or meat and of \$75, each bid for fish. All other bids must be accompanied by an amount equal to 10 per cent of the amount of the bid.

On each envelope should be inscribed the nature of the bid. Goods of Oregon manufacture or production will receive preference, other things being equal.

Schedules of the various lines of goods will be furnished upon application to the Superintendent.

Vouchers will be issued for payment on the 1st of the month following completion of contract, and quarterly on continuous contract.
