A PIONEER'S DEATH

WILLIAM FRENCH EASTHAM
PASSED AWAY AT SILVERTON

He Came to Oregon Fifty-three Years Ago, and Helped to Try the Murders of Dr. Marcus Whitman.

Wm. French Eastham, a pioneer of 1848, passed away at the home of his daughter, Mrs. J. M. Brown, at Silverton, Oregon, on Monday, December 30, 1901, after an illness of several weeks, aged 78 years. The funeral was held at Silverton yesterday, and interment was had at the Miller cemetery at 2 p. m.

William French Eastham was born in Mason county, Virginia, November 23, 1823; he migrated to Illinois in 1844 and came to Oregon across the plains in 1848. He was married to Delilah Ann Cleaver in Jersey county, Illinois, March 25, 1848. Mrs. Eastham died January 29, 1892. He was the father of fourteen children, nine of whom are living. They are: Mrs. J. M. Brown, Silverton, Or.; Mrs. Viola Thompson, Dayton, Wash.; J. E. Eastham, Vancouver, Wash.; J. L. Eastham, Rainier, Or.; O. V. Eastham, Oregon City, Or.; Miss Jessie Van Scoy, Helena, Mont.; Miss Ivy Eastham, Vigan, P. I.; and Mrs. Ruby Thiesgen, Washington, D. C. He left twenty-two grand children.

So far as known he was the last member of the jury which tried the five Indians for the murder of Dr. Marcus Whitman and family.

Mrs. Roberts' Funeral.
The funeral of the late Mrs. Hannah W. Roberts, the pioneer Methodist missionary, whose death occurred on Sunday evening, will be held from the First M. E. church, at 2 p. m. today. Rev. John Parsons, D. D., pastor of the church officiating. After the services at the church the funeral procession will proceed to Lee Mission cemetery, where so many of the Methodist pioneers sleep their last sleep, and will there be laid to rest by the side of the remains of the late husband of deceased.

BOUND OVER—W. R. Smith, charged with assault with a deadly weapon upon C. M. Hinkle, in Silverton, on December 23, was given a preliminary hearing before Justice of the Peace Ramsey in Silverton yesterday, and bound over to the Circuit Court in the sum of \$1000. The trial began at 11 o'clock yesterday morning and was not concluded until 3 o'clock p. m. and the court room was literally packed with people. In default of the bonds Smith was brought back to Salem, arriving at 7 o'clock last evening, by Deputy Sheriff B. R. Colbath, and placed in the county jail. J. M. McNary, deputy district attorney, represented the state at the hearing and W. H. Holmes was the counsel for the defendant.

SIX NEW COMPANIES

HAVE INCORPORATED

A Strong Organization to Begin Boring for Oil—Several Lines of Industry Represented by the New Candidates for Business Favors.

In the Department of State, at the Capitol, yesterday, six new companies filed articles of incorporation and received authority to begin business, as follows:

The Oregon Oil Company will operate oil and mineral claims, and do general prospecting and development work with headquarters in Portland. The company has a capital of \$10,000. G. W. Bates, D. M. McLaughlin and A. G. King are the incorporators.

The Ainslee Estate Company will deal in property of all kinds with headquarters in Portland. The company has a capital of \$50,000. George Ainslee, G. W. Collins and W. T. Muir are the incorporators.

George Ainslee & Co. will deal in lumber, manufacture lumber and do general development work, with headquarters in Portland. The capital stock is \$40,000. George Ainslee, G. W. Collins and W. T. Muir are the stockholders.

The W. A. Gordon Company will do a general grain business and sell farm products on commission. Portland is the headquarters. The company will operate with \$20,000 capital. C. Lombard, W. A. Gordon and M. E. Lombard are the incorporators.

The Vale Commercial Company will engage in general merchandising at Vale, with a capital of \$15,000, divided into shares valued at \$100 each. T. S. Smith, A. J. Goodman, L. W. Hone and M. G. Hope are the stockholders.

The Columbia Loan Company will loan money and do a general brokerage business at Portland. The capital stock of \$10,000 is divided into shares valued at \$100 each. A. Oberdorfer, Herman Thannhauser and Ben Neustadter are the incorporators of record.

A California Company

The Chico Nursery Company filed articles of incorporation with the county clerk yesterday. The capital stock of \$50,000 is divided into shares of \$100 each, and the principal office and place of business is at Chico, Cal. The incorporators of record are Archie McGill, Malcolm McDonald, E. A. Mitchell, Harvey C. Stiles and Leon Girod.

COUNTY CLERK HALL HAS PRE-
PARED NEEDED SUPPLIES

For the Registration of Voters, Begin-
ning on January 6th—Will Make
an Effort to Get Work Done Early.

County Clerk W. W. Hall and his deputies have been quite busy the past few days, getting the registration blanks and other necessary supplies ready to open the registration books on January 6th. There will be an effort made this year to finish up the registration work at the earliest possible date, and, in order to do this, Mr. Hall intends to personally visit all of those who are physically unable to come to the county house.

Last year about one-third of the voters of the county put the matter off until the last day and the last hour and the consequence was that Mr. Hall and four deputies were kept upon the keen jump up to the last minute and several were turned away as a result. Mr. Hall is going to try to avert a repetition of last year's rush if possible, and, on account of the vast amount of other business to be transacted in his department during the next six months he earnestly requests that everyone who is eligible to registration call as early as possible and attend to the matter.
