SUICIDES IN M'MINNVILLE

Two Young Women Take Their Lives With Arsenic

BOTH SUCCUMBED THOUGH EVERY EFFORT WAS MADE TO SAVE THEIR LIVES.

The Portland Boy Highwaymen Plead Guilty—Thompson Sentenced to Twenty Years and Wright to Ten Years in the Penitentiary—One of the Portland Hotel Diamond Thieves Gets Seven Years.

McMINNVILLE, Or., Jan. 22.—Two young women, Miss Nannie Ungerman and Mrs. Ollie Gaunt, are dead at the home of the latter here, from arsenic poisoning, administered by their own hands, probably with suicidal intent. Miss Ungerman was employed at the central telephone office last night, and her friend, Mrs. Gaunt, was staying with her. About 9:30 o'clock Miss Ungerman telephoned to a physician, that Mrs. Gaunt was sick, and when the doctor came they admitted having taken poison. Restoratives were administered, but it was too late. Miss Ungerman died at 2 o'clock today, and Mrs. Gaunt at 5.

Both women had good homes and their families are prominent. Disappointments in love and despondency are said to be the cause. Mrs. Gaunt had been separated from her husband for several months.

Highwaymen Sentenced.

Portland, Or., Jan. 22.—Bennett Thompson and Charles Wright, who were arrested Monday for highway robbery, were today sentenced to twenty and ten years, respectively, in the Penitentiary. They both pleaded guilty when arraigned today.

Thompson, who is only 21 years old, confessed that he had held up thirty persons in and near the city during the last three months. He was formerly in the Reform School.

Diamond Thief Convicted.

Portland, Or., Jan. 22.—Kelly Wiley (colored) was today sentenced to seven years in the Penitentiary, for robbing Albert Lowenthal of \$10,000 worth of diamonds at the Hotel Portland two months ago. Wiley was not the principal in the robbery but helped dispose of the jewels.

A Faud Settled.

Belleville, Texas, Jan. 22.—Three men were killed, one fatally wounded, and three others slightly wounded in a fight at the railroad station here this evening.

The dead are: Raymond White, constable at Wallis; Milam Odum, his half brother; Henry Dippert, a bystander; Walter Pennington, shot through the bowels, the bullet going entirely through the body.

The wounded are: Elihu Pennington, scalp wound; Antone Dippert, of Belleville, a bystander; John Havkath, a bystander, bullet through the foot.

The case of Walter Pennington, under indictment for the murder of J. C. Odum, brother of Milam Odum and half brother of Raymond White, was called today, and a large number of people came here from Wallis as witnesses, among them the relatives of J. C. Odum. The two factions met at the station and got into a quarrel.

The Mineral Wealth of Montana Leaves Its Tracks

"TIN PAI" BRIGADE AT THE BIG SMELTER IN EAST HELENA ATTRACTS THE ATTENTION

Poultry Journal, of this city, who is on his way East, to attend the big poultry show at Chicago, and who will take in several other shows and cities for that journal and the Homestead, writes in part as follows on the train the day after leaving Spokane, under date of January 18th. He was on the Northern Pacific:

"Left Spokane last night in a snow storm, and it was no little surprise this morning when waking and looking out of the train at Joke to see the sun shining and the ground entirely bare of snow and the atmosphere several degrees warmer. We have traveled all day principally in the mountains, with beautiful scenery. All along the road we have noticed where the mineral wealth of Montana has been taken from the earth, either in the form of gold, silver, copper or coal. The mountain sides all along the route have been punctured by the miners, some of the holes yielding fortunes and others disappointment.

"It was necessary to put on the second engine to carry us over the mountains before reaching Helena. Just before coming into Helena a band of horses was on the track, and one of them falling to get off in time, was struck by the engine, crippling it.

After going through Helena we passed the smelter at East Helena, which is running at full capacity twenty-four hours daily, employing over 1000 men. It was just at the change of shifts as we passed, and many of the workmen were returning home after their labor, each carrying with him his tin pail, making one think of the 'tin pail' brigade so often referred to in the last National campaign.

"We follow the course of the Missouri river from Helena, our view being hemmed in by rocks and mountains, until we come to the valley of the Gallatin river, an affluent of the Missouri. Here the hills recede both to the right and left, and it is in this rich valley that the famous barley of the Manhattan Breeding Company is raised.

"This company owns several thousand acres of this land, which is sowed each year to barley, having warehouses all along the main line of the Northern Pacific railroad.

"There is some good grazing land between Helena and Bozeman, and this is covered with horses and cattle apparently in fine condition, although the cold wave of a few weeks ago did much to take the flesh off them. At Bozeman we took on the second engine again to carry us to the summit of the Yellowstone mountains. We have just passed through the tunnel and are now at Muir, descending. Here we lose one engine again. The train service is excellent and everything is done that is possible for the accommodation of the passengers.

"The dining car service is elegant, the breakfast and luncheon being served a la carte and the dinners \$1 each. But such dinners. When you part with your dollar you are satisfied to see it go."

YET ANOTHER NEW BUILDING

Chemeketa Lodge of Odd Fellows Decides to Erect

A BUSINESS HOUSE AT THE WEST END OF THE NEW TEMPLE, FRONTING ON COURT STREET.

A Structure 24 by 85 Feet to Be Built Immediately—Will Be Leased for a Term of Five Years to a Business Firm.

Chemeketa Lodge No. 1, I. O. O. F., of this city, owners of the Odd Fellows' Temple, has decided to make further improvements on its property, the quarter block at the southwest corner of High and Court streets. At the regular meeting of the lodge last night, it was determined to erect a building 24 by 85 feet, one story high, with a regulation business front, at the west end of the Temple, the new structure to front on Court street. This building will be of corrugated iron, on a stone foundation of sufficient strength to carry a three-story brick building, which it is expected will have to be erected before many years.

The new building will be fitted up for a business house, and has been leased for a term of five years. The details of the lease and the name of the firm to occupy the building will not be available until the lease is drawn and signed, which will be in the course of this week, and it will be immediately followed by active operation on the new building.
