**A SENSATION
IN CONGRESS**
**Sibley Makes an Attack on
General Smith**
THE UNIFORM DISGRACED
**The Speech Was Cheered on
Both Sides of the
House**

IT IS CONSIDERED REMARKABLE
BY A DEMOCRAT WHO LEFT HIS
PARTY AS A RESULT OF THE
SPANISH-AMERICAN WAR—GEN-
ERAL DEBATE.
WASHINGTON, April 28.—Represent-
ative Sibley, of Pennsylvania, cre-
ated a sensation in the House today,
during the general debate on the agri-
cultural bill, denouncing General Jacob
H. Smith for orders he issued in the
Samar campaign. He declared that
General Smith was a disgrace to the
uniform he wore, and expressed the
hope that the President would strip
him of his uniform within forty-eight
hours. Sibley's speech was enthusias-
tically applauded by the Democrats,
and was received with some evidence
of approval on the Republican side.
The speech was considered more re-
markable in that it came from a Re-
publican who left the Democratic party
on the issues raised by the Spanish
war, and who has since been an ar-
dent expansionist.
Williams (Dem. Miss.) endorsed what
Sibley had said. Upon the conclusion

of the general debate, slow progress
was made with the bill, only twenty-
five of the forty-nine pages being dis-
posed of.
In the course of his speech, Sibley
said he had been an expansionist and
had defended the policy of the Admin-
istration in the acquisition of the Phil-
ippines. He then said:
"When I have heard the statements
that we were cruel in the con-
duct of war I have thought, perhaps a
partisan was speaking. But when I
have read within the past 48 hours that
a General, wearing the uniform of the
army of the United States, issued or-
ders not to conciliate a province, but to
leave it a 'howling wilderness' and to
kill all above ten years old, then it
seems to me that humanity must have
marched backward eighteen centuries,
and that Herod again appears. I have
read of Timour the Tartar; I have read
of Achilles; I have read of the Saracen
scourge, but I thank God that since
the tragic scene on Calvary it has
taken eighteen centuries to produce a
Smith."
"That man ought not to be permitted
to stay in the service of the United
States until the sun goes down. He is
a disgrace to every man who ever wore
the uniform of the United States. I
care not how adroitly his lawyers may
frame a plea—the fact admitted by his
own mouth, that he issued such orders
is sufficient for the hope that there is
the courage, patriotism, humanity and
Christianity at the other end of the
Avenue that will not let him wear the
Federal uniform 24 hours hence."

Another Inquiry.
Washington, April 28.—Representa-
tive Burleson, of Texas, today intro-
duced resolutions calling on the Sec-
retary of War for information as to
whether General Smith's order, relative
to the war in Samar, was based on
orders issued from Washington and
requesting the transmission of all or-
ders from Washington relative to the
suppression of the war in Samar.

The Water Cure.
Manila, April 28.—The trial by court-
martial of General Jacob H. Smith, on
a charge of conduct prejudicial to good
order and discipline, was resumed here
today. Major Littleton W. T. Waller,
of the Marine Corps, testified to receiv-
ing from General Smith the orders to
"kill and burn," and render Samar a
"howling wilderness," previously refer-
red to in these dispatches. The natives
of Samar, said Major Waller, were
more treacherous and implacable than
the tribesmen of the Soudan. With-
out General Smith's drastic measures
the war would not have been ended
yet. General Smith never intended
killing women or children. Corporal
Pritchard, of the Ninth Infantry, who
took part in the fight at Gandara, tes-
tified that he saw boys, of 12 years
fighting and slaying with bolos.
Sergeant Bonicastle, of the Ninth
Infantry, at Apache, testified regarding
Captain P. K. Schoefel's fight at Dap
dap province, Samar, against Dios
Dios fanatics. He saw a soldier at-
tacked by two boys, under 15 years of
age, one armed with a bolo, and the
other with a dagger.
Private Nicklo, of the Ninth Infan-
try, explained the dangers and diffi-
culties of service in the island of Sa-
mar.
Private Nanjot, of the Tenth Cavalry
told how Americans (natives friendly
to the Americans) were butchered there
in cold blood.
Sergeant Brumby, of the Ninth In-
fantry, a survivor of the Balangiga
massacre, described that disaster, in-
cluding the mutilation of American
dead by the Samar natives.

IN THE CIRCUIT COURT
**INSURANCE COMPANIES GIVEN
TIME TO FILE THEIR
ANSWERS.**
Stipulations were filed in the first
department of the State Circuit Court
yesterday, in the suits to recover insur-
ance on policies entitled State of Ore-
gon vs. Royal Insurance Co., and State
of Oregon vs. Hartford Fire Insurance
Co., wherein it was agreed by the at-
torneys for the plaintiff and the de-
fendants that the defendants were to
have until and including May 10th to
serve and file their answer to the
complaints.
W. H. Holmes, the defendant in the
suit to modify judgment wherein Ol-
ivia Kitchen was plaintiff, in the first
department of the State Circuit Court,
yesterday filed his undertaking on ap-
peal of the case to the Supreme Court,
from the decision of the Circuit Court.
This case was tried in the Circuit
Court during the October, 1901, term,
and a decision rendered in favor of the
plaintiff, on October 19, 1901, and
against the defendant for \$1,076.50, and
for the costs and disbursements
amounting to \$17.50. It is from this de-
cision that the defendant appeals. J. H.
McNary is the attorney for the ap-
pellant and defendant and W. T. Slater
is one of the attorneys for the recon-
dant and plaintiff.
In Justice Court.
The two suits in Justice of the Peace
J. O'Donah's court in one of which the
plaintiff, F. A. Schubinger de-
mands judgment against the defend-
ant, John Misterek, for damages to the
amount of \$12.50 and in the other the
plaintiff demands judgment in the sum
of \$250, one of which was set for hear-
ing for Saturday last and 10 o'clock a.
m., very both postponed until Monday,
May 5th, at 10 o'clock a. m., upon ap-
pointment between the attorneys in the
case Kaiser & Slater for the plaintiff
and Carson & Adams for the defendants.
Hon. L. T. Harris, of Eugene, had
business before the Supreme Court
yesterday and departed last night for
home.

Geo. Barker, who was arrested on
Saturday evening last upon suspicion
of having supplied the prisoners in the
county jail with means with which to
make their attempt to escape, was yester-
day arraigned before Justice of the
Peace O'Donah to answer to charges
preferred by Sheriff F. W. Durbin, of
conveying a saw to prisoners in the
county jail for the purpose of facilitat-
ing their escape. The prisoner waived
examination and was bound over to
the June term of the State Circuit
Court in the sum of \$500.
Barker had just completed a ninety-
days' sentence upon conviction of lar-
ceny from a dwelling, when he was re-
leased on Saturday morning, and was
not out more than two hours when he
committed the crime for which he is
now held to account and, if convicted,
is subject to a term of not less than
five years nor to exceed twenty years,
in the Penitentiary.
Sheriff Durbin found, upon inquiry,
that the saw had been purchased from
the John Maurer sporting goods es-
tablishment on Commercial street, and
was originally ten inches in length.
The saw had been broken in two and
the prisoners had only delivered over
one-half of the tool to the sheriff but a
diligent search of the jail department
on Sunday disclosed the other half
which had been concealed behind the
bath tub in the toilet room.
The prisoners, as a result of their ef-
forts to escape will hereafter be ac-
cording less freedom, so that their ef-
fort may not be repeated.

A BANK WAS ROBBED
**THE BROWNSVILLE INSTITUTION
ENTERED AND DESPOILED
BY BURGLARS.**

BROWNSVILLE, Ore., April 28.—
This town was thrown into a fever of
excitement at noon today, when the
Hon. J. H. Glass, the cashier of the
Bank of Brownsville, on returning to
his office from dinner, discovered that
the bank had been robbed during his
absence, and from \$1600 to \$1800 in
coin and currency carried away.
As is his custom, Mr. Glass locked
his office at noon, going to his home
for the noonday meal. He left the
money, taken out of the vault in the
morning, in a drawer of the counter.
During his absence some person or per-
sons broke into the office by forcing the
bolt of the back door, and carried
away the coin and currency. Nothing
else was disturbed. The loss was dis-
covered immediately upon the return
of Mr. Glass, and he gave the alarm.
Search was at once instituted, and the
finger of suspicion soon pointed to lo-
cal characters, Wm. Tyner and Thos.
Vennum. These men were placed un-
der arrest, and will have their prelimi-
nary hearing in the justice court at
9 o'clock tomorrow morning. The men
strenuously assert their innocence, but
there is some circumstantial evidence
against them. There is no trace of the
missing money. District Attorney J.
N. Hart, of Dallas, has been notified,
and he will be here in the morning to
conduct the case. J. H. Wyatt, of Al-
bany, has been secured by the two
prisoners to conduct their defense, and
the latter and Sheriff Munkers are ex-
pected tonight.

AMERICANS IN TROUBLE
**PART OF THE CREW OF THE
CRUISER CHICAGO ARE IN AN
ITALIAN PRISON.**

VENICE, Italy April 28.—The mem-
bers of the crew of the United States
cruiser Chicago, arrested for disorderly
conduct here yesterday, have been sen-
tenced to terms of imprisonment rang-
ing from three to four months each.
At their trial the prisoners admitted
they were intoxicated when the disor-
ders occurred, and pleaded that they
acted in self-defense when mobbed by
the crowd.
It is understood the prisoners will
pay the costs of the trial and com-
pensate the persons who sustained inju-
ries as a result of their disorderly con-
duct.
RIOTING SYRIANS.
NEW YORK, April 28.—Riot, attack
upon the police and indiscriminate
wounding of their fellow countrymen,
ended the celebration of the Easter
Sunday of the Greek church in the
Syrian quarter. The trouble was pre-
cipitated by a Syrian banker, who
struck one of his countrymen's female
relatives. In an instant the swarms of
hilarious men and women in the street
gathered, and some threatened the wo-
man's assistant. Policemen ran to
quell the uproar and arrested the bank-
er. He fought like a madman, and
when he found his resistance futile,
emitted the piercing yell with which
the Syrians summon their compatriots
to their succor.
Police reserves were called. They
rescued their comrades and placed
their prisoners in the wagon. Then
they had to fight their way back to the
station.
FROM THUNDER MOUNTAIN.
SALT LAKE CITY, Utah, April 28.—
A. M. Wantland, immigration agent
of the Oregon Short Line, arrived from
Thunder Mountain today. Wantland
says the country is heavily mineralized,
gold, silver and copper bearing rock
being found everywhere. Much pros-
pecting is going on and many rich
strikes are reported.
HIS CONDITION BETTER.
NEW YORK, April 28.—The condi-
tion of Archbishop Corrigan has great-
ly improved, and he passed a peaceful
day. The physicians report that the
pneumonia is thoroughly broken, and
the only danger now lies in the pa-
tient's weakened condition owing to
the long and severe illness.

**MONGOLIANS IN THE PHILIPPINES
WILL HAVE TO SECURE THEIR
CERTIFICATES—THE OLEOMAR-
GARINE BILL GOES TO THE
PRESIDENT FOR APPROVAL.**

WASHINGTON, April 28.—The con-
ferees on the Chinese exclusion bill
have reached a complete agreement.
It strikes out a portion of the Senate
bill limiting the extension of all exist-
ing laws to the life of the present
treaty and re-enacts them so far as not
inconsistent with the treaty obligations
until otherwise provided by law, and
extends the laws to our island terri-
tory as far as applicable. It allows the
Chinese to enter for exposition pur-
poses, and retains the provision regard-
ing the certification in the Philippines.
The conferees' report was adopted in
the Senate.

Work in Senate.
Washington, April 28.—Today the
Senate agreed to the House amend-
ments to the oleomargarine bill, as
passed by the Senate. The measure
now goes to the President.
Simmons (N. C.) addressed the Sen-
ate in opposition to the Philippines
Government bill. He urged that he
Philippines ought to be turned over to
the inhabitants of the islands.
Consideration of the Sundry Civil
Appropriation bill was not concluded.

More Civil Service.
Washington, April 28.—The Pres-
ident has signed the legislative bill.
Under its provisions a thousand or
more clerks who were temporarily ap-
pointed during the war with Spain are
given permanent employment, and are
placed within the operations of the
civil service law.

Increase Deposits.
Washington, April 28.—Secretary
Shaw said today that on May 1st he
would increase the deposits in the Na-
tional Bank depositories by three or
four millions. He will designate a few
additional depositories. It is under-
stood that a further increase in depos-
its will be made after May 1st, as the
repeal of the war revenue act is ex-
pected to result in a sharp decrease in
the Government receipts from the be-
ginning of the fiscal year.

The Oleo Bill.
WASHINGTON, April 28.—When the
Senate convened today Harris (Kan.)
presented a telegram from the Kansas
Millers' Association which stated an
account of foreign discriminations
with the best wheat in the world as
their door, Kansas millers are not pro-
ducing over one-third of their full ca-
pacity, and unless relief through rec-
iprocal concessions is afforded man-
mills will shut down indefinitely and
some of them will be forced to the
wall. The telegram was referred to
the committee on foreign relations.
The oleomargarine bill, as it came
from the House was taken up and Mr.
Culberson (Tex.) moved that it be
referred to the Committee on Agricul-
ture. The motion was defeated, 26 to
25.
Teller then offered an amendment to
the renovated butter section of the bill
as passed by the Senate, defining a but-
ter trust, and providing that a tax of
10 per cent shall be imposed upon the
products of such a trust and upon the
capital and assets of such a trust.
The amendment was defeated 25 to 28.
The amendment in charge of the measure,
moved that the Senate non-concur in
the House amendments and a confer-
ence be requested.
Cockrell (Mo.) interposed with a mo-
tion to agree to the House amend-
ments, and the motion was agreed to
without division, thus passing the bill.
At 2 o'clock the Senate took up the
Philippines Government bill and Sim-
mons (N. C.) addressed the Senate in
opposition to the measure.

THE USE OF GRAPE FRUIT
One of the wholesale fruit dealers of
New York remarked that the biggest
increase in his trade this year was ow-
ing to the public developing a fond-
ness for shadocks, or pomos, as the
East Indians call them. "Not so many
years ago it was impossible to sell a
grape fruit outside of New York city,
and even here the demand has been
restricted.
An occasional epicure insisted upon
having one for breakfast during the
season, but it was a waste of money
to keep them in small markets; it was
necessary, when wanted, to order be-
forehand from one's grocer.
Today not only are tons of grape
fruit sold on Manhattan Island, but all
through the country, in small island
towns, they are part of the regular
stock and are disposed of in great
numbers. Americans have learned to
appreciate their refreshing qualities,
and, as a rule, they serve as the first
breakfast course.
To prepare properly the grape fruit
should be cut horizontally in two equal
parts, the centre pith of fibre, remov-
ed; flesh drenched with West India
rum and powdered sugar, and then
set in the icebox until very cold. An-
other excellent way is to remove the
fibre, cut the pulp in cubes, drench
with sherry, and add a spoonful of
Curacao and some powdered sugar.—

**DESTROYED
BY CYCLONE**
**Terrible Havoc Wrought in a
Town in Texas**
SEVEN PEOPLE ARE DEAD
**And a Large Number Ser-
iously Injured at
Glenrose**

**WHILE MANY BUILDINGS IN THE
VILLAGE WERE DEMOLISHED
BY THE STORM—HELP HAS
BEEN SENT FROM THE NEIGH-
BORING CITIES.**

DALLAS, Tex., April 28.—A tele-
phone message to the News, from
Morgan, Tex., says a tornado passed
over Glenrose, a small town in Somer-
ville county, this afternoon, killing sev-
en persons, injuring forty more and de-
molishing much property. The dead
are:

Milan.

church.

Mrs. Gage.
A boy named Mudgrove.
An unknown.
The most seriously injured are: Mrs.
Tidwell, Mrs. Baschow, Mr. and Mrs.
Thomas Trice and baby, Miss Fogg,
Mr. and Mrs. Shields, Miss Lewis,
Weatherford. The names of other in-
jured are not obtainable at this hour.
The court house was badly damaged,
the printing office blown away, two
saloons were partly destroyed, Milam's
wareroom demolished, Lily & Sons gro-
cery store blown away, a blacksmith
shop destroyed, and four buildings of
Hendricks & Son totally demolished.
Assistance has been sent to Glenrose
from Morgan, but it will be morning
before definite particulars are obtain-
able.

THE BEAR GOES NORTH
**REVENUE CUTTER TO LAND
REINDEER FOR THE NA-
TIVES ON ARCTIC COAST.**

SEATTLE, Wash., April 28.—The U-
nited States revenue cutter Bear left
tonight for the annual cruise in Behr-
ing Sea and the Arctic. She had on
board Special Agent Hamilton, who
goes north for the Government to in-
quire into the condition of the natives,
especially as regards educational mat-
ters.
One of the chief missions of the Bear
this year is to land 400 Siberian rein-
deer on St. Lawrence island, for the
use of the natives.

AT THE FLAX MILL.
A. N. Douthart and his force of as-
sistants have just about completed the
work of repairs to the old flume at the
old flaxing mill on North Front street,
which is being overhauled for the new
flax-fibre plant. The old water wheel
was taken out and the waterway lead-
ing to it, and today it is expected that
the entire job will be completed. It is
thought that the work of reconstructing
the dam on Mill creek will be begun in
a few days or just as soon as the wa-
ter in the creek is low enough to per-
mit. Mr. Bosse is very busily engaged
in supervising the planting of the flax
crop and expects to have the entire
acreage (220) in before the close of
next week.

at Cottage Grove**
GOV. GEER TO OFFICIATE
**He Will Break the First
Ground for the New
Enterprise**

**AN ELABORATE CELEBRATION
PLANNED BY THE PEOPLE OF
LANE AND DOUGLASS COUN-
TIES, AND MANY NOTABLES
WILL BE IN ATTENDANCE.**

COTTAGE GROVE, Ore., April 28.—
At a meeting held here today, it was
decided to celebrate the opening of the
road of construction of the Bohemia
Railroad here, on Wednesday, April
30th, by impressive exercises. The
celebration will eclipse anything ever
attempted here. Gov. T. T. Geer will
break the first ground in the construc-
tion work, and will deliver the address
of the day. In the evening a public
reception will be given the Governor,
and prominent men from Lane and
Douglas counties will be in attend-
ance. Governor Geer will speak at this
reception, and others to deliver ad-
dresses on this occasion will be the
mayors of Eugene and Roseburg; Hon.
R. A. Booth, of Eugene; Dr. W. Kuy-
kendall, of Eugene; Judge J. W. Ham-
ilton, of Roseburg; Hon. E. R. Skis-
worth, of Eugene, and Hon. Lark Bil-
yew.

The Portage Road.
Portland, Ore., April 28.—A great
deal of interest is being taken in the
proposed extension of the portage road
at The Dalles, and the transfer of the
control of the same to the shippers
and producers east of that point. The
railroad committee of the Basin Board
of Trade is considering the matter and
will undoubtedly report in favor of the
proposed plans at a meeting Wednes-
day evening.
When asked if the proposed canal
above The Dalles would have any
effect on this enterprise, those inter-
ested said it would not, as it would
take, undoubtedly, twenty-five years to
complete the canal after the work be-
gan.
