LEASING OF

Would Be Greatly Curtailed if the Bill Is Passed

THE ANTI-CONSPIRACY HILL CAR-RIED IN THE LOWER HOUSE-LITTLEFIELD, OF MAINE, OP-POSED IT BUT WAS AWAY WHEN IT. WAS CALLED UP

WASHINGTON, May 2.-Senator Gibson, of Montana, today presented in the Senate a letter from Commissioner Herrman, of the General Land Office, in opposition to the policy of leasing the public lands as proposed by the bill now pending in the Senate. Mr. Herrman says that under the terms of the bill practically all public lands west of the Mississippi would be subject to leasing, and that as it is provided that, when under the lease, they shall not be disposed of except under the homestead and mineral land laws, the sale of the public domain would be greatly curtailed.

#### Anti-Conspiracy Bill.

Washington, May 2 .- The House today pasesd the anti-Conspiracy bill, reported from the Judiciary Committee without a word of debate. It came up rather unexpectedly, and Littlefield. (Rep., Maine), who had filed a minority report and had intended to offer some amendments, came in just as it was put upon its passage, and a vote FORMER SALEM MAN PASSED was taken before he understood what was going on. LEWISTON, Idaho, May 2 .- Miners arriving here today from Thunder Mountain report that Engineer Hill's garty are making a preliminary survey into the district for the Northern Pacific Railroad. Hill's party have been working beyond Dixie for several weeks, and are row in Chamberlain Basin country. It was announced at the time the party went out that they were viewing a trail, but stakes are being set and the low altitutes followed. The survey will be completed to Big Creek this week.

Hill's party number twelve or fifteen men, and the work is being pushed as rapidly as possible. The Northern Pacific three years ago completed a survey from Stites to a point near Elk City, and Hill's survey makes a connection with it near Salmon river.



A CABINET CRISIS.,


