Salem Will Entertain the A. O. U. W. Delegates Monday

AN EXCURSION TRAIN WILL BRING THE EASTERN VISITORS TO THIS CITY DURING THE FORENOON—REFRESHMENTS TO BE SERVED IN MARION SQUARE

(From Sunday's Statesman.)

The Supreme Lodge, A. O. U. W., and the Supreme Degree of Honor for the United States and Canada are in session in Portland this week, and before the delegates and visitors return east, they will be given excursions through various sections of Oregon, there to enjoy the hospitality of the people of this state, and to see the beautiful scenery and admire the sights of the various sections of Oregon.

The most important and extensive of these excursions is the one coming through the Willamette valley on next Monday, stopping in Salem and Albany, and returning by way of Corvallis down the west side. This excursion, coming on a special train, will reach Salem on Monday at 10:30 a. m., and the visitors will be lavishly entertained by the local A. O. U. W. and Degree of Honor lodges, assisted by the citizens of the Capital City of Oregon.

The excursion train will arrive in Salem on Monday morning at 10:30. It will back down to Commercial street, where the visitors will disembark. They will be met by the Salem Military Band and, led by that organization, and the local A. O. U. W. degree team, will be escorted down Commercial street to Marion Square, where refreshments will be served to the visitors. The tables will be decorated with choice flowers, and a substantial meal served, followed by Oregon strawberries, the choicest to be secured, and other seasonable Oregon products.

During the entertainment of the visitors in Marion Square, several informal addresses will be made by some of the leading visitors, and a most enjoyable day is predicted. The excursion train will leave Salem for Albany at 12 o'clock.

A large number of Workmen and members of Degree of Honor from the surrounding towns—Silverton, Astoria, Jefferson, Stayton, Mehama and others—will come to Salem to meet the visitors and assist in doing the honors. After the excursionists leave, the visitors from the surrounding towns will be served with refreshments and will enjoy the day in Marion Square. All members of the A. O. U. W. are requested to wear the colors of the order—a bow of red, white and blue ribbon in the lapel of the coat; and the ladies of the Degree of Honor will wear the colors of their order.

THE SCHOOL ELECTION

Tomorrow the school election takes place in this city, between the hours of 2 and 6 o'clock, and there seems to be considerable interest taken in the contest. Dr. W. H. Tomorrow evening at 8 o'clock the annual school meeting will be held at the city hall.

Directors Meet. The board of directors for school district No. 24 held an adjourned meeting last night, and considerable routine business was disposed of.

The clerk was instructed to place \$5000 to the indebtedness fund and call in notes Nos. 9 to 20, amounting to \$8000.

BUILDING AND LOAN

SUIT BROUGHT BY STOCKHOLDER AGAINST THE WASHINGTON ASSOCIATION.

An action was begun in the second department of the State Circuit Court wherein the plaintiff, W. J. Brown, obtained judgment against the Washington National Building, Loan and Investment Association, defendant, decreeing that the defendant be required to surrender up a certain mortgage upon lot No. 7 of block 87, of Salem, for cancellation, and that the plaintiff recover from the defendant the sum of \$297.90, which amount the plaintiff alleges he has overpaid the defendant upon said mortgage; for legal interest on each of the monthly installments from time of payment of each of them until judgment is rendered, for the sum of \$200 damages for the alleged

wrongful refusal and neglect of the defendant to release said mortgage, and for his costs and disbursements. The plaintiff alleges in his complaint that the property was formerly that of J. A. Rotan, and that the latter borrowed the sum of \$1500 from the defendant corporation and executed a mortgage in favor of the defendant upon said property in security of the loan. He also alleges that Rotan subscribed to fourteen shares of stock in the defendant corporation valued at \$100 each, payable in monthly installments. Rotan is further alleged, installments too much, amounting to \$207.90, and that the defendant wrongfully and usuriously claims that there is still due the sum of \$600. Carson & Adams are the attorneys for the plaintiff in this suit.

Conveyed the land to the plaintiff, subject to the mortgage, and also his interest in said stock, which he, the plaintiff, and Rotan paid in regular monthly installments until April, 1902, paying in all \$1871.10.

Plaintiff alleges that the stock was fully paid up in August, 1901, but that, through mistake, he paid nine months

A FINNISH INTERPRETER

WHO CAN SPEAK RUSSIAN AND SWEDISH WANTED BY CIVIL SERVICE COMMISSION.

The United States Civil Service Commission announces that on July 8, 1902, an examination will be held at the places mentioned in the accompanying list for the position of Finnish interpreter, qualified to speak the Russian and Swedish languages, in the Immigration service. The examination will consist of the subjects mentioned below, which will be weighted as follows:

Subjects—
Spelling (second grade)..... 4
Arithmetic (second grade)..... 4
Letter-writing (second grade)..... 4
Penmanship..... 4
Copying from plain writing (2d grade)..... 4
Training and experience..... 10

Total..... 30
Age limit, 20 years or over. From the eligible resulting from this examination it is expected that certification will be made to the position of Finnish interpreter, qualified to speak the Russian and Swedish languages, in the office of the Commissioner of Immigration at Ellis Island, New York, at a salary of \$1200 per annum, and to other similar vacancies as they may occur.

This examination is open to all citizens of the United States who comply with the requirements. Competitors will be rated without regard to any consideration other than the qualifications shown in their examination papers, and eligibles will be certified strictly in accordance with the civil service law and rules. Persons who desire to enter this examination should at once apply either to the United States Civil Service Commission, Washington, D. C., or to Zedee Palmer, secretary of the local board of examiners for application forms 504 and 1145, which should be properly executed and filed with the Commission at Washington. Persons who are unable to file their applications but whose requests are received at the Commission in sufficient time to ship the examination papers to the places of examination selected, will be examined. Form 1145 will be sent to the persons given as reference in Form 1141 for information relative to the applicant's knowledge of the language.

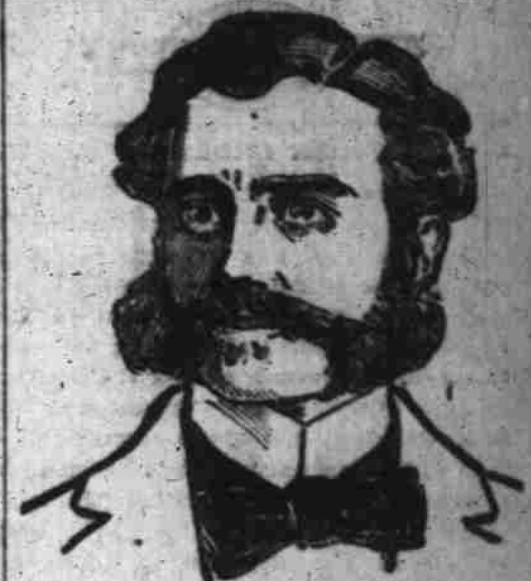
