A PUNITIVE EXPEDITION

Sent Into the Interior of Africa from Zambesi

TO SUPPRESS THE NATIVES

Who Have Committed Outrages on Europeans

RESIDENT WHITES AT ANGOLA HAVE BEEN COMPELLED TO FLEE, AND REACHED THE COAST IN A SAD PLIGHT AFTER A LONG MARCH.

LISBON, Portugal, July 21.—The Governor of Zambesi has notified the authorities of the despatch of a punitive expedition, consisting of 300 Europeans and 700 natives from China-for-Bareu, to suppress a native insurrection in Angola. The natives there have committed many barbarous acts against resident Europeans and compelled an exodus of the white population to the coast.

Seventy white persons have reached Cova Rodondo in a sad plight. They had traveled 250 miles on foot.

Loubet Interested. Paris, July 21.—President Loubet today received a delegation of the directors of the projected trans-Alaska-Siberian railway. Loubet granted his patronage to the undertaking. Steps will now be taken to obtain the support of Russia.

Old Settler Suicides. Kallispel, Mont., July 21.—James W. Stahl, one of the oldest settlers of Northern Montana, committed suicide this morning by shooting himself with a rifle. He was blind, and ill-health is supposed to have affected his mind.

INSANITY CHARGED

A POOR GERMAN ACCUSED BECAUSE HE COULD NOT SPEAK ENGLISH.

The quiet neighborhood of North Salem was plunged into great excitement yesterday morning through the appearance of an unsmooth stranger who, to the eye and mind of all with whom he came in contact, bore every evidence of being insane and wherever he made his appearance doors were slammed in his face and locked and blinds tightly drawn.

A messenger was despatched post-haste to inform the authorities who appeared before Sheriff Colbath and breathlessly informed him that there was a maniac at large in their peaceful neighborhood who was so blood-thirsty and rampant that it required four strong men to subdue him.

Deputy Sheriff Skipton repaired immediately to the scene in a cab and found that although two men had seized the maniac he had broken loose from them and was still at large, and Deputy Skipton started in pursuit. He finally overtook the man who proved to be of German extraction and his speech was so broken that he could not make himself understood. Deputy Skipton took him into the cab and brought him into the city and before the county court where he was subjected to an examination by Dr. J. N. Smith and County Judge John H. Scott, with the aid of an interpreter, and pronounced not insane. It developed during the examination that he was from Silverton, was known as "Dutch Charlie," and pruned trees for a living. He was identified by Senator L. J. Adams who knew him personally.

He explained, the best he could, that he had come to Salem on business and was trying to find his way out to return again, got lost in North Salem, and had stopped at several places to inquire his way onto the Silverton road when he was ruthlessly pounced upon and scared nearly out of his wits.

He did not understand the proceedings but when he was told by Mr. Adams that they thought he was crazy he exclaimed, "Mein Gott Im Himmel! I am not crazy, I want to go home!" He was furnished with the proper directions and took his departure, mentally observing, no doubt, that he would not visit Salem again.

TROUBLE WITH FISHERMEN

Japanese on the Fraser River Threaten Disturbance

THE UNION RATES ADOPTED

Do Not Suit Them at all and They Patrol the Stream

TO INTIMIDATE THOSE OF THEIR COUNTRYMEN WHO DESIRE TO FISH—AN OLD SETTLER OF MONTANA COMMITS SUICIDE ON ACCOUNT OF ILL HEALTH.

VANCOUVER, B. C., July 21.—Although the Union fishermen and cannerymen have agreed upon rates to be paid this year for salmon delivered at the canneries, the annual trouble in connection with this industry is being caused, this time by the Japanese, who do not wish to fish according to the Union scale of prices. The Japanese are trying to intimidate those who desire to fish, and have been maintaining patrol boats on the Fraser river.

On Suspicion. Vancouver, B. C., July 21.—Under the impression that they were notorious French swindlers Frederick and Eugene Humbert, the local police, at the instance of the French Consul here, arrested two tourists today. The suspected men easily proved their innocence.

A Brakeman Injured. Tacoma, Wash., July 21.—William Webb, a brakeman on the Northern Pacific, was struck by a train at Kanak and fatally injured. His parents reside at Roseburg, Or.

Serious Charge. New York, July 21.—A formal complaint of grand larceny was made against ex-Captain Putnam Bradley Strong, tonight by May Yoho, who charged Strong, who recently disappeared from his home, with the theft of jewelry which she valued at \$250,000. A general alarm was sent out for the arrest of Strong.

A Murderer Suicides. Fort Benton, Mont., July 21.—W. C. Pratt, who killed a sheep herder named McClure and tried to burn the body, was found dead in the Bad Lands yesterday. A letter was found upon the body, confessing the murder and stating that the crime weighed so heavily on his mind that he was determined to commit suicide.

Mysterious Shooting. Missoula, Mont., July 21.—Mrs. D. E. Durfee, wife of Judge Durfee, of Philadelphia, was mysteriously shot tonight. Mrs. Durfee was on her way home when she was hit by what is thought to have been a stray bullet. Little hope is entertained for her life.

MANY PEOPLE ARE DROWNED

Steamship, Loaded With Passengers, Cut in Two

AN ACCIDENT AT HAMBURG

A Tug Struck the Fated Vessel at Dead of Night

PANIC OF THE EXCURSIONISTS PREVENTED THE SAVING OF THE LIVES OF PEOPLE ON THE PLEASURE STEAMER—DIVERS ARE AT WORK.

HAMBURG, July 21.—The steamship Primus, of Hamburg, with 185 passengers on board, was cut in two and sunk by the tug, Hansa, on the River Elbe, at 12:30 o'clock this morning. So far as is ascertainable about fifty persons were drowned. The Primus was an excursion steamer from Buxtehude, Province of Hanover, Prussia. The disaster occurred between Blankens and Nienstadt. Among the passengers were the members of the Elbe Club Male Choral Society.

At the time of the accident the Primus was crossing the river channel near Blankens from the southern into the northern fairway. According to witnesses aboard the Hansa, the movement was made too soon. The Primus struck the tug's engine-room and the Hansa endeavored to push her ashore, but the tug grounded and the ships parted. The Primus then sank.

In the interval, however, about fifty of her passengers were able to reach the Hansa by means of ropes and ladders. Seventy more were picked up by the tug's boats, while others swam ashore.

The terrible panic that occurred on the Primus when the Hansa struck her rendered all efforts to save the passengers almost useless. The steamer Dolphin succeeded in saving sixty of those on board the sinking steamer.

Many couples were dancing on deck when the crash of the collision came. The vessel gave a great list, the deck taking such an angle that it was impossible for the passengers to keep their feet. Most of the persons in the saloon were drowned.

It is asserted that divers have already recovered forty-five bodies, but it is impossible to verify the death list.

WAS SERIOUSLY HURT

HERBERT CLARK, IN A RUNAWAY SUFFERS A SHATTERED THIGH—HEAD CUT.

Herbert Clark, who has been hauling lumber from Amend's sawmill at Aumsville, to the Goodale Lumber Company in this city, met with an accident yesterday morning and received injuries which, although not of a serious nature, were very painful and will necessitate his remaining in bed for several weeks.

Clark brought some lumber down on Saturday and stayed at his home near this city over Sunday. Yesterday morning about 7 o'clock he started back to Aumsville and when he had proceeded to a point about one mile east of the E. C. Cross slaughter house, his team became frightened at a broken down wagon alongside the road and shied from it. Clark was sitting upon a sack of feed, which he had placed upon the wagon reach, and this rolled off and took him with it. The team started to run and the hind wheel of the wagon struck him breaking the left thigh bone and cutting a long gash in his head. He was taken to his home, the first house east of Cross' slaughter house which he occupies with his mother and one sister, where Dr. C. H. Robertson was called and who adjusted the fractured bone, dressed the wound in his scalp and made him as comfortable as possible.

The team ran for a distance of about a mile from where the accident occurred where it collided with a tree and was found standing some time afterward by a party who was sent in quest of it.

GOLD BEATERS' STRIKE

EVERY WORKMAN IN THE COUNTRY JOINS IN DEMAND FOR DISCHARGE OF WOMEN.

PHILADELPHIA, July 21.—A strike was inaugurated today throughout the country by the United Goldbeaters' National Union of America. In this city, according to Ellis Gray, president of the local union, 56 goldbeaters and 40 apprentices are on a strike. The tie-up is said to be complete everywhere. There are about 400 goldbeaters in the United States, and all are members of the union. They demand the discharge of the women employed as moldfillers who, Mr. Gray says, do the work at the rate of 15 cents for which the goldbeaters formerly received 30 cents. The beaters he claims, can only earn \$12 to \$15 a week.

AT CAMP WILLIAMS

SOLDIERS WILL BREAK CAMP TODAY AND RETURN HOME—SUNDAY VISITORS.

Today the soldier boys will return from Camp Williams, at Albany, as the encampment of the Oregon National Guard will reach its end this morning. This will cause happiness to reign supreme in the hearts of the enlisted men, for from their point of view the camp ground was the poorest ever selected in Oregon, and there were more hardships and fewer pleasures than usual at this year's encampment. Not a tree or shrub was near the camp, which was located on a dry dusty field, the hot sun pouring down and the dust drifting so as to add to the discomforts of the Khaki-clad brigade of Oregon's citizen-soldiers.

A large crowd visited Albany and the encampment on Sunday, three excursion trains going from Portland. The visitors enjoyed the day in spite of the heat, and many went out to the encampment.

TWO BURGLARS ARE ARRESTED

Their Suspicious Actions Caused Their Downfall

TAKEN BY THE OFFICERS, THEY WERE FOUND LOADED DOWN WITH PLUNDER—QUICK WORK OF THE NIGHT POLICE—ONE OF THE ROGUES A MERE LAD.

Early on Sunday morning Night Officers Lewis and Murphy made an important capture in the shape of a man and a boy who had commenced a system of depredation in this city. The two strangers in Salem were seen going up Commercial street, at 4 o'clock Sunday morning and their actions being somewhat suspicious, the officers decided to follow them, when the strangers ran down Ferry street. The officers followed, chasing the strangers down Ferry to Front, down Front to State; thence on State to the river bank down into Court street, up Court to Front where the strangers were arrested, and taken to the city jail.

On being arrested they had a quantity of cigars, tobacco, cigarette papers, a bunch of skeleton keys, and one of them had a revolver. After locking up the men the officers went back over the streets enumerated above and found a quantity of plunder thrown away. When all was gathered there was found to be the following collection: Four silver watches, a compass, two razors, two revolvers, three bottles of whiskey, a quantity of cigarette papers, eight packages of Durham tobacco, and 50 cigars. Investigation showed that the whiskey came from the Annex saloon; the tobacco and cigars from George Statesman's cigar store; and the watches, razors and pistols from Shantz's second hand store. All of these places having been entered by means of a skeleton key except the saloon, that being entered by climbing over the transom.

One of the prisoners, Jos. Murphy, was a man aged 25 years; the other, Thomas Smith, was a lad 15 years old. The men were last evening brought before City Recorder N. J. Judah, for a preliminary hearing, and here the boy made a clean breast of the whole story. He claimed to have reached Salem on Saturday evening, when he met Murphy for the first time. That individual proposed to him to rob stores in this city, and he consented and they did the work during the night. The places were entered as above described, but nowhere did they get much money, a few pennies being all found in the cash drawers. The lad claimed this was his first trouble since he left Pittsburg, his home. After his confession Murphy smilingly acknowledged the truth of the lad's story, and he signed a statement, making a confession, and was bound over to the Circuit Court in the sum of \$500. The lad will be brought before Judge John H. Scott today, and probably sent to the Reform School.

The work of the police can not be too highly commended. On suspicion the men were arrested; in a short time after they landed in Salem their career of lawlessness was interrupted, and the further despoiling of Salem merchants stopped. Salem ought to be proud of its efficient police force.

ROOSEVELT IS SURPRISED

Senator McLaurin Declines Preferred Appointment

ON THE COURT OF CLAIMS

The President Regrets This Action of the Appointee

IS UNCERTAIN WHAT HE WILL DO FOR THE MAN FROM SOUTH CAROLINA, AS HE IS ANXIOUS TO APPOINT HIM IN RECOGNITION OF SERVICES.

OYSTER BAY, L. I., July 21.—President Roosevelt is in receipt of a letter from Senator McLaurin, of South Carolina, declining the proffered appointment to vacancy on the bench of the United States Court of Claims. The President much regrets McLaurin's decision, as he believed the Senator's senatorial experience and his career as Attorney General would render him a particularly good addition to the Court of Claims.

The President is now uncertain what he will do about McLaurin. It is understood he is anxious to appoint him to some position in recognition of what the President regards as his services to the country, and his demonstrated ability in public life.

The Anti-Aga n. Boston, Mass., July 21.—A number of anti-imperialists, including Charles Francis Adams, Moorehead Story, and Julian Odman, left here for Bolton's Landing, to join other leaders of the movement at a meeting of the special committee appointed last spring to investigate affairs in the Philippines, and securing publicity of the facts. It is possible that at the conclusion of the meeting the statement of facts developed will be sent to President Roosevelt.

PLAYED NAVAL WAR

COLUMBIAN WARSHIPS AND REBEL BOATS HAD A FIGHT AT LONG RANGE.

WASHINGTON, July 21.—The State Department has received a cablegram from Consul-General Gudgeon at Panama dated yesterday as follows: "Fighting at long range, five miles out, between Padilla and Cuitan and two Government vessels. No damage done."

This is the engagement in Panama harbor referred to in Saturday's dispatches.

The Navy Department also received the following dispatch from Commander Potter, of the gunboat Ranger, which was represented in the press reports as being in the line of fire.

"Panama, July 20.—A slight engagement has taken place between insurgents and Government vessels, Panama Bay. No damage. I have notified the insurgents that bombardment city or anchorage cannot be permitted."

The Ranger was dispatched today to report upon the revolutionary movements in that vicinity.
