

MR. BOSSE IS IN DISPAIR

Cannot Secure the Hands Required to Harvest His Flax

WILL PAY GOOD WAGES FOR A LARGE NUMBER OF PEOPLE FOR SIX WEEKS—MAY BE COMPELLED TO GO TO PORTLAND AND ENGAGE JAPANESE.

(From Saturday's Daily.)

Mr. Eugene Bosse, who has been entirely dependent upon Salem to furnish him with harvesters for his crop of flax, finds himself in a predicament and is at a loss to know what to do under the circumstances. He has advertised repeatedly for hands to pull flax and offers to pay wages according to ability and service, but so far he has been unable to secure help beyond a number of children, ranging in age from 10 to 14 years, none of them being reliable or to be depended upon.

Mr. Bosse began the harvest Thursday morning on the John Garber place in Polk county, with a force of sixty-two hands, composed largely of small boys and girls, but before evening the force had dwindled down to a very small one. Yesterday morning he went to work with forty-two hands and quit at 4 o'clock in the afternoon with only six. He says that he is a very patient man, but his patience is fast becoming exhausted and the situation is growing more critical every day, for with 100 acres of flax which must be harvested before the end of next week and no help to be obtained, he regards the matter in a very serious light.

Being convinced that he would be unable to secure help in Salem, he applied to the officers of the Indian School, but was informed that the number of boys at the school at this season was very limited and all were employed there; he then applied to Superintendent Lee at the Penitentiary, and met with no success. He says the situation is growing desperate, and as much as he regrets to hire help outside of Salem for he desires very much that the Salem people should get the benefit of the \$1500 which will be expended in the harvest, he must have at least a steady force of at least forty hands for the next six weeks and if he cannot secure them here this morning, he will be compelled to go to Portland today and employ a force of Japanese laborers. He deplores very deeply having to resort to this means of obtaining men, but he is forced to do it to protect his interests and save his flax, and he hopes, knowing the exact condition of affairs, that the people of Salem will not censure him for it.

DEATH OF CHAS. MEEHAN

PASSED AWAY AS A RESULT OF HEART DISEASE LAST TUESDAY MORNING.

Charles Meehan died suddenly at his home in Woodburn at 2 o'clock Tuesday morning July 15th, of heart disease. Mrs. Meehan heard her husband breathing heavily and choking, and becoming alarmed, called in the rest of the family, three minutes after whose arrival the husband and father breathed his last.

Charles Meehan was born at Ogdensburg, N. Y., April 13, 1845. The fore part of his life he farmed, then followed the avocation of a mechanic, and afterward was in the employ of the Chicago, Milwaukee & St. Paul in the construction of bridges. Later he retired from active life. He married Miss Marie Lindsay, of Rochester, N. Y., in 1875. From the state of New York they moved to La Crosse, Wis., and came to Oregon in November, 1890, locating in Woodburn a few months ago. It was his intention to buy a farm in this vicinity. A widow and two sons—William, aged 24; Peter, 26 years—survive him.

Deceased was a man of upright character, a conscientious member of the Catholic church, devoted to his wife and children, and a man who carried his own way in life and by hard work and close application met with success. His death is deeply mourned by all who knew him, and much sympathy is felt for the grief-stricken family.

The funeral was held from the Catholic church at Woodburn, on Thursday, and interment was had in the Catholic cemetery at Gervais, Rev. Lesques officiating.

MANY DEEDS RECORDED

YESTERDAY'S FILINGS ABOVE THE AVERAGE—BUSINESS IN THE RECORDER'S OFFICE.

WILL BEGIN BUSINESS

NEW CORPORATIONS FILED ARTICLES IN THE STATE DEPARTMENT YESTERDAY.

In the Department of State, at the Capitol, yesterday, three new companies filed articles of incorporation. They are:

The Belt Line Railway Company, of Coos Bay, will build, equip and operate railroads, telegraph and telephone lines, in Coos county. Portland is the headquarters, and the capital is \$1,000,000. W. L. Green, John W. Cook and John K. Kollock are the incorporators.

The Larson Quick Transit Company will operate boats, propelled by steam, electricity or other motive power, on the Columbia and Willamette rivers. Portland will be the headquarters. The capital is fixed at \$40,000, and L. H. French, C. J. Maher and John Larson are the incorporators.

The Seaside Sick and Accident Society will carry on a general sick and accident society at Seaside, Clatsop county. The society has a capital of \$250. C. C. Clarke, Albert H. Johnson and L. D. Coffman are the incorporators.

FOR STEALING A BIKE

JOHN McDONALD ARRESTED AND LATER DISCHARGED—THE CASE SETTLED.

John McDonald was placed under arrest yesterday morning, by Constable J. H. Lewis, upon a warrant from Justice of the Peace E. D. Horgan's court charged with the larceny of a bicycle belonging to Ed Coots, the private prosecutor. He was arraigned before Justice Horgan yesterday morning, but later in the day the case was dismissed upon motion of the district attorney, for the reason that the case had been amicably settled between the defendant and the private prosecutor.

Ed Coots, who is employed on one of the Willamette river steamboats, took the bicycle to the establishment of Shipp & Hauser for repairs, on July 8th, but the wheel was taken out of that place, while the proprietors were busily engaged in another part of the store, and taken to one of the local second hand stores where it was pawned for \$3.50. Coots, not wishing to prosecute the defendant, withdrew his charge upon the defendant redeeming the stolen wheel and paying the costs.

PROGRESS ON THE BRIDGE

Contractors Royal Are Making Very Satisfactory Progress

NARROW ESCAPE FROM DEATH OF A LAD WHO PLAYED ABOUT THE PILE DRIVER—PEDESTRIANS CAN PASS IN SAFETY, BUT IT IS NOT A PLAYGROUND.

Work on the west approach to the steel bridge goes merrily on, and the Messrs. Royal, the contractors, think they will have the repairs completed within the contract time, in spite of the fact that they have met with some interruptions. The long pile on the west bank of the river has nearly all been driven, the last of them to go in this morning. The rest of the piles will not take much time, as they are much shorter and easier handled.

The interruptions came in the matter of delivering piling. The material comes from this side of the river, and has to be hauled over the bridge, and in order to let the teams pass, the work of the pile driver has to be stopped, and the ponderous machine moved to one side to let the teams pass. This occasions the loss of two hours each day, and retards the operations considerably, but the crew employed by the contractors makes up for this loss of time by working fast and sure, when they are at work.

The bridge is used by hundreds of pedestrians daily, and there is a source of danger in this, as many of the passers-by are children, and they are frequently careless and in danger of falling through the partially dismantled bridge. The railing on either side of the bridge, at the point where the pile-driver is at work, has been removed, while some of the flooring has been taken up, being temporarily replaced only for the passing of the teams hauling material for the structure. Yesterday morning a lad, aged about 11 years, who was on his way to the city from the flax field on the Polk county side of the river, stopped to see the pile driver at work. He stood near the side of the bridge, where the railing had been removed. His feet rested on a short board the end of which extended over the edge of the bridge about two feet, and when the 3000-pound hammer dropped a distance of 25 feet, driving a pile into the ground, the boy involuntarily stepped aside of the board, and but for the quick work of young Mr. Royal who grasped the boy and drew him to safety, he would have plunged to the river bank, 60 feet below. Had the boy fallen, he would surely have been dashed to death, as the bank of the stream at this point is covered with timbers and logs of all descriptions.

The passing of pedestrians is perfectly proper, but the scene of the operations is not the place for children to play, and if they persist in stopping there while on their way across the bridge, it is feared some serious accident may occur. They can pass in perfect safety, however, if ordinary care is used.

FOR STATE DEPARTMENT

EXAMINATION TO BE HELD FOR MALE CLERKS UNDER CIVIL SERVICE.

(From Saturday's Daily.)

The United States Civil Service Commission announces that on August 12, 1902, an examination will be held for the position of clerk (male), Department of State. The examination will consist of the subjects mentioned below, which will be weighted as follows:

Subjects—Weights.

Spelling (1st grade)..... 5

Arithmetic (1st grade)..... 10

Pennmanship..... 10

Copying from plain copy (1st grade)..... 5

Copying from rough draft (1st grade)..... 5

United States History..... 10

History of American diplomacy..... 10

Constitutional history..... 10

One modern language—French preferred..... 15

Total..... 100

Competitors to attain an average percentage of at least 70 on the last four subjects of the examination will not be given ratings on the remaining subjects. Two days will be required for this examination. The first six subjects will be given on the first day and the remaining subjects on the second day. Age limit, 20 years or over.

From the eligibles resulting from this examination it is expected that certification will be made to the position of clerk (male), Department of State, at a salary of \$900 per annum, and to other similar vacancies as they may occur. This examination is open to all citizens of the United States who comply with the requirements. Competitors will be rated without regard to any consideration in their examination papers, and eligibles will be certified strictly in accordance with the civil service law and rules.

Persons who desire to enter this examination should at once apply either to Miss Zaidie Palmer, the secretary of the local board of examiners, or to the United States Civil Service Commission, Washington, D. C., for application forms 304 and 375, which should be properly executed and filed with the Commission at Washington prior to the hour of closing business on August 2, 1902.

CHINESE ARE ARMING

IT IS BELIEVED THAT A BLOODY FIGHT MAY BREAK OUT AMONG THEM.

Salem is likely to be startled one of these fine days or evenings, with a genuine Chinese battle—a battle of the Tonga. For several weeks conditions have been shaping themselves in this direction, and a bloody battle is possible in the near future. It is all the result of a dispute over a debt, and the debt, if it exists, may be paid with the life-blood of one of the parties to the dispute.

Ten days ago a Chinese farmer brought suit against a local Chinese

merchant for \$1000; the money, it was alleged in the complaint, was loaned to the merchant, and he refused to repay it. The complaint is on file at the court house. Since then Chinatown has discussed the matter in all its hearings, and most of the Salem Chinese side in with the defendant, who denies the debt.

The Salem Chinese are now becoming exasperated over what they consider an attempt to filch \$1000 from the merchant, and they openly assert that the plaintiff and his friends are "bad men," and acting upon this theory, they are arming themselves for the fray which is expected. A number of new revolvers have been purchased in local gun stores by members of the Chinese colony recently, and before the time for the hearing of the case comes, it is believed by those who have given the matter some thought and have observed the actions of the Chinese, there will be a battle royal, and blood may be shed in Chinatown.

A REQUISITION GRANTED

FOR A MAN WHO OBTAINED MONEY BY FALSE PRETENSES—IS IN CALIFORNIA.

Gov. T. T. Geer yesterday issued a requisition for Edgar A. Cooke, wanted in Medford for obtaining money by false pretenses. Cooke is in San Francisco, and the requisition, placed in the hands of the state's agent, H. G. McCarthy, of Medford, will be presented to Governor Geer. Cooke a short time ago appeared in the Jackson County Bank, at Medford, represented that he had money on deposit in the Carlock Banking Company's bank at Fort Jones, California, and he drew a check on that bank for \$100. This was readily paid by the Medford banker, who sent the check to Fort Jones for credit, but it was returned unpaid, Cooke having no money there. The fellow was located and arrested in San Francisco, and will be returned to Jackson county for trial.

FROM GRAND LODGE

MR. AND MRS. FRANK DAVEY RETURNED LAST NIGHT—A SUCCESSFUL SESSION.

His bid was 25 per cent higher than that of the lowest bidder, yet 72 votes were cast in favor of awarding him the contract, notwithstanding, also, that he lives outside of Portland, which is the most favored location for the official organ.
