

THE STRIKING MINeworkers

Committees Will Make Canvass of Large Cities

FOR FINANCIAL ASSISTANCE

Help of the Public Will Be Asked for the Strikers

THE FOREIGN ELEMENT IN THE ORGANIZATION THREATENS TO MARK NON-UNION MEN BY CUTTING OFF THEIR EARS FOR FUTURE RECOGNITION.

SCRANTON, Pa., Aug. 7.—Committees were appointed today by the District Board of the Union Mineworkers, to make house-to-house canvass of the city and suburbs for financial aid for the strikers. It is understood that the same plan will be followed in all the cities and the larger towns in the coal regions.

Charged With Murder.

Shenandoah, Pa., Aug. 7.—The coroner's jury investigating the death of Joseph Beddall who received fatal injuries in the riot last week, concluded its inquiry today and rendered its verdict, holding Joseph Paluwicz, Matthew Pauluska and many "other rioters unknown to the jury," responsible for the killing. The men named in the verdict are now locked up and other arrests will follow.

Cutting Off Ears.

Shenandoah, Pa., Aug. 7.—Rev. Charles Edwards, pastor of the Presbyterian church here, and formerly state president of the Young Men's Bible Society, says today that the young men in his congregation, which is made up principally of mineworkers, have informed him that foreigners have determined to cut off an ear of every man who returns to work so that they will forever be marked as "unfair workmen." The foreigners think this is the easiest method for preventing attempts to break the strike.

Throwing of stones at the troops was reported early this morning. This time the attack was made against the provost guards stationed at the Pennsylvania station near one of the foreign colonies in the southern part of the town.

Company A, Eighth Regiment, under Captain Garver, was on duty there all night and early this morning. The captain said he was greeted by a shower of stones that came from the top of a hill overlooking the railroad station. The captain rushed a detail to houses from which stones were thrown, but before the soldiers had reached the top of the hill the offenders had escaped.

EXPLOSION IN A MINE

A NUMBER OF MEN KILLED IN A DISASTER IN COLORADO—MANY VICTIMS.

PUEBLO, Colo., Aug. 7.—A special to the Chieftain, from Trinidad, says: "A disastrous explosion occurred this evening at No. 3 mine at Bowen, ten miles north of this place, in which thirteen lives are known to have been lost. The exact number of men in the mine at the time of the explosion is not known. The explosion was caused by firedamp. The rescuers reached a part of the men through the slope, but are unable to stay in the mine more than a short time. The known dead are: James Hunter, Tilden Winfield, Mike Cassidy, George Jordan, George Sausy, Thos. Sierra, Frank Groat, Walter Elliot.

The powder house in the mine blew up, and it is this which caused such a great disaster. The general belief is that the entire mine has been ruined.

MISERABLE CONDITIONS

AMONG LABORERS IN EASTERN GALICIA, CAUSED THE PRESENT BIG STRIKE.

VIENNA, Aug. 7.—After a special investigation among the agricultural laborers in Eastern Galicia, the Neue Presse Press draws a gloomy picture of the miserable conditions which led to the existing strike. The average mortality from famine for several years past, according to the paper, aggregated 50,000. Laborers' wages range from 5 to 10 cents a day, and women from 3 to 5 cents a day. The peasants rarely taste bread and exist chiefly on soup, the principal ingredients of which are water and herbs.

A Vienna dispatch on June 30th said that a great strike of agricultural laborers was in progress in Galicia, the

laborers demanding an increase in wages of 5 cents a day for men and 3 cents a day for women to double that amount. A Vienna dispatch on August 5th reported many conflicts between strikers and the military. A dispatch also to the London Daily Express, on August 6th, said that in an encounter between the strikers and the military 13 persons were killed and 118 wounded, and that in another fight 200 persons were killed and wounded.

Advices from Lemburg, Galicia, last night, were to the effect that the strike showed signs of coming to an end, compromises having been reached in several districts and the military authorities having quelled the disturbances in others.

They report that the conferences with the representatives of the Sultan, with reference to the proposed settlement of the Zionists in Palestine, have been without result. Dr. Herzl states that he has hopes of being able to convince the Porte of the beneficial results which would follow the settlement of the Jews in Palestine.

HARRY TRACY'S BODY ON THE WAY TO SALEM

His Captors Are Escorting the Remains of the Dead Convict to this City Under Instructions of Coroner Moore of Davenport.

They Left Last Night, Coming by Way of Seattle, and Will Arrive Here Tonight or Tomorrow Morning—Box in Which Remains Are Is Sealed and Will Not Be Opened Until Arrival Here—Many Requests to See the Remains En Route Refused by the Escort.

DAVENPORT, Wash., Aug. 7.—The remains of Harry Tracy, the outlaw, were taken from this place for Salem, Oregon at 7 o'clock this evening. They were in the possession of C. A. Straub, Dr. A. C. Lanter and M. Smith, three of the five Creston men who winged the bandit, who was forced to commit suicide to escape being captured alive. The party will go direct to Moscow, Wash., on the Great Northern. They will leave there for the West shortly after 9 o'clock. The party will pass through Seattle, thence to Portland and on to Salem.

In less than two hours after it was known here that the party would pass through the Sound and coast cities, the corpses received telegrams that the member be exhibited at the different stations, more especially in Seattle, where the party was asked to remain one full day. Dr. Lanter said:

"We will not stop at any of the stations. We are going under the instructions of Coroner Moore, and he has ordered the coffin sealed. His instructions are that we are not to make any stops, only where it is absolutely necessary."

The corpse was robed in a loose, cheap wrapper and was placed in a plain wooden box which was lined with zinc. The box was sealed. Dr. Moore was ordered to use such a coffin by Governor Geer. The laws of this state say that a coffin, being used under such conditions, must be sealed. The party had to pay all expenses in connection with the shipment of the body. The men paid for the coffin and for embalming the body.

(The remains are expected to reach Seattle this morning, Portland tonight, and probably will be in Salem on tonight's overland train, or at the outside tomorrow at 11 a. m. The remains will not be on exhibition at the morgue, as previously announced, Supt. J. D. Lee having, in response to numerous requests, decided to not exhibit the body of Tracy to the public. The body will be taken direct to the Penitentiary for identification and disposal.)

Verdict of Jury.

DAVENPORT, Wash., Aug. 7.—Tracy's body is on the way to Salem. The inquest was completed this afternoon, and the jury rendered the following verdict:

"We find that the body is that of Harry Tracy, the escaped convict from the Oregon Penitentiary; that said Harry Tracy came to his death by means of a gun shot wound from a pistol held in his own hands, after first having been wounded in the right leg by a party or parties, to this jury unknown; that Harry Tracy, at the time of his death, was fleeing from the officers and posess in pursuit, and that no one is blamable for his death, but that all efforts to effect his capture were praiseworthy and fully in accordance with the laws of Washington."

Davenport Excited.

Davenport, Wash., Aug. 7.—The career and killing of Harry Tracy, the notorious outlaw, are the chief topics of conversation. The body was embalmed and laid out in the morgue of the local undertaking establishment, where it was an object of inspection to a steady stream of people coming from far and near. Several excursions from surrounding towns came today, and this evening several hundred outsiders viewed the body of the man who has won permanent place in the world's criminal annals.

The bullet wound in the forehead, between the eyes, is large and jagged. A portion of the skull having been caved in by the bullet, and the concussion together. Outside of this the face is composed and gives evidence of a much better looking man than Tracy was generally given credit for being. The mustache had grown out to considerable length and the hair, likewise, was quite long and looked well kept. Two bullet wounds in the leg show plainly the cause of the desperado's giving up and committing suicide.

"There is absolutely no doubt as to the man," said Sheriff Gardiner today, "Sheriff Cuddehe and several other men have positively identified him."

There is much talk locally concerning the reward. The general sentiment is that whoever is credited with killing Tracy, young Goldfish, who gave the information concerning his stay at the Eddy ranch, should be rewarded. Something will probably be done for him.

Tracy's Rifle.

Spokane, Aug. 7.—The body of Tracy is being sent back to Salem, Or., for burial at the Penitentiary. Attorney Maurice Smith, of Creston, one of the posse that fought the last battle with Tracy, accompanies the body, representing the Creston men who claim the reward. The famous 36-20 rifle will be sent to the Oregon officials, while Tracy's other guns may be distributed among the Creston posse.

Sheriff Gardiner still holds the horses stolen by the outlaw, while other relics, such as the bandit's cartridges,

a bloody handkerchief and the strap which he bound his wounded leg, are already widely scattered over Eastern Washington.

Where Tracy Rested.

Spokane, Aug. 7.—A night and part of a day in the unromantic town of Wilbur, dressed like any ordinary citizen, the notorious criminal and outlaw Harry Tracy spent this length of time there last Friday and Saturday. While sheriffs, deputies and volunteer hunters from half a dozen counties were scouring the country and blocking every avenue of escape, Tracy was resting unmolested in Wilbur.

This new chapter of Tracy's "Two months of liberty" has just been brought to light and the author of the story is a man named McGregor, who runs a livery stable in the Big Bend town. Yesterday McGregor paid a visit in Davenport for the purpose of seeing the earthly remains of the famous bandit, and he stated last night, after accomplishing the object of his pilgrimage, that the identity of the dead man was the same as that of the Wilbur visitor.

The story of the outlaw's episode, which is the latest to come to light, is much out of the ordinary, and is related by Liveryman McGregor essentially as follows:

On Friday evening the proprietor of the livery stable and his men were at work about the place at their usual tasks, when a stranger, carrying a rifle, riding one horse and leading another which was used as a pack animal, appeared at the barn. He made no ado about himself or his animals, and seemed so ordinary that the Wilbur liveryman thought nothing of the circumstance, and in no way connected him with anything criminal.

The stranger instructed the barnkeeper as to the disposition of his pack and rifle, which he handed over without question, and then saying that he wanted the horse at 4 o'clock next morning, he left the place.

Where he went is a matter of conjecture, and it is not known whether or not he had a bed that night. It has been learned since, however, that he went into one of the restaurants of the place, ordered dinner, ate it with an apparently hearty appetite, and paying his reckoning, departed unmolested. The restaurant-keeper is now firmly of the opinion that the man who visited him was the very criminal, although at the time he had no such idea. It was 10 o'clock next morning before the stranger appeared at the livery barn and asked for his steeds. They were brought out, a settlement was reached, and the rider proceeded to start on his way when an accident put the liveryman on his guard and caused him to inspect the visitor closely.

The pack was placed on the bay horse, and when about to start, the position of it did not suit the liveryman, and he stepped up to straighten it, when the owner turned on him quick as a flash, and with an angry gleam in his eye commanded: "Keep your hands off that; don't touch it again."

This caused the surprised proprietor of the place to look over his man more closely, and for the first time he noticed that on either side of his waist was fastened a big six-shooter. He also took in the details of the man's appearance, so that if he should ever see him again he would know him perfectly.

"I didn't believe in Tracy's being in this country at that time," was the way in which McGregor explained his lack of suspicion, "and therefore did not think of such a thing as entertaining the notorious outlaw." As soon as the news reached Wilbur yesterday morning of the bandit's death, the occurrence came freshly to mind, and McGregor lost no time in getting to Davenport. He saw the corpse and was convinced that he had entertained a lion in sheep's clothing. He states that he cannot be mistaken in regard to the identity of the man.

DEAD CHILD ON TRAIN

LITTLE CORPSE SHIPPED AS BAGGAGE IN BABY BUGGY BY FATHER TO SAVE EXPENSE.

HOQUIAM, Wash., Aug. 7.—When the Northern Pacific passenger train arrived at 9:45 yesterday, the baggage men discovered that he had a baby buggy containing a dead infant aboard. When the train stopped at Aberdeen a tall man with a short, black beard, appeared at the station with a baby buggy with blankets tumbled about in it, and had it placed in the baggage car. He then boarded the train, and as the train pulled out remarked that his wife had got left and that he would get off and drive to Hoquiam. If the conductor would stop. The conductor put on the air and let the man off, and when the train was about half way to Hoquiam the baggage men discovered the dead child in the buggy. The child had all the appearance of having died of diphtheria or strangulation. When

the train arrived at Hoquiam, Coroner Smith was sent for, and upon his arrival it was learned that the child had died two days before in Aberdeen General Hospital. Its parents, Mr. and Mrs. Earl Jester, wishing to have it buried at Hoquiam, had sent it over on the train as baggage to save expense. The father was placed under arrest when the grievous find was made, but was released when the coroner explained matters to the Hoquiam officers.

The child was about 20 months old. It was neatly laid out with coppera on its eyes and placed at the bottom of the buggy with disheveled blankets over it to prevent suspicion.

THE PHILIPPINE QUESTIONS

FEDERATED CATHOLIC SOCIETIES ADOPT RESOLUTIONS OF SYMPATHY WITH FRIARS.

CHICAGO, Ill., Aug. 7.—The temper of the convention of the Federated Catholic Societies relating to the Philippine question was put to the test today. John T. Keating offered a substitute resolution for those brought before the meeting. Keating proposed that the delegates dismiss the friars and Philippine school questions with a mere expression of satisfaction with the manner in which the subject is being handled by the Vatican and the administration.

When the motion was put there was but one affirmative vote. Among the resolutions adopted was the following: "That we extend to the friars in the Philippines our fullest sympathy in this their hour of trial; that we appreciate the value of their services in the cause of religion and humanity; that we pledge them our support as American citizens in upholding the hands of our Government in its determination to see that they are treated with that common justice that belongs to all who enjoy the protection of the American flag."

INDEFINITELY SUSPENDED

Work of Repairing the Bridge Has Been Interrupted

CONTRACTOR ROYAL BLAMES THE CITY AND TWO COUNTIES FOR NOT SUPPLYING MATERIAL—SALEM BUSINESS MEN ARE THE LOSERS.

The work of setting the piling on the west approach of the steel bridge has been suspended for want of material, and the work of repairing the bridge is consequently interrupted for an indefinite time, with the result that the bridge will be closed to travel for a longer period than was at first contemplated. Contractor Royal explains the suspension of work, laying the blame on the city and the two counties interested. He asserts the city of Salem and Polk and Marion counties were to furnish the material as fast as he could use it, but none of it is to be had now beyond what has already been used, and he does not know when it will be secured.

This is a serious condition of affairs. Serious for the contractor who is losing valuable time, and consequently all the profit of the contract, but far more serious to the business men of Salem who are daily losing a large amount of trade as a result of the bridge being closed to travel, the people of the city being the greatest sufferers. There is a busy time coming right now, grain is to begin coming in every day, wood should be hauled, the hop harvest is near, and the State Fair only five weeks away. And with the bridge partially closed a serious condition exists. It is to be hoped the work will soon be resumed and rushed to completion, for the good of the city and the benefit of all classes of business here.

THE TROUBLE SETTLED

LOUISVILLE & NASHVILLE STOCK CAUSED SOME EXCITEMENT ON STOCK EXCHANGE

NEW YORK, Aug. 7.—The unusual strength of the Louisville & Nashville reports gave rise to a variety of rumors on the Stock Exchange today, the substance of which was that the trouble, which grew out of an attempt to corner the stock last spring, had been settled. These rumors were confirmed in part. August Belmont, chairman of the L. & N. road, and Samuel Spencer, president of the Southern Railway, conferred with the representatives of J. P. Morgan & Company, during the day and the return to town of John W. Gates, coupled with his protracted visit to Morgan & Company's office, were regarded as important. The story most persistently circulated was that Morgan & Company have agreed to buy the Harris-Gates holdings, estimated at something like 250,000 shares at \$1.50.

THE WYOMING DEMOCRATS

Make Many Demands in Their Platform

ARBITRATION OF DISPUTES

Arising Between Capital and Labor Are Demanded

MUNICIPAL OWNERSHIP OF PUBLIC UTILITIES, DIVORCEMENT OF STATE INSTITUTIONS FROM PARTISAN CONTROL AND INITIATIVE AND REFERENDUM

CHEYENNE, Wyo., Aug. 7.—The Democratic State Convention nominated Charles P. Clemmons, of Carbon county, for Congress; George T. Beck, of Big Horn county, for Governor, and other state officers.

The platform adopted declares allegiance to the National platform of the past, and demands the election of United States Senators by a direct vote, compulsory arbitration of labor disputes, divorcement of State Institutions from partisan control, municipal ownership of public utilities, and a return to the original Australian ballot. The platform takes a stand against trusts, and demands the creation of a Railroad Commission and the abolition of passes and free transportation to public officials, urges the opening of the Shoshone Indian reservation and advocates the establishment of the Initiative and Referendum.

Tennessee Election.

Nashville, Tenn., Aug. 7.—The returns from every part of the state show the election by large majorities of the Democrats Supreme Judges and of the Court of Appeals Judges. The former are W. K. McAllister, M. McNeil, John K. Shields, and W. D. Meard, and the latter are R. M. Barton, John W. Taylor, and S. H. Wilson.

At 1 o'clock tonight Chairman Frank Thompson, of the State Democratic Committee, announced that the Democratic judicial ticket had carried the state by 30,000 votes.

No Vacancy Exists.

Olympia, Wash., Aug. 7.—The State Supreme Court today handed down its decision in the test case as to the permanent increase of the membership of the court, and as to whether there exists a vacancy in the office of Lieutenant Governor and Governor. The Justices are unanimous in the opinion that no Governor is to be elected this fall, that Governor McBride fills the vacancy until the end of the term.

The Justices are divided on the question of an increase in the membership of the court. Justices Mount, White, Hadley, Fullerton and Dunbar hold that but one judge will be elected in November. Judges Anders and Reavis hold that three additional judges are to be elected.
