

BARTHOLIN IS ACCUSED

Of Murdering His Mother and Is Ordered Arrested

TWO ACCESSORIES HELD

They Are Also Charged With the Death of Minnie Mitchell

SOME IMPORTANT TESTIMONY DEVELOPED AT THE INQUEST HELD OVER THE REMAINS OF MRS. ANNE BARTHOLIN YESTERDAY—A NEW CLEW FOUND.

CHICAGO, Ill., Aug. 21.—The coroners jury, at the inquest over the body of Mrs. Bartholin, brought in a verdict recommending that her son, William Bartholin, be arrested and held as the principal for her murder, and that Oscar Thompson and Edward Counselman, who are under arrest accused of complicity in the murder of Minnie Mitchell be held as accessories.

New Clew Found.

Chicago, Aug. 21.—The second decisive step toward unraveling the tangle of mystery about the Bartholin-Mitchell murder case was begun today by the police, when the proposed inquest to determine the cause of the death of Mrs. Anne Bartholin and the responsibility thereof was renewed. The police hope for more substantial results from this inquest than came from the similar proceedings yesterday in the Minnie Mitchell case. Doubtful identity will be the burden of the defense of Oscar Thompson, John Clafey and Edward Counselman, who were held yesterday to answer for the supposed Mitchell crime.

As yet nothing definite has been heard of the whereabouts of William Bartholin. Much doubt exists, however, as to whether Miss Mitchell is dead.

The early testimony today pertained largely to the finding of the body of Mrs. Bartholin by newspaper men. Reporters who searched the basement of the Calumet avenue house told again the story of the digging up of the body, of calling in Dr. Noel to establish its identity, and in the latter identification by acquaintances of Mrs. Bartholin. Some interest was aroused when the inquiry was temporarily suspended in order that the Mitchell family might produce a witness. The police did not know who the witness would be.

A new clue to the possible solution of the Minnie Mitchell case was found today when it was learned that a man resembling Counselman had called upon Dr. J. L. Wilgus, on August 11th, with a young woman supposed to be Minnie Mitchell. Dr. Wilgus says the man wanted him to take the young woman as a patient, but that he refused. This story, together with that told yesterday that the girl was in a hospital, leads further to the theory that the girl may be alive.

A Body Found.

Chicago, Aug. 21.—This morning the body of a girl was found upon the beach in Rogers Park, the northern limits of the city. It was first supposed to be that of Minnie Mitchell, but the description does not tally with that of the Mitchell girl.

GREEN-GOODS SWINDLERS ROUNDED UP BY THE FEDERAL AUTHORITIES IN NEW YORK—A BIG CATCH.

NEW YORK, Aug. 21.—What is said to be the biggest round-up of green-goods swindlers ever made by the Federal authorities in this city was announced today. Five men and a woman were taken into custody, and an entire green-goods plant was captured. Four of the prisoners, Joseph R. Baker, Elmer Brown, S. Gottlieb and the latter's wife, were arrested in Newark, and George Brown and Thomas Henry were arrested in this city.

According to the Postoffice Inspector Boyle, he has secured as complainant against the prisoners Antonio Capers, a butcher of New Haven, Conn., who paid \$300 in cash to receive green paper in return. Many complaints of green goods victims have reached the Postoffice Department recently, and the alleged "plant" was located in Newark after much work. Yesterday the inspectors saw a man come to the house in the company of Elmer Brown, the alleged "steerer," and followed by Baker, who it is said was the "trailer." The pair entered the house and later came out. The victim carried a miniature trunk about 10 inches long and four inches wide. The "steerer" took the victim to an express office, where the little trunk, which the victim thought contained \$5000 in bills printed from stolen Government plates, was shipped to New Haven. Then the inspectors placed the "steerer" and the "trailer" under arrest.

The victim said he had paid \$300 for the supposed money, and was thunder-struck when the inspectors secured the trunk and showed him that it contained nothing but slips of green paper cut to the size of bills. A few moments after Brown and Baker had been arrested, the "plant" was raided, and the Gottliebs were taken into custody. In the house all manner of green goods paraphernalia was found; circular letters, a dozen or more of the little trunks and piles of green paper. Henry and Brown were arrested last night at the ferry. All the prisoners were arraigned today and held in \$2500 bail each.

SHE KILLED HER INFANT

A Mother's Awful Deed at Wilbur, Washington

BOTH PARENTS ARRESTED

Battle Between Officers and Negroes in Mississippi

FIVE MORE BODIES DISCOVERED IN THE JESSUP & MOORE PAPER COMPANY'S DIGESTING ROOM—ONLY ONE MAN IS MISSING—THE INJURED WILL RECOVER.

SPOKANE, Wash., Aug. 21.—A special from Wilbur, Wash., says, Mrs. Jasper Hyatt has confessed that she killed her baby yesterday, and that the story of the assault by an unknown man was false. The woman says she is subject to peculiar spells and is not accountable for her actions. During one of the spells she killed her baby. The woman and her husband are under arrest.

Official Frauds.

Chicago, Aug. 21.—Fraudulent records in the county treasurer's office, involving large sums, were brought to light today. It is announced, that a forged receipt for \$26,770 taxes, assessed against the Masonic Temple, had been issued. It is stated similar frauds involving other large properties have been committed.

Fight With Negroes.

Tupelo, Miss., Aug. 21.—James Randolph was seriously shot by negroes, and it is reported that three negroes were killed at Shannon, Miss., today. Rogers, Randolph and Barnard were deputized to arrest the negroes for shooting at a white man. The negroes took refuge in a barn and a fight ensued. Everything is reported quiet tonight.

More Bodies Found.

Wilmington, Del., Aug. 21.—Five more bodies were found in the ruins of the Jessup & Moore Paper Company's digesting room today. The bodies found were those of William Ruth, E. H. Mousley, Bernard Sweeney, William Scott and Joseph Henry. Joel Hutton is the only employee now missing. The injured in the hospital will recover.

PALMA OPPOSES A LOAN

HE DOES NOT ENDORSE THE CLAMOR OF THE CUBAN ARMY FOR PAY.

HAVANA, Aug. 21.—It is doubtful if any attempt at present will be made to float the proposed loan of \$35,000,000. President Palma and his Cabinet are strongly opposed to the revolutionary element which has been clamoring for the payment of the Cuban Army, and which saw in this loan the only means to bring this payment about. This element has been somewhat appeased by the movement started today to revise the Cuban Army lists, with the object of taking immediate steps to pay the soldiers as soon as the revision is completed.

General Maximo Gomez, assisted by General Maya Rodriguez, is at present engaged in revising the lists, and it will probably take from six to eight months to complete the task. By the time it is completed it is hoped that the republic's financial affairs will be in better shape and that the government will be able to see its way clear to raise the funds necessary to pay the soldiers.

The Cuban Government has recognized the contract made by the American military Government of Cuba with Monsignor Sbarretti, formerly Bishop of Havana, and settlement of questions of the ownership of church property and the payment of rentals for buildings returned to the church and now occupied by the Cuban Government are at present being made to the satisfaction of the church authorities. The building in question include the Custom House, the university and the Academy of Sciences.

The longshoremen and lightermen of all classes and the dock laborers have gone on a strike. They have several grievances, one being that coal should be unloaded per ton instead of by day wages. Efforts are being made by the union leaders to bring out the laborers at Cienfuegos and Cardenas.

WILL BE A CONSUL

W. F. DOTY LATE STUDENT AT PRINCETON GOES TO SOCIETY ISLANDS.

SAN FRANCISCO, Cal., Aug. 21.—W. F. Doty, lately a theological student at Princeton, sailed today to assume the duties of his new position as United States Consul in the Society Islands, a post to which he was appointed by President Roosevelt. Mr. Doty succeeds his brother, J. L. Doty, who has held the position for 12 years. He was formerly chief page of the United States Senate. He was graduated from Princeton University with honors in 1894, and entered the theological seminary, but ill health forced his retirement, and he went as a missionary and United States educational agent to Alaska. He is specializing in the study of comparative religion, and intends to continue this study in Tahiti.

REPUBLICANS NAME TICKET

Party in Idaho Adopts Strong Anti-Trust Platform

ROOSEVELT IS ENDORSED

The Opening of Agricultural Lands in Forest Reservations

DEMANDED BY THE RESOLUTIONS ADOPTED—TRANS-MISSISSIPPI CONGRESS WILL MEET IN SEATTLE NEXT YEAR—SHARP DEBATE INDULGED IN.

BOISE, Ida., Aug. 21.—The Republican State Convention today nominated for Congressman, Burton L. French, of Latah county; Supreme Judge, J. F. Albahle, Idaho; Governor, John T. Morrison, Canyon; Lieutenant Governor, James M. Stevens, Bingham; Secretary of State, Will H. Gibson, Fremont; Auditor, Theodore Turner, Banhook; Treasurer, H. N. Coffin, Ada; Attorney General, John A. Bagley, Lake; Superintendent of Public Instruction, Miss May L. Scott, Bingham; Inspector of Mines, Robert Bell, Custer.

The platform endorses the Roosevelt administration; favors a revision of the tariff which will put on the free list every article and product controlled by a monopoly; favors an amendment to the Constitution that will enable Congress to effectually regulate and suppress all trusts and injurious combinations of aggregated capital; favors the opening of lands in the forest reservations that are more valuable for agricultural than for other purposes. The railway merger is opposed.

Western Congress.

St. Paul, Minn., Aug. 21.—Seattle was selected as the city for the next session of the Trans-Mississippi Congress in 1903. The feature of today's session was the discussion of the resolution, introduced by William Henry Eustis, of Minneapolis, demanding that the address of F. B. Thurber, of New York, which Eustis' resolution declared was a specious plea in behalf of the so-called beef trust, be eliminated from the records of the Congress.

After much discussion, which at times became rather personal, Eustis withdrew the resolution, declaring its purpose accomplished, as the discussion would be embodied in the minutes of the Congress, and the public would see that a great portion of its members did not favor the so-called trusts.

The committee on resolutions reported tonight, and the report was adopted. The resolutions favor the admission as states of Arizona, Oklahoma and the Indian Territory; a call for the extension of the system of irrigation; endorse the good roads movement, and favor the establishment of a Department of Commerce whose head shall be a member of the President's Cabinet.

MORGAN HAS A FAD

MAY ESTABLISH A FUND TO EDUCATE ENGLISHMEN IN THIS COUNTRY.

NEW YORK, Aug. 21.—Much interest attaches to the arrival on the Oceanic of G. R. Parkin, president of the College of Upper Canada, Toronto, who has been entrusted with the details of organizing a system for the selection of English-speaking young men who are to receive the 200 scholarships of \$1500 a year endowed by Cecil Rhodes. Mr. Parkin also has suggested that it would be a good plan for some wealthy American or group of Americans to establish a fund for the education of 100 young men of Great Britain in the universities of the United States. He had several conferences with J. P. Morgan on the way over, and the financier is said to be much interested not only in the Cecil Rhodes scholarships, but in the plan which Mr. Parkin proposes for reciprocating the offers made under the will of the South African leader.

Mr. Parkin said that his object in coming to this country was to visit seats of learning and to talk with educators and men of affairs. Under the provision of the will of Mr. Rhodes, each state and territory in the United States is to have a scholarship. Mr. Parkin will arrange for competitive examinations or some such means for selecting those who are to receive scholarships.

THE SHORTS SQUEEZED

THE CORN PIT WAS IN A TUMULT IN CHICAGO YESTERDAY.

CHICAGO, Aug. 21.—Shorts in the corn pit were squeezed badly today and raised a tumult that closely resembled the recent scrimmage when John W. Gates and his clique of bulls had July corn cornered. When the Gates crowd was pushing prices skyward, the farmer took a hand in the business by sweeping his bins clean of corn and flooding this market with millions of bushels. As a result the corner collapsed and prices fell headlong until September corn recently sold at 50 cents. From rampant bulls the crowd

turned bears to a man and sold short many bushels.

Now the corn to fill September contracts is not in sight. The bad weather has retarded the maturing of corn crops until there has been talk that crops may not be harvested unhurt by frost. Under such conditions, shorts want to cover their contracts, but holders of the grain are loath to sell.

At the opening of trade today everybody turned bull. English markets were advancing strongly. Cash stuff was leaving this market at a good premium over September options. Stocks of contract corn on hand were rapidly diminishing. There seemed no relief for the shorts other than getting stuff in the pit at the best figure. As a result almost 5 cents were added to the price during the morning. September started 3/4 to 1 1/2 higher than yesterday's closing price, at 53 1/2 to 54, and in leaps and jumps rose to 57 1/2.

Excitement continued through the session. The bull crowd was buying and the shorts had little or nothing offered to help them out in their plight. At top prices some of the longs let go small lots for profits and prices slid off a little. September, however, closed strong and excited, 4 1/2 higher than yesterday, at 57.

Other markets responded to the flurry in corn. Wheat had a good bulge, September opening at 70 1/2 and selling as high as 72, but closing only 5/8 higher, at 71 3/4 to 72. September oats closed 1/16 higher, at 34 1/4 to 34 1/2. September provisions felt the corn strength materially.

Hogs were higher on the prospect of higher fodder prices, and September pork closed 7/8 higher, lard 4/8 up, and ribs 2 1/2 higher.

CAPE COLONY PARLIAMENT

MARTIAL LAW TO BE ABOLISHED—GOVERNOR URGES CONCILIATORY POLICY.

CAPE TOWN, Aug. 21.—On the assembly of the Cape Parliament, Sir Walter F. Hely-Hutchinson, Governor of the Colony, announced in a speech that martial law would be removed on the passage of a bill indemnifying the Governor and all persons concerned for acts committed under martial law.

Bills were introduced in Parliament covering unavoidable infractions of the law arising from the delay in summoning Parliament, condoning illegal expenditures incurred for the suppression of rebellion, prohibiting the immigration of Asiatics other than British subjects, prohibiting the sale of intoxicants to the aborigines and providing for the segregation of the natives. Bills were also introduced for numerous local works, loans, railroads, harbors, irrigation, etc., and the contribution of an additional \$100,000 to the imperial navy. The Governor expressed his belief that the expansion of trade would justify the required increase in revenue, and in conclusion he urged a policy of peace and reconciliation and the discussion of all measures in a spirit of moderation.

THE MERGER LITIGATION

PETER POWER'S ATTORNEY TELLS OF THE SCHEME—W. BURKE COCHRAN.

NEW YORK, Aug. 21.—Lawyer Geo. A. Lamb, attorney for Peter Power, today told all he knew about the North Pacific merger suit. He named the men, who, with Power as plaintiff and Captain Henry Stern as go-between, he said, had hoped to conceal their connection with the litigation and keep their identity hidden. Among those named was W. Bourke Cochran. The story of Power's wanderings came out and the plan to send him to Europe was revealed.

Lamb declared Cochran was one of the persons for whom, Lamb was given to believe, he was acting in pushing the suit and he was one of those who advised Power to stay out of the courts jurisdiction and was ready to supply him with funds to enable him to do so. W. Bourke Cochran tonight characterized all the testimony relating to him as false in every detail.

THE NAVAL MANEUVERS

MOVEMENTS OF TWO FLEETS OFF NEW ENGLAND'S COAST ARE UNIMPORTANT.

ROCKPORT, Mass., Aug. 21.—Up to midnight, the movements of the ships of Admiral Higginson's fleet "defending" the New-England coast against the fleet of the "enemy" under Commander Pillsbury were not important. A few scout ships came in, but reported nothing important. Pillsbury's squadron has not yet put in an appearance.

THE WATER CURE AGAIN

PAPERS IN CAPTAIN RYAN'S CASE RECEIVED IN WASHINGTON—AN ACQUITTAL SURMISED

WASHINGTON, Aug. 21.—The papers in the case of Captain James R. Ryan, Fifteenth Cavalry, tried by court martial on charges of administering the "water cure" to natives in the Philippines, have been received at the War Department. It is understood the court martial acquitted him.

DYING OF CHOLERA.

WASHINGTON, Aug. 21.—Between June 25th and July 18th, seventy-two deaths occurred among the enlisted men of the division of the Philippines. Of the total number of deaths, thirty-five were due to Asiatic cholera. The War Department has received this cable from General Chaffee at Manila, together with a list of those soldiers who had died. In addition to the thirty-five who died of cholera, seventeen died of dysentery, six of malarial fever and the remainder of various other diseases. Of those who died of cholera, nine were Philippine scouts and natives.

Whipple, of East Groton, Conn., said that the United States army was a disgrace to humanity. He said the President of the United States, who should be a man of God, is teaching his children the use of broadswords.

End of Strike.

Denver, Colo., Aug. 21.—A special to the Republican, from Cheyenne, Wyoming, says: It is reported here that the Union Pacific strike will probably be settled in a week or ten days.

Box-Makers Strike.

San Francisco, Cal., Aug. 21.—About four hundred box-makers went out today and the plants of all the packing box mills are shut down. The box-makers receive \$2 per day, and the sawyers \$2.50. The new schedule demand \$2.25 and \$2.75, respectively.
