President Roosevelt Does the Honors Doubly

MET BY THE STUDENT BODY

Upon Occasion of Dedication of New Central High School

CHEERED FROM 20,000 LUSTY THROATS—RESPONDED TO A TOAST DURING FOUNDERS' DAY BANQUET—BACK TO WASHINGTON—KING ENDORSED.

PHILADELPHIA, Pa., Nov. 22.—President Roosevelt, accompanied by several members of the Cabinet, spent today in the city.

During the afternoon the President was the chief speaker of the exercises incident to the dedication of the new Central High School for boys.

The President, tonight, responded to a toast during the Founders' Day banquet at the Union League Club. Upon the President's arrival at the Central High School he was met by the entire student body, each pupil bearing a flag, after which the President entered the hall, amid the plaudits of 20,000 persons.

For fully five minutes he stood facing the cheering assemblage before he could proceed with his speech.

At the conclusion of the banquet tonight, the Presidential party boarded a special train and departed for Washington.

No Women Clerks.

Tacoma, Wash., Nov. 22.—At a meeting of the Republican Senators here today, Senator J. J. Smith, of King county, was unanimously endorsed for President of the Senate, and Senator T. B. Sumner, of Everett, for President pro tem.

Sixteen Senators were present and seven were represented by proxy. The conference was secret, but it is declared that the Senatorial or Railroad Commission was not broached in any manner.

The only other business transacted was an agreement that no women should be given clerkships or employed in the Senate.

FEARED RUSSIAN SINGER

AN AMERICAN ARTIST, WHOSE DEATH IS A MYSTERY, WROTE OF HIM.

SAN FRANCISCO, Nov. 22.—Mrs. Colonel P. T. Dickinson, of Alameda, aunt of Mrs. Nellie Gore, who met with a tragic death in Paris, on Wednesday, has received a dispatch from Attorney Prevost informing her that her niece had left all her property to her in a will executed last December, and in which the attorney is named as executor. He stated that he had cabled to Paris to have the body placed in a receiving vault until further instructions were received.

Mrs. Gore wrote to her aunt twice a week, always an affectionate weaving of details and confidences. Through all the keynotes was her ambition to perfect herself in her art. In one of her letters, referring to De Rydzewski, she said:

"He wanted to come to live in the same pension with me. I wrote him if he did it would be against my wishes, and if he comes (I have an idea that he thinks that a woman's wishes are of no account), he will put me to the trouble of moving out."

Other letters plainly show that she was afraid of the Russian singer.

Funeral Monday.

Paris, Nov. 22.—Consul General Gowdy has received a cablegram from Attorney Butler, of Mexico City, in regard to the disposition of the body of Mrs. Gore, whose death by shooting occurred Wednesday. Mr. Butler telegraphed:

"Give the most kindly burial to Mrs. Gore."

Mr. Gowdy has accordingly arranged for the funeral to take place Monday afternoon. Many artists have expressed their attention of attending. The remains will be buried in the cemetery of Boulogne.

At Mr. Gowdy's written request, the morgue authorities held the body and stopped its burial in the potter's field yesterday evening.

Ellen Gore's Former Husband.

Victoria, B. C., Nov. 22.—Thomas Gore, whose divorced wife was killed in Paris, has been residing in this city and left Thursday night for San Francisco, where he was married less than nine years ago. Mrs. Gore visited Victoria often with her husband, her last visit here being about three years ago, when she stayed with her husband's family. During the husband's stay in this city he has been a valued member of the musical societies. It is rumored here that he intends to join an operatic organization.

TELEGRAPHERS TO STRIKE

OREGON SHORT LINE EMPLOYEES THINK THEY DESERVE MORE SALARY.

ONTARIO, Nov. 22.—There is a strike just now in the ranks of the Order of Railway Telegraphers on the Oregon Short Line. They are asking for an increase in wages amounting to about 5 per cent. The local men are in on the subject, but it has leaked out along the line that Superintendent Calvin is not inclined to recognize the order. A prominent railroad man said here that the road was well organized, including outside agents and operators, who had been dismissed from the service in times past. It is thought that the company figures on using a large number of these ex-agents and ex-operators in the event of anything serious.

IN PROBATE COURT

THE WILL OF MRS. WHITLOCK IS FILED AND ADMITTED—A GUARDIAN APPOINTED.

The last will and testament of the late Mrs. Annie R. Whitlock, who died in this county on November 9, 1931, has been filed for probate in the county court. The document disposes of real and personal property valued at \$2,000. It provides that H. Hayre, father of decedent, shall have the full and free use of the estate during his natural life, when it shall become the property of the testator's brother, Henry B. Hayre. Col. W. W. Hunt is appointed executor of the last will. In petition of Henry B. Hayre, County Judge John H. Scott appointed Mr. Hunt as executor, fixing his official bond at \$4,000.

George O. Savage, father of the late John W. Savage, whose demise occurred on Friday, November 7th, yesterday petitioned the probate court that letters of guardianship be issued to him for his daughter, Stella Savage, aged 10 years, who is the beneficiary of her late brother under his beneficiary certificates in the Ancient Order United Workmen and the Modern Woodmen of America. He held a policy in the first named order for \$1,000, and in the other for \$2,000, both in favor of his sister. Judge Scott appointed the petitioner as guardian of his daughter.

OUTLAW IS HANGED

AUGUSTIN CHACON SAID TO HAVE KILLED A SCORE OF PEOPLE.

SOLOMONVILLE, ARIZ., Nov. 21.—Augustin Chacon was hanged here today. Chacon was one of the most desperate outlaws whose criminal deeds have been recorded in the annals of Arizona.

It is believed he had killed at least a score of persons. The crime for which he was executed today was the murder of Paul Becker on Christmas eve, 1899.

WHEAT IN SAN FRANCISCO HAS REACHED HIGHEST POINT IN YEARS.

SAN FRANCISCO, Cal., Nov. 21.—Both May and December wheat on the local board today reached \$1.40, the highest quotation in four years.

The present condition of the wheat market on this Coast is strongly bullish. Cash wheat is exceedingly scarce and farmers are holding stocks.

BROKE UP IN A ROW

OKLAHOMA PRIZE FIGHT WINDS UP IN FREE-FOR-ALL SHOOT.

GUTHRIE, O. T., Nov. 21.—Trouble arose at a prize fight at Oklahoma City tonight and twenty-five shots were fired. Goldie Wilson fell dead; his brother is fatally injured, and two unknown men were shot, one through the shoulder and the other through the leg.

LOGAN FOUND GUILTY

MONTANA TRAIN ROBBER RECEIVES TEN COUNTS OUT OF NINETEEN.

KNOXVILLE, Tenn., Nov. 21.—Harvey Logan, alias John Curry, the Montana train robber and safe blow, was found guilty on ten counts out of a nineteen-count indictment in the Federal Court this afternoon.

TROUBLED WITH DEFICITS

THE IMPERIAL GERMAN GOVERNMENT FINDS ITSELF SHORT OF FUNDS.

BERLIN, Nov. 21.—In the Reichstag today Secretary of the Treasury Von Thielmann announced that the deficit in the Imperial budget for 1932 was estimated at \$35,500,000 and the deficit for 1933 was \$14,750,000. It would not do, as the Secretary said, to be always providing for deficits by loans, nor could the contributions of the Federal states be increased. What ought to be done was to increase the Imperial revenues so as to balance the expenditures.

THE TREATY SIGNED

ALL IS NOW PEACE AND QUIET IN ONCE TURBULENT COLOMBIA.

PANAMA, Colombia, Nov. 21.—Consul Guder landed from the battleship Wisconsin at 4 o'clock, bringing the news that the treaty of peace had been signed this afternoon by revolutionary General Herrera and the Government Commissioner.

Are Well Pleased.

Washington, Nov. 21.—Although they have not received official confirmation of the report, the officials of the Colombian Legation express great satisfaction over the news that the treaty of peace has been signed with General Herrera. They feel that this will terminate the war.

SON SHOT A MAN

UNITED STATES MINISTER'S SON OF GUATEMALA IN SERIOUS TROUBLE.

WASHINGTON, Nov. 21.—The State Department has been informed that the son of the United States Minister at Guatemala City, today shot and killed William Fitzgerald, of Grand Rapids, Mich. Hunter, who had been in the legation, and has taken refuge in the legation, and an interesting question has arisen as to his exemption from arrest.

MURDER IN COLD BLOOD

Consul General McNally Seizes Charges

THE STATE DEPARTMENT

Receives Report from Guatemalan Minister Hunter and Consul

GODFREY HUNTER, JR., CHARGED WITH THE CRIME AND SECRETARY BAILEY A PARTY TO IT—FLATLY DENIED BY MINISTER HUNTER.

WASHINGTON, Nov. 22.—The State Department today received reports from Minister Hunter, at Guatemala City, and Consul General McNally, at the same place, regarding the case of Godfrey Hunter, Jr., and Secretary Bailey, of the American Legation there, who were parties to the shooting affray resulting in the death of William Fitzgerald yesterday.

McNally's latest advice gives the aspect of a shocking and cold blooded murder, making it appear that Secretary Bailey was a party to the crime, holding up Fitzgerald with a revolver in front, while Hunter shot the man from behind.

Minister Hunter's statement is a flat contradiction of this report. He says his son, Godfrey, and Secretary Bailey, while sitting on a bench in the public park were attacked by Fitzgerald, who struck young Hunter and snapped a pistol which failed to explode. Hunter thereupon shot and killed him. The existence of a conspiracy between the members of the American colony, including Consul General McNally, is charged by Dr. Hunter.

It is known here that a bitter personal feud has existed for several years between Dr. Hunter and McNally. The State Department will wait to hear from the Guatemalan Government before taking action in the matter.

RECEIVED PAINFUL WOUND

FOREMAN AT SASH AND DOOR FACTORY SUFFERS AN ACCIDENT.

John S. Pennebaker, foreman in the Brown & Lehman Sash and Door Factory, is "carrying his face in a sling" now, for a few days, the result of an accident received while at work a few days ago in the shop. He was employed as usual at his work, when a small, sharp piece of board came flying through the air, which had been thrown from the rapidly revolving circular saw, being operated by two of the workmen, striking him in the left cheek, lacerating it quite severely. He laid off for a few hours to have it dressed, then resumed his work. The wound is still very painful and the cheek badly swollen, but no dangerous results are apprehended.

TAKES ANOTHER JUMP

SAN FRANCISCO WHEAT MARKET SHOWS SOME EXCITING FEATURES OF LATE.

SAN FRANCISCO, Cal., Nov. 22.—Wheat today scored the highest quotation since 1898. After wild scrambling among the panic stricken shorts to cover contracts, December closed at \$1.40. Another sensational advance was scored on the curb after the regular market closed. May rose to \$1.41 and December reached \$1.41. This forenoon the local millers advanced prices of flour 20 cents per barrel all around, as a result of the further rise in wheat.

FULLER IS DEAD

BODY OF MISSING PORTLAND MAN FOUND IN THE BRUSH.

PORTLAND, Or., Nov. 22.—The body of J. W. Fuller, the business man, who disappeared from his residence here a month ago, was found today in the underbrush on the canyon road near this city with a bullet hole in the head and a revolver by his side. Fuller had been in ill health for some time, and it was thought, had wandered away and perished from exposure. The theory of suicide had not been considered by his friends.

YALE THE CHAMPION

WIN A GLORIOUS VICTORY OVER THE HARVARD UNIVERSITY TEAM.

NEW HAVEN, Conn., Nov. 22.—Yale University established her supremacy on the football field today by defeating Harvard in the annual game in unimpeachable style. When time was called in the darkness of the early evening, the score stood 23 to 6, and Yale's shouting throngs overwhelmed their victorious heroes.

Nearly 30,000 spectators witnessed the great game, under weather conditions that could not have been improved from the standpoint of the on-lookers.

A BROTHER IN PORTLAND.

SACRAMENTO, Cal., Nov. 22.—Otto Kline, aged about 35, was run over by the Oregon Express in the depot here at 12:15 this morning, and his left leg was cut off. He probably will die. He said he had a brother in Portland, but did not give his name.

FRONT OF MASONIC TEMPLE

While Carrier Was in Building Robber Jumped Into the Rig

AND DROVE OFF—RIFLED SACKS AND HORSE AND RIG FOUND—CHASING IOWA TRAIN ROBBERS WITH BLOODHOUNDS—BIG WISCONSIN FIRE.

CHICAGO, Nov. 22.—The Chicago postoffice was robbed of probably \$10,000 today in a daring manner.

Two registered mail sacks containing money were left in an unprotected wagon in front of the Masonic Temple while the mail carrier went into the building. When he returned the horse and wagon had disappeared.

The robber had evidently been waiting his opportunity, jumped into the rig and drove away. The rifled sacks and horse and rig were afterwards found.

On the Scent.

Davenport, Ia., Nov. 22.—The officers in charge of the bloodhounds reported tonight that they had succeeded in picking up a trail and were following the supposed trail of the five Rock Island train robbers.

The hounds took the scent near the scene of the robbery and were working north at the last report. It is denied that a large amount of money was put on board the train at Davenport.

Fatal Wisconsin Fire.

Ashland, Wis., Nov. 22.—The Wisconsin Central Ore dock was destroyed by fire this afternoon, the loss being about \$225,000. In falling, the dock carried with it a number of firemen and dockmen, and a number of lives were lost, just how many will probably not be known for several days. A number of injured firemen were rescued from the ruins. The known dead are:

One Anderson, foreman.
William Linden, driver his heart.
Seriously injured: Andy O'Toole, a fireman, Charles Works, fireman; and Vivian Youngs.

Butte, Mont., Nov. 22.—A special to the Miner from Fort Benton, Mont., says: R. L. Conaster, ex-sheriff of Valley county, was drowned yesterday, near Glasgow.

A MAN IS A MAN

LORD CURZON ADOPTS HARSH MEASURES TO FIND NEGRO'S ASSAILANTS.

NEW YORK, Nov. 22.—Consideration of the case of the Ninth Lancers has occupied almost an entire sitting of the House of Commons, says a Tribune dispatch from London. The affair has been for days past the sole topic in military clubs. A native club was found near the lines of the Lancers in Slankot, India, during from injuries received from unknown assailants, whom the victim declared to be men of the regiment. Inquiries failed to detect the guilty persons. Lord Curzon was appealed to with the result that the regiment, which is one of the crack corps of the British Army, was publicly branded for having concealed criminals, and all leave of officers and men was stopped.

Lord George Hamilton had a difficult task in justifying the action of the Indian Viceroy, but he arose to the demands of the occasion, and when he sat down the sympathy of the House was almost entirely with the Government. Lord Curzon, he pointed out, had from the time he took office in India, exercised the whole of his power and influence in impressing upon his countrymen that it was their duty to do the utmost promptitude, and with just as sincere a desire to bring home injustice to culprits as if a white man had been assaulted.

WAS BURIED ALIVE

VICTIM OF LIFE INSURANCE SWINDLERS MEETS HORRIBLE FATE.

EL PASO, Texas, Nov. 22.—Upon exhuming the body of Mitchell, who died mysteriously at Chihuahua, Mexico, after being insured by men here, charged with defrauding a life insurance company, it is alleged to have been found that the man was buried alive as evidenced by the indications of a struggle in the coffin, the mouth being open, arms against the lid and the palms turned upward.

A BOY DROWNED

FELL INTO STREAM AND FRANTIC MOTHER PLUNGED AFTER HIM.

YANCOUVER, B. C., Nov. 22.—At Shoal Bay, yesterday afternoon, 9-year-old William Graham fell into the water from a log boom. His mother plunged into the stream and brought him ashore, but all efforts to resuscitate him were unavailing.

TRAITOR IN CAMP.

SEATTLE, Nov. 22.—A union member sold Charles Frye each day an account of the proceedings of the special strike committee during the late strike

and boycott against the Frye-Bruhn Company, and the hottest kind of treatment will be meted out to the individual if his identity can be learned.

The startling bit of information was not tipped off to the labor leaders until the strike had been settled. Then a retailer who had been keeping in touch with the opposition came to the committeemen and told them that President Frye, of the Company, had been furnished each morning with a copy of the proceedings of the meeting the previous evening.

A searching investigation is to be instituted and the penalty will be extreme if the traitor is located.

FOUND \$20,000—GOT \$1.50

WORKINGMAN PICKS UP HEAVY BOX OF GOLD DUST, IS REWARDED.

SEATTLE, Nov. 22.—How would you like to find a box of gold dust worth \$20,000 lying on the street, return said box to its owner, and for your trouble receive the munificent sum of \$1.50? That is what happened in Seattle this week.

Some time ago a shipment of gold dust was received from the North on one of the steamers, and was ordered taken to the United States Assay Office, on Ninth and Cherry streets. The Seattle Transfer Company undertook the job, and, somehow, in the delivery of the precious metal, the driver lost one box of the precious dust. An advertisement was inserted in the papers, saying that a reward would be paid for the return of the gold dust.

A poor workingman found the box, which he had it carried to the office of the transfer company. In his imagination there floated visions of the huge chunk of dust the owner would give him when he restored to him the box. The owner was notified, rushed breathlessly into the office, identified the box, opened it, found the dust all there, rammed his hand deep into the post-pocket, and gave the finder \$1.50. Shocked beyond description at the "big" reward, the poor workingman staggered out of the office, murmuring: "Thank you."

NO NEW JOKE HERE

A SEATTLE MAN'S SURPRISE AND HOW HE EXPRESSED IT.

A prominent Seattle business man coming down State street yesterday on the electric car, upon seeing the new Government building, asked what it was. Upon being told it was the post office building, his face assumed an expression of amazement and he said: "Well, it's a mystery to me how you Oregonians could secure a Government appropriation for a fine building like that in a city of 10,000 inhabitants, while Seattle, with twelve times the population of Salem, has its postoffice in a building that would be a disgrace to a country town."

He was told that Salem people were rustlers, and whenever any good things were being passed around, they tried to get their share. "That's so," he said, pointing to the magnificent structure. "That building is a standing illustration of the everlasting insatiable appetite of the so-called Salem hog." And he grinned as if he thought he had sprung a new joke.

FOUND A BIG DIAMOND.

NEW YORK, Nov. 22.—City detectives have arrested Mrs. Kate McCloskey in a West Side pawn shop, where they assert she was negotiating a loan on a diamond ring worth more than \$1,000. The prisoner said she had been employed at a Madison Square Garden in sweeping the carpets on the floors of the boxes. There, in a box occupied by members of the Vanderbilt family, the ring was found. She had watched the newspapers for some time to its owner, but none appeared. Her husband, a longshoreman, was unemployed, and in order to procure food for their six children she attempted to pawn the jewel.

No report of the loss had been received by the police nor the Horse Show management.

TO SAVE VANCE'S NECK.

TACOMA, Nov. 21.—An attempt is to be made to have the death sentence against A. F. Vance commuted to life imprisonment. His attorneys, John Lee, J. L. McMurray and Samuel McAdams, have served upon the prosecuting attorney notice that the petition will be presented December 1st. Vance will state that just prior to the shooting he was in a state bordering on insanity, having just passed through a distressing scene with his wife, Streas, laid upon the fact that Franklin, Vance's victim, and Vance, had been friends for twenty years, and there was no malice in Vance's mind against him. A number of names that are expected to bear weight with the Governor are to be attached to the petition.

DIRTY CHILDREN NOT WANTED.

BAKER CITY, Nov. 22.—At a meeting of the board of directors, of school district 5, held in this city today, a resolution was passed giving the city superintendent power to dismiss uncleanly students. The resolution is appended.

"Resolved, That the city superintendent is hereby vested with authority to suspend from school any child whose bodily condition, without sufficient cause, is injurious to the health, sanitary conditions or best interests of the school, and it shall be his duty to report such suspension, and the reason therefor, to the board for final action." The reason for such a law has not been made public.

CLARK PROVES ALIBI.

TRINIDAD, Col., Nov. 22.—Alexander Clark, who was arrested on suspicion of having been concerned in the attempted robbery of a Colorado & Southern passenger train last Tuesday night, has been released. He proved that he was working in a Gray creek coal mine at the time of the hold-up.

CHAFFEE AT HIS NEW POST.

NEW YORK, Nov. 22.—Major-General A. R. Chaffee has arrived at Governor's Island, New York, from which post he is to command the Department of the East. A salute of 15 guns was fired in honor of the new commander, who probably will remain at his post until his retirement from the Army.

COMMISSION IS ADJOURNED

Will Meet Again on December Third

AN AMICABLE ADJUSTMENT

Anticipated by the Lawyers for Parties to the Controversy.

SECRETARY ROOT HAS SUCCEEDED IN EFFECTING REDUCTION OF EXPENSES—KING COUNTY BAR ASSOCIATION WANTS TO EXCLUDE OREGON.

SEATTLE, Wash., Nov. 22.—The King County Bar Association today endorsed a number of changes in the Turner Bill providing for the increase of a number of the United States Circuit Court Districts. One amendment contemplates making a new division of the present Ninth District, which would put Oregon in the "south half," instead of including it with Washington, Idaho and Montana in the proposed Fifteenth District.

Another amendment would enable the court to hold its sessions here, as well as in Idaho and Montana cities.

A Large Decrease.

Washington, Nov. 22.—Secretary Root has succeeded in effecting a marked reduction in the amount of money received for the support of the Army and War Department.

Excluding the river and harbor appropriations, the Secretary said the estimates for the next year show a net decrease of \$31,420,000 compared with the estimates submitted for the current fiscal year. The estimates for the military establishment show a net reduction of \$21,862,921 from the estimates for 1933.

Scanton, Pa., Nov. 22.—The anthracite coal strike commission adjourned today to meet December 3, and it is the hope and expectation of all parties to the controversy that when the arbitrators again meet an agreement of the points in dispute will be ready for submission for the approval of the commission. The attorneys on both sides express the opinion that an amicable adjustment will be reached.

INJURED IN FOOTBALL

RODERICK NASH, OF CORVALLIS TEAM, SUFFERING FROM SPRAINED ANKLE.

Roderick Nash, one of the players in the football game yesterday, met with a serious accident, which will lay him up for the remainder of the season, so far as playing football is concerned. The accident happened at the beginning of the second half of the game. Nash was making a run and stepped in a hole or depression in the ground in such manner as to turn his foot, throwing him to the ground. He complained that his ankle was injured, and upon arising was unable to stand. His comrades quickly summoned medical assistance.

He was seen at the hotel last night where he was being waited upon by Dr. A. E. Tammis. The ankle was badly swollen and the doctor said it was impossible to tell the extent of the injury under the circumstances, but he did not think the bones were broken, though it was possible there might have been a slight fracture. The young man seemed cheerful and had no complaint to make over his misfortune, though it may make him a cripple for life.

A CHINESE HOSPITAL.

NEW YORK, Nov. 22.—Steps are being taken in this city for the establishment of a Chinese hospital, which it is believed will be the first regular institution in this country. Many of the Celestials residing in the Pell street section, known as Chinatown, are said to have lost their jobs at the closing of the tom-toms as cure-all, and propose to establish a hospital, the staff of which shall be entirely Chinese who have completed their studies in this country.
