
#### To Change Age Limit.

# HENRY NICOLAUS CLEARED

JURY RETURNED VERDICT OF NOT GUILTY UPON THE COURT'S INSTRUCTIONS.

ST. LOUIS, Mo., Dec. 3 .- Henry, Nicolaus, the millionaire brewer and director in the Suburban Street Railway Company, who was on trial today on the charge of bribery in connection with the passage of the Suburban bill night under instructions from Judge Ryan, who sustained the defense's demurrer to the state case, and ordered a verdict of not guilty returned.


