IN A NEW PLACE.

Trouble for David B. Hill has broken out in a new place. In his time Hill had plenty of trouble. His ambition has been to run the Empire State's Democratic machine, but he never got a real good grip on it, and he has always quarreled with other Democratic leaders in the state. He is very much of a peanut politician.

In anticipation of going to the front in next year's politics, Mr. Hill has been rousing up the rural forces—there is nothing in sight for him in the city of New York. He was engaged in this work recently when, at Albany, in his own county, he ran up against the forces which are trying to organize the New York Democracy for William R. Hearst.

It was quite a surprise to Hill. The Hearst agents declare that they are going to get control of the state convention of New York Democrats next year and get a resolution urging the national convention to nominate Hearst for President. Their proposition is that with the combined vote of other political organizations and the Democracy, Mr. Hearst can carry New York.

Here is trouble for Hill on which he has not reckoned. It will bother him. It is a new Richmond in the field and one who can seriously interfere with him. Many long years David B. Hill has been craving the Presidential nomination. His trouble is that he has never been able to find a considerable number of people who share his own belief that he is a good man for that candidacy or for anything else in the way of political honors worth having.

THE BLOODHOUND AS A WITNESS.

The Supreme Court of Nebraska has a case before it in which the chief point at issue is the weight that should be given to the evidence of a bloodhound in the trial of a man accused of burglary. On his trial there was little evidence against the defendant other than the fact that the bloodhounds had gone from the point where the burglary was committed to his home. With the evidence of the dogs as the strongest feature of the case, the fellow was convicted and sent to prison. From that conviction he now appeals. The Supreme Court's decision will have any specific bearing on the credibility of bloodhounds as witnesses, for in few courts is their unsupported testimony given great weight, but a reversal of the conviction in this case will be a warning to officers of the law generally that the hound's evidence must be strongly corroborated.

HISTORICAL ACCURACY.

The Chicago centennial celebration has been made the occasion of a new and authorized version of the Chicago fire. The tradition that has been generally accepted is that on the evening of October 9, 1871, a family named Chamberlain was rejoicing over the advent of a son. The Chamberlains lived in the same house with Mrs. O'Leary. When they found the supply of milk insufficient for the punch in which they were preparing to drink the health of the son, one of the Chamberlains said he would go out and milk Mrs. O'Leary's cow. He entered the stable in the rear of the house, carrying a kerosene lamp. As he seated himself beside the cow, the animal kicked the lamp, set the straw on fire and started the famous conflagration.

Now comes Mrs. Mary Callahan and tells what she claims is the truth, the whole truth, and nothing but the truth about the cow, the lamp and the catastrophe. Mrs. Callahan, who is now a grandmother, was still a young woman at the time. She and a party of young people had gathered on that Sunday evening at the home of Pat McLaughlin, which stood on the same lot where Mrs. O'Leary lived in a cottage at the rear. About 8 o'clock Mrs. McLaughlin got tea for the party, and when it was discovered there was no milk, Denny Connors, just from Ireland, proposed that Mrs. O'Leary's cow be milked. Mrs. O'Leary and her family had retired. So the party quietly went to the shed back of the cottage.

Denny Connors and the present Mrs. Callahan went to the shed where the cow was stabled. Mrs. Callahan carried the lamp, which was set on a milking stool. Connors knelt down on the left side of the cow and awkwardly began to milk her. Whether the cow kicked over the lamp or Connors fell over it, Mrs. Callahan cannot tell. At any rate, it was knocked over and started the fire. Denny Connors, thoroughly frightened, left Chicago and soon afterward returned to Ireland, where he died three years ago. Some of the others in the secret also left the city hurriedly.

This version places Mrs. O'Leary's cow in a more favorable light. She did not kick out from pure viciousness, or even in a spirit of protest at being disturbed at what was an unseemly hour for milking, but because she was being milked by an awkward and inexperienced hand. After thirty-two years of obloquy the cow has been vindicated.

DEVERY, THE GYNIC.

Although he may be losing his grip politically, Bill Devery is not losing his quaint, picturesque and often really humorous way of putting things. Some of the New York papers have accused Devery of being worked-out, but from some observations he made in a speech the other night it appears that "he has been merely resting his mind, as other great thinkers are obliged to do from time to time." Here is Devery's opinion of George B. McClellan, who is making the race for the mayoralty against Seth Low. "McClellan's gettin' gay, but he won't hurt anybody. George won't break the scales. If you should take McClellan to the top of

the Platon building and hitch him to the loose end of a spool of fine cotton thread he'd drop all the way to the curb without pulling the kinks out of the thread."

Speaking of another prominent New York politician who is not numbered among his friends, Mr. Devery observed: "I've been thinkin' over the old days, when they used horses on the cars, and it reminded me that Sport Murphy, that is just now wearin' around a counterfeit red badge of courage, used to be a conductor on a Second avenue horse car. My memory is all right, pard; an' at all comes back to me like a bill for coal that this great Murphy quit his job on the horse car the very day the conductors were handed bell punches." Thus Devery passes his compliments right and left to his contemporaries, and adds a spice to the New York campaign that is reliable.

MANCHURIA CONDITIONS.

In his report as consul at Niuchwang, Manchuria, China, Hon. H. B. Miller, under date of July 28, 1903, says: "Manchuria is a rich and undeveloped country and is capable of sustaining many millions more people than now occupy it. Under the Chinese Government it was growing fast in population and in trade. Its growth of exports and imports were far in excess of any other part of China, and in no part was American trade improving so fast. All of this growth was a result of expansion in agriculture alone. Manchuria has great opportunity for further expansion in agricultural lines, and under Russian occupation there should be a splendid market here for plows and various kinds of agricultural implements. If the iron, coal, copper, silver and gold mines of Manchuria are developed, it ought to become a good field for American capital, machinery and skill in mining. For the present the market ought to increase for beer, wines, tinned meats, vegetables, milk, fruits, etc. Harbin, Liaoyang, Dainy and Port Arthur are increasing in Russian population and should be good markets in all of these lines. I am informed that bids were received at Port Arthur by the Russian authorities a few days ago for the construction of electric light plants and electric railways for Moukden, Niuchwang and Harbin."

The State Board of Health should be asked to say, officially, in as public a way as they have recommended it, that the Salem water supply is FILTERED, and has been for some years. They recommend that it be filtered. The recommendation was adopted long before it was made. It would be the part of honesty for the Secretary of the Board to say so. That is all that is necessary. And there should be no delay about it. The recommendation of the Board concerning the wells of Salem that receive surface drainage, to-wit, that they be closed up, is a good one. Salem ought to want, and does want, to avoid every danger to the public health.

GOVERNOR PEABODY REFUSES TO REMOVE THE MILITIA FROM FIELD.

DENVER, Oct. 3.—Three thousand business men and citizens of Victor sent a petition to Governor Peabody for the recall of the troops. The Governor refused, saying to the bearer: "The militia will stay in the strike region until I am satisfied it is not needed." Governor Peabody today instructed Generals Bell and Chase, his representatives in the field, not to accept service on any process, civil or criminal.
