W. Schuman, the man picked up at the Southern Pacific passenger depot Thursday afternoon by Officer Lewis, was taken before County Judge Scott and examined as to his mental condition. The examination was made by Dr. P. E. Smith, upon whose affidavit Schuman was discharged, nothing being found to indicate that his mind was affected. The man's actions at the depot Thursday created suspicion that he was slightly deranged and as a matter of precaution he was taken into custody by the police.

Overrules Plaintiff's Motion

City Recorder Moores, as ex-officio justice of the peace, yesterday overruled the motion of the plaintiff for judgment on the pleadings in the case of Bernard Lyman vs. A. C. Hopf, Jr. The case is an action filed by Lyman to recover an amount which he alleges is due him upon a contract entered into with Hopf by which the latter agreed to employ him as waiter in Strong's restaurant of which Hopf is proprietor, during the session of the Legislature. The complaint states Lyman was discharged before the contract was completed and the balance which he claims, including railroad fares between La Grande and Salem, is \$48. Ed. Horgan is Lyman's attorney.

Flames Threaten Barn

Dr. H. C. Epley's barn, located at 140 Marion street, caught fire at 4 o'clock yesterday afternoon and but for the prompt action of the Salem fire department a serious conflagration would have resulted. The fire is supposed to have started upon the outside of the building, but instantly spread to the chaff upon the inside, and for a time it looked as if not only the barn, but Dr. Epley's house as well as other adjoining buildings were threatened. The origin of the blaze is a mystery. The only damage done was to Mr. Epley's buggy, which was in the barn, and was badly scorched by the flames. The fire was discovered by several little girls on their way home from school, who immediately gave the alarm.

About \$50,000 Collected

Up to closing hours last evening Sheriff Culver had collected in the neighborhood of \$50,000 upon the 1904 tax roll. In collecting this amount, 1187 receipts were issued. Since the new books were opened the sheriff and his competent corps of deputies have had but little time for "recreation," and not only have all mail remittances been receipted for, but the cash register as well is written up to date.

MARTIN THEODORE RINEMAN PASSES AWAY AFTER BRIEF BUT SEVERE ILLNESS.

Was One of Salem's Most Substantial, Progressive and Influential Citizens—Born in Ohio Forty-Eight Years Ago—Came to Salem in 1887.

In the death of Martin Theodore Rineman, which occurred at his home on Church street, in this city at 10:30 o'clock Sunday morning, Salem has lost one of her most substantial, enterprising and foremost business factors, while his bereaved family suffers the loss of a most kind and loving husband, and an affectionate and indulgent father. Mr. Rineman has been a long but patient sufferer of Bright's disease, and his death, though somewhat sudden, comes as a relief to a long siege of deep-seated and agonizing pain from which there was no earthly cure. Deceased was born in Fostoria, Ohio, in 1857. At the age of 10 years he went to Procton, Ohio, and entered upon the business career which he has followed up all his life. In 1880 he was married to Miss Carrie Lakestraw, at Hicksville, and nine years later went to Wisconsin, thence to Oregon, coming direct to Salem, and established himself in the grocery business on State street, where he has been located continuously since. Through a system of strict integrity, business sagacity and enterprise, coupled with economy and public-spiritedness, he succeeded in building up one of the best trades in the mercantile branch of the city's business realm which he enjoyed up to the hour of his illness and death. Mr. Rineman was strictly honest in all of his dealings, sober and religious, and enjoyed the friendship and esteem of all who had the pleasure to know him, and his scope of acquaintanceship was by no means limited. The sympathy of the entire municipality goes out to Mrs. Rineman and the children of the deceased in their hour of deep bereavement. Besides his bereaved widow he leaves four children to mourn his death: Mrs. L. E. Hooker, of Denver, Colorado; Chester W., Frank S., and Miss Grace, all of this city, and two sisters and one step-brother, who reside in Ohio. The funeral services, which will be held at the home at 2:30 o'clock this afternoon, will be conducted by Rev. W. C. Kantner, of the First Congregational church, and interment will be had in City View cemetery. During the funeral all the grocery stores in the city will close their doors as a mark of respect for Mr. Rineman.

Van Dusen's estate is valued at \$400 and by order of the court the newly appointed guardian furnished a bond in the sum of \$800, which was approved by the judge. James Forbes, Jacob Ogilvie and Amos Beach were appointed to appraise the property.

Mr. Brown owns part of the land lying south of the city on which the state is considering the location of the state deaf mute school under the plan recently adopted by the state legislature. Mr. Brown says he has inquired into a good deal concerning the result of the late freeze and whether it had been instrumental in damaging the growing grain to any remarkable extent, reported that so far as he could learn there was no noticeable damage done thereby. Mr. Brown said that the grain along the road as he came in yesterday looked exceedingly good and promising.

AN INCREASED APPROPRIATION HAS ITS EFFECT AND WINS OVER THE A.

Business Men of Salem Take Hand in Matter and Send Petition Against Fair for This Year and Newell's Bill Passes, Abolishing It

After two weeks of the greatest uncertainty on the part of the Marion county delegation, it was concluded yesterday morning to abolish the State Fair at Salem for the year 1905. As a result of this decision the Newell bill was submitted to the Senate with the recommendation of the special committee, consisting of the Marion county delegation in that branch of the Legislature. The bill was amended, however, to provide for an additional \$5,000 to be added to the \$10,000 as contained in the bill originally. This amount will be used for the improvement of the grounds.

DALLAS WINS

Defeats High School Basket Ball Team in Fast and Furious Game.

In the most exciting game of basketball played in Salem this season the second team of Dallas College defeated the Salem High school by the close score of 18 to 15. At the close of the second half the score stood 15 to 15 and according to rule play was continued until one team or the other scored two points. Dallas soon got one on a foul and after about ten minutes of hard play, managed to scratch in another goal from the free.

The boys from "over the hills" were much larger and more experienced than the High school boys, but nevertheless the home team put up a good stiff game and scored as often as their opponents up to the end of the last half. The star player of the evening was undoubtedly Frank Rhodes, who succeeded in scoring eleven points out of the fifteen, and holding his man, Arnold down for none. The rest of the High school boys played winning ball and deserve great credit for their effective work in the face of such odds, the latter especially doing well. For Dallas, Larner, Craven and Morton scored the points.

UNDER FIRE

Hoke Smith Takes a Hot Shot at Secretary Hitchcock.

WASHINGTON, Feb. 18.—An authorized statement, given out tonight by former Secretary of the Interior Hoke Smith, replying to a statement issued by Secretary Hitchcock, regarding the action of Smith in approving the oil and gas lease made with the Osage Indians in 1890, severely arraigns Hitchcock as making a "baseless charge." Smith states that at the time the lease was made no oil deposits were known to exist in the Osage reservation. He asserts that the lease fully protected the Indians, by enforcing ample royalties, and that the lease was approved by the Indians themselves and by Colonel Freeman, acting Indian agent at the reservation.
