

IT IS UNDECIDED

LAND BOARD TAKES CANCELLATION OF DE LAITRE CERTIFICATES UNDER ADVISEMENT.

Board Holds Special Meeting Yesterday and Hears Evidence in Matter of the Proposed Cancellation of Alleged Fraudulent Applications.

(From Wednesday's Daily).

The state land board, at an appointed meeting yesterday afternoon, heard the evidence in relation to the proposed cancellation of a number of certificates of sale of state school lands held by John De Laitre and others, of Minneapolis. After spending the greater part of the morning, during which the state introduced its evidence to establish the alleged fraudulency of the applications for purchase, and the afternoon, when the defense proffered testimony tending to show that they were innocent purchasers of the certificates, the board took the matter under advisement indefinitely. Although no date was set

for arriving at a decision it is thought the board will hold its decision in abeyance pending the termination of proceedings which are pending before the circuit court involving these same certificates.

The meeting opened at 10 o'clock, and the forenoon was spent by the introduction of expert testimony by the state by Teller A. A. Cunningham, of the Ladd & Bush bank, to the effect that the signatures to the applications were forgeries. This was supported by evidence given by District Attorney McNary to the effect that he had investigated all the applications, and believed they were obtained through fraud. The hearing was concluded in the afternoon, when De Laitre, who is represented by Attorney Watson of Portland, offered evidence in the case to the effect that he was an innocent purchaser of the certificates.

John De Laitre of Minneapolis, Minnesota, holds an aggregate of eighty-one certificates of sale to state school lands which are held up for cancellation by the state land board upon the ground of fraud in the manner of application and procuring of the certificates by the land operators. These certificates represent an aggregate of over 23,000 acres of land and were included in a list of several hundred furnished the board by the Marion county grand jury

last April as a result of a thorough investigation instituted and carried out solely by District Attorney John H. McNary.

The alleged fraud consists principally of forged applications, assignments, etc., which, the state officials believe, bear names of fictitious persons. Formal notice of the board's intention to cancel the certificates was served upon Mr. De Laitre and the other parties whom he represents, two weeks ago, and this was the day set for the hearing. The other parties owning certificates included in the De Laitre list are Howard M. C. P., Joseph A. and Karl De Laitre; S. S. Johnson, Richard E. Morris and Frank A. Boyer, all of Minneapolis. Mr. De Laitre has employed legal counsel and declares he will contest any attempt on the part of the board to cancel the certificates through the state and federal courts before he will submit to the exercise of such authority, and the case promises interesting developments before it is closed.

BURGULARS OPERATE IN SALEM.
Night Frowlers Enter Messon's Second Hand Store and Steal Watches and Revolvers.

Charles B. Messon's second hand store, located on the north side of Court street, near High, was burglarized some time during Tuesday night, several watches and revolvers being stolen. The burglar or burglars gained access to the building by prying open a rear window and the location of the store, with many dry goods boxes and other articles piled in the rear, gave the miscreants an excellent opportunity to operate without being detected. The burglary was not discovered until yesterday morning when the proprietor opened the store.

Among the articles stolen were four or five watches and three revolvers, a 44 Colt, a 22 Iver-Johnson and a 32 Harrington & Richardson. There were a large number of other watches and revolvers of different makes in the window and show case from where the several articles were taken, but these were not disturbed. This leads the proprietor to believe that the theft was committed by someone familiar with the premises and that the burglars knew the exact location of the most valuable articles.

There is no clue to the guilty parties and the officers are entirely in the dark as to their identity.

ALL GRATEFUL

INTERESTING RECALIT OF HISTORY CONNECTED WITH OREGON'S ADMISSION.

Editor of Worcester Gazette Notes and Acknowledges Appreciation of Oregon People's Gratitude Toward Massachusetts—Governor Is Rewarded.

That all native born and alien Oregonians are grateful to the person or persons who were responsible for their state's admission to the Union there can be no question, but there are doubtless few who are aware of the identity of the only person who was individually responsible for her success in gaining admittance at that time and under the then existing circumstances. That person was none other than Hon. Eli Thayer, member of congress from the state of Massachusetts and member of the congressional committee on states and territories. Some months ago the Statesman contained an article calling attention to the very important part which Congressman Thayer took in bringing Oregon into the galaxy of states, but the majority of the Statesman readers have doubtless forgotten the interesting circumstances connected with the state's admittance.

The sum and substance of the whole story is that, while the committee on states and territories was deliberating upon the question of whether or not Oregon should be admitted as a state, and the majority, including many Republicans, had decided to turn her application down because of the slavery bugaboo, it was then that Eli Thayer, the abolitionist, came to her rescue and carried the day against fearful odds. If the citizens of Oregon are grateful to the state of Massachusetts on account of her indebtedness to one of her most brilliant sons, the people of the latter state are equally grateful to the people of Oregon for having acknowledged that gratitude as is evidenced by the tenure of an editorial which appeared quite recently in an issue of the Worcester Evening Gazette, the home of the illustrious statesman.

Governor Chamberlain also took official notice of the prominent part which Mr. Thayer took in the admission of Oregon to statehood in his address at the Lewis and Clark fair upon the occasion of Massachusetts day. The people of Massachusetts took note of this public acknowledgment of obligation to their state for the noble services rendered and feel grateful in turn to the people of the now fast becoming great state of Oregon. Those who are interested in the history of how narrow a escape Oregon had at that time of not becoming admitted to statehood and the opportune and heroic interference of Mr. Thayer, will doubtless find interest in the perusal of the following editorial reproduced from the Worcester Gazette, bearing upon the episode and the circumstances, political, connected with it:

Oregon Grateful.
A correspondent calls our attention to the fact that the late Eli Thayer, abolitionist and representative in congress during the 50's from this district, was largely instrumental in the admission of Oregon as a state, in 1859, a year after the admission of Minnesota and two years before the admission of Kansas. A majority of the Republican members in the house favored the admission of Oregon, but owing to the united opposition of certain sections, the slave power being at that time all powerful in both north and south, the whole project was about to be thrown

out. Mr. Thayer, in a powerful speech, pressed the Oregon case so strongly that party discipline was overcome and enough Republican votes were mustered to carry the day. Had it not been for Mr. Thayer's speech, Oregon might not have been admitted to the Union until Washington was let in, in 1889.

The situation at the time Oregon was admitted to the Union was full of ominous foreboding. The southern states at that time were in the height of their power and apparently determined to prevent the further increase of political power in the north. Kansas, colonized largely through Mr. Thayer's efforts, and which had swung like a pendulum through northern and southern sentiment, was persistently seeking admission to the Union, but as neither Republicans nor Democrats were in favor of the political sentiment of the South, its appeal had fallen on deaf ears. California had been admitted in 1850. There had been a tremendous scrimmage between the slave power and the political leaders of the north, to determine whether California was to be a slave or a free state. When it was finally decided that California was to be free, the rage of the south was most unbecomingly to behold. From that time on, the struggle to extend the slave power on the one hand and to keep the free states in the majority, on the other, became a fiery intensity.

Minnesota, a free state, was admitted in 1858. There was no corresponding increase among the slave states, for there was no territory in all the south that could have been carved out as a state, unless Texas had been divided, which of course was impossible, in view of the well known hostility of Texas to any scheme of division. When, therefore, it was proposed, in 1859, to admit Oregon, another free state, the Republican legislators, although in favor of the proposition, were somewhat dubious as to what political results might follow, for the slave power threatened dire things. The Republicans were not at that time in the majority, though they were sufficiently numerous to hold the balance of power in congress. They did not grasp the reins of power until the next election, that of 1860. It was scarcely to be wondered at, therefore, that they showed some timidity in view of the oft-proven ability of the slave power to make good its threats.

But Mr. Thayer, taking the bull by the horns, succeeded in forcing the admission of Oregon against all threats of vengeance and fears of calamity to the rising Republican party. Oregon was there, and then created a sovereign and free state.

In his speech on Massachusetts day, June 17, Gov. George E. Chamberlain of Oregon made this statement:

"Massachusetts has probably done more in making the Lewis and Clark exposition possible than any other individual state in the Union. Years ago it was through the efforts and conviction of Eli Thayer in congress from Massachusetts that Oregon was admitted to the Union. Kansas had been refused admission and several of the strongest political factors in the country bitterly opposed and fought against Oregon, but Eli Thayer was undaunted and won the battle for Oregon. And for this alone we have reason to be grateful, outside the plotters who have

For the part which he took in acknowledging Oregon's indebtedness to the state of Massachusetts, and especially to Congressman Thayer, for her present high standing among the great states of the Union, Governor Chamberlain is recently in receipt of a communication from John Alden Thayer of Worcester, advising him that a life-size portrait of his deceased father had been shipped him by express, enlarged from a portrait taken of him at the time of the admission of Oregon to statehood. WILL DISCUSS IT

PROBLEM OF IMMIGRATION WILL BE CONSIDERED BY CIVIC FEDERATION.

Invitation Is Extended to Governors of all States—National Conference Is Proposed for Next December in New York—Topics to Be Treated.

NEW YORK, July 27.—To discuss immigration problems a national conference will be held in this city on December 6 and 7 next under the auspices of the National Civic Federation. Several ship companies, labor unions and those interested in the Civic Federation discussed the question, and it was then decided to give to the investigation a national scope.

To this end the governor of each state was asked yesterday by letter from a committee of the Civic Federation to appoint ten delegates to the conference. Some of the topics are these:

"What is the character of the net increase in the population of the United States from immigration of the past decade? Should existing legislation looking to the elevation of this character through the exclusion of undesirable elements be extended and made more effective?"

"Are there any external influences tending to stimulate the volume of immigration?"

"What domestic industries and what labor crafts are most affected by the influx of alien labor, and in what ways?"

"What percentage of European immigration remains in the ports of arrival?"

"What practical method can be devised for distributing immigration, especially for agriculture, to points where it may be needed?"

"What further methods can be devised for improving the condition, both of housing and employment, of aliens congested in large cities?"

"What will be the effect of the distribution of large numbers of immigrants in the south upon the problem of industrial education and social betterment of the negro race?"

"Should the exclusion of Chinese coolie labor be more rigid, and should it be extended to Japanese and Korean labor?"

The call is signed by August Belmont, Samuel Gompers, Oscar S. Straus, Cornelius N. Bliss, John Mitchell, Archbishop Ireland, Bishop Potter, Charles A. Moore, Warren S. Stone, Ralph M. Easley and Samuel B. Donnelly.

ROADCOMMITTEE SIX MONTHS IN JAIL AND FINE

GOVERNOR CHAMBERLAIN WILL PROBABLY NAME MEMBERS FIRST OF NEXT WEEK.

Will Investigate Feasibility and Adviseability of Building Base Road of Macadam from California State Line to Portland by Convict Labor.

Among the most important things which the governor has under consideration at the present time is the appointment of five competent citizens to act upon the state road commission, as provided by Senate Concurrent Resolution No. 31, to investigate the feasibility of the construction of a macadamized road from Portland south to the California state line, by employing the labor of convicts confined in the state penitentiary. The governor has had this matter under consideration for some time, but deeming it to be of no particular urgency, has deferred action until the present. He announces now, however, that he will be prepared to name the membership of this commission some time next week.

"That the building of a macadamized road from Portland to the California state line would be of great value to the state and would greatly encourage the building of similar roads adjacent thereto in other parts of the state, and that convicts confined in the penitentiary could properly and profitably be employed in the construction of such a highway," are the two beliefs which prompted the introduction and adoption of the resolution by the legislature, and the purpose is that, if the commission finds the construction of the road feasible and practical by means of convict labor, it shall prepare and submit to the next meeting of the legislature a bill to govern and regulate the construction of the road and shall report such other matters as shall be of assistance to the legislature in connection.

Governor Chamberlain had this resolution and the wishes of the legislature fully in mind when he advertised for bids for the leasing of convict labor for stated periods and it will doubtless have a considerable bearing upon the matter of letting the contracts upon the offers received from the Lowenberg & Going Company and the Portland Airtight Stove Manufacturing Company, as published. He still has the bids under consideration and may not arrive at a definite conclusion until the latter part of the present week, as the present contract with the Lowenberg & Going Company will not expire until Saturday, July 29.

In talking over the convict labor question yesterday afternoon Governor Chamberlain openly announced that he was neither in favor of leasing out the labor of convicts to private corporations nor particularly in working them upon the public highways. His idea is to have the state purchase or lease about 3000 acres of land and put the convicts to work in tilling the soil and raising variegated crops, since this is about the only employment in which they could engage without coming into direct competition with free labor, and what produce they would raise would not be sufficient to come in contact with the product of free labor in any sense of the word.

MAY BE SORRY

AMERICA AND GREAT BRITAIN MAY YET SEE REASON FOR REGRETTING WAR.

Count Cassini Declares Growing Power of Japan in Orient Is Greater Menace to Powers Than Is Russia—Ex-Ambassador Gives Interview in Paris.

NEW YORK, July 25.—Count Cassini, formerly Russian ambassador at Washington, expresses the opinion, according to The Herald's Paris correspondent, that all now depends on the Japanese, and that if their demands at the coming peace conference are reasonable peace is assured. Speaking of the Russian representative, M. Witte, Count Cassini said:

"I think this infinitely important task could not have been entrusted to a better representative. He is a man of extraordinary capacity and of the finest character. He knows the far eastern question as few men know it, and is a patriot."

"Regarding internal difficulties, Russia has now reached a critical moment in her history, but America has had such a moment; so has France. These difficulties will disappear and Russia will be stronger than ever. They were merely passing difficulties, and it would be unwise to attach too much importance to them."

Referring to the Chinese, Count Cassini said:

"I like the Chinese. It takes years and years of worry and trouble to bring them around to your way of thinking or to induce them to enter into any undertaking, but once convinced they are loyal. A Chinaman's word is as good as his oath."

"I speak with all caution and circumspection, but I am, nevertheless, afraid that at no very distant date England and America will have reason to regret this war. They may have more to fear from Japanese competition than from Russia."

STATESMAN CLASSIFIED ADS BRING QUICK RESULTS.

SENATOR MITCHELL HEARS DECREE OF FEDERAL COURT.

STAY OF EXECUTION GRANTED.

Case to Be Appealed and Fought Through to Supreme Court of the Land.

Judge De Haven States That He Takes Into Consideration Age of Defendant in Pronouncing Sentence—Aged Senator Sits Unmoved Through It All

PORTLAND, July 25.—Senator Mitchell, convicted of the prostituting of his office to further the law practice of the firm of Mitchell & Tanner, was today sentenced to pay \$10,000 and to serve a sentence of six months in the county jail. Pending a review of the case by the United States supreme court, the execution of the sentence will be deferred. In the meantime, Mitchell will be at liberty under a bond of \$2,000. Judge De Haven stated in passing the sentence that he had taken into consideration the advanced age of the defendant and the fact that he was forever barred from holding public office. Senator Mitchell did not move a muscle during the passing of the sentence and, when the words "county jail" fell from the lips of the judge, the aged senator sat as one transfixed.

Immediately upon the pronouncing of judgment, ex-Senator Thurston filed notice of an appeal, an additional bill of exceptions, a supersedeas bond of \$2,000 for appearance before the supreme court and a record of a writ and assignment of error. Judge De Haven then announced that the duty of the marshal to carry on the sentence of the court. In perfecting the appeal it will be necessary for Judge De Haven to sign the bill of exceptions, make an order allowing the writ of error and the supersedeas bond of \$2,000. The stay of execution will admit of time in which to do this, after which the appeal will act as a stay, until the appellate court passes on the questions involved.

The conviction and sentencing of Senator Mitchell does not render his office vacant. This principle was determined in the Burton case, when the supreme court affirmed the judgment of the trial court, its act would have the effect of vacating the office. Otherwise the governor will have no power to appoint a successor to Mitchell. The delay here six months in which to take an appeal to the United States circuit court of appeals, and this will most likely be done within the next few months. There is always a question of jurisdiction, where an appeal is taken direct to the supreme court, and an appeal to the next lower court would make the process of appeal more regular.

Senator Mitchell will, unless his conviction is affirmed, hold office for two more years. A decision is expected by next March.

TEST INDIAN LIQUOR LAW.

Pendleton Men Gaudy Selling "Red-eye" to Umatilla Redskins.

PENDLETON, Or., July 25.—To test the legality of the state law prohibiting the sale of liquor to Indians, two men, Bird Livermore and David Carlin, have been arrested here for having broken the law. The arrests were made at the instance of E. G. Valentine, private secretary to the Commissioner of Indian Affairs, who is here upon an inspecting tour. In company with an Indian, Mr. Valentine is said to have caught the two men in the act of selling the liquor to Simon Whitman, an Indian, a few nights ago.

When the two prisoners were brought before Circuit Judge Ellis yesterday they asked to be given until Wednesday to plead and the request was granted. Carter & Raley and James A. Fee have been employed to defend the men, and it is said that in the event of a conviction, the case will be appealed to the supreme court and the constitutionality of the law tested.

Since the recent decision of the United States supreme court declaring the federal law against selling liquor to citizen Indians invalid, that practice has been followed very freely with the Umatilla Indians, and as a result there has been much drunkenness among them. Until now no action had been taken by the state or county officials to stop the illegal trading and the present arrest is the first one under the state law.

SAYS BOYCOTT IS POPULAR.

Secretary of Chinese Legation in Paris Declares Movement Will Spread.

PARIS, July 25.—Mr. Lion, the first secretary of the Chinese legation, in an interview in The Matin, gives his views on the Chinese boycott of American goods. He says:

"The boycott of American goods is gradually extending, and will probably gain considerably in southern China. The Chinese press is taking an active part in the boycott, in the struggle over which China has nothing to lose. The movement is very popular and will only cease when the United States modifies certain laws affecting our countrymen."
