The Missouri River Threatens Great Damage by Floods.

BATCH OF JAPANESE NEWS.

New Minister to the United States-- Steamer Lost--Earthquake.

VANCOUVER (B. C.), March 26.
The steamer Batavia arrived to-day with the following Japanese advices: M. Mutsu, the newly appointed minister to the United States, will sail May 2; the steamer Swaton was lost near Namoa Island February 22 and thirty persons drowned; two earthquakes were felt in Tokio on March 1; during the week ending February 11, 44 persons died of smallpox in Hong Kong; the post-office at Tokio was burned on February 24, but most of the mail matter was saved.

The Examiner Cleared.
SAN FRANCISCO, March 26.—The charge of libel against Edward Townsend, business manager of the Examiner, upon complaint of ex-Assessor Holtz, accused by the paper of being the leader of a great opium ring in this city, was dismissed in police court this morning, the judge holding that the business manager of the paper is not responsible for what emanates from the news department.

The Big Muddy in Bad Shape.
YANKTON, (Dak.), The situation upon the upper Missouri is now identical with that of the spring of 1881, when the disastrous flood occurred. Heavy snow lies along the valleys, and a series of gorges have formed between here and Bismark. The most intense anxiety is felt.

Irish People and Police Again.
YOUGHAL (Ireland), March 26.—Wm. O'Brien attempted to address a meeting of tenants here yesterday in the town hall, when a free fight took place between the police and those in attendance. Clubs and bayonets were freely used, with fatal effect in several cases.

Bill for Funeral Expense.
WASHINGTON, MAR. 26.—The bill appropriating five thousand dollars to defray the expenses of Chief Justice Waite's funeral passed the house and senate to-day. The funeral will be held on Wednesday in the hall of the house.

Wilson is Acquitted.
PARIS, March 26.—The court of appeals to-day rendered a decision in the case of M. Wilson, ex-President Grevy's son-in-law, who appealed from the decision of the lower court. The judge reversed the decision of the lower court and acquitted Wilson.

Concealing Smallpox Cases.
VIRGINIA (Nev.), Mar. 26.—Dr. J. B. Zangerl, of this city, has been arrested for concealing seven cases of smallpox. The president of the board of health discovered the cases yesterday. Zangerl has violated an ordinance which requires physicians to report all contagious diseases to the board of health.

Another Eastern Blizzard.
ST PAUL, Mar. 26.—A severe snow and wind storm raged all day yesterday in northern Wisconsin, Minnesota and Dakota. Snow is from three to five feet deep. Street car travel is abandoned.

Cold Blooded Murder in San Francisco.
SAN FRANCISCO, March 25.—John McNulty killed James Collins to-night on Second street, between Mission and Howard.
They were both stevedores. They met on the street and had words, when Collins and a friend named Halpin walked on. Halpin states they had gone about ten steps when McNulty called them. Collins turned, when McNulty raised his pistol and fired, the bullet striking his victim under the left eye. It lodged in the brain and caused death in an hour and fifteen minutes later.
McNulty claims he carried the pistol and did the shooting in self-defense.
Halpin claims otherwise, and states that the cause of the shooting seemed to be imaginative on the part of Collins, who was no longer a warm friend to him as he had once been.
Collins was a single man, and about 24 years old. McNulty is a married man.
The police officers had a hard struggle to keep the crowd that surrounded the scene from lynching McNulty, as they claimed the shooting was entirely unprovoked.
McNulty's wife did not hear of the shooting until 10 o'clock, the hour after which no visitors are permitted in the city prison. When she called to see her husband she was refused admittance and wept bitterly at the gate. McNulty heard her voice and joined her tears. "Poor woman!" he sobbed. "She will soon give birth to a child that will have a man like me as its father. That's the only thing I am sorry for."

Sensational Murder Trial Ended.
BONHAM (Texas), March 25.—Contrary to the expectations of every one the sensational murder trial of Jim Scarlett, commenced Friday, has ended by Scarlett being admitted to bonds in the sum of \$3,000. Not one-half of the witnesses were examined, as evidence was conclusive that the man was living for whom Scarlett was standing trial for murdering. The story all the way through seemed stranger than fiction, and is unparalleled in the annals of Fannin county courts. But for a technicality in the verdict rendered five months ago, Scarlett would ere this have paid the deadly penalty, while the man for whom he was suffering the extreme extent of the law would have been alive and well. Lancefield, who was claimed to have been killed by Scarlett, but who tells an extraordinary story of escape from the river, where his would-be murderer had thrown him, is still in town. While his strange statement bears many sentimental features, yet, supported as it is by reliable witnesses, is believed by almost every one. Scarlett, who was rejoicing over the short respite from hanging granted by the last district court, can scarcely realize his good fortune. The strongest case that can possibly be made against him is attempt to murder, with a punishment not exceeding four years.

MORNING TELEGRAMS.
Lightning Flashes of What the World at Large is Doing.
THE QUESTION OF SUCCESSOR.
Speaker Carlisle's Chances Considered Very Good--Other Names Mentioned.
WASHINGTON, March 25.—There is no great speculation yet as to the late Chief Justice Waite's successor. Two who were much spoken of when there was another vacancy, Secretary Bayard and Attorney-General Garland, will not expect or desire the appointment. Judge Jackson, Judge Simms, and many others who were named then, will again be mentioned. What is thought to be most probable is that Speaker Carlisle will succeed Chief Justice Waite on the bench of the supreme court. It is known that he was offered the seat that Justice Lamar now occupies before it was offered to that gentleman. He declined it very reluctantly, and his declination was as reluctantly received, but it was agreed between him and Mr. Cleveland, after talking the matter over, that the political situation and party necessity required Mr. Carlisle's presence in the house to organize it, and to work to bring the party together for the passage of a tariff bill. Mr. Carlisle at the same time told Mr. Cleveland that no other public position or trust could so suit his disposition and inclinations as that of supreme justice.
Hon. W. H. Barnum, chairman of the democratic national committee, expressed the opinion that Judge Thurman ought to be appointed to succeed Chief Justice Waite.
It is urged that the appointment must go to the sixth district, which includes Michigan, Ohio, Tennessee and Kentucky. Carlisle, Thurman and Dickinson, of Michigan, are all three in this district.
