RECENT disasters to tenement houses in New York by fire, accompanied with severe loss of life, have led the fire department of that city to experiment in methods for rescuing inmates from upper stories. On the 2nd inst, a novel exhibition was given at the fire headquarters. A female performer at Barnum's, Mrs. George O. Starr, jumped from a third story window, a height of forty feet, into a net held by the firemen in the street. This net was a small but strong affair, with a large circular cushion in the centre. She took her position on the window sill, attired in ordinary female garb, tied a piece of cord about her skirts and leaving her resting place with an easy movement, she fell upon her back into the net. She was not hurt in the least, and refused proffered assistance to help her out of the net. The leap had been previously made by two firemen, and their success encouraged Mrs. Starr to make the attempt. It is said this method of escape will be adopted by the New York fire department, and the men are drilling in the dangerous exercise with great readiness.

There is a chance of one murderer coming to justice, and the reason given is that he is without money. Anschlag, who sacrificed two victims, for the base purpose of robbery, has been sentenced to hang on Friday next, and now lies in the jail at Los Angeles awaiting the execution of his sentence. He is making frantic efforts with his friends in Germany to send him money to take an appeal, but they are so overwhelmed at the disgrace he has brought on his family that they are disinclined to render aid. Without the successful prisoner's lawyers refuse to move further. It is to be hoped that this remorseless homicide will be kept without means to defeat the award of justice, and that the day set for his execution will see him swing.

The Oregonian reporter at the democratic convention in Pendleton says the Multnomah delegation was "knocked out." They were badly disappointed in the rejection of their man Killin for chairman of the state committee, and charge treachery upon "smoothies from up the valley." The preference was for A. Bush, of Marion, because his usefulness as chief manager are known, while Mr. Killin was an unknown quantity, and the convention was not willing to take chances. The CAPITAL JOURNAL takes becoming pride in the preference shown for a fellow townsman.

The prohibitionists in state convention in San Francisco, are not presenting to the world an edifying spectacle of harmony and brotherly love. Dispatches from that city say the delegates seemed to represent four factions, and so keen was the struggle for supremacy that the discussion became quite heated. In this body of uncompromising reformers we should look for a more Christian spirit to prevail.

**THEY STAND ON THEIR MERIT.**

The Republican ticket nominated for Marion county is approved by all the party journals of the county as fairly and judiciously selected, and its success at the polls is looked upon as morally certain. But this success, it must be borne in mind, will not be achieved, without faithful work. The republicans have two parties to fight in the election, and as the frame of mind of the average voter is in an indeterminate state, constant effort must be expended in exposing misstatement, and keeping the merits of the republican cause before the people. It has been truthfully urged that partisan politics have but little to do with the fitness of a man for county or municipal office. The administration of local affairs calls for sound judgment and good business qualities, and the man who combines with these good moral character and rectitude of conduct, is the one who may be safely chosen without regard to his party. This has been so often insisted upon that it has grown to be a truism. And it will be noticed that our county delegates in selecting men for office were governed by this consideration, because the slate they made up stands on its own merits, and commands the confidence of every right thinking man. No machine tricks were resorted to, no bossism attempted, no barter and sale. The proceedings of the entire session were jealously watched, and the bitterest partisan, who might be present, has made no intimation of trickery or collusion. The seven or eight score of delegates seemed to be animated with one spirit fairly to represent the communities who sent them, and to choose a set of men for public office whose intrinsic merit would command the support of their fellow citizens.

A business thus fairly inaugurated will be honestly carried through. Few reasonable, unprejudiced men, no matter what their politics, are willing to sacrifice their material interests to win a party triumph. When the security of our property is at stake, the preservation of the public peace, the care of the county funds, and the general ordering of our public affairs are involved, they naturally look for capable and trustworthy men for such a trust, giving slight heed to what party they may be allied with. Proved by such a test the men set up for republican support at the polls are fully equal to the requirement, and if elected next June, will reflect credit on the party they belong to. This is a tower of strength; and if vigilance is exercised during the canvass, and the proper effort made, men will go to the polls with a proper understanding of their true interest, and the success of our ticket is certain.

**SENTIMENTAL RESPECTABILITY.**  
 The San Francisco Chronicle sums up Gov. Penney's pardon with the following remorseless logic:  
 The pardon of the San Francisco woman who has been masquerading in Oregon as Pearl Page, is, we think, mistaken leniency on the part of the governor of Oregon. The woman left a good home to become the paramour of a rogue; when she agreed to aid him in swindling she should be made to pay the penalty of her wrongdoing. The fact of her sex ought to have no weight with an executive, any more than with a jury.  
 The Examiner takes this view of the case:  
 The good people of Oregon, including the governor, have decided that a woman who abandons herself to vice and crime is entitled to immunity from punishment, provided she can be shown to have betrayed a good husband and broken the hearts of her family. An ordinary thief in the place of Pearl Page, would not have been made the subject of petitions for pardon from all the sentimental respectability of a state, and if she had been the governor would have paid no attention to them. We do not know exactly the moral of this episode.

The democrats in congress are at last waking up to a realizing sense of their duty with regard to the territories. A caucus of the democratic members of the house will be held to-morrow evening to consider the question of admission; and the house committee on territories has agreed on the order of business for the few days and evenings allotted it next week. The Oklahoma bill, about which the greatest popular clamor is raised, will first be debated and put on its passage; then the omnibus bill will be brought up which provides for admission into the union of Dakota, Montana, Washington and New Mexico. Three of these territories are certainly republican, but that is no bar to the enjoyment of their political rights by the citizens.

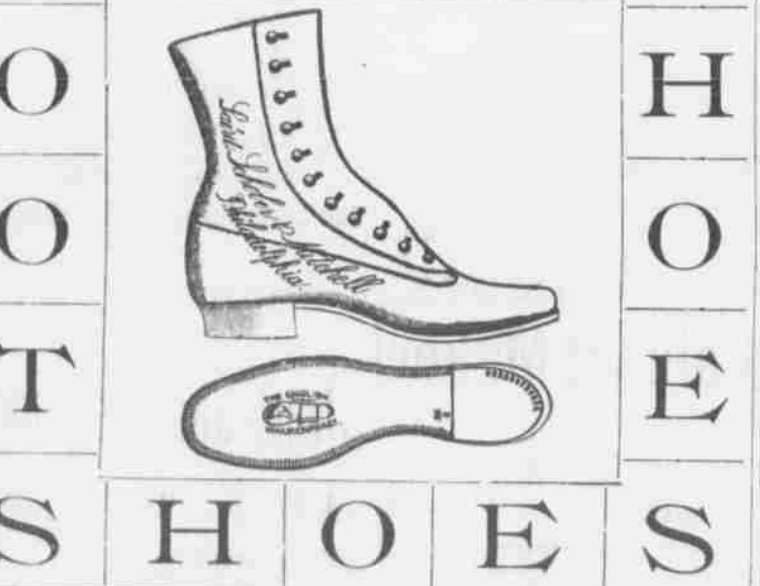
