THE FORGER AGAIN.

Pyburn Acquitted and Evidence of Guilt Turns to Jordan.

Charles Pyburn was given preliminary hearing yesterday before Recorder Conn on the charge of having written the forged order upon which Willis Jordan and Jack Morgan obtained two suits of clothing from the store of G. W. Johnson. In so much as sufficient evidence was adduced to satisfy the court that Pyburn cannot write he was released. There is no record of Pyburn ever having performed any writing. Upon all occasions where his signature has been required he has made his mark.

Jordan is quite apt with his pen and the opinion gains ground that the forged order was of his creation. The court had Jordan produce a sample of his handwriting yesterday during the trial and, although evidently disguised, it bears a marked resemblance to the general style of the forgery.

Dr. Port Goes to Europe.

Dr. Luke A. Port left this morning for Vancouver, B. C., where he has some landed interests and where he is contracting for the erection of a big brick block on some of his lots there. From Vancouver the doctor will sail after a few weeks for San Francisco. He will spend a few weeks at the Golden Gate, when he will go overland to New York City. Thence he takes a steamer for the Azores Islands and Europe and Germany. Dr. Port goes upon a mission in which he has the prayers for success of his many friends, his object being to try and locate something of his lost son, Omega. It will be remembered that the son sailed from New York December 22, 1887, on the vessel Glenavon, bound for Liverpool, where he was to have completed his education. Nothing was ever heard of the ship, and a faint hope exists in the breast of the anxious father that the son might have been cast away and rescued on some of the islands of the Atlantic. Dr. Port will continue his search for three years, when he will return to Oregon. Would that he may be successful.

News of the River.

The rains of the past forty-eight hours have just begun to tell on the river and the rise will be about one foot. The Three Sisters came up last night with a light cargo and this morning proceeded on up the river. The Champion came in last evening having on board 500 sacks of wheat for the Salem flour mills. She took on board here about eighty-six tons of freight, making altogether 190 tons for Portland. The Occident ran onto a snag at the mouth of the Santiam and had to go to Portland for repairs.

A FATAL SHOOTING AFFAIR.

Harvey Ogle Shot Last Night by W. E. Hawkins.

OGLE EXPIRED AT NOON TO-DAY.

Hawkins in Jail—The Coroner's Inquest—Interviews, Etc.

What few people were on the street last night, near the corner of State and Commercial, at 9:30 o'clock were startled by the report of four pistol shots in quick succession. The shots were fired by W. E. Hawkins and directed at F. H. Ogle. The latter was struck and reeled, about to fall, but was caught by Wm. J. Clark and Hugh Thompson, who were attracted to the place by the shots.

THE WAY IT HAPPENED.

J. H. McNary, deputy county recorder, and F. H. Ogle were walking down Commercial street and upon reaching State they took the street railway track—the sidewalk being impassable at that point. Ogle had previously told McNary that he was expecting trouble from Hawkins, and that he was unarmed. They continued on the street car track until nearly in front of Wm. Brown's shoe store when they met W. E. Hawkins. As they neared each other Hawkins made the remark: "I hear you have been talking about me again." But nothing more was said, and the only thing known as to what immediately followed is as told by Hawkins. He was seen in jail by a JOURNAL reporter and said that when they met immediately each reached as if for pistols and the firing began. Hawkins says they reached simultaneously to their hip pockets. "I shot," said Hawkins, "in self defense. I saw Harvey put his hand back as if to draw a weapon and at the same time and as quick as a flash I got my pistol and began to fire. I don't know who shot first. I thought I was wounded and could not believe but that I was pierced by bullets until an examination revealed no wounds."

At the first shot McNary, who was with Ogle, sought a place of safety. He saw no weapon in the hands of Ogle. Thompson and Clark, coming up after the shooting, saw nothing. J. N. Knox of Portland was standing on the east side of the walk in front of the Columbia saloon at the time and heard the conversation and the firing. He returned to Portland this morning, after telling the JOURNAL reporter that he saw Hawkins in the act of shooting.

THE WOUND A FATAL ONE.

Immediately following the occurrence Drs. Smith and Byrd were summoned to the drug store of Gibson & Singleton, where the wounded man was carried. An examination revealed the fact that a bullet had struck and broken the collar bone and penetrated the left breast. The weapon used was a .38 Smith & Wesson. The wound was not probed to the bullet, as the patient was spitting so much blood. Hope of his recovery was not entertained for a moment, and he was removed to the home of Mrs. T. H. Cox on Front street. His wife, who was here with him, is a niece of Dr. Horace W. Cox and is prostrated over the great trouble.

WHAT HAWKINS DID.

As soon as the shots had been fired Hawkins rushed into Fry's drug store declaring he had been shot and was in mortal agony. He located his wounds as being in the shoulder. But when his coat was removed nothing was found. He then went on the sidewalk in front and stood there. Policeman Lake had heard the shots and was on the scene promptly. He asked Hawkins who shot. Hawkins said the man ran down the alley. Lake was off but returned at once and arrested Hawkins, and with Sheriff Croshaw took him to jail. Hawkins was in jail before ten o'clock. Mr. Lake having arrested him within six minutes after the firing.

HAWKINS INTERVIEWED.

Through the courtesy of Sheriff Croshaw a JOURNAL reporter was permitted to visit Hawkins at the jail this afternoon. He is nervous and weak, but gave the reporter a welcome. He said he had nothing more to say, particularly. "I regret it all," he said, "but all I did was in self defense. No, I had not been drinking." The first intimation Hawkins had of the death of Ogle was given him by the reporter. When he learned that his victim was dead he said, "My God, I'm sorry." A shudder stole over him at the mention of the word "dead." He seemed not to realize for a moment, but when he did his countenance changed and a look of pain and horror filled him. When he learned that Mrs. Ogle was crazed

with grief, he again expressed much regret.

WHO AND WHAT.

Hawkins says it was all in self defense. He is a son of Mr. Hawkins who has charge of the opera house, and by profession is a druggist. The true cause of the trouble may never be known. But it is known that Hawkins worked for Ogle until December last, when they parted in a quarrel. It is said the deceased accused the prisoner of having stolen something from him. He told some one yesterday that Hawkins had robbed him. This is no doubt what Hawkins heard, hence the remark when they met in the evening.

THE DECEASED.

The deceased, whose full name was Franklin Harvey Ogle, was born Oct. 22d, 1858, at Paloma, Adams county, Illinois, and came to Oregon with his parents when he was thirteen years old and has resided here since. His present home is about four miles northeast of Lebanon, Linn county, where he owns a farm. He came to Salem yesterday to attend to some business with Dr. H. W. Cox. He is a son of Jacob and Matilda A. Ogle who live out on Howell Prairie.

This is the second son of Jacob Ogle that has met his death through fire arms. The old gentleman is here to-day, and through his tears said "Harvey would never have been shot had he kept good company." What he meant may never be known. The other son, Curtis, died when seventeen years old. Ten years ago he was duck hunting and while creeping up on his game accidentally discharged the weapon, the charge taking effect in his breast, from which he died a few hours after.

Dr. Richardson attended to the first case and this one to-day also. Harvey had not seen his parents for three months and they were not aware of any trouble he had had with Hawkins. He was a member of the Odd Fellows and Knights of Pythias, also of the Congregational church. He leaves a wife and no children. The body will be buried Saturday at 11:30 o'clock in the Odd Fellows cemetery. He was married September 13th '82, to Miss Carrie M. Cox, in the same room in which he died to-day.

THE CORONER'S JURY.

Coroner Byland arrived in the city this afternoon and the following jury was empaneled: G. W. Johnson, C. M. Parmenter, George Collins, T. E. Holverson, George Ogden and J. B. Arbergust.

After the examination of the body at the house the jury repaired to the city recorder's office where the examination was continued.

THE CORONER'S INQUEST.

Hugh Thompson was first called and testified as follows:

Shortly after nine o'clock last evening Wm. J. Clark and myself were talking together just inside the door of Gibson & Singleton's drug store. We heard one shot and immediately afterward three. I ran out on the edge of the sidewalk, saw a man come running with his head down toward me, and when within about fifteen feet of the walk, looked up and called me by name and said "I am shot, help me." At that moment he commenced to fall. I ran two or three steps and caught him and assisted him into the drug store. He did not say anything and we immediately removed his clothing. On removing his shirt we found a wound on his shoulder. Someone asked him if that was the only wound, he said "yes," and afterward remarked that it was the first shot fired, and that was all he said until we took him home.

Did Mr. Ogle make any statement to you in regard to the cause of the shooting after you had taken him home?

About 11 o'clock last night he opened his eyes and said: "Is that you Hugh?" I said yes. He said do you remember what I told you sometime ago? I said yes, and he said that is the cause of this. You may state what it was he referred to as having been told you sometime ago.

About three years ago we were in business together. Mr. Hawkins was working for us. There was some money missed at the time. There were also two other men working for us at the same time and we talked it over sometime and never concluded what became of the money. What he referred to was about six weeks ago, I met him on the street and he asked me if I remembered the loss of the money at the time. I said I did. He said, "I have had sufficient dealings with Mr. Hawkins since to believe him the one that got the money and that is all I know."

Dr. W. H. Byrd testified: When I first saw Ogle he was breathing heavily and rapidly from the effects of a pistol shot wound. He was at Gibson & Singleton's. The ball entered the chest about the point of the left shoulder and just below the

meeting line. I traced the ball about a couple of inches upwards and inward, striking the lower and under part of the clavicle and fracturing it. That was as far as I attempted to trace it as he was too weak to attempt any further operation. I administered a dose of morphine to quiet him down, as he was suffering considerable. I did not think he would live long, and told him if he had any statement to make before he died, he had better make it. He said that that fellow had been robbing and stealing from him and that he had told him of it and Hawkins took out his pistol and shot him. Death resulted from the wound.

I assisted in the post mortem examination to-day and we found that the ball had entered the left chest fracturing the left clavicle about the middle or the inner third and from there the ball deflected downward into the right chest cavity entered the right lung. It passed diagonally down through the lung and lodged in the outer wall. We found the lungs completely collapsed and both full of blood. This wound was necessarily fatal.

Here the doctor presented the ball that had been taken from the body of F. H. Ogle. The ball was cut almost in two or flattened. This was caused by striking the bone as it entered the body.

The inquest will be continued until a late hour, as there are many witnesses to be examined. Among them are Ed McAfee, M. B. Goldstein, C. Paulus, Dr. J. N. Smith, J. N. McNary and others.

SKIPPED THE COUNTRY.

Robert Bannon, the Wagonmaker, Leaves His Wife and Creditors.

Robert Bannon, the man who was employed by John Holm, has shaken the dust of Salem from his feet and sought pastures new and green. On Thursday of last week he went to Portland, presumably to purchase stock, but since then no word has been heard from him.

Aside from leaving his wife, who has rooms at Mrs. Wilson's near the bridge, he leaves a large number of anxious creditors for greater or lesser sums. Among them are John Holm, E. S. Lamport, G. F. Smith, A. T. Yeaton, Amos Strong and others.

The rumor was current, among those who were in a position to know, that the married life of Mr. and Mrs. Bannon was not as smooth as it might have been. Although they seemed to live happily together there was a great gulf between them.

Mrs. Bannon was seen this evening by a JOURNAL reporter. She said her husband had gone and she knew not where. When asked about leaving her, she said: "Yes; he's left me and all his debts. He didn't tell me where he was going, neither did he leave me a cent of money. We never quarreled until about six weeks ago. Then we had a big quarrel and since that time I have known that we could never live together. Yes; he was hard to get along with, but never did any violence to me." With tears in her eyes she said she was "left penniless, but that was better than riches and him to live with."
