From Silver Creek Falls.

R. Reid of Silver Creek Falls is in Salem to-day and reports everything in the region of that popular summer resort as moving on nicely. Mr. Arnold, who purchased the John Heppner place, has arrived from the east and will begin the construction of a new hotel at the springs at an early day. He will also establish a sawmill of good capacity. Considerable property is changing hands and the season promises to be a prosperous one. A direct road from the Springs to McManis among the early possibilities, petitions for it being now in circulation.

From the Front.

A Gatesville correspondent in the Albany Herald says that news that work is to be resumed at once on the Oregon Pacific railroad is hailed with delight there. It means lively times all along the line. Game hunting is all the rage. One was killed in town the other day. Land along the line of the O. P. is being taken up by settlers. It is yet unsurveyed and is held by squatters. There is a foot and a half of snow near the Summit.

Those New Postoffices.

Yesterday's telegrams convey the information that new postoffices have been established in Marion county as follows: Argenta, with George A. Lehman postmaster; Lewisburg, Samuel Lewis postmaster; and Willard, with Mary A. Starnes as postmaster. These offices are on the new route established between Salem and Silver Creek and will be a great accommodation to a large population.

One of the Survivors.

On board the overland train this morning, bound for Portland, was one of the survivors of the wrecked Alaskan who had escaped in one of the life boats and landed near Florence. He made his way to Eugene, where aid was tendered him. There were eleven men saved with him. They were tossed in an open boat for three days, with nothing to eat but six cans of peaches and nothing to drink but salt water.

A New Department.

There being so many inquiries for homestead, pre-emption, timber and school land claims, the Oregon land company has decided to add a "locating" department to their business. They will soon be prepared to locate settlers on government land, as they will put men in the field for the purpose of cruising out the most desirable tracts.

A Daily Mail Service.

A number of the business men of Salem and Independence having signed a petition requesting it, a daily mail service has been established, beginning to-day, between Salem and Independence. This is a service that has long been needed and will be a great convenience to the two cities, now that it has been established.

Receiving Congratulations.

Townsmen George H. Burnett and John G. Wright are receiving the congratulations of their friends and brothers in their election to honorable posts by the Grand Lodge of Odd Fellows in session at McMinnville last week. The former was elected Deputy Grand Master and the latter Grand Treasurer.

Work Commenced To-day.

At the corner of Commercial and Chemekete streets, on the east side, all is activity to-day, the preliminary work having been commenced on the big new brick block. The excavations are being made and the brick are being delivered on the grounds. The contractor will hasten the buildings to a completion as soon as active work is commenced.

In matter of the guardianship of Thomas, Mattie and Walter Swartz, Laura A. Randall is appointed guardian, and files her bond in sum of \$2,000, which is approved.

In matter of the guardianship of Wm. Atten, George E. Good is appointed guardian, and files his bond in sum of \$500, which is approved.

In matter of the estate of Thomas W. Diley, John W. Thorndike, executor, files bond in sum of \$400, which is approved.

A BAD DAY FOR ACCIDENTS.

Sunday Mishaps—Several Severe and Painful Accidents.

Yesterday was an unlucky day for several citizens of Salem, as a half dozen of her citizens sustained more or less serious accidents. Among the most painful and dangerous mishaps were the following:

A SHOULDER DISLOCATED.

J. M. Rogers of the Salem abstract and land company met with a painful accident Saturday evening that will lay him up for some time. He was out showing a newcomer some land about two miles east of the city and was driving along the road close to the edge of a big ditch when one of the horses slipped and fell into the ditch, jerking Mr. Rogers out of the buggy. He fell on the buggy tongue between the horses, in such a manner that his shoulder was dislocated. The gentleman with him jumped out, caught the team and prevented them from running away, which would have undoubtedly been dangerous to the life of Mr. Rogers in the perilous position he was thrown. He was taken to the home of his father-in-law, Mr. Humphrey, who lives close by, where he will remain until able to come to town. Medical aid was summoned and his shoulder reset. Word comes this morning that he is resting well, considering the accident.

CUT HER KNEE.

Yesterday evening a little daughter of Mrs. Maery, who has been visiting her mother, Mrs. Frazier, on Front street, was playing on the walk, and started to run, when she stumbled and fell on a broken dish, cutting her knee badly in two places. Dr. Holmes was called, and dressed the wound and the little sufferer is resting easy this morning. She will be compelled to remain indoors a week or so.

BROKE HIS ARM.

George Allingham, a young man who lives in North Salem, had the misfortune yesterday morning to break his arm. With some other boys, he was jumping over a board, each trying to see who could make the highest running jump. Allingham ran and just as he made the rise his toe caught on a board and he was thrown to the ground. He tried to save himself by reaching out his arms. The result was that he fell on his left wrist, breaking it. Dr. Richardson was called and set the broken member, and the boy is doing well, but will not exercise his talents in jumping very soon again.

THROWN FROM A CART.

Last evening about 6:30 o'clock, while John Holman, foreman of Drake's foundry, was out driving, he was thrown from his cart while making a sudden turn. Holman was driving to the depot and was riding in a small cart. He was going at a good rate of speed and started to go up into the driveway on the south side and as he turned the cart tilted to one side in such a manner that he was thrown violently to the ground and received a bad scalp wound, besides a number of bruises on his face and head. Had he fallen three inches farther east he would undoubtedly have been instantly killed. A number of persons were out at the depot at the time, and saw the accident and ran to his assistance. He was placed in cab and brought up town, when medical aid was summoned and his wounds dressed. To-day he is resting easy, although pretty well shaken up. After he was thrown to the ground the horse ran away and the cart came in contact with a post at the north end of the depot platform which caused a sudden stopping of the horse and a badly demolished cart.

JUMPED FROM A DRAY.

At noon to-day Chas. Winters, the sixteen year old son of L. S. Winters the grocer, met with a painful and dangerous accident that will cause him considerable pain. He was riding on a dray and attempted to jump off when his hand was caught on a hook and three bad gashes in the back of his hand around the thumb was the result. Dr. Rowland dressed the hand. It took eleven stitches to bring the hand together. The boy was then conveyed home, where he is resting easier but suffering from a number of pains.

Badgerow, crown attorney for the past three years.

A SUICIDE AT ST. PAUL.

Richard Garvais of St. Paul Blows His Brains Out.

Word reached Salem this morning of the suicide of Richard Garvais, better known as "Dick," at St. Paul, on Saturday evening.

Garvais is an old Frenchman that has been in that locality for about six years, working around among the farmers with whom he could find work. He was a quiet and unassuming person and had little to say to anyone. He has been working of late for Mr. Coleman on the farm. He lived by himself in a little shanty and has made that his home since his coming.

The first known of the crime was Saturday evening when Charles Pelland was riding along the road and discovered Garvais in a fence corner, with his head almost blown away. He was lying within about one hundred yards of his little shanty and had the appearance of having been dead several hours. Pelland quickly made the fact known at St. Paul, and a number of persons hastened to the fatal spot. The constable summoned a jury and held an inquest, the verdict of which was "that the deceased had met his death by his own hands."

An old Springfield musket was found beside him, and it was with this that he killed himself. Part of his head and brains were blown some thirty feet by the shot. It was almost impossible to recognize him as he was so badly disfigured.

No cause is assigned for the rash act, only that he had become melancholy and was disgusted with himself and the world at large, and decided to end his miserable existence as above stated.

Obtained Money Falsely.

Smith Bruer, who has been interested in the running of a restaurant at Dallas, was arrested and brought to this city Saturday, on a warrant sworn out by Mrs. Catherine Beaty, charging him with having obtained money under false pretenses. Mrs. Beaty is the grandmother of Frank Starr and she alleges that she gave Bruer \$100 for an interest in his Dallas restaurant. The restaurant has gone up and with it Mrs. Beaty's money. Bruer was arrested this morning before Justice Goodell and took until to-morrow to plead. The case will be heard at ten a. m.

The Body Recovered.

A gentleman who arrived up from Oregon City this morning says that the body of Robert Stewart, the man who went over the falls there Wednesday of last week, was found yesterday by two fishermen, floating in an eddy 200 yards below the falls. A bad cut on the head indicates that he struck a rock when he was hurled over the falls. Nothing is known of him except the name on the company's pay roll.

Insane Commitments.

Benjamin Harvey of Forest, Jackson county, aged fifty-four years, was committed to the asylum to-day for the fourth time. The cause of his insanity is intemperance in his habits, with a desire for women, he being a bachelor. He gets up at night, walks two miles and reads to himself. John Drishell of Portland, aged fifty, was brought to the asylum to-day for treatment. His insanity is caused by intemperance. This is his first attack.

Articles of Incorporation.

The Pendleton street railway company have filed articles of incorporation with the secretary of state. The aim is to construct and operate a street railway either by horse or motor power; capital stock \$25,000. The incorporators are J. E. Bean, T. J. Donaldson, G. W. King, J. D. Murphy, J. H. Raley, L. Reith and J. P. Wagner.

Articles of incorporations were to-day filed with the secretary of state of the Klamath river lumber and improvement company, with principal place of business at Portland, with a capital stock of \$500,000. The incorporators are J. E. McLaughlin, James Steel and W. S. Rungton. The object of this corporation is to deal in real estate, lumber, construct saw mills, etc., and improve navigable streams of water in the state so as to carry on a lumber business.
