And Still They Come.

Dr. W. S. Mott arrived in the city yesterday with his family, from Williams Grove, Pa. Dr. Mott was here during the winter, when he purchased residence property on Commercial street. He now returns to become a full-fledged Oregonian and will cast his future lot in Salem. His family are spending a few days with their old friends and neighbors, Mr. White and family.

There also arrived here yesterday L. H. Rowland and son from Mt. Gilad, Ohio. They were here last fall and took such a liking to Salem and the valley that they decided to locate among us. Mr. Rowland purchased property here and comes prepared to make Salem his home. He brought a car load of household goods, including a fine driving horse, blooded chickens, etc.

Judge Dawson Dead.

Judge William Dawson died at his home in Monmouth Sunday evening of heart disease and dropsy.

Judge Dawson was born at Northumberland, Scotland, Dec. 21, 1816, and was raised in England, received his education in Scotland, and came to the United States in 1838, and to Oregon in 1845, crossing the plains with the Stephen Meek party, and first settled in Yamhill county, near McMinnville, and was commissioner of that county for several years. He was a Mason of fifteen years' standing, and a member of the Christian church since 1849.

The Modoc Arrived.

Last evening the new steamer of the O. R. & N. arrived in Salem on her first trip southward from Portland. She was bearing a sixty-five ton burden and made the trip up easily. Leaving Portland at six a. m., she made ten stops during which she received and discharged cargo, and arrived at the Salem wharf before six o'clock. This time she will discount materially as soon as her machinery is worn a little and she is accustomed to the route. This light draft steamer will be a boon to shippers, as it is proposed to keep her on the route during the entire year.

The Fire Chief.

The election held by the fire department yesterday did not close until late in the evening. The voting was quiet, but a lively interest was taken. The candidates for chief were T. A. Howard, of the Capitals and G. G. Bingham, of the Alerts, endorsed by Tigers. There were cast 128 votes, of which Bingham received a majority of fourteen. For assistant chief A. J. Basy of Tigers was elected without opposition.

Gone Back to Denver.

Frank Raven, who was arrested by Sheriff Croisan on information telegraphed from Denver, was taken to Colorado yesterday to appear. A detective came after the man and Raven consented to return with him. The charge is forgery, but as the young man is of good connection it is probable the matter will be settled by a compromise.

One More Sale.

H. Bartholemew, who resides on his farm about three miles north of Haystack, sold twenty acres of his farm to H. W. Cottle for about \$65 per acre. Mr. Cottle owns some land next to this place and can now join them together, making him a nice farm.

Work Will Begin.

The contracts for the construction of the new stalls for use of the horses of the speed rig have been let, and work will begin on them at once. This improvement will be one of the greatest convenience and will keep the speed departments near together. Every indication is that the fair this year will be a great success.

A Runaway Accident.

A runaway occurred near Hubbard yesterday. Mr. Hink's, father-in-law of Oliver Darling, baggage clerk at the depot, was thrown out of the vehicle and had his ankle badly sprained. A doctor from the city was sent for and Mr. Hink is resting easy to-day.

Fell From a Tree.

A little son of Mr. Eley, who lives on Summer street, fell from a tree this morning and was badly injured. The little fellow was knocked senseless and had his wrist badly sprained. At last accounts he was resting easy.

ACCIDENTAL SHOOTING.

A Little Boy and Girl Receive a Charge of Bird Shot.

There was a serious accident near Turner last evening, which came near resulting in the death of the little son and daughter of Mr. Wagner, a farmer of that vicinity. The accident is the result of the careless handling of fire arms.

Mr. Wagner and his family who live on Jackson Mill about nine miles southeast of Salem, on the Jefferson road, were out blackberrying. Mr. Bruce, son-in-law of Mr. Wagner, whose home is in Portland, was visiting the family and on the way home they discovered a few birds. Mr. Bruce took the gun and shot at the birds and stunning one of them by the shot he was told by one of the party to shoot again before the bird could fly away. In the meantime, the little son and daughter of Mr. Wagner were running around in the bushes. Mr. Bruce shot at the bird, the greatest part of the load striking the two children.

The little boy received severe wounds, but as the gun was loaded with fine shot he may recover. The little girl's body was also perforated by fine shot.

Three physicians were at once summoned and have been in constant attendance since the accident. They give it as their opinion that the children will recover, as the shot did not penetrate vital points and as the shot were very small. From the body of one of the children over forty shot have been taken. One of the shot struck one of the children just above the eye, making a most dangerous as well as a painful wound. The physicians have probed it but without success.

This morning the children were resting easily, nursing their wounds. Mr. Bruce, who fired the shot, is alarmed and severely censures himself for his carelessness.

THE STATE TEACHERS' INSTITUTE.

The Second Day—Many in Attendance—Annual Election of Officers.

Yesterday evening the state teachers' association opened. A large number of county and city superintendents and teachers from all parts of the state are present. The program commenced last evening, but the department of superintendents met late in the afternoon and elected the following officers: President, W. A. Wetzel of Multnomah; vice president, T. V. Hutchinson of Douglas; secretary, F. Rigler of Clackamas.

The following committee was appointed to report on the advisability of forming a state reading circle: Superintendents Pierce of Umatilla, Baker of Yamhill, Hutchinson of Douglas, Rigler of Oregon City, and Randle of Marion.

The evening session was devoted to the hearing of the lecture of Prof. L. F. Copeland of Harrisburg, Pa. The subject of his lecture was "Snobs and Snobbery" and he entertained the large audience completely in his brilliant enunciation of what he terms truths.
