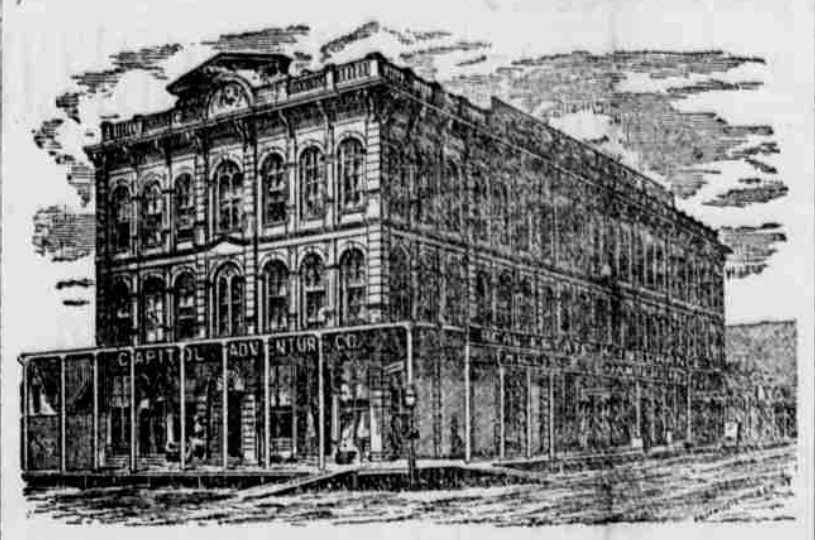

AN IMPORTANT ARREST. The Train Wreck the Result of A Practical Joke. THREE HARVEST HANDS DID IT! Wanted to have Fun by Running the Train to Lebanon.

Special to the Capital Journal. ALBANY, Or., July 31, 3 p. m.—W. A. Hill, a harvest hand who has been laboring in the vicinity of Lebanon Junction, was arrested this afternoon by the authorities of Linn county, charged with displacing the railroad switch at Lebanon Junction Sunday evening. The engine demolished, and engineer Jack Miller killed and fireman Quint Guthrie seriously if not fatally wounded. The officers succeeded in arresting Hill and are after two other harvest hands whom Hill says were accomplices. When asked why they displaced the switch, Hill said one of the others did it to run the train to Lebanon as a joke.

Small Attendance. CHICAGO, July 30.—Department commanders of the G. A. R. from Illinois, Iowa, Minnesota, Missouri, Indiana, Michigan, Kansas and Nebraska had a long session here. A decision was reached that the posts represented, approve and accept the manifesto issued in this city, July 2, in which a general attendance at the encampment was discouraged if the railroads did not recede from their position, and that some time in the future the representatives present will issue a circular that will be signed by eight department commanders and possibly more, withdrawing the departments represented from the parade advertised to take place.

Natural Gas Struck. ELLENBURG, W. T., July 30.—The coal company, while engaged in boring for coal at Roslyn, at a depth of 480 feet struck a flowing well, which throws a volume of water forty feet above the surface. With this stream is a strong flow of natural gas, which burns with great brilliancy, and is attracting crowds of people to witness the grand spectacle.

Canada Is Alarmed. SAN FRANCISCO, July 30.—The steamer Dora arrived from Behring sea last night, and brings the first detailed account of the capture of the British sealer Black Diamond by the United States revenue cutter Richard Rush. July 11, the Rush overtook the Black Diamond, and ordered her to heave to. The captain of the Black Diamond refused to do this. Thereupon the commander of the Rush ordered the lowering of the ports and the turning out of the guns, which caused the schooner to heave to.

Sixty Dervishes Killed. CAIRO, July 30.—Advices from Assouan say the advance of Dervishes continues, though slow. A skirmish occurred yesterday between the Egyptian patrols and Dervish outposts. Sixty Dervishes were killed. The Boulangerists. PARIS, July 30.—La Presse, the Boulanger organ, accused the government of falsifying 3,000,000 voting papers at the election Sunday. The corrected returns show that Boulanger is elected in twenty-three cantons.

More English Capital. NEW YORK, July 30.—An English syndicate has offered H. R. From them details of the wreck are learned for the first time. Cape Lisburne was sighted the morning of October 31.

A Noted Outlaw. BIRMINGHAM, Ala., July 30.—Rube Burrows, train robber and general outlaw, for whose capture \$8000 is offered, with four companions is defying state authorities in mountain fastness. The sheriff of Lamar county has asked the governor for militia.

Disastrous Earthquake. YOKOHAMA, July 30.—A dispatch from Neguzaki states that a dreadful earthquake occurred in the western portion of the island of Kiu-siu. The town of Kamoata was destroyed and many people perished. A vast amount of property was destroyed.

White Lead Monopoly. NEW YORK, July 30.—The World this morning says the Standard Oil company has bought up all the white lead companies in the United States, the estimated amount being \$30,000,000.

CONDENSED DISPATCHES. The New York printers declare they will resist all attempts to lower their wages. The greenback party is preparing to take an active part in the political field this fall. Riots were indulged in at Cincinnati over the attempt to prevent the selling of liquor Sunday. Hundreds of persons have been killed by a cyclone in Hungary, and enormous damage done to houses and crops. Don Pedro's assault says he was instigated to make the attempt on the emperor's life by the republican association of Brazil. The elections in France for members of the council-general, was generally quietly conducted. The Boulangerists are badly defeated, electing only 12 members out of 550.

OCCIDENTAL JOTTINGS. An Albany man has an ingenious invention in the way of a harvester. It is a patented combined header and thrasher and is drawn by twenty-two horses. Its manufacturer claims for it that it will take the wheat standing, cut and thresh it, leaving the grain sacked ready for market.
