Change of Management.

Hop Growers Wait.
Some of the Portland hop dealers are putting off wonderfully wry faces. One of them informs a reporter that "on account of the large crop in Europe and the east, hops are inactive. There is no market for them and no market price. I have not an order for a single pound of hops, and if a lot of hops were offered now I would not know what price to name for them. Those who made contracts for them at 12 1/2 to 15 cents last fall are fortunate." Just such wails as this have been heard before; hop-rabbers have become frightened and sold for most anything they could get. Our Polk county hop-growers should turn a deaf ear to all such howls, and "lay low" for future development in the hop market.—Dallas Observer.

Cause of Newburg's Fire.
Chas. Mosburg, who recently lost his store by fire, was arrested in Portland a few days ago on a charge of arson, and taken to Yamhill county for trial. The building and stock were insured for \$2,500. Mosburg claims he lost \$1,500 in excess of the insurance and that enemies burned him out. At the time of his arrest he was rebuilding in Newburg, and he was in the metropolis buying a stock of goods. He formerly owned a grocery store at Eugene. It is claimed that the insurance was much more than his stock, which was very low, and he fired the building as a speculation.

Back from Alaska.
Among the passengers who were on the steamer Ancon when she went to pieces in the northern waters was Capt. M. W. Hunt of Salem. He was returning from Omak, where he had gone to look after the commission to which he had been appointed under the present administration. It is probable he will not return. On the same vessel was D. N. Murphy who served Marion county as county clerk two terms during the seventies. Mr. Murphy has resided in Alaska for the past six years and returns accompanied by his daughter and son-in-law, Mr. and Mrs. D. Sonney. This party arrived in Salem last evening.

The Santiam Mines.
The Gold Mountain and Dry Gulch gold and silver mining company have most encouraging reports from the Santiam mining district. Old miners say that the lower they go the richer the finds, as the soil is so loose the metal settles. Already some good sized nuggets have been found, and they are hopeful of striking some rich leads as soon as active mining operations are commenced. Old miners who have visited the mines of the Santiam give it as their opinion that much gold will be taken from them when worked.

Lively Runaway.
About twelve o'clock to-day a buggy and horse belonging to Mrs. Richard Dearborn of South Salem, took quite a lively run. Miss Zaidie Palmer was in the buggy, and after the horse had run a few blocks she succeeded in stopping it. No damage was done but Miss Palmer was badly scared over the event.

Small Fire.
A small fire occurred last night about one mile from the city. Five or six acres of ground was burnt over and about forty rods of fence. The property is owned by Thomas Davidson and is on the line of the O. C. R. R.

Mind Over Matter.

During the recent institute at Roseburg the Plaindealer says that while Prof. Hull was lecturing upon the nervous system he incidentally alluded to "soul force" or power of mind over matter. This remark called out a little discussion that led to a reference to spiritualism or mind readings as it is called. The professor, in order to prove his theory of mind reading, tried his power upon Miss Hoxie. After Miss Hoxie had been blindfolded, a pocket knife was placed upon one of the desks several feet in front of her. The professor and an assistant then, placed one hand each upon Miss Hoxie's shoulders and stood still for about three minutes, when Miss Hoxie moved forward, under the mental impulse the professor claimed to have exercised upon her, and placed her hand upon the knife as unerringly as if she were not blindfolded and knew where the knife was. Prof. Hull claimed that his knowledge of the locality of the knife, by his will force, was communicated by contact with that of Miss Hoxie through the nervous forces and moved her mind to be cognizant of the object he had in his mind. This he claimed was the philosophy of mind reading or spiritual phenomena, but he denounced as false the return of disembodied spirits to influence the minds of mortals or communicate with them.

Articles of Incorporation.
Articles of incorporation were filed with the secretary of state to-day as follows: The Tide Creek dam and boom company, with S. Kinder, A. P. Usher and B. C. Egart as incorporators; capital stock, \$2,500, divided into twenty-five shares of the value of \$100 each. Some of their business is to erect a boom across Tide Creek for the purpose of driving logs and timber into. The principal office shall be at Tide Creek, Columbia county, Oregon. The United hack, truck, livery company of Oregon City. Their business is to construct and carry on a livery and sale stable, and the running of drays, wagons, hacks and other vehicles for the conveyance and transportation of passengers and baggage and all kinds of freight. The capital stock is \$20,000, divided into shares of \$100 each. With C. B. Clement, J. W. Noble, W. H. Cook and H. F. Johnson as incorporators. The principal office is in Oregon City.

Astoria's Railroad.
A gentleman identified with the Astoria & South coast railway was in the city yesterday, and judging from his remarks, the report of the railroad meeting held at Hillsboro Wednesday evening was not so full as it should have been. Old-timers talked encouragingly, and further, proposed to see that the road was built. The meeting was very enthusiastic, and the outcome was refreshing to spectators. "Hillsboro is all right," said the gentleman referred to, "and will put up her money without ceremony. The line is being located as far as money and men can do it, and Astoria will have a road in a short time."—Pioneer.

Accepting the Lines.
Yesterday afternoon Manager Koehler of the Southern Pacific's Oregon lines came to Salem and drove over to Macleay, where he was met by Receiver Scott of the narrow gauge. It will be remembered that the Southern Pacific recently purchased the lines of the narrow gauge and they are now being turned over to the purchasers.

High License.

(Correspondence of the Capital Journal.)
The saloon men will tell you that "to demand license or tax of liquor dealers is a burden on them. Thousands of poor men either know or can do no other business. Why tax them more than other people? Do you tax a blacksmith, a baker, a stone-cutter? If you must tax, put it on all alike."

Yes, that is just how they talk and think. They actually believe they are in a business like other people, doing good, aiding the world to create or exchange wealth, and building up society. And so they are, to a certain extent, but their business is accompanied with an awful amount of evil. The only good they do is in helping to exchange and consume a large amount of product which would be far better limited in its amount to a third of the present quantity and then disposed of under certain restrictions and limitations as to its retail. But you must convince people of this first, and you begin it by license. Can any man in his sober senses favor the unrestricted selling or giving away of liquors? Take up any daily paper that gives a full, true report of the doings for any day in the cities. I take the first at hand—"Times." It does not pretend to report the effects of the liquor traffic, the number of drunks, the quarrels and fights around saloons, the sickness, the misery. It would be impossible. But here is an item: "A colored man who acts as porter for a saloon tried to carve with a dangerous carving knife those who happened to pass along the side walk. While attempting to cut and stab an old man who was passing by, he fell down insensible and was carried away to sleep off his overload of grog."

The foregoing is a fair sample of the work turned out by the saloon. Are your wives or daughters walking the streets of the great church going town? They are liable at any time to be assaulted, or insulted, or are in real danger of bodily harm from men who have put the enemy in their mouths to steal away their brains. The world is bad enough, God Almighty knows, in its best estate. Famine and pestilence, earthquake and storm, poison in air and water, accident—these destroy millions. But their results are a mere trifle compared with the evils man brings on himself by his accursed greed which is the father of slavery, tyranny, monopoly, war, intemperance. Pandering to the greed of a few society endures the most horrible evils. To-day we can in truth indict alcohol among the head evils lingering upon earth. And the man who retails liquor is not doing an act that can properly be called business. He is doing not only no good but a vast deal of harm. Even if the use of wines and beers is needed at the table in many cases, and is indispensable in disease—all of which I believe, still it is no excuse for the everlasting tipping that is fostered and encouraged by having grog shops at every corner. The men who sell tobacco do no great harm; those who retail cakes and candies do little good, but those who are eternally sticking their grogshops everywhere to tempt the feeble and ignorant, so that poor hard working men going home with their earnings are tempted at every ten steps, are plying their trade till it is a nuisance. Tax them out of existence. The occupation has no excuse. It is an evil and must be regulated. It cannot be abolished nor prohibited, but it can be regulated and the lines around it can be drawn tighter. I would discriminate between victuals who furnish light wines or beers at tables of guests and those who merely sell grog to drink. Fanaticism can never master the evil. Why there were people actually all through the South during the days of slavery advertising temperance and prohibition. Yes, living under and upholding an institution which was in itself the "sum of all the villainies of earth," which was legalized robbery, murder, theft, adultery, prostitution, tyranny, the very fiends and mock of God and man, they made a terrible ado about the small pimple of intemperance. So to-day there are many terrible general evils in the world, evils of man's own creating. Many of these evils do doubtless increase that despair and rage and want that drive men to intemperance. Let us act wisely and try to reform the evils in the world. We cannot abolish at once. It may not be wise to do so if we could. Doubtless many of the evils are permitted for a wise purpose.
