A BLOODY LAMB.—In reading of the history of the last woman sent to the penitentiary the writer is reminded of a little history of the first. Her name was Lamb. She had one daughter and three sons. Her husband needed killing, but his wife was hardly the proper person to do the work. The family lived about six miles north of Oregon City, near the railroad station, "Clackamas," on a donation land claim selected by the husband. He was a cattle thief and had made way with a number of cattle belonging to emigrants, and spent most of his time in hunting a favorite pasture time of the early pioneers. He and a neighbor who had been absent several days on a hunting tour and returned late in the evening, laden with the fruits of the chase. Mrs. Lamb and the daughter hurried up supper and the neighbor was urged to remain but he preferred going on home, and he left the family apparently in the best of feelings. Supper was ready and the family all sat down, when a letter was observed by the father, protruding from the bosom of the daughter's dress, and, as she had a lover whom the father did not approve, he requested to see the letter. She refused, and went out of the room. The mother arose, and, passing behind the husband, took a sharp axe from behind the door and, while the husband continued eating, she deliberately struck him three terrible blows in the back of the head, neck and shoulder. She then turned and fled. The husband staggered to his feet and followed her to the yard, where he fell, and the brains as well as the blood freely flowed from the wound in the head. The woman ran to the neighbors and gave the alarm and they, coming to the place, found the man as he had fallen, conscious, but yet unable to rise, and, strange as it may appear, did not die for six or eight days after the affair. The woman was confined in the jail at Oregon City and attempted to play the crazy dodge to escape punishment, and she was only saved from the gallows by the fact that the law could not be enforced without inflicting punishment on the innocent. She was sent to the Oregon penitentiary for life. Her babe, a son, was born within the prison walls. As she gave the authorities so much trouble with her mean, devilish acts they entered a complaint and had her conveyed to the insane asylum, where her punishment was equally as great as behind the prison bars. The records of Clackamas county might throw some light, or rather clouds, over the character of this woman which it would be just as well for the people not to know, suffice to say that this Lamb was a bloody, scheming wretch, unworthy the name of woman.

THE WORLD'S RECORD LOWERED.—At Terre Haute, Indiana, on the 11th of this month, Axtell, the famous 3-year-old stallion, broke the world's record that afternoon, going a mile in 2:12. The little bay went with a running mate and was driven by his owner, Williams. Axtell came down to the stand at tremendous speed. He got the post, went up the course at a 2:10 gait and reached the half mile post in 1:05. The crowd went wild and when the wouder kept up this rate to the three-quarter post, it was evident the record was to be broken. He came under the wire without a break. Thousands of spectators went crazy and broke into the track and quarter stretch and carried Williams over the course and surged about Axtell. Never before was such a scene witnessed on a western race course. President James, of the trotting association, proposed three cheers for Axtell, Williams and the Terre Haute Trotting association. Axtell's record is 1/2 seconds better than the 3-year-old world's record.

The latest thing to be exposed by the CAPITAL JOURNAL is a confidence counterfeit money to a Salem gentleman who in turn hands the following letter to the JOURNAL. It will pay everyone to keep a sharp eye open for these sharpers and many a person who is not satisfied with this earthly goods that is made by the sweat of the brow are biting or have now in their possession some of these "goods" ready to dispose of them to the innocent. Take advice in time and look out when a stranger tenders you a large bill for change or part payment for some purchase made.

Following is the letter received by the gentleman mentioned above but who requests his name to be kept out of print.

PHILADELPHIA, Pa.
MR. —: MY DEAR FRIEND—I wrote you recently and gave you full information about my business, I explained to you what a fast, easy and safe money-making business it was. I also told you how you could telegraph me for instructions in order that you could come on here and make a face-to-face deal, as I always consider that plan the best. I then told you if you could not come on, or did not have \$300 to invest, to simply let the matter drop until you heard from me again. You have done exactly as instructed; you have been guided by my advice, and I am proud to say, that I believe you would do me no harm, and would make me a true and honorable friend. Now my friend, do not ask me to do business in any other way, as I shall refuse. I have to pay big money for the use of these plates and I am not in this business for charity or love. In conclusion, to make you doubly safe, and to prove to you that I am a square white man, I have requested my bankers with whom I have a large account, to write to you and tell you what kind of a man I am. They, however, do not know what line of business I am in.

In ordering state how many of each denomination do you want. If you want them made to look old and worn I will do it for you. I will send them to you new or old just as you wish.

I do not care whether you accept my proposition or not, as I greatly prefer to transact my business in person. If you come here for the goods at my rates (and buy not less than \$200 worth) it would please me better than to have you send me money. Should you conclude to come on, and make a face-to-face deal, and invest \$300 or more, simply say "Send instructions."

Sign your name always as per "pass word" and number given you. Trusting you will make up your mind to come here instead of remitting, and that you will let me hear from you at once, I am, my dear friend, very truly yours, in honor, friendship and love.

Along with the letter is a letter of recommendation from a firm who style themselves as Simmons Bros.

& Co., bankers, with a capital stock of \$1,500,000. The money dealer's name is signed Charles Wilson.

SENATORS COMING WEST.

They are After Information by Which to Settle Large Railway Issue—Will Probably Visit Salem.

On Saturday Leland Stanford, and A. F. Towne, Creed Haymond and L. M. Clement left San Francisco for Oregon to meet the United States Senate Committee on Pacific Railroads, consisting of Frye of Maine, Chairman; Daves of Massachusetts, Davis of Minnesota, Hiseock of New York, Butler of South Carolina, Morgan of Alabama and Hearst of California.

The committee is now traveling in special Pullman train over the Union Pacific road, and will arrive on today (Monday). It will immediately come over the Central Pacific in company with Senator Stanford and the other gentlemen mentioned. The train will run on special time, stopping at whatever place the committee desires. It is expected that quite a number of stops will be made coming over the Sierras, so as to give Stanford, Towne and Haymond an opportunity to explain what a gigantic piece of work that was, and why, in their opinion, it cost more to build over those mountains than it would have cost to construct a road from their eastern slope clear through to Chicago.

On arriving in San Francisco the committee will take a rest for a few days, and then go over the California and Oregon road to Portland. From Portland it will go over the Oregon Short Line, and then back East over the Union Pacific.

The committee has an important work to do. It came into existence at the last session of congress, the objects of its creation being two-fold. To it was referred the report of the Pacific Railway Investigation commission, a very lengthy document on the operations of the Union and Central Pacific roads, their government indebtedness, and how the same should be collected. It was also instructed to prepare and report a plan for the final settlement of the debts of these roads. Some progress has been made in the matter, and for the purpose of getting additional information to guide it, the committee is taking its present trip.

It has made a report concerning the settlement of the Union Pacific's debt, but it was referred back, with instructions to include the Central Pacific in the report.

These notable and distinguished gentlemen will, no doubt, pass through Salem one day this week and the business men of the capital city of Oregon should try and provide some way to have them spend a few hours in the city. It may have immediate good to the city and on the other hand it may prove to be worth thousands of dollars to the city. It can undoubtedly be easily arranged and the JOURNAL hopes to see some disposition on the part of Salem's enterprising citizens shown in this matter. Even if these gentlemen do not intend to build a branch railroad, their little stay in the city no doubt will make a favorable impression on their minds of the city that to-day is the pride of the Willamette valley, and when Senators Mitchell and Dolph spring out proposed postoffice bill, these gentlemen, having seen the surroundings of Salem, will, with out a doubt, support that measure with all their strength. Come to the front, citizens.

A BLOODY BULL.

John Calvin Sons is Severely Gored By a Fractious Bull—The Third Victim.

Sunday evening a young man known as John Calvin Sons, well known in this city, was severely gored by a bull, on the farm of Thos. Davidson, about one mile south of the depot. Sons has only been employed on the farm for the past two weeks. He was formerly employed at the Chemekete hotel, and was a young man who was well liked. It seems that on yesterday evening Mr. Davidson was unwell and for the first time sent young Sons out to care for this famous leucis, that has come near causing the death of three persons. Mr. Davidson warned him to use precaution and to not get in the same lot with the "critter," but Sons had not been gone but a short time until Mr. Davidson's little boy came running in and told his father that the beast was after the hired man. Mr. Davidson went at once to the poor victim's rescue and soon beat the man-killing beast off. It was then discovered that Sons had received several very bad wounds, one in the lower part of the bowels, one over the shoulder, and also two severe wounds near the base of the spinal column. Dr. J. N. Smith was immediately summoned and dressed the wounds and this evening the young man is resting easy, yet is in a bad condition, although the doctor does not consider them dangerous.

This same animal has come near killing three different persons, and this morning an end was put to his career by taking him out and killing him. Only about three weeks ago an accident similar to the above occurred at the same place.
