A Thief's Conscience.

SAN JOSE, Oct. 19.—C. F. Smith, who has been working on a ranch near Madrone, to-day surrendered himself to Deputy Sheriff Erwin Frost, saying that while working as cook in a hotel in Bucoda, W. T., in June last, being temporarily left in charge of the house, he stole \$410 from his employer's trunk and came to California. His conscience has given him no rest since that time, and he desired to give himself up and make restitution so far as possible. He says he can refund all the money except \$120. A telegram from Bucoda this evening says Smith is wanted there and further particulars will be sent to-morrow.

The Forestry Congress.

PHILADELPHIA, October 20.—In the closing session of the American Forestry Congress to-day B. G. Northrup read an essay on "Arbor Day in the Schools," in which he showed that the vernal holiday is now being celebrated very generally. He said that the children were planting millions of trees, California taking the lead. A resolution was adopted asking congress to withhold public lands from sale until the timber is old enough to cut. Hon. James A. Beaver, of Pennsylvania, was elected president, and the meeting then adjourned sine die.

LATEST BY TELEGRAPH.

WRECKED BY A TIDAL WAVE.

Eight Hundred Lives Lost in a Japanese Flood Recently.

YOKOHAMA, Oct. 1.—Japanese papers give an account of another disaster which occurred on September 11th, the same day hundreds of buildings and nearly all the gardens of Yokohama were wrecked by a typhoon. Most of the damage was done by a tidal wave, which swept away about 800 people and ruined over 2000 houses. The coast of Owari and Mikawa, on the Gulf of Owari, and of Miyagi Prefecture, near Shioyama, was the scene of the calamity, of which the Mainichi gives the following account: Heavy rains were experienced in the vicinity of Hazugori, Mikawa province, on the afternoon of September 11, and about 8:30 p. m., a large tidal wave invaded the sea coast. Many embankments were destroyed and the sea soon spread inland. The wave is said to have been 15 feet in height in Yoshidamura. A large number of buildings were carried away in various villages and much loss of life caused. In Oguri-Shinden 23 houses were swept away, and out of 90 persons 54 were killed. In Koyabumura over 40 houses were carried away, and out of 250 persons 60 are missing. In Ikutamura 120 houses were carried away and 20 others were crushed, 40 persons being drowned. In Yoshidamura out of 650 houses 350 were swept away, and out of 3200 persons 428 lost their lives. In Tobamura, out of 220 houses and 1130 population 12 houses were crushed and 40 persons were killed. The total number of bodies recovered is 369, and 250 persons are missing.

The Samoan Imbrolio.

WASHINGTON, Oct. 20.—Secretary Blaine declines to speak of the question regarding Germany's illegal refusal to recognize the recently elected King Mataafa of Samoa. It is stated in well posted quarters, however, that the United States cannot take strong ground in opposition if Germany makes this stand. Germany yielded Tamasese, her favorite for kingship, and everything else in the negotiations, and it is not surprising that she objects to this defiance from Mahieton shown in Mataafa's election. It is thought that the United States will try to get him to resign.

The Oldest Moonshiner.

JACKSON, Tenn., Oct. 19.—Deputy United States Marshals Bell and Collier have arrived here, having in custody Bill Matton, the oldest moonshiner in southwestern Kentucky. West Tennessee officers have been searching for him for the past twenty-five years. He was captured on the Tennessee river while selling fish. In 1879 a posse went out from Mayfield, Ky., to capture Matton. He turned the tables, capturing their guns and routing the officers.

LIVELY RUNAWAY.

—Mr. O. H. Thomas, of Stayton, had quite a runaway, Saturday. He had been in Salem and purchased a fine goat of W. H. Byars and returned home and was unloading it from the wagon, when his team became frightened and ran away. It ran some distance and succeeded in totally demolishing the wagon. No one was injured.

NOTARY PUBLIC.

F. M. JOHNSON and B. M. JOHNSON, of Corvallis, Robt. G. Morrow, of Portland, were appointed notaries public by the governor to-day.

ADDITIONAL CITY NEWS.

COOS COUNTY MURDERER.

To Suffer the Penalty for Committing One of the Most Cold-Blooded Crimes Ever Perpetrated

(Correspondence of the Capital Journal.)

EMPIRE CITY, Oct. 17, '89

During the last week this city has been thronged with people who have gathered here to listen to the trial of John Gilman, the Coos county murderer.

The case was called on Tuesday, the 15th. Judge Bean on the bench, James Hamilton prosecuted for the state and Hon. J. M. Siglen and Grady Owen defended the prisoner. About forty witnesses testified in behalf of the state. The evidence was very conclusive, and, although the able counsel for the defense did all in their power to save their client, the jury returned a verdict of murder in the first degree, after being out of the court room only twenty-two minutes.

At 4 o'clock this (Thursday) afternoon the prisoner was arraigned for sentence. The attorneys for the defense made a motion for a new trial, which was overruled. Judge Bean then pronounced sentence upon the prisoner, which was, that on the 13th day of December, between the hours of 10 a. m. and 2 p. m., he shall be taken from the jail and hanged by the neck until dead.

John Gilman, the murderer, is an old, gray-haired man. He stands erect and is over six feet high; has mild blue eyes, and does not look like a man who would commit a murder.

The crime for which he has to suffer death, was committed on the 13th day of July, last, on the Coquille river, about three miles above Coquille City. A man by the name of Eatonhover, whose family consisted of himself, wife and one child, were living in a rented house on Gilman's farm, where they had resided for a year past. Mr. Eatonhover was away from home during the week, working in a logging camp, and only came home on Saturday night. Gilman, for some cause (which did not appear in the testimony at the trial) on Friday morning, July 13th, went to the residence of Mrs. Eatonhover and killed her at a spring near the house, where she was in the habit of going for water.

She was supposed to have been knocked down and then choked to death, as there were bruises on her head and finger marks on her throat. The evidence also showed that her mouth and throat were stuffed full of moss. After killing her he caught her little five-year-old boy, choked him with a cord as he happened to have around his neck and he then took the child between his knees, and twisted his head around until he dislocated the vertebrae. He then concealed the two bodies in the cavity made by the uprooting of a large fir tree, and laid in wait for the husband and father; intending to kill him when he came from his labor the following Saturday night.

When Mr. Eatonhover, came home on Saturday evening Gilman assaulted him, when near his house with a club, (fearing to use firearms for fear of the neighbors hearing the report.) He felled him to the ground, and then attempted to cut his throat with a hand knife, inflicting severe but not dangerous wounds. Eatonhover being a young and vigorous man, after recovering from the blow on the head succeeded in making his escape and gave the alarm.

Officer Johnson, with a posse of deputies, arrested both Gilman and his wife, late that night. Both had blood on their clothing. Search was made the next day and the bodies of the woman and child were found.

It was with difficulty the officers at Coquille City, saved him from a mob after his victims were found; but better judgment prevailed and the law was allowed to take its course and Judge Bean and District Attorney Hamilton have the thanks of the entire population of Coos county for so speedily bringing this worst of criminals to justice.

Mrs. Gilman was indicted by the grand jury as an accessory to the crime. She has been in jail with her husband since July 16th, but is now out on \$3000 bond. Feeling at first was very bitter against her, but it has now begun to subside.

Gilman bore up and received his sentence with apparent indifference, but it is rumored this evening that after the balliff put him back into his cell he broke down and cried like a child.

A BAD ACCIDENT.—Henry Stout, of Mehama, met with a dangerous and painful accident on one day of last week. He was one of the many men employed at clearing the Quartzville road by the Gold Mountain and Dry Gulch Gold and Silver Mining Company. He was chopping away at a stick when the ax glanced, striking his foot between the second toe and splitting the foot wide open to the instep. The wound is a bad one, and Mr. Stout will more than likely be compelled to remain indoors for several months, if he does not lose his foot.

FIRE AT NEW ERA.—A dwelling house at New Era, a small station on the line of the O. & C. R., caught fire, Saturday afternoon, and burned to the ground. Some of its contents were saved but a large portion of them were burned. The fire originated from a defective fuse,
