THE regular winter snow storms in the Dakotas have begun. When the new United States senator are elected they will be in big luck if they are able to get through the drifits between the home and Washington.

GROVER CLEVELAND says he is satisfied with the recent elections. Grover expressed the same sentiment about a year ago, but he wasn't satisfied just the same. There is considerable difference between what the ex-president says and what he means.

ENGLAND pays out nearly \$9,500,000 a year in subsidies to its merchant marine, and it is money well expended. France is also building up a great commerce in the same way, it annual subsidy amounting to \$1,077,778. But what is the United States doing in this direction? Nothing; absolutely nothing.

A MEMBER of Canyon City, Or., was slowly strangled to death by a bungling hangman last Friday. It will be interesting to have electricity tried in Kemmerer's case in New York, for it is proved that the apparatus inflicted sure and pained death then we may expect to see it supersede the gallows. Under the present system, the only way to avoid judicial stranglings that torture the criminal, would be to appoint a state hangman, an expert whose skill and nerve would be proof against any incident on the gallows.

QUESTIONS AND ANSWERS. Editor JOURNAL: What is the Australian way of voting? Ans: The Australian system of voting is a systematic one and in many respects is widely different from the system practiced in the United States. To explain this system thoroughly, would consume considerable space but to make the system understood we submit the following.

In Australia the names of every candidate is printed on the same ticket. No matter if there is a democratic ticket, a republican, prohibition or an independent ticket in the field the name of each and every candidate must be printed on the one ticket, which work must be uniform—the tickets all of the same size and color, etc., etc.

Secondly: At the voting place, from three to six stalls or passages are arranged, and a voter starts in at the door of the voting place; as he enters he is handed a ticket by one of the judges, and walks on into one of the boxes, at the end of which a desk is arranged, and at this desk the voter looks over his ticket, and for those men he wishes to vote for he places a cross (X) opposite such name. He then walks to the ballot box and deposits his ballot.

No two persons are allowed in a box at the same time and no tickets are allowed to be circulated outside of the voting places. This is done to discourage political scheming and is said to work admirably. No person is given but one ticket when he goes in to vote and should he spoil the first one he obtains he is compelled to go to the judge and obtain a second one but not before the judge is satisfied that the first has been destroyed.

The above is a concise explanation of this voting system and a bill was introduced in the legislature of Oregon in 1877 by Wager, of Pendleton, to adopt this system in Oregon. The bill was read the first time and passed into the hands of a committee from which it failed to ever appear again. The system is now in vogue in Montana.
