COUNCIL MEETING TO-NIGHT.—This will be the first regular council meeting this year. A full attendance of all the city aldermen is expected, as much business is to be transacted.

Word was received this morning by Mrs. J. N. Shaw announcing the death of her sister, Mrs. Clara Wade, at Woodford, Cal., on last Thursday, of paralysis, aged eight years.

A DISTINGUISHED MEETING.—Capt. Geo. C. Ramey, Commander of the U. S. war ship Charleston, spent the day in Napa yesterday with Mrs. A. T. Cox of Oregon, a cousin whom he had never before seen and who for some time had been a guest of Mr. and Mrs. Wm. M. Boggs—Napa Daily Register. The Mrs. Cox referred to is a mother of Mrs. W. S. Boggs, of this city. Captain Ramey and Mrs. Cox had never met before. The captain is a fine looking man; forty-eight years old and also been in the navy thirty-two years.

THIRD OF LIVING.—Mr. Prunty, foreman of the track in the railroad yards at this place, was up to Junction yesterday on business for the company, and on his return this morning he brought the particulars of a man throwing himself in front of the train that passed here last evening 6:45. About one and one-half miles this side of Eugene a man stepped out on the track in front of the approaching train and the engine and baggage car passed over his body, severing both limbs and causing instant death. From letters found on his person it was learned that his name was Andrew Christie, and he was from Massachusetts. He had been stopping in the city for a week or two at the Minnesota House, and yesterday afternoon he paid his board and started north on the railroad track, this was the last seen of him until he was brought back to the city last night a mangled corpse. The reason for this rash act cannot be accounted for, as he seemed to be in good circumstances. He had about \$10 on his person when picked up.

TO SILVERTON WE GO!

The Motor and Belt Line Is Assured.

FAR BETTER THAN WAS EXPECTED

Salem Will Have Another Railroad in Operation in the Early Spring Time—Everything is Lovely.

We are informed that the Marion County Improvement company is about prepared to receive bids for material and construction on the projected and long-talked-of Silverton Motor Line and Belt railroad. Gen. Odell came up from Portland yesterday, and in an interview stated that his company is now prepared to begin active operations. The belt line about the city he says will be in operation about May the first, and the Silverton road will be finished a month later. This is good news, which our people will be greatly pleased to hear. The track will be a standard gauge and constructed of the best materials. A six ton motor will be secured for the belt line, which will accommodate about twenty passengers, and an extra trailing car for additional accommodations. Aside from this there will be sufficient additional rolling stock to operate the Silverton line, which will include a heavier motor, passenger and freight cars, etc. The above information has been hastily obtained just before going to press, and does not give any of the details of the enterprise. However, we expect to give all attainable information as fast as it develops, in the columns of the JOURNAL. Salem is to be congratulated upon the assurance of this first competing line of road. That she will have more is not doubted by any sane person, and that in the near future.
