CHILDREN ARE SNEEZING.

A Large Number of School Children Ill With La Grippe—No Let Up to the Malady.

A large number of the pupils in the public schools of Salem are kept at home by reason of colds, la grippe, or complications of that prevailing disorder. A JOURNAL reporter visited the East Salem school building this morning to ascertain how many of the scholars were ill.

Superintendent Handle being absent on account of a severe attack of the la grippe, your reporter found Mrs. Grubb attending to his duties, and this being examination day, she informed us that the attendance was larger to-day than it would have been had this not been the case.

Mrs. Grubb, having her own and the Professor's duties to look after, she invited the reporter to visit the several rooms and secure from each teacher the number absent, and the following is a complete list:

Miss Coper's room, 60 pupils enrolled, 16 absent; Miss Phillips' room, 60 enrolled, 28 absent; Miss Newton's room, 60 enrolled, 13 absent; Miss Mellon's room, 75 enrolled, 17 absent; Miss Northrup's room, 60 enrolled, 11 absent; Miss D'Arcy's room, 60 enrolled, 11 absent; Miss Allen's room, 40 enrolled, only 3 absent; Mrs. Grubb's room, 42 enrolled, 6 absent; Miss McNary's room, 34 enrolled, 8 absent; Miss Litchfield's room, 48 enrolled, 5 absent; Miss Van Wagner's room, 48 enrolled, 10 absent; Miss Gillingham's room, 56 enrolled, 13 absent.

The number absent last week was at least 150 more than this morning, but as the scholars are now passing through an examination for promotion each one is anxious to be present and be examined. The teachers said that they were well satisfied that a large number of children present who ought properly to be at home under medical treatment.

The number ill in the North Salem schools are slightly more on an average than at the East Salem schools and the same can be said of the South Salem schools.

Most of the teachers, by rigidly guarding their health in the early stages of this popular malady, "La Grippe," and so far no deaths have been reported caused directly from the disease. As it is, a little over 20 per cent of the scholars are absent, and studiously endeavoring to recover from La Grippe at their homes.

The absence of so many pupils have not prevented the regular bearing of classes in any of the departments, but the afflicted scholars will have to work harder to catch up with their classes when they return, to whom the pupils still attending school have not been serious enough so far to prevent them from pursuing their studies at school. The number remaining at home are still on the increase and it is quite possible that a much larger number of the scholars will be sneezing within the week. Probably a safe total estimate of the number of school children ill with La Grippe is 300.

A NEEDED IMPROVEMENT.—Supt. Geo. Downing has just completed an improvement that he will receive many thanks for. It has long been known that a walk connecting the Asylum with the penitentiary was much needed. Last fall Dr. Lane completed such a walk, a portion of the way and then lay it down. Mr. Downing to meet him with his part of the walk. On one day last week, the walk was completed, and now a good substantial four-foot walk from the asylum to the penitentiary is down for the use of those who may have occasion to use it.
