NEW BANK AT PENDLETON.
WASHINGTON, D. C., Mar. 6.—The comptroller of the currency has authorized the organization of the National bank, of Pendleton, Oregon, with \$100,000 capital, and with the following officers: Jacob Frazer, President; Thomas F. Roarke, Cashier.

EMINENT SAN FRANCISCO DEAD.
SAN FRANCISCO, Mar. 6.—The funeral of James Melvin Donahue, president of the San Francisco and North Pacific Railway Co., took place this morning. The remains were followed to the cemetery by an immense number of mourners, among whom were a number of delegates from Sias of Golden West and Fifth infantry regiment of national guard, of which he was a colonel.

EXCITEMENT IN CANADA.
OTTAWA, Can., Mar. 6.—There is much excitement here over the proclamation issued yesterday by President Harrison regarding restrictions as to the Behring sea fisheries. Members of parliament condemn the proclamation. One of them said to-day: "Just at this time, when negotiations are going on for a peaceful settlement of the matter, the issue of a proclamation looks like a slap in the face of Canada. No wonder that public indignation is aroused. We confess that the Canadian government could not do anything practically in the matter. They thoroughly deserve censure for their lukewarmness throughout on this question of the Behring sea which is one of most vital importance to Canada."

COUNTY COURT DOINGS.—In the matter of a private road for John Coleman through lands of Thos. and John Kirk, the latter filed motion to dismiss said petition, which motion was overruled, and a remonstrance against said road was stricken out and the road established as per petition. In the matter of a road running north from Mill City the report of viewers was read a second time to-day and the said road was ordered established. At 2 o'clock the court received a delegation of business men and citizens of Salem and surrounding country, and listened to arguments and suggestions touching the report of the committee on the Willamette bridge, but no conclusion is reached up to the hour of going to press.

IMPORTANT CHANGE.—The resignation of Prof. S. A. Randle as city superintendent of the Salem public schools, has been handed in, and accepted by the board of directors. An effort is being made by the board to secure for the position the services of ex-County Superintendent Geo. A. Peebles, who is now principal of the McMinnville schools, but with what success is not yet known. Prof. Peebles would receive a hearty welcome back to Salem, and his management would have the perfect confidence of the patrons of the school.

ARTICLES FILED.—Articles of incorporation were filed to-day by the Astoria Land and Trust company with C. R. Thompson, George Noland and Lottie Noland incorporators; capital stock, \$90,000.

If this is complied with there will be less complaint from taxpayers, road supervisors and county officers.
