LOST PROPERTY OFFICE.

An Institution of Great Benefit to Thoughtless Persons.

A Place Whither Are Brought the Lost and Forgotten of Lovers and Friends—Queer Articles Found in Cabs, Cars and Omnibuses.

The majority of articles left by their owners in public carriages consists of such things as umbrellas, sticks, hand-bags, wraps, cigar cases and opera and field glasses. It is easy to understand, says the London Times, how such small items of personal impedimenta as these may be left behind, especially after dark, for although some of the better class of hansom men carry inside lamps this luxury has not yet been extended to the greater proportion of them or to any of the four-wheeled cabs. But it is astonishing to find what a number of really valuable properties have been left in cabs during the last few years. The following is a list of some of the principal ones, with the values on which the rewards to the drivers were based: A bag of jewelry, valued at \$1,500, and another at \$1,000; a case containing \$1,000 in Bank of England notes; a diamond necklace, value \$1,000; a diamond tiara worth \$850; several packets of bonds valued at \$3,000, \$1,500 and \$1,000 respectively; silver plate weighing 1,084 ounces, valued at \$240; a parcel of bank notes for \$380, and numerous other items of the same nature, but rather less valuable. Of course all the articles and properties just named were claimed by the owners, the drivers of the cabs in which they were found receiving pecuniary rewards; but, although it can not be said that the sums paid them were inadequate, they certainly can not be considered excessive. Thus, for the diamond tiara, valued at \$850, the reward was \$35. In cases, however, where bank notes or bags of gold are deposited the sums awarded are properly based upon a considerably higher scale.

The most valuable deposit was made some years ago, when a thoughtless clerk, belonging to a bank situated in a hundred yards from Scotland Yard, left notes and securities amounting to several thousand pounds in a cab that he discharged at the door of the bank. Within two minutes of being paid his fare the driver had deposited them in the Lost Property Office. It is a nice point in ethics whether, as the cabman knew to whom the property belonged, he was justified in taking it to the Lost Property Department. Self-interest, however, and a literal interpretation of the statute or the subject outweighed any conscientious scruples the cab-driver may have had on that score, and the result to him, at all events, was satisfactory, as he received a reward sufficiently large to enable him to start as a small cab proprietor with a couple of horses and a "hansom" cab.

It may seem a strange assertion to make, but it is nevertheless true, that the owners of some of the articles found in cabs have been by no means anxious to claim them. Indeed, some of their misfortunes in life have been directly traceable to a momentary forgetfulness on their part when leaving these useful and long-kept articles in the pigeon holes of the Metropolitan Police Department are to be found documents and letters which, being taken to the Lost Property Office, gave a timely warning to the police of some intended fraud or outrage, cleared up a doubtful clue, or possibly led to the arrest of a swindler who had long been preying upon the credulity of the public. If rumor is to be believed, even some police officers themselves have not the pleasantest recollections of some unfortunate lapses of memory which were the means of bringing to light secrets (left by them in cabs) that were never intended for the eyes of their official superiors. The Lost Property Office, too, has been the scene of many an interesting recovery. It would be difficult to do justice to the feelings of the young undergraduate who, while relating one morning to an officer of the Lost Property Department his various wanderings the night before in a hansom cab in which he had left his cigar-case, discovered at his elbow an affectionate parent, of whom he had taken leave before he started on his previous day's venture on a somewhat similar inquiry after a favorite umbrella. More than one matrimonial jar, too, has been traceable to the unexpected meeting at Scotland Yard of husband and wife, intent on the recovery of property lost on journeys in which their mutual interests were by no means concerned. For such misfortunes as these, however, the department is not responsible.

Few people can have any idea of the immense amount of trouble the Lost Property Office takes to retrieve for the inhabitants and visitors of the metropolis losses that their own carelessness has brought upon them. It is certainly not the fault of this department that the owners of the articles deposited here for recovery are not more numerous. Every publicity is given by advertising them in the daily papers, and notices of properties found are sent to occupiers of houses, managers of hotels, and theaters, if cases in which the driver gives the number of the house, hotel, etc., whence he was hired. Weekly notices are now sent to the Lost Property Department of the Railway, of articles found in cabs when they are taken up or set down their "fares" at railway stations. These notices are very useful aids to the recovery of lost property, as claims are frequently made on the railway companies for articles which are subsequently found to have been left in cabs.

The Hole in the Wall.
A gentleman who has recently returned from quite a long trip through "the land of the Aztecs" has been giving some interesting details of his experiences to his friends. Among other things he said that when he was in the City of Mexico he was shown through some ancient buildings—convents and palaces—that were erected by the Spaniards several centuries ago. In the wall of one of these ancient edifices he saw a small opening; so he naturally inquired of his Mexican guide what purpose it served. He was told that it was one of those buildings in which criminals were walled up alive. "But what was the use of the hole in the wall?" he asked. "Well, senior," replied the guide, "as long as the prisoner lived his food was handed to him on a plate and he handed back the empty plate through the hole; but when the prisoner handed back the plate with the food on it untouched then the jailer knew that he was dead already and didn't give him any more."

A Youthful Philosopher.
A St. Louis bootblack says he can tell the size of a man's feet by looking at his face. "If he is tall and raw-boned, with a lean face," says the knight of the brush, "I know I got to deal with a pair of No. 10's, or even bigger shoes; but if he's short and plump and round-faced I know that his foot is small and well-shaped. The tall, angular man is likely, too, to wear coarse shoes that give me a great deal of trouble, and the other man will, in nine cases out of ten, have on soft and well-made shoes of ten, only a little coarsening to take a shine one can see one's face in."

A GOOD BEAR STORY.

But Unfortunately It Was a Very Sad and Unsatisfactory Ending.

Many years ago a New Hampshire boy found a very young bear cub near Lake Winnepesaukee, and carried it home with him. It was fed and brought up about the house of the boy's father, and became as tame as a dog, says the New York Ledger. Every day its youthful captor had to go to school at some distance, and by degrees the bear became his daily companion. The first the other scholars were shy of the creature's acquaintance, but ere long it became their regular playfellow, and they delighted in sharing with it the little store of provisions which they brought for their day's sustenance in small bags. After two years of civilization, however, the bear wandered to the woods, and did not return. Search was made for him, but in vain.

Four succeeding years passed away, and in the interval changes had occurred about the school alluded to. An old dame had succeeded to the ancient master, and a new generation of pupils had taken the place of the former ones. One very cold winter day, while the school-mistress was busy with her humble lessons, a boy chanced to leave the door half open on his re-entrance, and suddenly a large bear walked in. The consternation of the old lady and her boys and girls was unspeakable. Both school-mistress and pupils would fain have been "abroad," but the bear was in the path, and all that could be done was to fly as far as possible, and hide behind the benches. But the bear troubled nobody. He walked quietly up to the fire-place and warmed himself, exhibiting most satisfaction in his countenance during the process. He remained thus about a quarter of an hour and then walked up to the wall where the provender bags and baskets of the pupils were suspended. Standing on his hind feet he then took hold of these successively, put his paws into them and made free with bread, fruit and other eatables therein contained. He next tried the school-mistress's desk, where some little provisions usually were; but finding it firmly shut, he went up again to the fire, and after a few minutes' stay before it he walked out by the way he came.

As soon as the school-mistress and her pupils had courage to move, the alarm was given to the neighbors. Several young men immediately started after the bear, and as its track was perfectly visible in the snow, they soon came up with it and killed it. Then it was that, by certain marks upon its skin, some of its pursuers recognized in the poor bear a enemy, but an old friend of their own recent school days. Great regret was felt for the death of the creature. It was like killing a human friend rather than a wild animal.

ALL KINDS OF GHOSTS.

Monsters and Guardians Invented by Various Races of Men.

I have been in almost every country in the world, says a writer in the New York Mail and Express, and everywhere I have found people who have seen and believe in ghosts. In western countries ghosts are generally harmless, but in Asia and Africa they are of a malignant and vicious type. The dread of ghosts is common to all aboriginal races of India and China, and the only means employed to oppose their rancor and mischievous dispositions is to build shrines for them and to make them offerings. Any severe illness, any epidemic disease, as small-pox, cholera, etc., is attributed to the malignancy of certain of these spirits, who must be propitiated accordingly. In India the man tiger is, perhaps, the most dreaded of all these demon phantasms, for when a tiger has killed a man the tiger is considered a man in spirit, as the spirit of the man rides upon his head and guides him in all his doings. Accordingly it is believed that the only sure mode of destroying a tiger who has killed many people is to begin by making offerings to the spirit of his victim, thereby depriving him of their valuable services. In China the ghosts most propitiated are of those who have met a violent or untimely death, whether by accident or design. Evil women with the child-bed or wretches who have had their crimes are believed to have the same power of causing evil to the living as those who have been killed by any other violent causes, including poison, disease, lightning, etc. All these diabolical spirits are often distinguished by some term denoting the manner of their death. Thus the "tiger ghost" is the ghost of a man killed by a tiger; the "snake ghost" is the ghost of a person who was killed by a snake. In Africa the "wady" and "lightning" ghosts are the most common, but the most dreaded spirit is the Sirocco ghost, which is reputed by the natives an implacable spirit. Most of the deceased persons whose spirits are now worshipped were the ancestors of some of the aborigines.

The ceremony of exorcising or exorcising the ghosts consists mainly of the offerings of fowls, pigs, goats, as well as of flowers and fruits, of the recitation and singing of certain prayers and charms before the different shrines. These charms or prayers are addressed to the deified ghosts of the dead for the purpose of compelling the spirits to cease from doing harm or to appear and receive the offerings of the people. After two or three successive performances the ghost is understood to be placated.

Turn About Fair Play.
In the early history of the European and North American railroad the female passengers did not enjoy that exemption from the annoyance of tobacco smoke which is now accorded them. Among them on one trip was an elderly lady of stern countenance and an elevated nose, whose whole aspect seemed to be in accord with the little car, which she held in her lap and favored with many tender endearments. A little way in front of her sat a "greenhorn" man, industriously and peacefully puffing a large cigar. The wrathful lady, viewing him for a time in cold displeasure, and then standing majestically down the aisle she seized the offending cigar and threw it out of the window, with the quiet remark: "If there is anything under heaven that I hate it is a miserable little cigar."

Edison's Queer Fellow.
Not long ago I called at Edison's home, expecting to see him. He wasn't there, and Mrs. Edison told me she hadn't seen him for three days. I soon found that he was at his old tricks—working night and day in his laboratory, having his meals sent to him and sleeping on the floor with his clothes on and a stick of wood under his head for a pillow. When working he never leaves his laboratory, and he seems to think that by keeping his clothes on he can better preserve the nervous tension after he has started to work. Then he perseveres until he has accomplished his purpose. His time he regards as very valuable, and this is the reason he doesn't want to come here until it is necessary. His deafness has not improved any, remaining about the same.
