A COMPLETE SUCCESS.

The Planter's Wife Presented to a Large Audience and in a Most Excellent Manner.

A fine audience greeted the home company at Reed's opera house last night to witness the presentation of the pleasing comedy drama, "The Planter's Wife," which was placed upon the boards in a very acceptable manner. The plot is something like this.

Edith Gray, a young, innocent school girl in the north, marries a designing, deep-dyed villain, Harry Livingston, finds out his character, refuses to live with him or assist in his nefarious schemes; some time afterward bears his death and thinks herself free. Goes to the South and after some years is wooed and won by a worthy planter, Albert Graham. About this time Livingston turns up and makes heaps of trouble. After much suffering on Edith's part, the mystery is cleared up, the villain is unmasked and all goes well.

The comedy parts are a young Southern coquette, Angie Gordon, an itinerant "item hunter," Simon Simon, who is gathering material for a "history," and manages to catch up some things of great value in clearing up the mystery, a negro waiter and Angie's mother.

Miss Jennie M. Long carried the leading part—Edith Gray—and did it grandly. Her powerful, well-trained voice enabled her to give an eloquent force and finish to the important passages which had a due effect. Her acting was faultless. Mrs. Leona Willis, as Angie Gordon, was the most admirable character. It has been the good fortune of this writer to behold on any stage in many years. Her girlish build, charming voice, sweet voice and her every movement and gesture were exactly appropriate and kept the house in raptures with her the whole time. She sang in a delightful manner the "Soo Song," from the opera, "Olivette," in the last act, which capped the climax. Miss Willis will be Salem's pet of the footlights hereafter. Miss Nellie Gilbert as Dora Graham was also a grand character and is entitled to a full share of the generous encomiums that are heard. George Morris, as the Planter, carried his part in excellent style, as did also Dr. J. M. Keene, as the villain of the play, while W. F. Dugan, as the newspaper correspondent and historian, covered himself with glory. Henry W. Meyers showed remarkable adaptability to the several positions assigned him as pretended preacher and as lawyer and friend of the planter. Horace Willis as the waiter and officer, received hearty praise for his superior work.

Mrs. Jessie Hayzen, as Mrs. Gordon, exhibited fine talent, but she took a minor part, and her great work, and for which she is entitled to sincere praise, was the management of the play throughout. It was no easy task and she can certainly feel assured that there are few such successes recorded in an amateur performance as that scored last night. Salem can well feel proud of its home talent. It is due to the orchestra, also, to say that the overture and interludes were pleasingly rendered and highly enjoyed.

WESTERN OREGON.

Its Exceptional Climate and Home Advantages.

THE OREGON LAND COMPANY.

What It Has Done For Salem and the Willamette Valley.

This enhances the value of city property, and stimulates an activity to which all interests contribute. School lines are extended by a rapid increase in the number of pupils, and a shop being overcrowded with work, a second is started; an extensive fruit evaporator calls for a chimney, which is now being built, and a new woolen mill starts its looms humming to join in the chorus.

Nor is this expansion confined to the city; the spirit of progress has taken possession of the surrounding country. On all hands we see the large and neglected farms of the pioneer settlers divided up into small parcels, and then five ten or twenty acre patches settled on by incoming families. A number take themselves to poultry raising, there being a ready market for all the eggs and poultry that can be offered; others devote themselves to orcharding, ten acres of fruit securing a good living for a family; berries are a profitable crop, and the canners will take all the sweet corn, tomatoes, cauliflower and other vegetables that may be offered.

The Willamette valley, five million acres in extent, is surpassed in fertility by no similar body of land on this continent, and it is capable of supporting a population fifty times as large as it now contains. The donation tracts, ranging from 500 to several thousand acres in extent, are not profitable to the owners, and as the land becomes more valuable, they will be brought into the market, and be made the homes of thousands of happy and prosperous families. The human tide is flowing in this direction in increasing wave, and as all have a right to a home, land proprietors must be restricted, and God's footstool be carved up to suit the wants of His intelligent creatures.
