

HONORS FOR SALEMITES.

Some of Our Citizens Seem to be Appreciated at Spokane Falls.

The following from the Spokane Review, will interest many Salemites, for Chief Warren, Chas. Barlow and M. G. Harbord have hosts of friends in Salem:

Chief of Police J. F. Warren is a very popular man with his officers. Anyone present at the banquet given the members of the police force by the genial chief yesterday afternoon could not mistake this fact.

Joel F. Warren joined the Spokane police force April 12, 1884, the star worn by him at that time being made of tin. Three years later he was elected to the office of chief of police. On the 12th instant he will step down and out, after having filled the position for three years, to give place to M. G. Harbord.

The date of his departure from their ranks drawing near, Chief Warren requested all the members of the force to be present at the headquarters at 3 p. m. yesterday, in full uniform. After the officers had all assembled, with the exception of M. G. Harbord, a line was formed and they marched down Riverside avenue double file. The officers presented a splendid appearance as they marched down the street headed by Chief Warren and Captain Martin. One lady, the wife of a prominent banker, was heard to say: "I am sorry, Mr. Warren isn't going to be chief any more, because he is such a nice looking man in his present position. See how he towers above the other officers."

When the procession reached the Merchants' hotel Chief Warren drew the officers up in line and a photographer who had been engaged for the occasion took a picture of the group. The policemen then returned to the headquarters, where they were invited to attend a banquet given by the chief at the Merchants' at 5 o'clock.

IN THE BANQUET HALL.

Two hours were very pleasantly passed at the banquet table, and all had a very sociable time. Many of the officers made remarks complimentary of their chief, and many were the toasts offered. Chief Warren, in acknowledgement, thanked them both for their good wishes and the diligence with which they had performed their duties during the time he acted as chief. He also thanked the members of the press for the treatment he had received at their hands. A resolution of thanks was extended the press by the police department. The reporters present in turn thanked the chief, and the officers individually, for the many courtesies shown them in their daily search for news.

Upon leaving the Merchants', the officers marched up past the engine house and gave the fire ladders three cheers, which were returned with will. Arriving back at the police headquarters all the officers assembled in the council chamber, where Chief Warren told them that inasmuch as his term of office would expire next Saturday, he would not likely be able to again see them in a body. He then thanked them for their past favors.

A PRESENTATION.

Officer Charles Barlow then stepped forward and said: "Chief Warren, on behalf of the members of the police department, allow me to thank you for the kind and impartial treatment we have received at your hands. I take great pleasure in presenting you with this cane on behalf of my brother officers, as a token of the esteem in which we hold you."

Officer Barlow handed the chief a handsome heavy gold-headed black ebony cane. On the head of the cane was engraved "Presented to J. F. Warren by the police officers of Spokane Falls, April 8, 1889."

Chief Warren was visibly affected, but he thanked his friends warmly, saying in conclusion: "If I live till my hair is white and my shoulders stooped, you will find me still the possessor of this cane. Again I thank you."

It may be well to state that while the officers were enjoying Chief Warren's hospitality, the latter had special officers patrolling the streets at his own expense. He did this that the city might be protected while the police department had a few hours to themselves.

The Australian System.

The main points in the Australian ballot A. E. can be summarized as:

1. All ballots must be printed and distributed at the public expense.
2. The names of all candidates must be printed on the same ticket.
3. The ballot must be delivered to the voter within the polling place by sworn officers of election.
4. No ballots may be voted save those delivered.
5. The voter must be guaranteed absolute privacy in preparing his ballot.
6. The secrecy of the ballot must be made compulsory.

The Hop Outlook.

Hop men are all quite busy just now preparing their yards for the season of 1890. There is considerable work in clearing the ground and making ready for the new crop. The poles all have to be reset and this is the work that takes up the time of the hop man. There will be about the same acreage this year as last, judging by the opinions of a number of growers who have been interviewed on the subject. The last year price was not so high as to encourage the planting of many new acres, although the outlook for a firm market next fall is good. There will be a meeting of the Willamette Valley Hop Growers' association in Salem May 9th, which promises to be largely attended by the members, of whom there are sixty. The meeting will be of considerable importance, in so much as it will be discussed many topics of interest to the fraternity.—Albany Herald.

GOVERNOR PENNOYER'S SPEECH

In Accepting the Democratic Nomination for Governor at Portland.

Mr. President and Gentlemen of the Convention: If there is one man living, who more than any other, owes a debt of gratitude to his fellow men for favors received far beyond the ability of payment, I am that man. To be nominated as I was four years ago for the high office I now hold, without one single effort on my part to procure such nomination, to be triumphant ly elected at the polls, and to be now renominated by this convention, imposes upon me obligations which I am unable to cancel.

It was not my intention to again be a candidate. Two years ago, when upon a canvass of the state, I assured my friends everywhere that I would retire at the close of the present term, I had at that time carefully weighed the cares and responsibilities of the high office against its honors, and I had fully determined to not again be a candidate for that position.

WHY HE DID NOT WANT TO BE NOMINATED.

But above and beyond this there were other grave reasons why I did not wish to remain in public life. When I saw, as I have seen, the inequality of the burden of taxation in this state, when I have seen repeated efforts to remedy that abuse rendered futile, and in addition to that, when I have seen persistent efforts made to exempt by statutory amendments a certain species of private property from taxation, and when I had seen still greater abuses in the federal government where wealth is entirely exempted from taxation, where the burden of such taxation falls mainly upon the poor, and where in addition the poor are taxed for the benefit of the rich and remembering as I do, that there is a just God in heaven who, alike controls the destinies of nations and of men, and who will ultimately punish any nation guilty of so great injustice, I determined to absolve myself by a retirement to private life, from all responsibility in the administration of a government, so unjustly administered.

But you have again called me to stand as your candidate, and yielding my private preferences to your demand, I accept the nomination, and I thank you for it, and I promise you that if you will stand at my back as you did four years ago, and I know you will, that I will be re-elected by a largely increased majority.

We are now in the valley of the shadow of death. I tell you gentlemen of this convention, that the slogan you have here sounded will summon forth such a gathering of forces in that valley as has never before been witnessed, and our ever-swelling and triumphant hosts will emerge from that shadow out in the broad daylight, and on the second day of next June they will plant their standard upon the very mountain top of victory.

If Mr. John Minto should be elected to the legislature from Marion county, he would at once want a bill passed providing for a tariff of about six bits a pound on his wool.—East Oregonian.

Mr. Minto will undoubtedly stand by every American industry, which is more than the average democrat can be depended upon to do.

BURNED TO DEATH.

A Frightful Holocaust in a Silk Factory.

ALLENTOWN, April 24.—At 6:30 this morning fire started in the dye house of the Union Silk mill at Catasqua. The flames spread with remarkable speed and destroyed the building, together with the machinery and a quantity of fine silk.

Many of the employees were already in the mill at work. John Cooper, Chas. Trick, John Tuttle and J. Totejeaxi, an Italian, lost their lives and about thirty-five more were hurt. Three or four may die.

While the firemen and employees were working hard to control the fire an explosion of vitriol and other acids took place, and before the firemen could escape several were caught by the falling wall, and many were hurt by the flying debris.

The following have been taken from the building: John Good; Joseph Lodigiani, an Italian; the boss dyer and two others, whose bodies have not yet been found, and an unknown; Ulysses G. Everett, aged 18, fatally hurt; Charles Trick, skull fractured, will die; M. Morgan, internally hurt, cannot live.

Many others were hurt. The fire is supposed to have been caused by spontaneous combustion. The loss will reach \$110,000.

THE CARPENTERS WIN.

Chicago Eight-Hour Bosses. Able to Resume Work.

CHICAGO, April 24.—It was the original intention of the American Federation of Labor that the carpenters only should at present make the demand for the eight-hour day, but the developments to-day and yesterday show that other trades are not likely to conform to the instructions of President Gompers. Nearly every prominent trade of the city has, through its union, declared an intention to also demand the eight-hour day on May 1. Gompers desired the other trades to hold off and contribute financially to the carpenters' assistance until the latter had gained their point, and then the other trades to come in, turn by turn. But President Gompers' circular has been entirely disregarded, and in addition to the carpenters, the stock yards and packing house employees, gasfitters, iron-molders, stair-builders, mill-carpenters and harness-makers have already declared an intention to fight, and their example is likely to be followed by the tailors, shoemakers, plasterers, lathers, cornicemakers and other trades.

The revolution in labor thus becomes more sweeping than it was intended and is a great success before the time fixed.

Dallas Observer: Senator Mitchell has addressed the senate in favor of the constitutional amendment proposed by him for the election of senators by popular vote. Already fifteen changes have been made in the constitution, and who could say any of them was not well advised? All those amendments led up logically to the pending proposition. The present system of electing senators, he declared, was un-republican and vicious. It was in purpose a declaration that for some reason it was unsafe to commit the election of senators to a vote of the people, and a reflection on the honesty, capacity, or both, of the voting classes. Among other things Mitchell declared that the secret executive session was no longer in harmony with the spirit of the age. It was a relic of monarchy, and should find no recognition in a republic.

The Cleveland Fake.

S. F. Alta: The editorial confession of the World that its recent interview with Mr. Cleveland was a fake, that it never took place, reveals a fine condition of metropolitan journalism. That interview furnished Dana of the Sun the chance to unload himself of a lot of black-guardism, the like of which was never before attempted by an American newspaper.

OREGON CLIPS.

Albany Democrat: The election of a governor in June has now assumed such a shape that the contest is not a party question. The nomination of a man with eighteen banks is an open challenge to the virtue and integrity of the voters of the state. It is not whether the governor shall be a republican or a democrat. With two clean men that would be a matter of small importance. But when a candidate and his particular supporters assert that he will spend a hundred thousand dollars if necessary to secure his election, if this is not prima facie that there is something rotten in the candidate whose party has eight or ten thousand majority in the state to back him, find it necessary to make such threats? Is he such a man that decent republicans can not vote for? There is something rotten in Denmark and the issue is above and beyond that of a mere party. It is a question as to whether this rising commonwealth can be bought even by a man who has eighteen banks. We can not believe that it can.

Corvallis Times: The ticket nominated in Portland at the republican state convention last week is undoubtedly the strongest that has ever been presented by the party in Oregon for years and we candidly believe that the entire ticket will be elected. Of course there are some objections made in a few instances, but the ticket as a whole gives more than ordinary satisfaction. R. S. Bean received the nomination for supreme judge and we consider him the strongest man on the ticket. He will receive a good support from the democrats of the second judicial district and we will stake our judgment against a jug of juice that he leads in the race next June. R. S. Bean is a worthy candidate, a man among men and a judge above reproach. His election is unquestionable.

San Francisco Examiner: The confession of the New York World that its alleged interview with Mr. Cleveland, upon which the Sun's scurrilous attack was based, was "fake," leaves Mr. Dana in an unenviable position. As between the Sun and the World honors are even, and the only party to the three-cornered controversy who comes out of it with any credit is Mr. Cleveland. When the World carries sensationalism to the point of inventing interviews that are bound to make trouble it deserves rebuke, but the deliberate malignity of the Sun is even worse. The two ought to frame a joint apology.

Dallas Observer: One of the natural products of this section is the fine building rock an exhaustless bed of which lies within a short distance of town, and the ease with which it can be worked and the fact of its being so close to market, will in the near future make it an item for the candid consideration of men with means sufficient to work it on a large scale. Like everything else, though, we presume it will take time to make it thoroughly understood.

Polk County Observer: In Salem upward of a hundred buildings are in course of construction or contracts are let for building of same. Yet population is pouring into the city so fast that enough stores and dwelling houses cannot be provided to meet the demand. This will be a year of unusual building and activity in the state capital.

Monmouth Democrat: It is said that there are 321 convicts in the Oregon penitentiary, and among that number there are only two women, being one to every 20,000 in the state. This speaks well for the women of Oregon.

Who will take up the fight for protection in the free-trade ranks of Democracy is hard to determine, but a better one will never be found than Hon. S. J. Randall, of Pennsylvania.—The Dallas Times-Mountain.

It will not be taken up by any one in the Democratic party, dear brother. The Democratic party is practically a unit against "protection."—East Oregonian.

Dallas Itemizer: As an evidence that Salem is rapidly advancing and that property to and around the city is daily increasing in value several instances can be cited. Isaac Vandyn came here a stranger a little over a year ago, invested in real estate and has cleared over \$25,000; Mr. Alsworth invested \$9,000 in Dec. 1888, and has sold out for \$22,000 clearing \$13,000; Mr. Adams invested \$500 and took out \$800 profit.

Ordinance No. 191.

An ordinance bill to amend section 7, title 2, chapter 14, of the City laws relating to nuisances.

Be it ordained by the common council of the city of Salem:

Section 7, title 2, chapter 14, of the City laws be amended so as to read as follows:

Section 7. Any privy or cesspool within the city limits which shall be maintained on any block in which there is a public sewer, and which shall not be connected with said sewer as provided by ordinance No. 188, as amended by ordinance No. 174, and which shall be so accessible to a public sewer, which shall be in such condition as to emit a noxious and offensive smell or odor, or which shall be in such condition as to be a nuisance, and upon being so declared by vote of the common council, the marshal shall immediately notify the owner of the premises where such nuisance may be found, to abate the same within ten days from the date of the service of such notice and in case the order is not obeyed within the time limited the marshal shall abate the same at the expense of the city, and such expense when ascertained shall be charged to the owner of the premises where such nuisance existed, and the recorder shall enter the same against him on the docket of city liens, and such expense shall be a lien on said premises as provided in said ordinance, of section 5 of the city charter. Provided however that the time for connecting with such sewer may
