BLUNTED MORALITY.

BALTIMORE, Md., Aug. 20.—Mary Metzendorf, the fifteen-year-old poisoner now in jail awaiting trial on a charge of murder, is a curious psychological monstrosity. Though intelligent enough to retain employment at Kohler Medical Company's she seems to be entirely devoid of moral sense, and neither appreciates the heinousness of the crime she committed nor the seriousness of the punishment it involves.

She got poison at the factory and one morning before going to work, put it into the coffee-pot, and her little brother and a woman boarder who drank it, died, while her mother narrowly escaped death.

A curious feature is that Mary, in confessing the crime, said she had no ill-will towards, any one and does not know what led her to do it. In a letter which she wrote to her stepmother from the jail, after expressing her sorrow for the dead and her love for her home, she asks that her best dresses, ribbons, bustle and other garments be sent to her as she wants to present a respectable appearance when she goes to court.

OFF FOR THE NORTH.

PORT TOWNSEND, Aug. 20.—Telegraphic dispatches from San Francisco stated that some alarm was felt about the revenue cutter Corwin, which had sailed from here some time ago. As a matter of fact, the Corwin's fate should cause no alarm, as that vessel has been anchored in the Port Townsend bay, except on a few occasions when the officers took parties to clam lakes and the like. After nearly two months of pleasure, the officers and crew will have to do a little sea service, for on Saturday orders were received by Captain Hooper, instructing him to proceed at once to Behring sea. It is, however, rather late in the day for the revenue cutter to go North and be of any service.

The poachers have all made good catches and the 20,000 skins shipped to Victoria as the first installment from the fleet, is now on the way to London. The orders from Washington will, notwithstanding, have to be obeyed, and the Corwin left here this morning for Seattle where she will call and then proceed North, first going to Sitka.

IN MEMORY OF ERICSON.

WASHINGTON, Aug. 20.—By command of the president, acting secretary of the navy, sent the following letter to the commander of the New York navy yard: "Upon the occasion of the embarkation of the remains of Captain Ericson, it is the desire of the President to give solemn expression to the cordial and fraternal feeling that unites us to a kindred people, the parent source of a large body of our most valued citizens, of whom the late inventor, a Scandinavian by birth and an American by adoption, was the most illustrious example. In recognition of this feeling and of the debt we owe to Sweden for the gift of Ericson, whose genius rendered us the highest service in a moment of grave peril it is directed that at this other moment, when we give back his body to his native country, the flag of Sweden shall be saluted by the squadron. The department, therefore, issues the following instructions: The colors of the squadron will be at half mast during the embarkation and minute guns will be fired from the monitor Nantuxet, during the passage of the body from the shore to the Baltimore. As the Baltimore gets under way and passes the vessels of the squadron each vessel will masthead her colors, display the Swedish ensign and fire a national salute of twenty-one guns. The Baltimore will immediately proceed to Sweden."

MCCONNAUGHEY WINS HIS SUIT.

PORTLAND, Aug. 18.—The Swamp land suit brought by McConnaughey against Governor Penney and the remainder of the board of state land commissioners, settled by Judge Deady, who overruled the demurrer to the amended bill of plaintiff, enjoins the board from issuing deeds to any part of the tract of 42,000 acres of swamp land which was purchased from the state about two years since by the plaintiff. The board held that the act of the state legislature annulled the act under which the land was purchased and that the land was again open to sale, notwithstanding the fact that McConnaughey had paid for it.

DOES IT MEAN WAR?

NEW YORK, Aug. 19.—A dispatch to the Herald from Tacoma says the Corwin has sailed with orders to seize and dismantle British sealers. Commenting on this the Washington correspondent of the Herald says: "If this is true Sir Julian Pauncefote, British minister, will ask for his letters, which will be virtually a declaration of war. The Corwin was last heard of at Seattle, where she was said to be awaiting orders from Washington. In all previous cases the United States revenue cutters have been sent to sea under sealed orders which leads to the inference that this report is exaggerated."

WASHINGTON, Aug. 19.—Assistant Secretary of the treasury Nettleton confirms the report that the Corwin has been ordered to Alaska, but will say nothing more.

FIFTIETH ANNIVERSARY.

Hand in Hand for Half a Century. Rev. Daniel Bagley and His Wife Have Gone Through the World Together.

Seattle Telegraph, Friday, Aug. 18.—Rev. Daniel Bagley and his wife Susanah R. Bagley celebrated their golden wedding, it being the fiftieth anniversary of their wedding, their marriage having been solemnized at Meadville, Crawford county, Pa., on August 15, 1840. Mr. and Mrs. Bagley removed to Seattle in October, 1860, and have resided in this city ever since.

Daniel Bagley was born September 17, 1818, in New York state, and Susanah R. Whipple, his wife, was born May 8, 1819, in Massachusetts. In their early childhood their parents removed to Meadville, Pa., where the children grew up. After their marriage the young couple made a home for themselves near Princeton, Ill., where Mr. Bagley taught school and managed a farm. In 1842 he was admitted to the ministry in the Methodist Episcopal church, sharing his early pastoral labors with Owen Lovejoy, and they, together with Thomas Mercer, now of Seattle, taking a very prominent part in the anti-slavery movement. In 1852 he was sent to Oregon as a missionary. At that time there were no railroads, and the party made the perilous trip across the plains by wagon. The party included beside Mr. Bagley and his wife, the families of Thomas Mercer, Dexter Horton, William H. Shouley and Adron Mercer. Of the ladies who accompanied the party Mrs. Bagley is now the only one living.

Mr. Bagley settled in Salem, Or., September 21, 1852, where he remained as a missionary for nearly eight years. During the rebellion he was the only minister who had a charge in Seattle. In 1865 he built the "Drown" church, which was a landmark until consumed by fire. When the university was located in Seattle Mr. Bagley together with John Webster and Edmund Carr were appointed the first commissioners of that institution.

In 1870 Mr. Bagley associated himself with George F. Whitworth, Josiah Little, and his son, C. B. Bagley, and began the development of the Newcastle coal mines. In 1885 he gave up preaching regularly, but has done much towards building up small churches in Ballard, Yesler, and other suburban districts.

Mrs. Bagley has been an invalid for many years, but she has borne her affliction with Christian fortitude. Last evening the anniversary of their wedding was appropriately celebrated, and the old couple were the recipients of the hearty congratulations of their many friends. The presents were in keeping with the occasion. A patch work quilt made of choice silks and plushes, each square being the handiwork of some lady friend of Mrs. Bagley's in the church was indeed a work of art. Everybody joined in wishing the couple many more years of happiness.

Three Dollars a Week.

"Looking Backward" is beginning to bear fruit. Twelve young ladies of Indianapolis, employed in stores and offices, have rented a suit of twelve rooms and are living on the Bellamy plan. Each pays in to the treasury \$4 per week, and a cook is employed to prepare meals. In addition, each is assessed 25 cents for a contingent fund, which is held to meet unusual expenses. The young ladies room in couples, and each week two are appointed purveyors. The only time they are together is at supper, but they are contented and enjoy their way of living.
