BOLD ROBBERY.—Yesterday seems to have been a very unpropitious day at the fair grounds, as a number of bold thefts were made in broad daylight. A man named Miller, of Albina, lost \$100 from his pocket at the grand stand while a farmer named Lord was relieved of \$50 about 7 o'clock last evening. The theft was committed on the street car. There were three men got on the car and after it started, remarked: "We don't want to ride on this thing," and then jumped off. The conductor recognized them as being a part of the Portland crowd of toughs. Mrs. L. C. Folsom, who lives on Summer street, on Peity hill, lost \$75 in a shameful manner. During a rush to get on the street car the bold-faced thief took the purse from the old lady by force. The purse was in a pocket under her wrap; the culprit seized the pocket and wrenched the contents from it and made his way through the crowd and escaped. Mrs. Folsom was so badly scared that she can't give much of a description of the man, but her daughter, Miss Craig, who was with her, can give a good description of him. A number of men were standing near, and allowed the thief to run off with the ill-gotten money, without making any special effort to catch him. Mrs. Dr. J. S. Parsons, of Ashland, lost \$75 while riding on the street car, and Mrs. John Hughes, of this city, was robbed of \$10 on the fair grounds. These are all thefts of this kind that the reporter obtained in the little time he was out last evening. This dirty work is done by a mob of about fifteen toughs and thugs from Portland, who manage to create a jam during which time they go through the pockets of the honest people, whom they get in their toils. They will also make a sham row among themselves, to draw a crowd of men and then have their pick pockets do their low work. The officers should handle the fellows in a manner in which the case demands.

BRAN NEW SUITS.—The Second Regiment band gave a street parade this afternoon for the first time in their new suits. This band now has the finest looking uniforms that have been worn in Salem by a band from abroad or a home band for a long time. Of all the bands that have been in this city this summer, the Second Regiment makes the best appearance and their playing is second to none that has been produced here. This band is fast taking the rank where the Salem band stood a few years ago, and that is the best band in the northwest. One other feature conspicuous in the band today was a new silver-plated tuba and baritone blown by Ed. Crawford and A. T. Wain. The band now has a fine composition of sixteen pieces.

AT THE OPERA.—Ward's comedy and specialty company was greeted by a good audience last night, and the play had more of real merit than any play that has been produced in Salem for some time. They will produce another interesting play to-night. They intend to make this their big night. They gave a fine parade this afternoon on the street and also on the fair grounds. THE BIGGEST CROWD EVER HERE.

A Cattle Parade that Has Never Been Equalled—Fair Notes.

THE CATTLE PARADE.

The immense crowd of Oregon people who were on the fair grounds at 10 o'clock this morning were more than delighted at the showing of fine stock brought out at the parade, which took place at that hour, and which was well conducted, the animals marching in a file, surrounded by a cordon of admiring humanity that kept the best of order under Marshal Arai's good-natured management.

FAIR NOTES.

Wednesday night's slight rain cooled the atmosphere and brought the people out in grand style to-day.

Everybody was in better humor Wednesday. As the crowd increases to more than usual proportions and prosperity is everywhere evident, kicking has ceased and all are seeing how much of the general pleasure they can enjoy.

The Second Regiment band of Salem will be on the ground to-day and everybody is pleased with the announcement. They will show the crowd how instruments can talk. A livery team driven by M. A. Rains and a lady companion took a fit of kicking this morning on the ground and badly smashed the fine buggy, also kicking the young lady, but not injuring her. She jumped out and saved herself.

There is the largest crowd in years in attendance to-day.

LEG CUT OFF.

A Nine-Year-Old Boy Meets with a Painful Accident at the Fair Grounds this Morning.

Ralph, the nine-year-old son of W. B. Jolly, who resides at 208 South First street, Portland, was run over by the 11 o'clock train this morning and had his right leg cut off below the knee.

Mrs. Jolly came up from Portland the first of the week and has been visiting at J. H. Settlemier's at Woodburn until this morning when she and the boy came up to Salem to attend the fair and visit with Mrs. Jolly's parents at Howell prairie. They had just got off the train at the fair grounds and the boy was standing near the car with a lunch basket on his arm when the train started and some one running to get aboard the train ran against him and knocked him down under the car and in his endeavor to scramble up the wheels caught his right leg a few inches above the ankle and cut it almost completely off. His ankle and leg for several inches was horribly mangled. It was not known who knocked the boy down as there was a large crowd on the platform at the time and it was purely accidental, though with undue care.

The boy was at once brought to the city to Dr. Hall's office, where Drs. Hall, Byrd and Smith amputated the limb a few inches below the knee, and properly dressed the wound. Those who saw the accident, say the boy was fortunate to escape with his life. His father was telegraphed for, and will probably come up on the evening train. It has not been decided where the boy will be taken, but if the doctors will allow it, he will be taken down to Woodburn, where Mrs. Jolly has relatives.

Mrs. Jolly is a daughter of T. N. Woodworth, of Howell prairie.

THE SILVERTON MOTOR.

The Engineers Take the Field This Morning.

TO LOCATE THE LINE OF THE ROAD.

Will Soon be Ready to Order the Iron and Commence Grading.

Engineers E. A. Willach and A. Goblet with T. W. Miller, Chas. Mayer, Rodolph Swallen, S. Tyler and John Maul, commenced the new survey for the Silverton Motor line.

The work was begun near the Capital Lumbering Mills, on Front street, and will be continued to East Pudding river, near Silverton. The line up to that point has been surveyed, or rather the old survey from there to the terminus will be used. The party will rush the work as fast as possible, until the complete survey is made, which will be about a week. As soon as this work is done, Mr. Thielson, of Portland, will start East to look after the interest of the road in the way of rails and rolling stock. Mr. Thielson waits for the survey to be made in order to take the surveys notes with him.

A reporter called on Gen. Odell this morning and he stated that they had nothing special to give to the press to-day more than the facts above given, and that everything looked favorable for active work to be soon begun on the construction of the road. His object is now to get everything in shape that the work may be commenced in a satisfactory manner and be pushed until Salem has a steam motor line.

It seems that Salem may have this line yet before the year ends. It would have had an immense business had it been in operation during the fair, both in bringing people from all the outside regions, and in operating between the fair grounds and the city. No one doubts for a moment that it will pay for the very start. Gen. Odell is to be congratulated and so are our citizens that the work preliminary to construction is now actually taken up.

TO-DAY'S RACES.

SECOND HEAT.

Pools sold Rosy C. \$40, Mollie Cooper \$10 and the field \$10.

This heat was very pretty, but not so fast as the previous one. Mollie Cooper took the lead on the first turn but did not maintain it very long. Mink went to the front on the back stretch and held her position to the wire, going under in 2:25. Rosy C. 2nd and Mollie Cooper 3rd. Coming down the home stretch they looked very fine, in one, two, three order almost lapping. Time by quarters: 36, 1:15, 1:50, 2:25.
Mutuals paid \$9.10.

THIRD HEAT.

Pools sold on this heat Mink \$20, and other two \$4 each. It was uninteresting except in the disgust created by Mollie C breaking and running on so many occasions during the round. Mink had no trouble in winning the heat in the walking time of 2:33. Mollie Cooper 2nd and Rosy C just saving her distance. Time by quarters: 66, 1:14, 1:53, 2:33.
Mutuals paid \$8.25.

FOURTH HEAT.

A change in drivers was made for this heat, John Savage being put being put behind Mollie Cooper in place of Davis, who suiked considerably and was about to evade giving up the keys of the stall, when Apperson informed him that unless they were produced immediately, he would be fined and suspended. The driver of Rosy C. was also changed, George Graves taking Clancey's place.

The result was very noticeable. The race was full of excitement. Mollie Cooper taking first place and holding it to the finish, which was made at an easy gait in 3:28. Mink 2nd, Rosy C. third. Time by quarters: 36, 1:12, 1:50, 2:29.
Mutuals paid \$11.50.

FIFTH HEAT.

Pools sold \$25, for Mollie Cooper, \$17 for Mink and \$3 for Rosy C.

Here another change occurred in drivers, Smith taking the place of Woods behind Mink.
On the send off Mink took the lead and never lost it. Mollie Cooper made a terribly bad break before passing the eighth and fell way behind, but by the prettiest work imaginable she closed the immense gap, and at the three-quarter pole had passed Rosy C. and was pressing Mink somewhat closely. She had too much to overcome, however, and Mink went under the line, the winner of the heat and race, in 2:27. Mollie Cooper 2nd and Rosy C. distanced. Time by quarters: 37, 1:18, 1:50, 2:27.

THE SPECIAL PACING RACE.

One of the most interesting racing contests of the fair was the special race provided for pacers, purse \$400, (\$200, \$80, \$40, free for all, heats best three in five. It was postponed last night and was announced for 12:30 to-day. The grand stand was packed from end to end, the estimate being about 5000 people. The race proved all that was expected for it, a pretty exhibit of speed.

Judges, J. T. Apperson, D. H. Looney, T. L. Davidson; starter, Apperson; timers, T. H. Tongue, and Col. Fitzmaurice.

The following horses started in the order named from the pole: Rosy C. St. James, Mink, Mollie Cooper.

FIRST HEAT.

Pools sold, Mink \$20, field \$10.

The horses got off well at the second trial, Rosy C. two lengths behind. St. James took the lead for a short distance, but fell back and the real contest settled down between Rosy C. and Mollie Cooper, both doing fine work on the last half, Rosy holding her gait to the wire, under which she went a header in 2:21. Mollie Cooper, 2nd, Mink 3rd and St. James distanced. Time by quarters: 34, 1:10, 1:47, 2:21.
Mutuals paid \$25.50, showing that the bookmakers got the worst of it. This was the fastest heat ever trotted or paced in Oregon.

WALKOVER TROT.

In the trot for 3-year olds there were three entries. T. H. Tongue's Pandora, Galbraith and Goucher's Canemah, and Sam Reed's Cour d'Alene, but the first two would not start unless the latter would agree to leave out the distance flag, which he refused to do, so he was allowed to drive around the course for his entrance money. The time was not officially taken, but it was between 2:45 and 2:50.

THREE YEAR OLD TROT.

The third race was a special trot made up for three-year-olds on Canemah and Pandora as starters in order from the pole as named, purse \$150, best two in three.

Pools sold, Canemah \$20 to Pandora \$12. Canemah had a slight

lead at the start and never lost it, although the contest was very close at times and some thought Pandora would crowd ahead before home was reached. Not so, however; Canemah won the heat in 2:40. Time by quarters: 42, 1:20, 2:07, 2:40.
Mutuals paid \$8.50.

SECOND HEAT.

Auction pools took a curious turn this time, Pandora going up to \$15 to \$20 for Canemah, but buying was very slow. A very fine even start was made and Pandora took the lead on the first turn, Canemah making a damaging break which caused a wide breach.

This was gradually narrowed until as the third quarter was covered Canemah's nose was in line with Pandora's wheel. Canemah broke again on the home turn, but was coming in with threatening rapidity, when she lost her feet near the wire and Pandora went under in 2:43, after a very pretty race. Time by quarters: 41, 1:23, 2:04, 2:43.

THIRD HEAT.

Pools sold at Pandora \$20 to \$15 for Canemah.

FAIR NOTES.

Capt. Taylor, of Portland, an old time steamboat captain, while preparing to buy a ticket at the gate to the fair grounds, had his pocket book, containing \$500 stolen out of his inside vest pocket. Some of the most brazen robberies ever perpetrated have characterized the mob of toughs from Portland that surround the fair this year.

The Second Regiment band, of Salem, appeared on the ground this afternoon in their new uniforms, and their advent was the signal for a hearty cheer. They played some beautiful airs and were roundly applauded.

IRISH LEADERS ARRESTED.

Dillon, O'Brien and Other Leaders Jailed

ON THE EVE OF GOING TO AMERICA.

Great Britain Fears to Let the Case go to an American Jury.

DILLON AND O'BRIEN ARRESTED ON THE EVE OF THEIR TRIP TO AMERICA.

DUBLIN, Ireland, Sep. 18.—The American tour of two eminent Parallels will have to be deferred. The Hon. John Dillon was arrested this morning and conveyed immediately on a special train to Tipperary. The train was accompanied by a large military escort. William O'Brien was arrested at Glengarriff and taken to Cork in a similar expeditious manner. The charges on which Dillon is arrested are in substance an accusation of conspiracy and inciting tenants on Smith Barry's estate not to pay their rent.

THE EFFECT.

The arrest of Dillon, O'Brien and other noted Irishmen is the absorbing topic of the day. Arrests were a surprise as no hint of the government's intention or action had reached the public. No explanation for the reasons of the government's course is vouchsafed. On all sides doubts are freely expressed as to the political wisdom displayed, but it is too early to predict the effect on the public of England. The Parallels' theory of the arrests at this juncture is that the government decided on them to prevent the departure of Dillon and O'Brien to America because they feared the effect of the speeches of the Irish orators in America.

TAKEN UNAWARES.

DUBLIN, Sept. 18.—Here in Dublin the police are keeping strict watch at the headquarters of the Land League. Dispatches from Tipperary reported organizers of the local branch League, there under close surveillance. It is thought the government is contemplating further arrests. The Irish nationalists had no suspicion of the impending blow and are at a loss to know what it portends.

BARO RELEASED.

The trial before Justice Goodell last evening was quite lengthy. John Dean was the first witness called to the stand and his testimony was a confused statement with several contradictions. He seemed to know but little of what he had been doing since he came to Salem Monday evening. The next witness, Dean's friend, Curran, from Portland, He was not very familiar with the English language, but he gave a straight forward statement, but nothing that would indicate that Dean got the counterfeit money of Baro. Mr. Baro was next sworn and was greatly embarrassed and mixed up his statement a little. Mr. Rogin, a partner in the saloon was the last witness examined. He gave a strong testimony and the case was submitted to the court, who considered the evidence insufficient
