AT THE CANNERY.—One who
has not seen it would probably be
told in believing that there is now
stored at the cannery scores of tons
of green fruit awaiting to be canned
or dried. A JOURNAL reporter took
a hasty look through the establish-
ment Saturday. In the cannery
they were principally occupied in
putting up green corn, while in the
evaporator apples were the fruit
being disposed of, and that rapidly.
The most attractive part of the
work noticeable in the cannery was
the operation which the corn went
through, from the time the husk
is pulled off until it is sealed in the
cans. The corn is husked by hand
and then goes to the "sheller," so
called, where the corn is cut off by
machinery and is done as rapidly
as two boys can feed the mill, of
which there are two, by putting in
one ear of corn at a time. The corn
is carried from here by an endless
chain and cups to what is known as
the "slicer" where it goes through
the first process of cooking. From
this it is conveyed in a similar
manner to the can filler, and from
there they go to the solers where
the cans are all soldered, after
which they go to the retorts where
they receive the final cooking, and
then are ready for the labels and the
boxes. The entire establishment is
handling an immense lot of fruit.
Wagons laden with fruit are being
unloaded at every hour in the day
and often many awaiting their
turn to drive up to the bins. The
company expects to have fruit
enough to keep them in operation
until winter, at least.

SALEM ILLUSTRATED.—This
week's issue of the West Shore gives
some fine views of state, city and
country buildings of Salem, with a
sketch of the various industries and
public institutions. The account of
Salem is a very favorable one. In
addition to what it has to say of the
various enterprises, the following is
a part of the statement of the city
in general. "Salem is pulsing with
life and energy. The rich blood of
enterprise and prosperity is flowing
in the arteries of trade and industry.
New enterprises are on foot that
will aid materially in promoting
the growth of the city. The lead-
ing street car line, extending from
beyond the depot through the city
and to the fair grounds, will soon be
converted into an electric line, mak-
ing the permanent location of the
line between Salem and Silverton,
and the indications are that this
most valuable feeder to Salem's
business will be finished and in
operation by the end of the year.
* * * The splendid roads leading
out to the surrounding country, so
famous for its agricultural products
and fruits, rendering a large area
locally tributary to the city on both
sides of the river." The above is
only a little of the glowing picture
the West Shore has painted in letters
of Salem. As a town for a
home it speaks in the highest terms,
and all of which is true. Salem's
reputation is spreading wide and
the most beautiful and desirable of cities
for a home.

MARION COUNTY TAX LEVY.

It is Made as Economically as Possi-
ble to Meet the Extraordinary
Requirements.

The county court of Marion county,
consisting of County Judge Wal-
do and Commissioners Grimm and
Watson, met Saturday for the pur-
pose of levying the taxes necessary
for the ensuing year. The net valua-
tion of taxable property this year
is \$7,654,930. The average general
expenditures of the county for some
years have been \$30,000, but this
year the county has its share of two
large bridges to pay for, \$6,400 on the
Jefferson bridge, and the agreed
proportion of the Willamette bridge
at Salem.

It is not yet known what the
state levy will be, but the county
court did not think it advisable to
wait for this to be made before hav-
ing the books perfected and placed
in the sheriff's hands for collection,
so they proceeded on the hypothesis
that the state tax levy would be
five mills. The tax of two-tenths
of a mill for indigent soldiers was
not levied this year because last
year's levy raised \$12,000 and there
has been only \$102 of this expended,
so the levy made is as follows:

State tax, 5 mills, \$382,746.50
County tax, 2 mills, \$153,098.60
Total, \$535,845.10

The county levy of 11 mills will
raise a tax of \$84,204.23. Deduct from
this \$4,400 for the Jefferson bridge,
\$80,000 for running expenses of the
county and \$15,000 as a part of the
county's share of the Willamette
bridge, and there will be but \$6,804
for such unforeseen extra expenses
as may become necessary. But if
the state levy should be the same as
last year—6 mills—then that \$6,804
would be more than absorbed by it
and the county will have barely
enough to meet the immediate de-
mands. Of course it may not be
necessary to pay as much as \$15,000
of the county's share of the Willamette
bridge this year, but the sooner
it is paid off the better the people
will like it.

Last year the county waited for
the state levy to be made before car-
rying out the tax and this threw the
collections at least three months be-
hind, but County Clerk Halewick will
this year carry out the 11 mills and
place the books in Sheriff Crisman's
hands in about fifteen days, so he
can proceed with collections. When
the state levy is known it can be
segregated from the other funds.
This will bring in the county taxes
in their proper season and do away
with paying interest on warrants
for these extra three months.

SYSTEMATIC BILL RINGING.—
Why the ill system of church bell
ringing is in vogue now in this city
is not easily explained or accounted
for. It is not an uncommon thing
to hear strangers remark "what is
the matter with the church bells?"
No city of its size can boast of as
fine a combination of bells as Salem.
There is not a missing chord, from
the sharp tenor of the Episcopal
bell down to the deep tones of the
Congregational. Yet for some reason
the bells do not begin nor con-
clude ringing at the same time, but
one or two ring at a time and when
they stop a few others take up the
ringing, and thus it continues for
some ten or twelve minutes, instead
of all beginning and ending at the
same time. The chimes of the
church bells have furnished numer-
ous tunes for the masses. But the
ill system as practiced here would
make a poor subject for a poet.
Let the churches adopt a uni-
form system and awaken the Salem
muses.

CHECKING OPENING.—The Alka-
Hesperian hotel had its first meet-
ing for the season Saturday evening
and the result was very satisfactory.
An interesting business meeting
was had, three new members added
their names to the list and an im-
promptu debate in favor of early mar-
riages resulted in a very interesting
discussion and a victory for the af-
firmative. Attorneys M. W. Hunt
and John A. Carson were ap-
pointed leaders for next Saturday
evening, with power to select a
question and report it in time for
publication. The indications are
for an unusually interesting and
useful season's work by this associa-
tion of literateurs.

CAPITALS VS. JUVENILES.—There
was an interesting game of base
ball at Highland park grounds Sat-
urday afternoon between the two
home amateur clubs, the Capitals
and the Juveniles, in which the
former were badly defeated. The
Juveniles seem to be a hard team to
down. They are the same lads who
so discouraged the Oregon City boys
during fair week and by their good
playing the Statesman nine were
compelled to take defeat.

THE GALLERY INCREASED.—Su-
perintendent Downing of the Ore-
gon state prison has three more to
have photographed and interviewed
by the Oregonian. Sheriff Wilcox
of Gilliam county, arrived yester-
day with Roy Brady, sentenced to
serve four years for horse stealing,
Wm. Smith one year on a similar
charge and Ed Biderly one year
for house breaking and stealing
various articles.

SALEM'S MARKED PROGRESS.

The Jefferson Review has these en-

ANOTHER ELECTRIC LINE.
Horse Car Street Railways Soon to Be
a Thing of the Past in
Salem.

The report was current this morn-
ing that the Salem street car line
had been sold to a Chicago syndi-
cate and that the old line would be
replaced at once by a first class elec-
tric motor line. In view of the
rumor a JOURNAL reporter called at
the office of the Oregon Land Co.,
the owners of the line, to ascertain
the facts if possible. He was in-
formed that Mr. Cook, who is now
East, had sent a dispatch stating
that satisfactory arrangements had
been concluded. The managers do
not think that the statement neces-
sarily means the sale of the road,
as it is not their desire to sell.
It is the intention of the com-
pany to secure money at as low
interest as possible, and on long time,
and properly equip the road,
which doubtless means an electric
road. Mr. Cook will be home in a
few days, when the facts will be
known. Until then it is only a
speculation, though one thing is
pretty sure, and that is, the road is
going to undergo a reformation, and
that soon, either by the present
company or by some other.

ing between here and Wheel-
land and will probably be taken
in to-day. Roshlight is in the
