MORE OF THE SHOOTING.—The shooting scene that was reported in the JOURNAL yesterday, took place near Buena Vista, was up in the justice's court yesterday afternoon. Tice was charged with assault with a dangerous weapon. He waived examination and was bound over to await the action of the grand jury, which meets next week, with bonds fixed at \$500, which he was unable to furnish, so he is now in the county jail. The trouble seems to have grown out of a misunderstanding, and can probably be settled without any serious difficulty. Tice is an old man and lives by himself, and has been doing some grubbing for steel, the man who had him arrested. A few days ago some disagreement took place between Tice and Steel, over the work, but everything was quiet until Tuesday night, when some boys who were out hunting, fired some shot into Tice's portable cabin, and he, thinking it was Steel, attempted to use his gun on him the next morning, with the results as already stated.

Mrs. Kaiser is feeling easy but is still quite weak from the effect of the shock which she received.

THE SALEM BRIDGE.

A General Public Demand for a More Watchful Supervision—Tax Payers Attention.

The JOURNAL is only one taxpayer out of thousands who are interested in and will have to pay for the \$75,000 steel bridge that is going up at Salem. It is furthermore a newspaper that to a certain extent is dependent for its existence upon the good-will and business patronage of those who are in control of the erection of this bridge. On the other hand, as a public newspaper, that solicits support from thousands of disinterested taxpayers, it is under obligation to a certain extent to furnish intelligent information as to how the work is progressing and how well it is being done. Salem feels a deep pride in the new bridge. It was the unanimity and enthusiasm and enterprise of Salem business men that hastened the plan by which, speedily action to replace the bridge was secured.

But every taxpayer in Marion and Polk counties has just as much interest in securing a good, lasting piece of work on that bridge as the JOURNAL has, as any citizen in Salem. The city will be full of prominent freeholders next week when the circuit court will be in session. All these representative citizens and heavy taxpayers will be able to make investigation for themselves as to the progress of the work.

Much information has come to the JOURNAL to the effect that crooked or poor work was being done. The first bad break was the defective pier work, that has already necessitated an extra expense of over \$10,000. The disinterested engineer who was largely responsible for this is still retained, and such supervision cannot but prove costly in the construction of the whole bridge. How many more \$10,000 extras will come in no one can tell. This is plain, frank talk, and yet we feel that there is little use minding matters.

Another important matter that it is not too late to investigate is the financial standing of the surities on the contractor's bond. It is well known that no effort was made to recover on the loss sustained by the other bridge going out; yet it went out without the bonds washing away or anything striking the bridge. It simply fell down. The county had no security. It is well known as a rule, that large bridge contracting firms are not found solvent when asked to face a loss of \$75,000. If any accident happened to this bridge in the course of its construction it is almost certain the taxpayers would have to bear the loss.

The original plan seems to contemplate that the east end of the new steel structure shall rest upon the shell cylinder piers that supported the old bridge. To place that immense steel span upon those two faulty connected shell-iron pillars is about equal to setting a ten-story granite building upon stilts. The same pillars failed to hold up the wooden bridge. How shall they sustain one of steel?

The embankment that two years ago was one-third the width of a street is nearly all gone. No one knows but that those piers were settled when the other bridge went out. More than likely they were.

THE JOURNAL has received a number of communications and complaints upon this enterprise, so important to taxpayers. This is but natural. We have so far refrained from comments or publications. We do not consider that anything can be gained by longer silence. The fullest airing must be given these matters in the press that people may have confidence that their work is being done right, and the taxpayer's money rightfully expended. To investigate and make public such matters is not a pleasant task or anyone, much less a newspaper, at whose business those taken to task can daily strike blows. But so far as the JOURNAL is concerned, no personal feelings enter into the matter. It does not assail the integrity of Supervisors Gondaal and McCoy. But those gentlemen cannot in turn throw the responsibility of the first \$10,000 blunder in construction upon each other without the public losing confidence in their joint supervision. Some one is to blame. Let the public decide. In the meantime let intelligent taxpayers take an interest in their bridge. We can only voice the public sentiment as it comes to us without fear or favor. But we believe that the public is entitled to the watchful supervision of a skilled steel bridge engineer, whose duty it shall be to see that the specifications of the contract are faithfully complied with. The superstructure is now to go on. It is still time to get the steel bridge that is called for, and get it right. To get it right will be the cheapest in the long run.

A FREIGHT DEPOT.

The Facilities for Local Freight Business Entirely Too Limited—Where Is That New Depot?

All this season merchants and shippers have complained at the unequal treatment accorded Salem by the Southern Pacific in the matter of freight facilities at Salem. The depot is not half large enough, the promised new freight depot never having materialized. The greatest difficulty is sometimes experienced in getting freight out promptly, and also in handling cars for loading and unloading. The side tracks, switching facilities, platform room, depot room are all of primitive dimensions better suited to some small rural station than to the booming traffic of the rapidly growing second city of Oregon.

The Southern Pacific was very ready to promise a new freight depot last spring when it wanted favors and extensions of right of way in our city. But all this was done to secure additional favors. When it comes to fulfilling its promises not so great a degree of readiness is manifested. But this is in line with its general policy. It will only act as a last resort when forced to do so. It generally pursues a dog-in-the-manger policy. The threat of the not-so-tempered Truism Supt. Koeniger at Portland that it would be a long time before Salem would get any favor of the S. P. is being carried out. Because our city had the audacity in a feeble way to ask for fair terms, that became magnate has spotted Salem as a place to be broken out. He has marked our city as an object of his spite and nothing remains but a vigorous fight for the rights of our city.

Supt. Koeniger judges the temper of Salem people if he imagines we can carry on the old Ben Holladay struggle against the Capital City with any degree of profitable success in the long run. This city when fully aroused will be found to defend its claims for just treatment in an intelligent and aggressive manner, and against any Bonaparte usurpation of authority by one who should be a public servant instead of a private executive.

Salem is entitled to a first-class freight depot and good yard service in place of the present ramshackle, catch-as-catch-can service. It was fairly promised our city. Our board of trade and our city authorities when this is called to their attention may consider it worthy of their notice, and if no redress is had a case can be made up and taken before the railroad commission. One thing is certain: Salem needs a better freight depot.

THE NEW BRIDGE.—So many people are putting off important business matters until the completion of the new steel bridge. This is not the case however in some lines of trade and one clothing firm report that they have disposed of more suits to customers from Polk and Yamhill this season than ever before. What their business will be when the new bridge is up they cannot tell, but they say they may have to double their store room. This refers to Johnson, Bonshay & Co.

READING CIRCLES.

All the students, from the third year preparatory to the senior class inclusive are required to appear before the entire school and the visitors who may attend, once every semi-term. The first exercises of the kind took place on last Wednesday, when the hours from eleven to twelve in the forenoon, was given to the rhetoricals in the presence of a number of visitors. The exercises consisted of essays, recitations, interspersed with music from the Conservatory department. While many students have a great dislike to reading before the public, an education is only half completed that is allowed to be acquired without paying due attention to original composition and thorough drill in speaking and appearing before an audience. The first index to culture is in the demeanor.
