IMPOSED UPON.—The law regulating the examination of teachers for the public school must have been made by upstart men or those who thought little of the pleasure of the school teachers. The way the law now stands the county school superintendent is compelled to hold the examination on two legal holidays in every year and teachers wanting certificates are required to attend them. These days are Decoration day and Thanksgiving. A number of teachers were at the court house yesterday passing the examination. Legal holidays are not so numerous as to require any one to break a law. These examinations could be held a week earlier or a week later just as well. This is a small affair, yet is worthy of the attention of the next legislature.

HUNTING TRAIN-WRECKERS

A Detective Arrives With Tramp No. 1.

HE IS MYSTERIOUSLY RELEASED.

Local Employees Refuse to Identify Him, But He Will Not Talk.

Deputy U. S. Marshal Wm. Smith of Portland came up from that city Thursday night, in company with one Frank Burns a plasterer, from no known residence, a kind of a tramp in fact.

A Journal reporter, knowing that Mr. Smith was also a special detective for the Southern Pacific, one of a large force employed in this wreck, attacked him for the facts. He was at first reluctant to give out anything, but evidently thinking it would help the company to have a tramp train-wrecker made public, divulged the following:

STATEMENT OF THE DETECTIVE.
It will be remembered that on the night of the Labish wreck a man was seen by Mr. Hogan, tailor at the Indian school, and Miss Baughman also at the school, and an Indian boy by the name of Lincoln Tredway, midway between the school and the scene of the wreck, walking rapidly towards town. In answer to questions put to him by Mr. Hogan and Miss Baughman he said he had been on the train and that the engine and tender only had gone off the trestle; he guessed the engineer was killed but thought the fireman was all right. The same man was passed by City Marshal Ross who was on his way to the wreck, who only saw his outline and build but not his face and did not speak to him, but merely saw him hurrying away from the wreck. The man was next seen at the waiting room of the Salem depot, where he was seen and recognized by Mr. and Mrs. Darling who conversed with him. He told them he was not on the wrecked train. He acted so suspiciously that Mrs. Darling wanted her husband to arrest him. He left the depot at daylight. City Marshal Ross got a trace of his passing through Turner on foot. He was next seen at Eugene by Deputy Sheriff Day and Constable Cochran. He was afterwards seen by a co-killer at Springfield, three miles above Eugene. I was at the scene Monday after the wreck, and have been on his track ever since. The man I have secured has told parties in Portland that he was the man referred to in the papers as seen by Hogan and has confessed to seeing Hogan on that night, remembering his brass buttons and government uniform. This man answers the description of a man seen hanging around the tool house by the Salem section hands and carpenters crew. I found him at Vancouver yesterday. He had told Deputy Sheriff W. W. Morgan at Portland the keeper of the Red-front lodging house, and others that he was the man seen coming away from the wreck, and pointed to his wounded head as evidence of his having been at the wreck, and that he was injured in it. I went to Vancouver and found him in a camp with a lot of tramps, representing himself as an attorney and got him to make the same statements to me that he did to Morgan at Portland. I brought him along to bring a suit for damages against the company, but upon reaching this side of the river, I disclosed myself and he told me I had got the wrong man, that it was a job put up between himself and two tramp partners to defraud the railway company if possible; that two days before the wreck he had got into a fight at Independence where he got his wound; and being arrested under the name of Frank Sheffield he had had his wound sewn up in jail; this last statement I found true and have released him this morning. I have the following letter from Constable Cochran at Eugene:

THE LETTER.

EUGENE, Nov. 27, '90.
Will Smith: The man who you were looking for here is supposed to be in the vicinity of Cottage Grove. He was seen near Creswell the latter part of last week, near there by a lady who asked him about a road; he answered her in a short way and struck out through the fields. The constable at Cottage Grove was notified and watched the tracks and country road two or three days and nights, but could get no trace of him. A man answering his description has since been seen at Creswell, dodging around as tho' he were half crazy and I have no doubt that this man is the one you have been looking for, etc.

W. W. COCHRAN.
"I have an idea this man was on the train and got away with some of the spoils, as he disposed of a good overcoat at Vancouver. He is a suspicious character and we have not given him up. At present he is free."

The above is the detective's story and it is no doubt a very complete statement of the theory the company is operating upon to find a supposed train-wrecker. It may be that it was desired to give this theory to the public. Further investigation shows that the detective who brought suspect No. 1 to Salem did his best to secure identification by the section men here and did not succeed. While they realize that

their places depend on doing what the company asks of them; they also realize that the company wants a conviction at any price and the detectives want the money.

THE TRAMP WRECKER

was not identified by the Section Boss Young. He said flatly that he did not know him, had never seen him, and believed in doing right and justice. Other employees here declined to assist the detectives in fastening this awful crime upon tramp No. 1 at this time. It may still be done later.

THE ALBANY WRECK

On July 27th, 1889, was settled in this way, and the man convicted by the company is in state's prison for life. He is likely to have a fellow-prisoner for the Labish wreck, if all the plans succeed.

THE TRAMP RELEASED

Unable to secure any identification whatever, detective Smith ordered the tramp released this morning. He was seen by a reporter but evidently had a patent lock-up attachment on his tongue and would not talk. He was approached by four delegated inquirers of this paper, including one of his own species, but was auster-proof. He evidently was acting under advice and took the first train for Portland. What will be done with him? Why was he released?

DETECTIVES

are scouring the country about Eugene for tramp No. 2. One of the other of these tramps has no doubt been selected for the purpose of a prosecution. Which one, time alone can tell.

BUSINESS EXAMPLE.

The Builders of the Salem Steel Bridge Could Learn Something from the School Directors.

The directors of the Salem public schools have received the North Salem public school and released the contractor from any further obligation. The directors went at this public work in a business-like way. They advertised for bids and had each bidder to hand in his plans and specifications with his bid. They then let the contract to the lowest bidder after he had given the requisite bonds to secure the public against any possible loss that might occur if he should fail to comply with the contract.

They even went further than this, they put a man there with the specifications in his pocket, who should superintend the work and see that the contract was fulfilled to a letter. The consequences of this close oversight and good judgment is, the city has a new school building that is a first-class structure in every particular. The board of directors commended the contractor for the faithful manner in which the work was executed. The building from base to dome has not a bad piece of timber in it, and the workmanship has been of the best.

The building will not be ready for the pupils for a week yet. The heaters are not yet completed, and the blackboards are to be put in yet. The contractor of the building had nothing to do with this part of the work. The contract for these were let to other parties, but will have the same close oversight. This building is an ornament to the city, and the school board deserves praise for the efforts to secure such a building at so small a cost.

If the county had used the sound and precaution in regard to the bridge, that the school board did, in the construction of this building, there would now be a good bridge over the Willamette at this city or else the counties would be out nothing. There would not be those little "tin soldier piers" for the first high water to wash away. While it is too late to rectify the bridge it is not too late for men to learn how to use public funds.

STAMPING THE RING.

The Sheriff and Deputies Sweep Down on the Prize Fighters in the Midst of the Sport.

The glove contest between Jack Murphy and Jack Flaherty was anticipated to come off on Wednesday night somewhere near this city, did really begin a short distance below this city on the appointed evening in the Razzles circus tent. A large number of the curious from the city were in attendance.

Sheriff Croisan had his schemes well laid to raid the camp at the proper time. With his usual tact he had the spot for the contest well located. When the fight had well begun he and his two deputies walked up to the door, where tickets were demanded but the doorkeeper on a second look recognized the officers and at once left the tent without further orders and did not even give the alarm to those inside. The peace officers walked in with their great coats on and the collar turned up and were not recognized. Time was called just as the officers entered, so they stood on the inside until the next round was commenced, in order to take the men in the midst of the fight. When the third round was fairly under way the officers jumped over the rope into the ring and took possession of the gloves and their owners. In less than two minutes the entire tent was cleared of its two hundred persons, who had been visiting the contest. The most serious man in town would have been constrained to smile at this point in the scene if half the reports are true. They dispersed through the tent on all sides. On one side, near the tent, was a woman wire fence, and a score or more darting under the tent, thrust their heads into this fence. One man ran squarely against a house, and many others fell down over boys and stumps, while others in their haste to get away, trampled on them. A number run over the high bank and fell rolling, down to the water's edge; one man ran even into the river, and another was brought to a halt by coming into contact with a clothesline. One man, who had ridden down in a buggy, near to town and had left his team—one marmos-headed quill-pusher, started north, and ran to the poor farm before he stopped.

Never did a lot of stamped Mexican steers act wilder than did the crowd, who were out at this fight. The sheriff said it reminded him of a hawk, swooping down into a band of chickens.

THE TRIAL.

Jack Murphy and Jack Flaherty were called up in Justice Bacheler's court this afternoon, on a charge of prize fighting. Geo. G. Bingham appeared in behalf of the state and Edmond Ford for the defendants. Tim M. Croisan was the first witness called to the stand and told what led him to seek out the place and make the arrests. Frank Miller was next called to the stand. A. T. Wain was next sworn. He stated that one of the defendants said, after the arrest was made, that if he had known that the officers would have interfered he would have knocked his opponent out in the first round. Other witnesses were still being sworn when the JOURNAL went to press.

The laws of this state are very plain on prize fighting. The defendants are making the plea that it was not a prize fight, but simply a glove contest for points and will very probably clear themselves on this point.

FAVORED THE SCHEME.
The Salem Board of Trade Favors with a Unanimous Voice the Fur-ture Factory.

The Board of Trade met Wednesday afternoon in pursuance to the call of the president to consider the proposition of T. H. Hudson & Sons to put in a furniture factory in this city. There was not a dissenting voice to the scheme. There was some difference of opinion as to how to go to the work to make it the most effectual. It was decided to have the secretary of the board telegraph to the firm that it was the unanimous opinion of the board that the money could be raised and for them to send their representative at once, when all necessary arrangements could be perfected both to secure the firm and the citizens. It seems that there will be no difficulty in raising the money.
