THE LAST MEETING.—The city council met in adjourned session last evening to finish up the business of the year. Mayor Williams took the chair on time and roll call found present Councilmen Hirsch, Gray, Collins, Lafere and Brown. There were also present Recorder Conn. Captain of Police Minto, Surveyor Gesner and Street Commissioner Graham. The only business attempted was the fixing of bonds for the newly elected city recorder, marshal and treasurer. Mr. E. Goodell, recorder, had his bond already made out in the sum of \$4,000, with O. E. Krause and E. C. Small sureties, and the amount was ratified by the council, the mayor to approve the sureties. The bond of Marshal Minto was fixed at \$2,000, which he made out and had signed by J. J. Murphy, Edw. Hirsch and Geo. Collins. Treasurer Swafford's bond was fixed at \$10,000, but he was not present. Thus ended a council which has done a vast amount of good work for the city.

OREGON'S PERPETUAL VEGETATION.—Salem is well up in the foot of the Cascade mountains and yet here is a portion of a letter from an esteemed subscriber of the JOURNAL residing there, Mr. J. A. Richardson: "I am not much of a writer for papers, but Christmas is past and summer is not over yet, so I thought I would try my hand. Christmas day I picked some fine apples off the tree as you ever closed your lips over. If you don't believe it, just come over and I will show you more of them still hanging on the trees. This, I expect, will sound like a big fish story to people in the land where blizzards come, but who could believe that grain and grass are growing so fast, and cattle so fat on the range, unless they could see for themselves?" Friend Richardson is but one of the thousands in the Willamette valley who could bring in like testimony.

STILL STANDING.—The old trestle near the Salem Flouring mill is still standing in such a condition that it may fall at any moment. The puzzle is how it could have stood as long as it has in its rotten condition. This morning three cars were standing on it, one box car being loaded with flour and two empty flat cars. This trestle has already been condemned by the county authorities and yet it remains unpaired. The attention of the railroad company is not called to this simply for a complaint on the part of the JOURNAL but it is to avoid the possibility of an accident which is liable to be attended with serious consequences.

PAID FOR THEIR FUN.—A few days ago a young man of Halsey, inexperienced as a peace officer, was given papers and instructions to go to Albany and arrest three tramps who were expected to come there on that evening. Three young men of Albany thought they would have some fun at the young officer's expense. So they dressed up as tramps and got some old packs and shortly after dark came marching up the railroad track. They were invited to accompany the officer to the justice's court, but they refused. Their refusing was as naught. They were released on each paying a fine of \$7.50, and now think it not such a capital joke after all.

A SERIOUS RUNAWAY.

A Lady and Child Knocked Down by a Street Car Horse—A Damage Suit Pending.

A serious accident occurred this morning on Commercial street, which probably cannot be settled without the unpleasantness of a damage suit. The accident was caused by a horse getting loose from the street car at the transfer at the intersection of Commercial and Center streets. He dashed up Commercial street to Court and then turned down Court towards the river and in crossing the walk near J. J. Dalrymple & Co.'s store he ran against Mrs. C. B. Brown, who was wheeling her nine-months-old baby in a carriage. The horse knocked her down and threw the baby out in the mud, badly bruising its head and face. Mrs. Brown was badly frightened and how serious her injuries are is not yet known. The horse fell, when his feet struck the walk, on the baby carriage, and shattered the vehicle into splinters. It is almost miraculous how the infant escaped being crushed to death under the horse. The only reason is, it was knocked clear out of the way by the force of the horse striking the carriage as he fell. Mrs. Brown was almost midway between the stores of J. J. Dalrymple & Co. and Squire Farrar & Co. when she saw the horse coming and then she endeavored to run back to Dalrymple's store, pulling the carriage after her and when going up the incline from crosswalk to the cement walk the horse struck them with the above results.

Mr. Brown was near by and when interviewed by a JOURNAL reporter as to the condition of his wife and child, he talked very freely in censuring the street car company. He claims that he has seen other instances narrowly avoided by the street car horses running away. He also claims that the company lay themselves liable to meet damage suits when they bring wild horses from east of the mountains to Salem and break them on the business streets and thoroughfares of this city. He said that he would bring suit against the company at once. It is hoped this matter may yet be settled amicably and that this city will not have the unpleasantness of witnessing a damage suit. All appreciate the benefit of having the cars run through the city and as the city gets larger it is expected that more accidents will occur than when Salem was a country town.

While Salem is comparatively free from serious runaway accidents, yet one occasionally happens, which might have been avoided had more care been exercised. This is especially true in regard to farmer's teams. An old plow team or team that is only accustomed to do work about a quiet farm, will stand wherever left with no danger of them running off. There are some teams, when driven to town, will often get scared and be the biggest fools of any. Many times the old gentle horses, are those that run away and cause the most damage. No one should leave a horse, however gentle, on the streets of a bustling city without first securely tying him.

MISS INFORMED.—Mr. T. A. Howard informs the JOURNAL that he at no time had any intention of engaging in the saloon business, though at one period he thought of occupying with his cigar business one side of the building to be used by Mel Hamilton as a saloon. This he has also abandoned, as Doug. Minto and Geo. Waters have bought his cigar stock and will continue in the same place. De Leon will occupy with his barber shop the building in which the Japanese bazar now is.

ENMITY IN THE WALDO HILLS.—A few people in the Waldo hills seem not to live in perfect peace and harmony. Aunsville has just had the notoriety of a neighborhood row and now the report comes of another fight in the hills between two farmers over a misunderstanding about some land. Those engaged in this unprofitable work were Thos. Perky and Dick Jones. No arrests have as yet been made.

What can Land be Bought for Near Salem and in Marion County.

Within five miles of Salem good farming and fruit lands can be bought for from \$30 to \$50 an acre according to amount of improvements. Garden lands nearer the city—from one to two miles—range from \$100 to \$300 an acre, and are in the market in acre, five acre and ten acre tracts.

THERE IS SOME GOVERNMENT LAND.
This is all in the eastern part of the county, in the foothills of the Cascade range. It is rough, timbered, but fine for sheep and cattle ranches and enough tillable for hay, vegetables and fruit. In all the foothills there is some snow, but winters are not severe. The temperature is mild and more even if anything than in the valley. There is a good deal of unsurveyed land in this section, which is open to settlers and when there are enough in at ownership a survey will be ordered.

THERE IS RAILROAD LAND.
This is mostly rough, but much of it is tillable, adopted to stock, grain and fruit. It has plenty of timber and water and can be had at \$3.50 an acre.

Good improved farms within 10 to 20 miles of Salem can be bought for from \$30 to \$50 an acre, according to lay and details can be obtained of any of the real estate men of our city.
