S. B. NO. 142.

Authorizing City of Albany and Counties of Linn and Benton to erect and Maintain Bridge Act. No. Williamson. In effect by approval.

S. B. NO. 145.

Amending sections 3082, 3 and 4, relating to wills.

Sec. 3082. Is changed so that last word reads "executed" instead of "proved."

Sec. 3083. Requires recording of wills of non-resident same as resident.

See. 3084. A devise of real property shall be deemed and taken as a devise of all the estate or interest of the testator therein subject to his disposal unless it clearly appears from the will that he intended to devise a less estate or interest, and any estate or interest in real property acquired by any one after the making of his or her will shall pass thereby unless it clearly appears therefrom that such was not the intention of the testator, nor shall any conveyance or disposition of any real property by anyone, after the making of his or her will, prevent or affect the operation of such will upon any estate, or interest therein, subject to the disposal of the testator at his or her death. An Act to Establish a Rogue's Gallery at the Penitentiary of this State.

Sec. 1. Makes it duty to establish such, "in which shall be placed the pictures of all persons hereafter confined" "upon conviction of robbery, arson or grand larceny."

Sec. 2. Supt. shall procure apparatus to take pictures, etc.

Sec. 3. Supt. shall furnish pictures to sheriff or chief of police in Oregon when he deems it for public good, etc. In effect by approval of governor.

Granting Consent of State to the Purchase by U. S. of Land in City of Portland for Federal Buildings.

S. B. NO. 154.

To Protect Laborers for Work in Clearing and Improving Lands and to Define and Create Liens on Land so Cleared or Improved.

Sec. 1 Any person who shall hereafter clear or improve land by ditching, digging, or tilling at request of owner or person in lawful possession, shall have a lien on said land so improved or cleared for his wages and charges for service, which lien shall be preferred to any other lien, mortgage or encumbrance of subsequent date.

Sec. 2 Person claiming lien must file with county clerk of county where land is situated within sixty days after completion of clearing or improvement, or after completion of any contract so to do, rendering bill and description of land, etc.

Sec. 3 County clerk shall record same.

Sec. 4 That lien may be foreclosed same as mortgage.

Sec. 5 That lien shall cease to exist unless action to foreclose is begun within six months.

Amended Fees, 3, 4, 5, 6 and 17, of Act Feb. 25, 1889, to prevent spread of Contagious Diseases, in following respect.

Sec. 3. Salary of state veterinarian shall be fixed by commissioners and not to exceed \$1500 a year and necessary travelling expenses; salaries of commissioners shall be \$200 a year.

Sec. 4. Shall be the duty of commission to protect health of the domestic animals of the state from all contagious diseases or infectious diseases of a malignant character, is authorized to employ local inspectors where deemed necessary.

Sec. 5. Makes it duty of local stock inspector to immediately report any disease to state office.
