Provisions for the State Reform School.

THE NEW COUNTY ON WILD ANIMALS.

The State Board of Equalization and Primary Election Law.

S. B. No. 177.

To Provide for Further Establishment, Advancement and Development of State Reform School Located at Salem.

Sec. 1. Establishes and permanently locates same at Salem, "for confinement, discipline, education, employment and reformation of juvenile offenders."

Sec. 2. Creates governor, secretary of state and superintendent of public instruction permanent board of trustees for management with full authority and exclusive control, under such rules and regulations as they may adopt.

Sec. 3. Shall make all needful rules and regulations, shall see that its affairs are properly conducted and "strict discipline maintained and that suitable employment and education are provided for its inmates." Authorized to make contracts for all supplies, "to build shops and other buildings necessary," and maintain and operate the same.

Secs. 4, 5, 6, 7. The board shall appoint superintendent and fix salary, and "such other officers and such assistants" as may be required, or remove same. Officers to be selected annually.

Sec. 10. Board shall hold meetings at capital first Monday of month; shall receive salary of \$250 and expenses.

Secs. 11, 12. When building is equipped, board shall make proclamation of fact, and children of 8 to 16 shall be received as committed upon conviction of not less than one or more than thirteen years.

Sec. 13. Grand jury may commit without trial. Other sections fix details of control and discharge of youth.

S. B. No. 178.

An Act Declaring that Proceeds of Sales of 10th and 30th Sections of Every Township Shall Compose Irredeemable School Fund.

Approved. In effect May 22.

S. B. No. 179.

Provides Suitable Terms for Holding Teachers' Quarterly Public Examinations.

Sec. 1. That county board of examiners, two of whom shall constitute quorum, shall hold quarterly examination, commencing at 1 p. m. on 21 Wednesday of February, May, August and November. All other acts on this subject repealed.

Approved. In effect May 22.

S. B. No. 180.

Amends Sec. 4229 Relating to Bounties on Wild Animals.

Empowers county court to pay for panthers or cougars not more than \$10 nor less than \$1; for each bear \$5 to \$10; wild cat, catamount \$2 to \$5; wolf or coyote \$20 to \$1; muskrat \$1; otter 5 cents; blacktail rabbits 5 cents to 1 cent; that persons in pursuit, or whose dogs are in pursuit, shall have two thirds of bounty is same is killed by another.

Not approved. In effect May 22.

S. B. No. 184.

Amending Sec. 3218, Relating to Corporations Incorporating by Articles Filed.

Requires copy of articles to be filed with county clerk of county where principal place of business is located, as well as with secretary of state.

S. B. No. 185.

To Authorize School Directors of Dist. No. 8 in Coos County to Issue Bonds of \$10,000 for New School House.

Not approved. In effect May 22.

S. B. No. 188.

To Amend Sec. 1859, Relating to Criminal Code on Adultery, to Read as follows:

Sec. 1859. A prosecution for the crime of adultery shall not be commenced except upon the complaint of the husband or wife, or, if the crime be committed with an unmarried female under age of twenty years, upon complaint of the wife, or of a parent or guardian of such unmarried female, and within one year from time of committing crime, or the time when the same crime to the knowledge of such husband or wife or parent or guardian. When the crime of adultery is committed

between a married woman and an unmarried man, the man shall be deemed guilty of adultery also, and be punished accordingly. Not approved. In effect May 19.

To create a State Board of Equalization, Defining Powers and Duties. Secs. 1 and 2. Provide that Governor shall appoint one member from each judicial district, same offices to be filled by election in June, 1892. Board be composed of two classes, those in odd numbered districts shall hold for two years and those in even-numbered districts shall hold for four years after first election.

Secs. 2 and 3. Define duties and oath.

Sec. 4. Board shall select one member president and elect a secretary.

Secs. 5-9. Define duties.

Sec. 10. Members shall receive \$10 a day, mileage and not to exceed 30 days.

Not approved. In effect May 22.

S. B. No. 192.

An Act to Regulate Holding Primary Elections in Cities of 2500 Inhabitants.

Sec 1. All elections held by any voluntary political association or party, for delegates to any convention for purpose of nominating candidates for public office must be held under provisions of this act.

Sec. 2. Notice of such primaries must be published in newspapers of general circulation.

Secs. 3 to 15 define details of act. As it applies only to cities of 2500 we omit further publication but shall publish same in full in time prior to next regular election in Salem.

Approved. In effect May 22.

S. B. No. 4.

To Provide for Appropriation of Water From the Lakes and Running Streams for Purposes of Irrigation and Supplying Water for Domestic Use and Stock, Upon Dry Lands, etc.

This is a general irrigation law mostly of interest to the arid parts of the state.

Not approved. In effect May 22.
