FOREIGN.

BRITISH VICTORIOUS.

SIMLA, India, Apr. 28.—General Graham's column on Saturday last surprised a force of about a thousand Manipuris entrenched behind earthworks. A savage hand to hand fight followed, and the enemy was completely routed, losing 200 men. One British officer was killed and four officers were wounded.

BOWING MATCH.

MELBOURNE, April 28.—A sculling match for £400 and the championship, was rowed on the Parameeta river today between McLean and Stansbury, and was won by Stansbury.

FROM SAMOA.

MELBOURNE, April 28.—Advices received from Samoa, state that Ex-King Tanisese is dead. He had been suffering from Bright's disease of the kidneys for some time.

The number did not surprise the family as their house has been for years a resort for scores of young and old alike. Mr. Parker is in a few days move to Moscow, Idaho, where he expects to engage in business with his brother G. J. Parker and perhaps his eldest son Clyde. Mr. Parker is one of our best and trusted citizens and will be sadly missed in this community.

FROM CHEMAWA.

President Harrison wired the superintendent that he would stop a few minutes, Tuesday, May 5th at this place. Our artist Mr. Jackson, a student of the school will be on hand to take the pictures of the distinguished party.

The Walla Walla Trouble with the Soldiers.

PENNOYER'S EXPLANATION.

About the President, Blaine Will not Run, The Detroit and Other Strikes, Cotton Oil Trust, The Name of the Burglar, Etc.

VON MOTLKE'S FUNERAL.

BERLIN, April 28.—The funeral services over the remains of Field Marshal Count von Motlke took place at 11 o'clock this morning in the ball room of the general staff building. Emperor William, the king of Saxony, the grand dukes of Baden, Saxe Weimar and Hesse, and the principal members of the royal family of Germany together with the leading German generals, were present.

THE WALLA WALLA AFFAIR.

VANOUVER, Wash., April 27.—The official report of Col. Compton, commanding at Fort Walla Walla, regarding the lynching of Hunt on Friday night by soldiers, was received here today by Assistant Adjutant General Ward, and immediately forwarded to General Ruger, at San Francisco. The contents were not made known here.

WALLA WALLA, April 27.—At a parade this evening the commanding officer had a telegraphic message read from Ruger, commanding the division of the Pacific, expressing the sense of grief of President Harrison at the act of the soldiers in lynching Hunt on Friday night, and declaring the necessity of better conduct in the future and a full explanation of the present crime.

Private Miller, who was shot by Hunt, died this evening.

PORTLAND, Ore., April 28.—Captain J. E. Lombard, of this city, was in Walla Walla when Troop D, Fourth cavalry, lynched A. J. Hunt, the gambler, who shot Private E. Miller. Speaking of the occurrence last night he said:

"There is no doubt but the soldiers employed generalship. All the details were arranged carefully and the work was well done. Nothing occurred to arouse the suspicions of the people. The soldiers came into town in squads. They came from all directions and slowly surrounded the court house. It was estimated that over one hundred men took part in the lynching. Twenty of them did the actual killing and the others formed two picket lines around the courthouse and kept the people back. It was all over in a very few minutes and the soldiers returned to the fort in squads, just as they came. I do not believe Colonel Compton, the commander of the post, anticipated trouble at the time. While I was at Walla Walla, I was informed that he told the sheriff so, and added that if there was any trouble it would occur late at night. He evidently thought that the men would slip out after turning in at 11 o'clock, and in that event he would be able to detect the offenders. The soldiers, however, did the work early and were inside the lines on time. The military officers at Walla Walla are looking into the case, but the town people have no idea that the lynchers will be arrested unless some soldiers tell them."

WASHINGTON, D. C., April 28.

Secretary Proctor has taken no action in the matter of the lynching at Walla Walla. If a court of inquiry is deemed necessary, as the president seemed to indicate in his telegram, then it must be ordered directly by the president, as the secretary of war has no power to take that step.

THE PRESIDENT CRUISING.

SAN FRANCISCO, April 28.—The president and party spent the forenoon in cruising about the bay in the steamer City of Pueblo.

STRIKE ABOUT OVER.

SCOTTDALE, April 28.—The situation in the Coke region is more harmonious today than it has been for a week. No undue excitement is reported, and men are returning to work and are not being molested. The strike is about over at Whitney works, where 200 ovens are in full blast and 225 working.

ANOTHER STRIKE.

ZANESVILLE, Ohio, April 28.—A strike of all the building trades was made today. All the building works are stopped.

THE DETROIT STRIKE.

DETROIT, April 28.—Several hundred strikers congregated in the vicinity of the Michigan Car shops this morning. The police immediately began clearing the streets.

The strikers, armed with sticks and stones made little resistance. Police fired some shots into the ground, one of which accidentally wounded Charles Keintz.

BLAINE WILL NOT RUN.

POUGHKEEPSIE, N. Y., April 28.—The News this morning publishes the following: "Stephen B. Elkins, is the authority for the statement that James G. Blaine would shortly announce his decision not to under any circumstances, allow his name to be used at the next Republican National Convention as a candidate for president." It says Blaine's letter of announcement will be so positive as to admit of but one construction, that he will never again be a candidate for the presidency.

COTTON OIL TRUST.

ST. LOUIS, April 28.—A special dispatch from Little Rock, Ark., says: "All cotton oil mills in Arkansas with the exception of one, are to be consolidated under the name of the Little Rock Cotton Oil company with a capital stock of \$27,000,000. It is difficult to learn anything about the object of the consolidation."

PENNOYER'S EXPLANATION.

PORTLAND, April 28.—Governor Pennoyer yesterday handed the Associated Press the following:

"The interview relative to my resignation of President Harrison in Oregon, as published in the press reports, was an imperfect statement of a private conversation with a member and an ex-member of the Oregon legislature, and was not intended for publication. While I insist, with all deference to the opinion of others, that my proper place to receive the President is at the state capital and not at the state line, where he will be met by a legislative committee, yet I concede that if I had authorized the interview as published I would be liable to censure, which under the true state of facts is unmerited."

THE NAME OF THE BURGLAR.

PORTLAND, Or., April 28.—The jury returned the following verdict: That the deceased was named William Hayes, a native of New York, that he came to his death by gunshot wounds, inflicted by Albert B. Strowbridge on the morning of April 27, 1891, between the hours of 5 and 6 o'clock, inside the store, 168 Second street, city of Portland, Or., said store being the property of the said Strowbridge. We further find that from evidence adduced the said Hayes had broken into said store and was at the time engaged in a felonious attempt of robbing said store. We find that no blame is attached to said Strowbridge for killing said Hayes; that, on the contrary, he was justified in so doing.

Cleveland's Flap.

It was sometimes said that the age of miracles is past, but the statement recently written by Grover Cleveland to State Treasurer Stephen B. Elkins on the silver question seems to disprove it, inasmuch as the "Stuffed Prophet" admits that he has been mistaken twice on the silver question, and such an admission is little short of a miracle.

Said Mr. Cleveland: "When the law was passed for the coinage of two millions of silver dollars monthly I feared the result, for I thought it would prove an injury to the business interests of the country, for a time at least. However, the law proved a benefit, for, contrary to my opinion, the country was ready for the change. When the present law providing for the coinage of \$4,000,000 a month passed I thought the measure too radical and that it might have the effect of driving gold out of the country, but in this I was mistaken."

Thus far the oracle of the Democracy merely admits that he was human and therefore liable to error; but there is a corollary to this admission which, in view of the impending Presidential contest, is more interesting than the confession. As is well known, a number of Southern and Western States are pronounced in favor of the free coinage of silver, and some of them, though Democratic through and through, have declared that no anti-silver man need not look for the Democratic nomination for the Presidency in 1892. Here is where the corollary comes in. Mr. Cleveland said, in reply to a question as to what he would do with a free coinage bill were he elected in 1892: "If I should be elected President in 1892 he bill would not reach me until 1894. What would be had for the country to-day might be necessary in 1894."

Those opposed to as well as those in favor of free coinage believe the present law is a fine one, in as far that the country was benefited by it. With the rapid strides the country is making it is impossible to say what financial measure we may be ready for in 1894.

If that is not a "Good Lord, good devil" statement of the case, then no man in public life ever made one. It is as bold a bid for the nomination in 1892 as could be conceived. It puts Cleveland into the position of one who is willing to sacrifice every principle which he has held for the sake of carrying favor with one wing of a political party, at the same time expressing doubt enough as to the correctness of his position to leave his retreat open in case of a sufficiently vigorous protest from the other wing. He is Banyan's "Mr Facing-both-ways" to perfection.

But what becomes of that dauntless courage and sturdy determination which have been the chief characteristics of Grover Cleveland, according to his friends and admirers? Where are the stiff neck and unbending backbone of which we have heard so much? What has effected the wondrous change in the man who wrote the Warner letter, and who, while president, never missed but one chance to urge on congress the suspension of silver coinage? Alas for the democratic party. Its favorite leader, its hope for 1892, has carried out the traditions of the party by doing the wrong thing at the right time, and has set himself a straddle of the fence just when his party was proclaiming most loudly that nothing could swerve from the fixed line of principle and policy.—S. F. Chronicle.
