The enthusiasm of the strawberry and rose show got to such a pitch Saturday that many were seriously proposing a fruit and flower palace be erected for this purpose next year.

Enthusiasm will do a great deal more than money. Money was not relied upon to make the rose and berry fair a success. All money-making features were kept out—even advertising. It was a success at the smallest outlay of anything ever conducted in Salem.

Without turning our columns into a catalogue of rose nomenclature or a directory of Salem's loveliest women who grew roses, it was impossible for any paper to enumerate the exhibits at the rose show in detail. A mere list of the strawberry entries would have nearly filled a column.

It is announced that the annual meeting of the Oregon Press Association will convene at Astoria on the 27th, 28th and 29th of August, 1891, the programme for which is prepared and will soon be sent out. "History of Oregon Journalism" is the title of an interesting paper now in course of preparation by a committee consisting of Messrs. H. L. Pitcock, H. R. Kincaid and A. Solter.

This paper does not stand alone among Oregon papers in objecting to Jo. Simen's law partner being made federal judge for life. Many papers are either willing to see the power of bossism extended over our courts or else do not realize the importance of this proposed appointment being defeated. The JOURNAL believes it is both for the interests of the republican party and the true interest of the people to defeat Dalph's selection.

At the Oregon State Grange just held at Hillsboro, resolutions were adopted asking that Judge W. P. Lord, of the Oregon supreme court, be appointed judge of the United States court of this circuit. Judge Lord is a man who has come up from the ranks of the people, and who is no wise under obligation to, or connected with any of the great transportation companies, so far as the JOURNAL can learn. We believe he would make an untrammelled judge.

A Wheelbarrow Portage.

The Dalles Chronicle: Among the thousand mercies for which the devout citizens of the Inland Empire daily bend the suppliant knee there is one that should never be forgotten, namely the fact that the great man who bossed the obstruction of the government works at Cascades has consented to allow the people to have three feet of ground across the government land whereupon to build a portage road. The stupendous generosity displayed in such an act ought to place Major Handbury as high in the temple of fame as the topmost pinnacle of the galleys of Haman the Agagite. Three feet of ground will give ample space for a train of wheelbarrows to transport our produce across the portage, one sack of wheat at a time, if the wheelbarrow propellers are not too fat. Wheelbarrows are infinitely superior to bicycles for transporting heavy produce and cheaper too. What a mercy that the Major did not confine us to a bicycle track. It may be difficult to put big fat steers into cars accommodated to a three foot track but it would be more difficult to get them on a bicycle.

After all he is a peculiar man, this same Major. That he is owned body and soul by the railroad companies whose traffic is threatened by an open river, is the firm belief of thousands. If his every action is not made in the interests of the railroads they have this result, which is just the same thing, as far as the interests of the people are concerned. He has pulled the wool over the eyes of the governor and the result is a delay of three months in the construction of the road while the river has risen to such a height that the building of tramways and inclines will be attended with additional difficulty and expense, and every hour of delay is money in the pocket of the Union Pacific. He pulled the wool over the eyes of the legislative committee by pretending that he was in favor of a standard gauge road being built at the government expense and when the usual amount of red tape, with its months of delay had been reeled off he informed the department at Washington that a three foot road was all that could be allowed and the portage commission were foolish enough to accept. A three foot road is simply next to no road at all. When the portage at The Dalles is opened it won't be worth a bean towards handling the traffic that will naturally ensue. But it will suit the Union Pacific well enough. The track on the Washington side of the river at the Cascades is three feet and a half and this is as narrow as any road ought to be. A standard gauge, it is well known, is four feet, eight and a half inches. The people ought to demand a track wide enough to meet their requirements. It is not yet too late. Major Handbury ought to be taught that he is the servant of the people and not their master. The damning outrage of a paid servant of the people frustrating every effort to obtain deliverance from the worst railroad oppression that ever cursed any community should be rebuked and we shall deserve that our chains be riveted more closely if we do not rise up in our righteous indignation and do it.

GENERAL NEWS NOTES.

The employees of the various omnibus companies of London have decided to go on a strike.

The Toledo, O., grand jury has returned four charges of embezzlement, aggregating \$22,000, against ex-Police Clerk W. H. Cook, of that city.

Sidney Bell the footpad, convicted of the murder of Samuel Jacobson in August last, appeared in court at San Francisco on Saturday, but sentence was postponed for two weeks.

E. F. Moore, ex-president of the People's National bank, of Fayetteville, N. C., is charged with embezzling \$50,000 of the bank's funds.

Lawyer Bartine died at Asbury Park Saturday from the effects of a cat bite. He suffered very much from convulsions, and frothed at the mouth towards the last. His agony toward the end was heart rending. The case has excited widespread attention.

The debate in the Canadian parliament on the motion of Louvier, censuring Sir Charles Tupper, high commissioner in England, for participation in the recent elections, was continued Saturday. A final vote resulted in the government being sustained by a majority of 21.

Mrs. Elizabeth T. Harrison, widow of the president's brother, Archibald J. Harrison, lieutenant-colonel of the Twenty-seventh Indiana Volunteers, received \$8,329.93 Thursday, in settlement of a pension claim, which was favorably passed upon at Washington within the past three weeks.

Ed Callihan, a mining man, and well-known sport, was murdered by a masked man about two miles south of Salt Lake city at an early hour Saturday morning. Josie Hill, a woman of loose morals who was with him at the time, has been arrested, charged with luring Callihan to his death.

Chinese in transit from China to Cuba, who are practically in bond, have been kept at that city by domestic Chinamen taking their places. This has been going on for some time, and recently the substitutes have been arrested and compelled to surrender the money paid to them. Joseph Lamb, Chinese agent of the Southern Pacific, has also been arrested.

The Lumber Trade Association decided at New York that the lumber yards should be opened Monday, June 8, as non-union yards. Members of any trades union will not be employed to the exclusion of others seeking employment.

Philip Reyron was murdered Friday night while sleeping in the house of John Olson. The house was afterwards set on fire. Reyron has a son in Washington. Robbery is supposed to have been the object.

August E. Behnke, the defaulting salesman of Goldberg, Bowen & Co., was brought back to San Francisco. He says his shortage amounts to \$1100, and that he started east to obtain the money to pay it back.

An effort was made in the Federal court at Chicago on Saturday to have quashed the indictment against George J. Gibson, ex-secretary of the whisky trust, his attorneys arguing there were no Federal statutes covering the case.

Dr. Samuel Hall was held to answer before the superior court at San Francisco for the murder of Ida Shaddock, through a criminal operation some weeks ago. Hall was fixed at \$50,000 in default of which the doctor went to jail.

Joseph Shanahan, convict on his way to Sing Sing, N. Y., to serve a sixteen-year sentence, escaped from a deputy sheriff at the Grand Central depot, New York, Saturday. The deputy sheriff, while pursuing him, fell and dislocated his shoulder.

Captain W. B. Miller, the builder and former owner of the New Orleans steamer Guiding star, is a defaulter. While secretary of the Mutual Gas company, of Detroit, he is said to have embezzled nearly \$14,000 and \$4550 more from his benefactor, Commodore Thompson Dean, the Broad street broker, of New York.

The suit of S. H. Kneeland, of New York, against the Toledo, St. Louis, & Kansas City, on a contract involving over \$22,000,000, has been settled in favor of the defendant and the road has been turned over to the company.

On Friday evening while a party of young men were out sailing at Prospect lake, Colorado Springs, the boat capsized. Edward Elliott, brother-in-law of the daughter of Julia Ward Howe, and at one time in the English navy, was drowned.

MISCELLANY.

A CHINAMAN OUTRAGED.

GRASS VALLEY, Cal., June 8.—Friday on Squirrel Creek, a Chinaman was most horribly maltreated. He was working a gravel claim for Lin Loy, a Chinese merchant here. Three white men went to the Chinaman's claim and demanded his money or gold dust. He said the dust was taken to town every day. The men then proceeded to torture the Chinaman to make him give up his gold. The Chinaman managed to get to town, and was treated by a surgeon, but he is badly injured, and may die. He says he can identify the men.

KILLED BY APACHES.

TOMBSTONE, ARIZ., June 8.—The superintendent of the Grand Central mine received a telegram from Frank, Sonora, of the killing of Frank Cathem by Apache Indians, fifteen miles from Arispe. Cathem was employed as a swamper on the mine train. There were two other men with teams, and how they escaped is unknown, though it is understood that the remaining two men stood off the Indians, as teams and freight were reported safe. It is believed the Indians will make for Southern Arizona. Ranchers have been notified, and will keep careful watch for them, as they are determined upon extermination of the band of Apaches.

REDUCTION IN LIQUORS.

CHICAGO, June 8.—The whisky trust is figuring on a reduction of prices of spirits. The Japanese process of distilling, called Takamine, will be adopted immediately by the companies in the combine, and, in consequence of the great saving resulting from the new system, the expense of distilling will be reduced about 15 cents per bushel of mash. This makes it possible for producers to cut the old price of whisky three or four cents per gallon. Retail men as well as wholesale dealers will be benefitted by the reduction, and consumers, are the only ones who will derive no profit from the new list of prices.

DESPERATE DEED.

SALT LAKE CITY, June 8.—In a fit of jealousy, caused by suspicious conduct on the part of his wife, Sam Liday, restaurant keeper, Saturday shot her alleged paramour, John Kirby, night yardmaster of the Rio Grande Western, his own child, aged five years, and, after firing a shot at his wife, turned the pistol on himself and committed suicide. Kirby will die.

MISERY IN BERLIN.

LONDON, June 8.—Berlin is witnessing misery not equalled in many years. This is partly due to the influx of Hebrew refugees from Russia and greatly also from the high price of the necessities of life. The municipal authorities are hardly able to meet the demands of their local distress without giving aid to the uncanny exiles from Russian barbarity. Private charity is inadequate to deal with the exigency, although public appeals to the benevolence of the Berliners are made almost daily. The misery of the expelled Jews is indescribable. Most of them are anxious to go to Houth American, especially Brazil, for which country it is said they have free tickets, but they have no idea of the state of things there and are almost destitute. A singular feature of the arrivals lately has been the flight from Russia of a number of Roman Catholics along with the Jews. The Roman Catholics are mostly Poles. They report that the persecution of the Jews has been accompanied in Russia by being severely oppressive against Roman Catholics, whose pastors have in several instances been imprisoned on frivolous charges. Their churches are arbitrarily closed and tempting inducement made for conversion to Orthodoxy.

A NEBRASKAN DEAD.

OMAHA, Neb., June 8.—Byron Read, a pioneer settler of Nebraska and the wealthiest landowner in the city, being rated at \$2,000,000, died Saturday morning. The will leaves a valuable piece of land upon which to erect a public library. His collection of incomes is also left to the city, and he makes numerous charitable bequests, amounting in all to over \$100,000. In early life Read
