TAKE THEM UP AT THEIR OWN PROPOSITION.

The best interests of Salem now demand that the proposition accepted by the city council at the hands of the principal property owners and taxpayers of Commercial, Court and State streets be promptly and strictly carried out.

No fairer, safer or more just offer was ever made the city. The city has accepted it. There is nothing in the way now to have our principal streets put in fine condition. The condition they will be put in by this plan, if it is intelligently, honestly and fully executed, will give us the best streets possible for the money and if it is desired in future they can be covered with a more expensive paving.

The plan adopted is founded upon the best principles of road building, and principles adapted to any soil or climate. It is a plan that can be carried out right here at home, with every dollar expended for raw material right about our city and for labor that will again employ the money in Salem improvements.

Under this system perfect streets can be built, there is not the slightest doubt. Under this system our outside contractor will run up a big debt against our city. The people can see this work done and can know what it costs.

It is the great merit of Salem as a city that streets here can be easily improved. Grades are light; drainage is not difficult; the soil is porous and easily disposed of and seldom do rains come down like a water spout, as in so many eastern states. Our streets can be easily made as fine as any in the Union.

Under the proposed plan there is no room for frauds if only proper specifications are adopted and strictly enforced upon the contractors. Let the business men's plan of paving be at once acted upon and the city will never have cause to regret.

PREVENT A RAISE IN INSURANCE RATES.
Several facts have been established by the interviews published in the JOURNAL about the recent fire sensation and the efforts of a foreign insurance trust to re-rate our city, that will justify our citizens in taking any steps to prevent a raise. There should be a meeting of rate-payers to protest and lay the facts about our water supplies and the facts of our excellent fire department and the infrequency of fires before the underwriters.

All doubts and all clouds of suspicion raised about inadequate fire protection at Salem should be completely dispelled. No city on the coast has a better fire record, and no city so rapidly growing has enjoyed such immunity from destructive fires as Salem. Thousands of dollars are taken annually of Salem premiums to pay losses on other cities getting as low rates as Salem does. All this shows the injustice of any advance in rates on any Salem property.

The leading underwriting agencies on the coast should be officially informed of the facts in the case and the silly lie that Salem is in standing danger of a great conflagration should be knocked silly. It is a lie that must be completely counteracted or it will cost our citizens dearly. Insurance business as it is now conducted is as sensitive as a barometer. Underwriters take alarm at the conditions of a city growing as Salem is growing and are forced to advance rates upon the given statement of published facts. It is the facts however that will sustain Salem most strongly in protesting against any advance in rates.

APPOINT ONLY DEMOCRATS ON THE BALDWIN.
N. W. Reform Journal: W. A. Sample has been appointed regent of the Agricultural college by Gov. Penneyer. As Mr. Sample is not now, and as we understand it, never has been a democrat we fall to see the connection. MISCELLANY.

WILL BE A BARONET.

CHICAGO, July 28.—President W. C. Van Horne, of the Canadian Pacific railroad, recently renounced his allegiance to the United States of America and promised to become a loyal subject of Victoria, queen of Great Britain and empress of India. Mr. Van Horne was moved to do this, it is stated, because an alien cannot hold the position of president of the Canadian Pacific roads and steamship lines, which, by special proclamation, were some time ago declared to be an imperial highway.

This entitled the company to a small subsidy annually from the English government, in return for which, in case of war, the government must seize the railway without notice for transportation of troops and stores, or its needs in any particular, of course paying for this use. It is whispered among knowing ones that Mr. Van Horne will at an early date be elevated to the baronetcy. Mr. Van Horne has won his way into a strong position in the combination, albeit it is less than ten years since he resigned the position of general superintendent of the Chicago, Milwaukee & St. Paul to accept the general management of the Canadian Pacific, which at the time, was principally described by the expression "under construction."

THE EMPEROR FREDERICK.

BERLIN, July 28.—A book concerning the Emperor Frederick has recently been seized by the police. It contains much that is remarkable and many statements that are highly sensational, although apparently based on information from the most authentic sources. There was never, the author says, a nobler hearted prince than Frederick. His income while crown prince was not in consonance with his charitable impulses, for the Emperor William I., with the thrift characteristic of the house of Hohenzollern, was clothed with all his children, consequently the Crown Prince Frederick's generosity involved him in a network of debt and compelled him to resort to usurers frequently for aid which his father refused. He was obliged sometimes to pay 60 per cent. The author says he saw one of the crown prince's notes for 3300 marks at this rate of interest. In 1882 his debts became so enormous that relief was exceedingly difficult. Finally Emperor William learned of the difficulty and worried over it almost constantly. He made efforts to extricate his son, but found his savings to be insufficient to wipe out the debts. Leading Berlin banks came to the rescue and bought up and consolidated Frederick's obligations. His financial embarrassments so prayed upon his mind that he several times proposed to renounce his right of succession. When he ascended the throne his total indebtedness fell little short of 15,000,000 marks. Frederick never recovered from the tortures of mind and body to which his financial troubles subjected him. After ascending the throne, Frederick's first care was to discharge all his obligations. The most interesting part of this remarkable book, and probably the one which caused a prompt seizure of it at the government's instance, concerns Emperor William. The author says that the reigning Hohenzollern also was involved in great financial difficulties in his last year before ascending the throne.

FRANCE AND RUSSIA.

St. Petersburg, July 28.—The Grand Duke Alexis banqueted the officers of the visiting French squadron Sunday evening on board the Russian flagship. The utmost cordiality prevailed and the assemblage was brilliant in the extreme. The czar, after the visit on Saturday of the French fleet, sent a message of congratulation to President Carnot, who replied in the most friendly manner. Nihil Vremiya declares it is not for the destined and for Lord Salisbury, but for Bismarck and France, to dictate their will to Europe. The order of the French vanguard was diminished by the absence of all reference to the republic. This is explained to them by the statement that the czar cannot drink to the welfare of democ-
